

2022 Dutch Soccer School 4v4 Team Hold Harmless Agreement

By accepting, I, the parent or legal guardian of the player listed below, ask that he/she be admitted to participate in the 4v4 Dutch Cup (the "Program") held by Dutch Soccer School. I understand the risks and hazards associated with my child's participation in the Program and certify that my child is in good health and give my permission for his/her participation in the program.

I authorize all emergency and medical treatment which may be needed in the event of any injury. I also understand that primary insurance coverage is my own responsibility. In consideration of such admission, I am aware there are risks to me of exposure to directly or indirectly arising out of, contributed to, by, or resulting from an outbreak of any and all communicable disease, including but not limited to, the virus' severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)", which is responsible for Coronavirus Disease (COVID-19) and/or any mutation or variation thereof. Participation in Dutch Soccer School programs, events, and activities involves the potential exposure to, and illness from infectious, communicable diseases, including COVID-19. While following Federal and State guidelines, State Soccer Association "Return to Play" Guidelines, and Dutch Soccer School COVID-19 Protocol may reduce the risk, the risk of serious illness and death does exist. Dutch Soccer School, the tournament location, cannot, and does not guarantee, warrant, or represent that participants will not contract a communicable disease, including but not limited to covid-19, as a result of participation in its programs, events or activities. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, HOLD HARMLESS, AND FOREVER DISCHARGE Dutch Soccer School, tournament location, its officers, officials, agents and/or employees, other participants, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event (RELEASEES), from any and all claims, demands, losses, liability, rights, or causes of action of whatsoever kind arising out of, or in any way connected to or related to any illness, injury, disability, damages or death I may suffer or sustain as a result of my participation in Dutch Soccer School programs, events or activities, whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law.
