

# B ail-Out annuity SRA 1 Standard Insurance

The SRA 1 has a provision that allows a client to Bail-Out/leave the contract with no penalties. If the interest rate drops below the initial crediting rate by 1.00% or to 3.50% whichever is greater for years 2-5 and below the initial crediting rate by 2.00% or to 3.50% whichever is greater in year 6.

Surrender is 6 years 7,7,7,6,5,3 NO MVA. Other features include a <u>return</u> of premium guarantee at any time, nursing home/terminal illness waivers and a persistency bonus of 1% in year 7 and 0.25% for years 8 and beyond. Commission is 3.75% (0-80) 1.85% (81-85).

Currently the rate on the SRA 1 is (over \$100,000) 4.70% first year 3.70% base rate, (under \$100,000) 4.60% first year 3.60% base rate.
