GM Ends Program that Shared Customer Driving Data with Brokers and Insurance Companies

Well, that didn't take long.

We first told you a few days ago of a *New York Times* story about a [lawsuit filed against General Motors](#) by a customer upset that his driving data had been shared with insurers.

Friday, GM announced it has stopped sharing information about braking, acceleration, and speed with a couple of firms that then used that data to produce driver risk profiles for insurance companies.

This week's decision comes in the aftermath of a recent lawsuit filed by Romeo Chicco, a Florida man who claims [sharing his driving data caused his insurance rates to nearly double](#) for his 2021 Cadillac XT6 and furthermore led to his rejection by seven other insurance companies late last year.

The Times reported earlier that GM had been sharing this driver data for years, with some customers saying they were enrolled without their knowledge in OnStar Smart Driver – an app that collected information about their driving habits and promised feedback and digital badges for good driving.

GM responded quickly to the suit, announcing in an emailed statement that since Wednesday, March 20, “OnStar Smart Driver customer data is no longer being shared with LexisNexis or Verisk,” two companies that had generated risk profiles with the information provided by GM.

“Customer trust is a priority for us,” GM spokeswoman Malorie Lucich said in the email, “and we are actively evaluating our privacy processes and policies.”

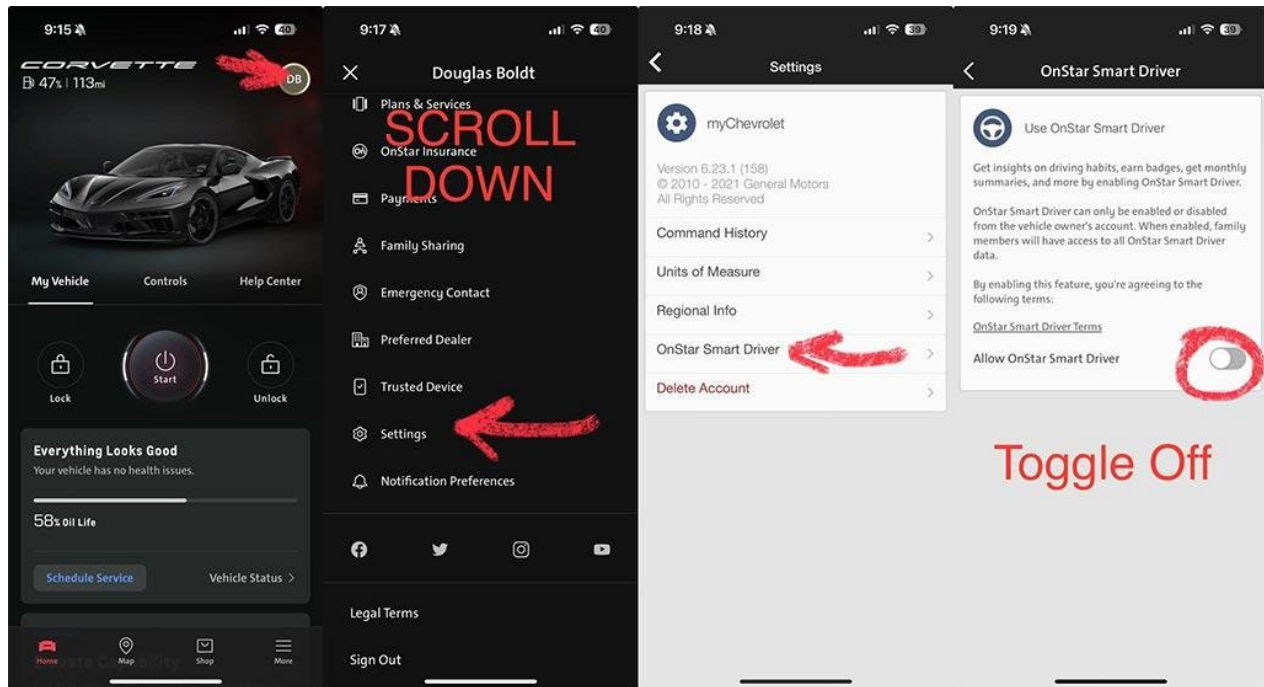
The Smart Driver program had more than 8 million vehicles registered as of 2022, generating annual revenue for GM in the low millions of dollars, the Times discovered in an internal GM document.

But, if you still would like to prevent them from capturing that data:

Check Your MyChevrolet App to Opt Out of GM Sharing Your Driving Habits with Insurance Companies

The OnStar Smart Driver program requires a 2015 or newer GM Vehicle and an OnStar Safety and Security Plan, which means that C7 Corvettes (2015-2019) (excluding 2014 Stingrays) and all C8 Corvettes could be spying on you and reporting how often you brake hard, accelerate fast and drive faster than 80 mph. Starting in 2022, Chevrolet made the \$300 OnStar subscription mandatory on all new Corvettes, so it’s possible that you are enrolled without your knowledge.



To make sure you are opted out of the program, pull up your MyChevrolet App and make sure you are not enrolled in the OnStar Smart Driver program. The graphic above was posted to Facebook on the C8 Corvette Owners group, and it shows the steps you need to take on the app to no longer consent to the program.

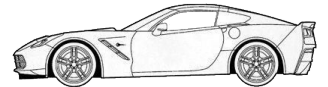
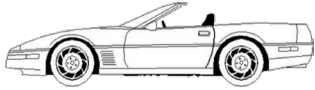

VICE PRESIDENT'S MESSAGE

MARCH 25, 2024



On March 20th I looked through the Western States Corvette Council (WSCC) website to see what was new. I found some old things actually as the front page has events from 2023. The website is not really being maintained. On the Board of Directors page, only four directors are shown leaving four unfilled seats. WSCC would love to have anyone join the board that is willing to. The Member Benefits page has not been updated.

Western States Corvette Council (WSCC) held their latest membership meeting March 23, 2024 in person at the Casa De Fruta complex in Hollister. Steve and Barbara Boyer attended with me on behalf of NBCA.

WSCC reported that there are 206 Memberships and 346 total members counting spouses. There has been 1 new member added in 2024. NBCA has not notified WSCC of any membership changes since 2022. The lawsuit has a scheduled court date of October, 2024, however, the planned depositions at the end of 2023 were not done as yet. WSCC stated that they do have liability insurance and there is club D & O insurance, but still there is no moving vehicle insurance. Chubb is the current insurer.

As Norm, the President of WSCC sits on the National Corvette Museum board, he spoke about the goings on at the museum. There is an ongoing national search for a replacement CEO. When asked why the last two CEOs had very short tenures, he stated that they didn't end up being very good fits. Without a CEO, Bryce Burklow is acting COO. Norm commented that their newest leadership hire, Ryan Eichler is scoring points in his role as Director of Marketing. The next major event at the museum is the 27th annual Michelin NCM Bash. The Bash is being held from March 25 to 27.

Norm stated that the museum expects about 6000 Corvettes to arrive in Bowling Green for the Caravan. The Bowling Green police will not allow for a formal timed arrival at the museum for a drive around due to traffic and safety vehicle requirements. There simply are too many cars for a formal "arrival."



In January, Norm attended the NCM museum board meeting by Zoom. He further stated that there are required travel to the Museum that WSCC will reimburse. The travel is for the Bash and again right before or in coordination with the Anniversary Celebration in August.

The Treasurer Margie stated that year to date the club has spent \$2400 and there is \$50,000 in the bank. The expenses are minimal organizational expenses such as Post Office box rental, the storage unit, website, postage and other miscellaneous costs. WSCC is trying to sponsor a golf cart rental at the IMSA races in May at Laguna Seca but will only do so if insurance can be secured. The cost is nearly \$1000.

I keep an eye on the National Council of Corvette Clubs (NCCC) website and also the NCCC West Coast regional site. The only events listed for 2024 in our West Coast region included an autocross held in Santa Maria by the Vapor Trail Vettes club on March 9 and the Santa Clara Corvettes Car show scheduled on September 15. There is very little event activity scheduled for the West Coast NCCC region in 2024.
