- 3. TREASURER'S REPORT: Galen D. Paid up on New Magma
 - a. General Account: \$20995.83 as of July 2023
 - b. Irrigation Account: \$1184.08 as of July 2023

4. OLD BUSINESS:

- a. Easement obtainment for the well site on Felix to the New Magma turnout on the canal road, funding needed
 - i. New Magma will release 2024 water availability in Oct 2023
 - ii. 2023 demand higher than allotment
 - iii. Motion to spend up to \$13,000 to obtain easements through Goff and Green properties, survey and legal costs to ensure easement is legal. Motion: Tyler H., Seconded Jody T. Motion Carried
 - iv. Discussion regarding New Magma possibly having funding for pipe system through grant monies, may repay incurred costs as a onetime lease fee in exchange for 18 year lease
- b. Lighting concerns in the neighborhood
 - Request for Board of Directors to send a letter citing the section of CC&Rs and requesting the offending property owners come into compliance
 - ii. Request to update impacted property owners as actions are taken

5. NEW BUSINESS:

- Maintenance and clearing of wash along Magma Road to prevent possible flooding
 - i. Ditch has historically been cleared with road maintenance, mesquite trees currently growing in ditches
 - ii. Possible solution to spray then physically remove debris
 - iii. Possible solution to rally neighbors to work together to clear ditches
 - iv. Tyler to get estimated costs to spray as first line of action
- b. Discussion held regarding culvert location at the intersection of Magma and Aladdin
