More than one beneficiary may be selected at the discretion of the BGCA Board of Directors. Required questions are below, and this application requires Board of Directors/Chairperson/President signature.

- After January 29: Initial inclusion on Festival of Trees promotional materials
- May/June: BGCA meets with beneficiary(ies) staff/Board of Directors to review details, logistics, and planning
- October 1: Festival of Trees tickets on-sale (shared promotion from beneficiary(ies))
- November 23: Festival of Trees event (beneficiary(ies) presentation to attendees
- December 30 (or before): BGCA privately provides funds raised to beneficiary(ies)
- January 2026 (TBD): Festival of Trees "Sponsor/Volunteer Thank You Reception" (beneficiary(ies) are publicly presented funds and they present to sponsors)
