Payment of the balance may be made by cash, order or PayPal (3% surcharge applies). Buyer has paid a non-refundable deposit of \$_____ Postal Money Order, or PayPal (3% surcharge applies).

Buyer acknowledges and agrees that Buyer will forfeit the deposit and any rights to the Dog if:

(a) Buyer fails to complete the purchase of the Dog for any reason, or

(b) Buyer fails to pay the balance of the Purchase Price within _____ days of the agreed delivery date.

In either event, Seller shall be free to sell the Dog to another party.

In the event that the Dog is not available due to sickness, death, or any other circumstance owing to the fault of Seller, Buyer's deposit will, at Buyer's option, be either (i) refunded, or (ii) transferred to the next litter of puppies.

A boarding fee of \$_____ per day will be charged for each day the Dog is boarded by Seller past the agreed delivery date.

It is our intent to sell puppies that are happy, healthy, and free of any contagious disease. Every puppy is up to date on vaccines and will have been examined by a licensed Veterinarian, and will have a health certificate if it will travel. We provide a health guarantee for 7 days upon taking possession of the puppy for any contagious disease and a one hear guarantee for life threatening congenital disease. It is up to the Buyer to have the puppy examined by a licensed Veterinarian at the Buyers expense within 3 days of taking possession of the puppy. If the Buyer fails to do so, the Health Guarantee will be null and void. In the event the puppy dies within the one year Health Guarantee period, the Buyer will provide to the Seller the contact information from the Licensed Veterinarian who examined the puppy. At that time, the Buyer will release all pertinent medical records to the Seller, who will have the records reviewed by a licensed Veterinarian. If the puppy has died due to a life threatening congenital disease, the puppy will be replaced by a puppy of equal value within 12 months. The replacement puppy may or may not be from the same parents as the original puppy. Cash refunds are not given. Puppies do not have a fully developed immune system until they have received their full set of vaccinations. They require three rounds of vaccinations starting at 8 weeks of age and every three to four weeks for the next two rounds. Until the puppy has had its full set of vaccinations, <u>DO NOT</u> take the puppy to any areas where it can come into contact with life threatening diseases and sone in your possession for <u>7 days</u>, it is no longer guaranteed against any contagious disease and you are responsible for the financial care of these diseases if your puppy should contract one of them. To ensure that Buyer does not euthanize the Dog or take it to an animal shelter, Seller will take the Dog back at any time during the Dog's lifetime.
