**Both parties understand and agree to the following:**

Stud is guaranteed to be in good health and up to date with vaccines.

Health tests via Animal Genetics or Uc Davis will be presented upon request.

**1 or less pups does not constitute a litter. Le Pepite Frenchies will not charge a second stud fee to repeat the breeding if only 1 or less pups are produced. 2 puppies constitute a litter.**

Other factors may also warrant rebreeding.

Le Pepite Frenchies must be notified of failed pregnancy within 68 days of insemination. Failure to do so will result in termination of contract.

Owner of the bitch is required to show proof of correct progesterone levels before insemination, unless progesterone is done in-house with Le Pepite Frenchies.

Free rebreeding will not be included if bitch owner proceeds with insemination outside of good breeding range.

Should the bitch not take again for the second time, the contract is then terminated, and further evaluation at a reproductive specialist is recommended.

Rebreeding (aside from in house breedings): Any fees associated with extraction, insemination, and or shipping are required to be paid by the bitch's owner. (Costs will vary per vet and carrier for extraction and shipping). **In house progesterone with Le Pepite Frenchies is not included.**

Bitch Owners are required to keep the bitch properly confined to guarantee no other stud has come in contact and bred with the intended bitch before mating season is finished.

**Final Agreement:**

All parties have read and understand the terms of this agreement. **No other warranties or guarantees, expressed or implied, are made under this contract, except as stated within.** This contract is legal and binding. Agreement is signed and dated in duplicate. This contract is signed in the County of Fairfax, in the State of Virginia. Any civil action brought between the breeder or buyer must be filed in the County of Fairfax, State of Virginia.
