- Artwork that can be wall hung, e.g. 2 dimensional
- Original art only. No copies of -artworks or artists. No reproductions or giclees, or AI enhanced work.
- Show consists of a Main Juried Exhibition and Portfolio Display

- It is understood that artist's images may be used for promotional purposes.
- By submitting work, the artist understands and agrees that the Art·Venture organization, and the Hunterdon Chamber of Commerce, along with their members, directors, and officers are not liable for loss or any damage to artwork. All submissions will be handled with the utmost care and professionalism. We recommend that members insure their work while it is at the Chamber.

ENTRY & SHOW DETAILS

- **Entry Fee:** \$35 Member, \$45 Non Member
- Maximum of two pieces may be entered.
- Digital images: 1920 pixels on the longest side, JPG format only. No larger than 3MB file size.
- One photo of each piece. Do not include the frame in the image, only the artwork.
- Images **must be** labeled:
ArtistName_Title_Size_Medium_Price
- Incomplete submissions, improperly labeled JPGs, or submissions received after April 13 will not be considered
- All work must be for sale
- Commissions 30% of sales will be taken by Art·Venture.
- Payment for sold works will be made within 30 days of exhibit closing.

SELECTION & AWARDS

- Notification of acceptance will be emailed to artists and posted on the website by 4/26/26 (www.artventurenj.com)
- Awards will be given at the jurors' discretion. The decision of the jurors is final.

ACCEPTED WORKS

- Works with protruding nails, staples or saw tooth hangers will not be accepted.
- Use braided wire or strong plastic line.
- All works on gallery wrapped canvas must have painted sides and be wired for hanging or will be declined upon delivery.
- Size limit for all framed pieces is 40", inclusive of frame, on longest side.
- Artist name, artwork Title, Medium, Size, Price and artist's phone number must be **on the back of all pieces** prior to drop off.
- ArtVenture reserves the right to reject artwork not properly framed or inaccurately represented in digital submission.

PORTFOLIO PIECES: *All entrants* may exhibit up to two portfolio pieces. They must be wrapped in a protective clear plastic covering. Each item must be labeled on the **front in the lower right-hand corner** with artist's name, title, medium and price, in addition to the labeling on the back.
