## ELIGIBILITY

- ArtVenture will accept paintings, works on paper, mixed media, photography & digital art.
- Anyone 18 and older may enter.
- Original art only. No copies of artworks or artists. No reproductions or giclees.
- Maximum of two pieces may be entered.
- Digital images: 1920 pixels on the longest side, JPG format only. No larger than 3MB file size.
- One photo of each piece. Do not include the frame in the image, only the artwork.
- Images must be labeled:  
ArtistName\_Title\_Size\_Medium\_Price
- Payment must accompany entry. Deadline for show = deadline for payment and entry.
- Incomplete submissions or submissions received after DATE will not be considered
- It is understood that artist's images may be used for promotional purposes.

## Exhibition Specifications

- Works with protruding nails, staples or saw tooth hangers will not be accepted.
- Use braided wire or strong plastic line.
- All works on gallery wrapped canvas must have painted sides and be wired for hanging or will be declined upon delivery.
- Size limit for all framed pieces is 40", inclusive of frame, on longest side.
- Artist name & phone number must be on all pieces accepted for hanging, prior to drop off.
- All works must be for sale.
- ArtVenture reserves the right to reject artwork not properly framed or inaccurately represented in digital submission.
- Accepted artists may submit one or two portfolio pieces. They must be wrapped in a protective clear plastic covering. Each item must be labeled on the front in the lower right-hand corner with artist's name, title, medium and price.

## Selection and Awards

- Notification of acceptance will be emailed and posted on the website on 7/01/25. [www.artventurenj.com](http://www.artventurenj.com)
- Awards will be given at the jurors' discretion. The decision of the jurors is final.

## Sales

- Commissions 30% of any sales will be taken by ArtVenture.
- Payment for sold works will be made within 30 days of exhibit closing.
