Monitoring Activities

Surface water

- The next sampling date is planned for 9/15-9/16/2020.
- Most recent sampling date on 8/18 – 8/19/2020.

Pesticides (August 2020 results pending)

➤ July 2020

- Union Island – Pyrethroids; 44 Concentration Goal Unit (1 CGU is the trigger limit)
- Temple Creek – Pyrethroids; 2 CGU

Both sites (Union Island and Temple Creek) are in management plans for pyrethroids. Union Island July pyrethroid exceedance is very high at 44 times the trigger limit. Both exceedances were due to bifenthrin.

Toxicity (August 2020 results pending)

➤ August 2020

- Algae toxicity at Roberts Island and Walthall Slough.

➤ July 2020

- Algae toxicity at Mokelumne River and Roberts Island.

Groundwater

2020 Trend Monitoring

- 2020 trend monitoring complete. Results pending.
- Next steps include identifying members who have nitrate levels above the maximum containment limit (MCL), and sending a notification form if they have not received notice before.
- Once data is QC'd, members will receive groundwater well nitrate level results as a packet (est. October 2020).
