

General information

This policy sets out our privacy practices and explains how we handle the information we collect when you visit and use our sites, services, mobile applications, products, and content ("Services").

What we may collect

We collect information about what Euphoric With Style pages you access, information about your mobile device (such as device or browser type), information you send us (such as an email address used to register or communicate with us), and referral information.

When you use Euphoric With Style Services, we may collect and store your Internet Protocol address. We may use this information to fight spam and other abuse; to personalize Euphoric With Style Services; or to generate aggregate, non-identifying information about how people use Euphoric With Style Services.

When you create your Euphoric With Style account, we collect your e-mail address, username and password (encrypted).

Email from Euphoric With Style

Sometimes we'll send administrative emails about account or service changes, or new policies. You can't opt out of them. You can always opt out of non-administrative emails such as daily digests.

We won't email you to ask for your password or other account information. If you receive such an email, send it to us so we can investigate.

Disclosure of your information

As a rule, we don't share your personal information outside the company.

We won't sell your personal information.

We may share your personal information with third parties in limited circumstances, including: (1) with your consent; (2) to a vendor or partner who meets our data protection standards; or (3) when we have a good faith belief it is required by law, such as pursuant to a subpoena or other legal process.

If we're going to share your information in response to legal process, we'll give you advance notice so you can challenge it (for example by seeking court intervention), unless we're prohibited from doing so by law or court order. We will object to requests for information about users of our site that we believe to be improper.

If we merge with another company such that your information will become subject to a different privacy policy, we'll notify you before the transfer. You can opt out of the new policy by deleting your account during the notice period.

Cookies

We use cookies and similar technologies such as pixels and local storage to recognize you when you return to our Services. We use them in various ways, for example to log you in, remember your preferences (such as default language), evaluate email effectiveness, show relevant ads, and personalize information.

Some third-party services that we use, such as Google Analytics, YouTube, SoundCloud, Spotify or Facebook, may place their own cookies in your browser.

If you turn cookies off, Some of the features that make your site experience more efficient may not function properly. Some of the features that make your site experience more efficient and may not function properly.

Functional cookies

With cookies it is possible to retrieve information from previous visits during follow-up visits. This is used in practice to keep track of the fact that you are logged in, that you have saved certain settings and that you have seen certain site elements before. Cookies that adapt the functioning of the site to your wishes are called functional cookies.

Analytical cookies

Analytics cookies that anonymously remember your computer or mobile device when you visit our website. They keep track of browsing patterns and help us to build up a profile of how our visitors use the website.

Marketing cookies

Marketing cookies are used for advertising purposes. Some parts of our website rely on advertisement revenue to keep the website running.

Third party cookies

Third party advertising and analytics cookies, which are placed by or on behalf of independent advertisers who are advertising on our site. These cookies may be placed within the advertisement and elsewhere on our site. They are anonymous – they cannot identify individuals. They are used for statistical analysis by allowing the advertiser to count how many people have seen their advertisement or have seen it more than once. They might also allow the advertiser to tailor advertising to you when you visit other websites.

We have no access to third party cookies and third party organisations have no access to ours. The third party organisations that place cookies have their own strict privacy policies.

Data Storage

Euphoric With Style uses third-party vendors and hosting partners, for hardware, software, networking, storage, and related technology we need to run Euphoric With Style. We maintain two types of logs: server logs and event logs. Our data is hosted in the European Union (EU) and subjected to EU Privacy laws.

Modifying your personal information or deleting your account

If you have a Euphoric With Style account, you can access and modify your personal information. If you want to delete your account, please contact us.

To protect information from accidental or malicious destruction, we may not immediately delete residual copies from our active servers and may not remove information from our backup systems.

If you delete your account, your account and content may be unrecoverable.

Data security

We use encryption (HTTPS/TLS) to protect data transmitted to and from our site. However, no data transmission over the Internet is 100% secure, so we can't guarantee security. You use

the Service at your own risk, and you're responsible for taking reasonable measures to secure your account (like using a strong password).

Data Protection Statement for European Union Users

Euphoric With Style collects and stores some personal information about its users to customize their experience and enable personalized distribution of content. It shares minimal data with its service providers.

Purpose of processing

- Provide, test, promote, and improve the services
- Gather usage statistics of services
- Provide a customized experience
- Publish and distribute user-generated content
- Fight spam, fraud, and other abuse of services

Legal basis

In order to provide the services, Euphoric With Style collects and stores personal data about its users on the legal basis of consent given when you create an account and agree to the Privacy Policy.

Euphoric With Style also pursues its legitimate interests by collecting minimal data of logged out users to provide the services, as outlined above.

Where Euphoric With Style collects and stores personal data about non-users, it does so under performance of contract obligations with users who use the services to publish content on web sites hosted by Euphoric With Style. In such cases, users authoring such content containing personal data of third parties are responsible for that content. Euphoric With Style will consider related complaints in compliance with the General Data Protection Regulation's rights of the data subject, as well as rights of expression and access to information.

Public Nature of Personal Data

Logged-in users may choose to interact publicly with the Euphoric With Style Services in the form of creating topics, creating forum posts or interacting with other users. Where such personal data may reveal special category protected data, it is processed on the basis that it is manifestly made public by the user. Additional information on potential consequences of such processing can be found below. Euphoric With Style shares minimal personal data with third-party processors in order to provide the Services. These processors offer at least the same level of data protection as that set out in this statement. This includes the following categories of recipients:

Search engines will index user profiles, public interactions, and any user-generated content.

Embedded Content

Euphoric With Style posts may contain third-party embeds, which may in some cases collect and store personal data. The use of personal data by embedded content providers is not covered by this statement, but by the privacy policies of those sites or services.

Potential Consequences of Processing

By creating an account on Euphoric With Style, users may make certain personal data about themselves public and accessible to others on their profile and through network interactions. This may in some cases constitute special category protected data which is considered manifestly made public by the user.

Due to the public nature of information posted to Euphoric With Style, it may be possible for third parties to derive identifying personal data from posts, whether by reading, inference, supplemental research, or automated extraction and analysis.

Users are free to use their real name and information, or a pseudonym of their choosing, for their account. Users may also choose to use the service without posting data or engaging in network interactions. However, if you do not agree with and accept the risks of such usage, you may not use the services.

Retention

Euphoric With Style retains personal data associated with your account for the lifetime of your account. If you would like to delete your personal information, you can delete your account at any time. Deleted account profile pages will yield an error 404 "file not found" page, immediately upon initiating deletion, and will become unrecoverable in our system after a period of fourteen days. It may take several additional days for your personal data to be de-indexed from search engines, depending on those search engines'™ practices, over which Euphoric With Style may have limited or no control.

Rights of Data Subjects
