


LETTER FROM THE DEPUTY DIRECTOR



GULF COMMERCIAL FISHERMAN PROGRAM

The launch of the <u>Gulf Commercial</u> <u>Fisherman Program (GCFP)</u> in October 2024 was the result of five years of dedicated effort by the Shareholders' Alliance and industry leaders across the Gulf of Mexico.



Working collaboratively with experts from diverse commercial fisheries—including reef fish, shrimp, pelagic longline (PLL), stone crab, and spiny lobster—we developed a program tailored to address the workforce challenges facing the fishing industry. By combining input from experienced fishermen with targeted training strategies, the program equips participants with the knowledge and skills they need to succeed in commercial fishing.

The 'graying of the fleet' is not just occurring in the Gulf - it's happening all across the country. In response and recognizing that there are commonalities across fisheries and fishing communities for the barriers next generation face, the Shareholders' Alliance is spearheading the formation of the National

Future Fishermen Coalition (NFFC). This Coalition, formed in 2023, comprises six member organizations, all of whom have programs engaging and assisting generation fishermen.

The current Steering Committee members are: Alaska Longline Fishermen's Association, Commercial Fisheries Center of Rhode Island, Maine Coast Fishermen's Association, New England Young Fishermen's Alliance, Cape Cod Commercial Fishermen's Alliance, and Bob Gill, an independent fisheries expert.

We are thrilled to have added Maite to our team to lead this effort. In the last year, she and coalition members are building the foundation for the NFFC, and we look forward to having our website and brand finaleed in the coming years. Stay tuned for more information on this exciting initiative.

HURRICANES AND WATERFONT RESILIENCE

This year, Hugh won the Leadership for Climate Resilient Fisheries Fellowship, which funded work focused on waterfront resilience. Hugh and Ally Aplin, our Spring 2024 intern, traveled to Madeira Beach, Crystal River and Steinhatchee, produce a short documentary educating consumers and policymakers on the value of protecting working waterfronts, with support from a number of Shareholders' Alliance members. Ally also created an infographic providing information about the resources available to commercial fishermen in the wake of hurricanes. Finally, Hugh organized and moderated a panel of disaster relief experts from the Florida FIsh and Wildlife Conservation Commission, Florida SeaGrant, and the Florida Small Business Development Center at the November 2024 Gulf Council Meeting in St. Petersburg, Florida.

The Quota Bank completed its tenth year of operation this year! In that time, it has provided 611,431 pounds of Red Snapper allocation to 68 distinct fishermen around the Gulf who would otherwise not have had access. This equates to \$3,616,545 in gross revenue and an estimated \$1,023,671 in profits. In 2024, the program provided 79,986 lbs of allocation to 18 fishermen! We'd like to thank again those Shareholders' Members who have made this work possible through their generous donations of shares to the Quota Bank and look forward to another ten years reducing discards and supporting fishermen Gulf-wide.

GULF COUNCIL WATCH: REGIONAL POLICY IN ACTION

This year has been a pivotal one for fisheries management in the Gulf of Mexico, with the Shareholders' Alliance actively participating in critical discussions and decisions at the Gulf of Mexico Fishery Management Council (Gulf Council). Read on to discover key developments for some of these issues and how they impact the Gulf's fisheries.



GULF COUNCIL WATCH: REGIONAL POLICY IN ACTION

NEW LEADERSHIP ON THE GULF
COUNCIL

Commercial and charter fishermen and those that care about sustainability and accountability - scored a major win in 2024 with the appointment of Juan "John" Sanchez and Captain Troy Frady to the Gulf Council. Both bring a wealth of experience and a deep understanding of what it takes to make a living on the water. Already, they have shown their value as Gulf Council members by standing up for science and advocating for balanced approaches. Their management contributions are helping ensure a more fair, equitable and sustainable future for the Gulf's fisheries.



ELECTRONIC LOGBOOKS APPROVED

After years of advocacy, the Gulf Council finally approved the use of electronic logbooks (ELBs) for the commercial reef fish fishery, with implementation expected by the summer of 2025. This transition from paper-and-pen reporting to a modernized, electronic reporting system will streamline reporting, reduce redundancy, and provide better data for managing the Gulf's fisheries. This is a win for efficiency, good science, and for the industry's (and Agency's) ability to adapt to modern management needs.



GULF COUNCIL WATCH: REGIONAL POLICY IN ACTION

RED SNAPPER

Our partnership with the charter/for-hire industry continues to grow stronger as unite we in addressing concerning trends with red Across the Gulf, snapper. fishermen are reporting alarming declines in red snapper size and abundance.



Together, we are urging managers to adopt precautionary measures when considering management changes to ensure the long-term health of the stock and stability for fishing businesses.

AMENDMENTS 58A AND 58B SHALLOW AND DEEP WATER GROUPER



We are closely monitoring the progress of Amendments 58A and which propose significant changes to the shallow and deep water grouper fisheries. amendments could have far-reaching consequences for commercial fishermen. For detailed information, check out our last Gulf Council update. As always, we are committed to advocating for science-based solutions that protect fishermen's livelihoods and do not reward a sector that continues to without meaningful accountability measures.

GULF COUNCIL WATCH: REGIONAL POLICY IN ACTION

AMENDMENTS 59 AND 60: IFQ PROGRAMS

We are also tracking Amendments 59 and 60, which propose updates to the Individual Fishing Quota (IFQ) programs in the Gulf of Mexico. The Shareholders' Alliance is carefully analyzing these proposals to determine their potential impact on our members and, in particular, the Reef Fish Quota Bank. We strongly believe in the value of the Quota Bank, which has been instrumental in supporting next-generation fishermen and reducing discards and providing a grassroots community-based approach to management, and we will advocate for its continued operation. We are also analyzing the potential impacts of the actions and alternatives in these documents on the different factions and roles in the fishery (i.e. deckhand, owner-operator, fleet owner, fish house).

We encourage all members to stay engaged and informed as these policies develop, and we thank you for your continued support in these efforts.

FEDERAL POLICY UPDATE: NAVIGATING CHANGE AND ADVOCACY

The federal policy landscape continues to evolve, and the Shareholders' Alliance remains committed to staying informed and proactive on the issues that matter most to our members. We encourage our members to stay informed and engaged, as these issues will shape the future of our fisheries and our communities.



FEDERAL POLICY UPDATE: NAVIAGTING CHANGE AND ADVOCACY

PRESIDENTIAL ADMINISTRATION TRANSITION

As the country prepares for the presidential administration transition, we are closely monitoring what changes may lie ahead and engaging strategically in this process. While we know that fisheries management and marine conservation are often perceived as bipartisan issues, the specific priorities and policy directions under a new or continuing administration remain uncertain. We are also closely watching to see who potential candidates might be for key positions, such as NOAA Administrator, and NMFS Administrator, as these roles will significantly influence federal fisheries policies.



FEDERAL POLICY UPDATE: NAVIAGTING CHANGE AND ADVOCACY

LEGISLATIVE SUMMARY

Seafood in the Farm Bill

Progress is being made to include provisions for seafood in the 2024 Farm Bill. These measures aim to strengthen support for working waterfronts, seafood expand marketing opportunities. and ensure American seafood has a seat at the table in federal agricultural policy. We are encouraged by the bipartisan attention this issue is receiving.

FISHES Act

The Fishery Improvement to Streamline Untimely Regulatory Hurdles post Emergency Situation (FISHES) Act. sponsored by Congressman Byron Donalds (R-FL), seeks to expedite the distribution federal disaster relief following official fisherv disaster declarations. The Shareholders' Alliance has joined a coalition of 100 organizations over support of this bipartisan legislation, which has passed the House and is now under consideration in the Senate.



FEDERAL POLICY UPDATE: NAVIAGTING CHANGE AND ADVOCACY

AQUACULTURE

The conversation around aquaculture operations in the Gulf of Mexico are still progressing. While aquaculture has the potential to complement wild-caught fisheries, we are advocating for stringent oversight, transparency, and careful consideration of how these operations impact the environment, wild stocks, the seafood marketplace, and coastal fishing communities.



Currently, NOAA Fisheries has released a Draft Programmatic Environmental Impact Statement (DPEIS) for the Identification of Aquaculture Opportunity Areas in U.S. Federal Waters of the Gulf of Mexico. The public comment period is open from November 22, 2024, through February 20, 2025. We encourage you to review the DPEIS and submit comments to ensure that any developments in aquaculture enhance—not harm—our marine ecosystems and the livelihoods of fishermen. OFFSHORE WIND

The push for offshore wind energy development in the Gulf of Mexico is gaining momentum, most recently with the December 12, 2024 announcement from the United States Bureau of Ocean Energy Management (BOEM) that there is competitive interest in two Wind Energy Areas in the Gulf.


We are actively engaging in these efforts to ensure fishermen's voices are heard, advocating for responsible development that minimizes impacts to our industry and the marine ecosystem that supports our businesses and coastal communities.

Legal Updates: Key Fisheries-Related Court Cases



AP BELL V RAIMONDO (AMENDMENT 53/RED GROUPER

On March 1, 2024, the DC Circuit Court of Appeals ruled that NMFS used a flawed economic analysis in justifying Amendment 53's red grouper reallocation away from commercial fishermen to the recreational sector. While the Court didn't vacate the Amendment 53 (that is, the reallocation still stands). the remanded the case back to NMFS for further analysis. Despite repeated requests from the Shareholders' Alliance, the concerned public, our lawyers, and Gulf Council members, NMFS refuses to bring this new analysis to the light of day and appears content with conducting it behind closed door and without any public - of Gulf Council - involvement.



We will continue to work to bring transparency to this process, reverse this decision based on flawed analysis and to return the red grouper allocation that was taken away from commercial fishermen.



LEGAL UPDATES: KEY FISHERIES-RELATED COURT CASES

FISHERY MANAGEMENT COUNCIL CONSTITUTIONALITY CASES

Several lawsuits have been filed challenging the constitutionality of the Fishery Management Council system, which is responsible for managing U.S. fisheries. These lawsuits generally focus on the following key issues:

- 1. **Delegation of Power:** Critics argue that the Fishery Management Councils, which are made up of industry representatives and other stakeholders, are given too much regulatory power. This could violate the Constitution's separation of powers because the councils act like government agencies but aren't directly accountable to voters or the president.
- 2. Appointments Clause: Some lawsuits claim that council members are not properly appointed under the U.S. Constitution. The Appointments Clause requires certain officials to be appointed by the president and confirmed by the Senate, but Fishery Management Council members are often appointed by state governors or the Secretary of Commerce, which plaintiffs argue violates this rule.
- 3. **Unreasonable Search/Due Process:** Some lawsuits argue that the councils' actions harm fishermen by imposing costly and intrusive regulations, like requiring monitors or limiting fishing practices, without providing adequate procedural protections or input from the affected parties. This, they say, violates rights against unreasonable searches and due process rights guaranteed by the Constitution.



LEGAL UPDATES: KEY FISHERIES-RELATED COURT CASES

LOPER BRIGHT ENTERPRISES V RAIMONDO (OVERRULING "CHEVRON" DEFERENCE)

Earlier this year, the Supreme Court issued a ruling on a suit brought by herring fishermen regarding whether or not the MSA authorizes NOAA to require them to pay for fisheries observers on their vessels. The Supreme Court did not decide that question, but used the case as an opportunity to strike down the so-called "Chevron doctrine." Under that doctrine, courts should defer to government agencies when they interpret unclear laws. In this case, the Supreme Court ruled that if a law is unclear, the government's interpretation is not the last word. Instead, the courts must determine what the law means, and agencies can't just fill in the gaps however they want.

The full implications of this ruling are still being understood. While this seems like a win for fishermen and fishing businesses, there are concerns about larger scale impacts this could have. The question of whether the MSA allows NOAA to force industry to pay for observers is now being litigated in the lower courts. We will keep you updated as we learn more.

The Shareholders' Alliance continues to monitor these legal developments closely, recognizing their potential implications for fisheries management and the commercial fishing industry. We remain committed to advocating for fair, science-based policies that support sustainable fisheries and the livelihoods of our members.



Advancing Science Through Cooperative Research

Cooperative research is a vital tool that brings fishermen and scientists together to collect data and find solutions to pressing challenges in fisheries management. By combining practical, on-the-water expertise with sound scientific methods, cooperative research ensures that management decisions are rooted in real-world observations and experiences. The Shareholders' Alliance is actively engaged in several projects, and is seeking new opportunities to engage in these collaborative efforts, recognizing their importance in promoting sustainable fisheries and supporting the long-term health of the Gulf's marine ecosystems.



ADVANCING SCIENCE THROUGH COOPERATIVE RESEARCH



The Shareholders' Alliance, in partnership with the Center for Fisheries Electronic Monitoring at Mote Marine Laboratory (CFEMM), is advancing electronic monitoring (EM) technologies in the Gulf's commercial reef fish fishery. EM systems use onboard cameras to record data on catch, bycatch, and fishing activities, providing accurate, timely information that enhances fisheries management. CFEMM has equipped numerous volunteer fishing vessels with EM systems, demonstrating the technology's value in filling critical data gaps and directly involving fishermen in the scientific process.

OPTIMIZED RETENTION

Working with CFEMM, several bottom longline vessels are testing whether keeping red grouper below the current size limit can reduce discards, create market demand for smaller fish, and provide valuable biological data to improve understanding of the species. Most age and length data rely on otoliths (ear bones) from fish 18 inches and larger, so this initiative offers insights into smaller grouper often excluded from research. Undersized red grouper are tagged and cameras used to record catch activity. This highlights the potential of EM to enhance data collection and explore innovative, science-based management solutions.
