Donna Brooks has been part of the commercial fishing industry for the past 35 years, starting when she married a fisherman, with whom she raised three kids – two of which are active in Gulf fisheries today. Together they started and grew their business as her husband fished offshore for the first 8 years.

After that they built several more boats and hired captains and crew which gave them time to get involved in fisheries management, including attending meetings of the Gulf of Mexico Fishery Management Council, Florida Fish and Wildlife Conservation Commission, and outreach trips to Washington DC. Donna also

attended a fishermen's exchange trip in Campeche, Mexico to discuss fishery management solutions and ideas.

Donna is very passionate about educating the public about domestic and sustainable seafood. She served on the Shareholders' Alliance board for two years and is currently on the board of [Gulf Wild™](#) - a tracking and traceability program for Gulf seafood. Donna and her family are now revitalizing a small fish house near their home in Inglis, Florida into [Brooks Dockside Seafood](#), where they will offload boats of fresh seafood and operate a small retail market to serve the local community.

## Meredith Pelton



In 2020, Lisa was [recognized by NOAA](#) as one of a core group of women who support electronic technologies in fisheries throughout the nation. Lisa believes in providing young fishermen with opportunities to build their businesses to keep the future of commercial fishing alive in the Gulf of Mexico.
