

# **Guide to Immigration Processes for Newcomers to Canada**


# **Main Immigration Programs for Permanent Residence**

Canada's immigration system is managed by Immigration, Refugees and Citizenship Canada (IRCC). The primary categories include economic immigration, family reunification, and humanitarian programs. Here's a breakdown:

Program	Description	Target Admissions (2025-2027 Levels Plan)
Express Entry	Points-based system for skilled workers. Includes Federal Skilled Worker (FSW), Canadian Experience Class (CEC), and Federal Skilled Trades (FST).	Around 110,000-115,000 annually (part of economic class).
Provincial Nominee Program (PNP)	Provinces nominate candidates based on local needs. Can be Express Entry-aligned or direct streams.	Approximately 110,000 in 2025, decreasing to 100,000 by 2027.
Family Sponsorship	For spouses, partners, children, parents, and grandparents.	About 114,000 in 2025 (22% of total admissions).
Atlantic Immigration Program (AIP)	For skilled workers and graduates in Atlantic provinces (Nova Scotia, New Brunswick, Newfoundland and Labrador, Prince Edward Island).	Integrated into economic targets; around 6,500 spots.
Start-up Visa	For entrepreneurs with innovative business ideas supported by designated organizations.	Small portion of business class.
Humanitarian & Refugee	For resettled refugees and those applying on compassionate grounds.	15% of admissions (around 75,000 in 2025).

Overall, Canada plans to admit 395,000 permanent residents in 2025, down from previous years to address housing and infrastructure pressures.

## **Eligibility Criteria**

Eligibility varies by program:

- Express Entry: Minimum 67 points out of 100 for FSW (based on age, education, work experience, language proficiency in English/French). CEC requires at least 1 year of Canadian work experience. Comprehensive Ranking System (CRS) score needed for invitations (typically 470+).
- **PNP**: Varies by province; often requires job offer, work experience in in-demand occupations, or ties to the province.
- **Family Sponsorship**: Sponsor must be a Canadian citizen/PR over 18, meet income requirements (e.g., Low-Income Cut-Off +30% for parents/grandparents).
- **AIP**: Job offer from designated employer, language level CLB 5, education (high school+), and settlement funds.
- **Humanitarian**: Demonstrated compelling reasons, such as family ties or hardships; no fees for refugees.

Check your eligibility using <u>IRCC's online tool</u> before applying.



## **Application Steps**

- 1. **Assess Eligibility**: Use IRCC's Come to Canada tool.
- 2. Gather Documents: Prepare proofs (see below).
- 3. **Create Profile/Apply**: For Express Entry, submit online profile. For others, apply via IRCC portal or paper if required.
- 4. Receive Invitation to Apply (ITA): If in pool, wait for draw.
- 5. Submit Full Application: Pay fees, upload docs within 60 days.
- 6. Biometrics and Medical: Attend appointments.
- 7. **Decision**: If approved, get Confirmation of Permanent Residence (COPR).

For family/humanitarian, sponsors apply first.

#### **Required Documents**

Common documents include:

- Passport or travel document.
- Language test results (IELTS, CELPIP, TEF).
- Educational Credential Assessment (ECA) for foreign degrees.
- Proof of funds (e.g., bank statements; \$13,757 for single applicant in 2025).
- Police certificates from countries lived in for 6+ months.
- Medical exam results from panel physician.
- Job offer letter (if applicable).
- Birth/marriage certificates for family.

Ensure all are translated to English/French if needed.

### **Processing Times (as of October 2025)**

Processing starts upon complete application receipt. Averages:

- Express Entry (CEC/FSW): 6-8 months.
- PNP (Express Entry): 6 months; Non-Express: 11-20 months.
- Family Sponsorship (Spouse outside Canada): 12 months; Inside: Varies.
- AIP: 11 months.
- Start-up Visa: 37 months.
- Humanitarian: Up to 50 years in extreme backlogs (e.g., 12-600 months for some).

Use IRCC's personalized tool for your submission date. Backlogs affect some streams heavily.

#### **Tips for Success**

- Submit complete, accurate applications to avoid delays.
- Monitor IRCC account for updates.
- Prepare for potential interviews.
- Use settlement services upon arrival for support.
- If eligible, apply from within Canada for faster processing in some cases.
- Stay informed via official IRCC website; avoid scams.
