SJ's Dachshunds ONLY breeds longhair dachshunds as of the date on this contract, *no other coat type is available.*

Waitlist Deposit Amount: \$100 (Non-Refundable)

Payment Methods: Venmo or Zelle

1. Purpose of Deposit

This deposit secures the Buyer's place on the SJs Dachshunds waitlist for upcoming litters. Selection will be made in the order deposits are received and at the Breeder's discretion based on availability and suitability.

2. Deposit Terms

- **The \$100 deposit is non-refundable under any circumstance.**

- Deposits are transferable between litters, should the Buyer decide to wait for a future litter.

- If the Buyer chooses to pass on available puppies from a litter, their deposit remains valid for the next planned litter(s). **This deposit does not expire.**

- The Buyer understands that wait times can vary depending on heat cycles, litter size, color, and gender availability.

- Waitlist deposit is separate from a regular puppy deposit that would be placed AFTER a puppy has been born and selected. The \$100 is NOT deducted from that deposit or total purchase price of the selected puppy.

3. Payment

Deposits must be sent via Venmo or Zelle to the account provided by the Breeder. A screenshot or confirmation of payment must be sent to the Breeder to confirm placement on the waitlist. **IMPORTANT NOTE: If original contact has been made via the GOODDOG platform- ALL payments must go through the platform. It is a violation of my contract with them to take payments outside of their platform. * If you wish to opt out of the fee's associated with the good dog platform, please contact my Facebook page via messenger. Messages between buyers and myself are monitored, do not discuss any outside payment or payment forms inside the messaging app in the good dog platform.**

4. Puppy Selection

When puppies become available, Buyers on the waitlist will be contacted in order of deposit received. The Breeder retains the right to first pick(s) from any litter. If multiple Buyers request the same color, gender, or coat type, **placement will be determined by deposit order.** This deposit does not guarantee that the first available puppy meeting the Buyer's preference will be offered to them.

5. Transfer & Forfeiture
