Applicants will receive confirmation by September 12, 2025. Vendor spaces are limited and we encourage vendors to apply early.

Our goal is to create the experience of an international bazaar with crafts, art, music, dance, and family entertainment. Children delight in the Kid's Zone and game / play area. Greek delicacies and pastry abound in our Greek Food Court. Greek music fills the air!

Festival Details

- Festival Days and Times:** Friday, October 17, 2025 5pm-11pm
Saturday, October 18, 2025: 11:00am - 11:00pm
Sunday, October 19, 2025: 11:00am - 9:00pm
- Vendor Fee:** Vendor fee covers three days (no one-day rates available) and includes tent, table, 2 chairs, light fixture, and electrical outlets. The tent size options are:
Option 1: **\$500** for 10'x10' tent. Option 2: **\$900** for 10'x20' tent.
- Vendor Setup:** Begins 2:00pm, on Friday, October 17th. If you require additional time, contact us. Event opens at 5:00pm Friday. Vendors are expected to leave festival grounds Sunday, October 19th by 10:00pm.
- Vendor Deposit:** If you are accepted as a festival vendor, a deposit of \$250 is required no later than September 12th, with full payment due no later than September 26th. A cancellation fee of \$100 will be charged if you cancel on or after September 26th.

Terms and Conditions If you are accepted as a Festival Vendor, the following terms and conditions will apply to your participation in Temecula Greek Festival 2025. Please let us know if you have any questions about the following terms and conditions.

- Permits:** Vendor must submit a copy of Vendor's California Seller's Permit to Vendor Coordinator on or before September 12, 2025.
- Taxes, Licenses, Fees & Permits:** Vendor acknowledges and agrees that Vendor has the sole responsibility for the payment of all applicable federal, state, and local taxes, licenses, and permits for the merchandise sold by Vendor during the Festival. Vendor license must be compliant with Riverside County fire, safety, and health regulations.
- Security:** Festival grounds are locked each day at closing time. The Festival provides security throughout the Festival and overnight Saturday night. However, sponsors, Saint Nicholas Greek Orthodox Church, and The City of Temecula, cannot assume any responsibility for any loss of, or damage to, Vendor's merchandise during the festival.
- Liability Exclusion:** Sponsors, Saint Nicholas Greek Orthodox Church, and The City of Temecula, assumes no liability for any claim of personal injury, loss and/or damage sustained by Vendor, Vendor employees and/or representatives.
- Required Vendor Indemnification:** Vendor shall defend, indemnify and hold Temecula Greek Festival 2025 Sponsor, Saint Nicholas Greek Orthodox Church, its officers, employees, volunteers, agents and representatives harmless from and against any claim, demand, suit, loss, cost or expense which may be asserted, claimed or recovered against, and or from Temecula Greek Festival 2025 Sponsor Saint Nicholas Greek Orthodox Church, its officers, employees, volunteers, agents or representatives by reason of any property damage, bodily injury or otherwise, of Vendor or of Vendor's employees, contractors, agents or representatives.
- Required Liability Insurance:** Vendor must submit proof of \$2,000,000 Liability Insurance to Vendor Coordinator on or before September 12, 2025. Vendors without their own special event insurance may purchase a two-day permit for an additional \$50 due no later than September 12, 2025.
- Vendor Requirements:** Booth setup must be completed by Opening Time each day.
Vendor cannot strike booth before Closing Time each day.
No vehicles are allowed on festival grounds during the times specified for each festival day.
Vendors must maintain a clean and safe space within their booth.
Extension cords must be grounded type listed for exterior use. No interior extension cords

are allowed.

Interior display lights are permitted if connected by exterior extension cords.

Vendors are required to always staff their booth, unless by prior agreement.

Financial transactions for sale of Vendor merchandise are the responsibility of the Vendor. Festival prohibits distribution of any political materials.

Vendors must leave property in same condition as prior to occupancy or be subject to additional clean-up charges as determined by Festival (\$200 minimum clean-up fee).

Vendors are required to handle customer complaints in a reasonable, businesslike manner, so as not to bring discredit to St. Nicholas Greek Orthodox Church.

Vendor is welcome to invite guests to the festival, but those guests are responsible for paying admission. Only those individuals working the Vendor booth are entitled to free admission. If a Vendor expects more than two individuals to be working the booth, they must alert Festival staff in advance and arrange admission.

**Grounds for Removal
from Festival:**

Sponsor, Saint Nicholas Greek Orthodox Church, reserves the right to remove Vendor from the Festival for (1) unruly behavior including but not limited to intoxication, verbal abuse or threatening behavior to any Festival patron or participant; (2) loud/amplified music or other sounds; (3) contraband, counterfeit, or bootlegged goods; and/or (4) dangerous objects.
