

# Why conduct an Annual Data Review?

## Change is Constant


- Communities do not remain static, neither does the data describing the community.

## Annual Tune-Up

- Simple and effective way to check and see if the current plan and community data are aligned.

## Focus on Results

- Plan activities should be linked to community issues of concern.
- Plan for both program-level impact and systems-level change to address root causes.



# Embedding Systems Change

## Definition


- Any activity that the collaborative undertakes to identify challenges and promote change in the current systems of services in the community with a specific focus on reducing inequities.

## Examples

- Changing attendance protocols
- Creating shared referral systems
- Shifting funding to support mental health initiatives in schools

## Things to Consider

- Have we shifted any systems as part of our strategy work?
- How can we use data to support our system change efforts?










## ER Visit Rate, Intentional Self-Harm (incl. Suicide Attempts), Carroll County, GA, 2018-2024





## Number of ER Visits by Census Tract of Residence, Carroll County, Intentional Self-Harm (Incl. Suicide Attempts), 2020-2024






During the past 12 months, on how many occasions have you seriously considered attempting suicide?
