Pet Registration Agreement

This is a contract between Karma Dog Kamp, LLC. (herein after called the “Company”) and the pet owner whose signature appears below (hereinafter called “Owner”).

1. The Owner specifically represents that he or she is the sole owner of the pet.
2. The Owner certifies that all information given about said pet is accurate.
3. The Owner specifically represents to the Company that the pet has not been exposed torabies, canine/feline distemper, or canine cough within a thirty-day period prior to boarding or services.
4. The Owner agrees to be solely responsible for any and all acts or behavior of said pet(s) while the pet(s) is in the care of the Company.
5. The Company shall exercise reasonable care for the pet(s) delivered by the Owner to the Company for boarding, off leash doggie day camp, grooming, training or other services. The Owner agrees that despite the efforts of Karma Dog Kamp, LLC staff to provide a safe environment, there may be unpredictable or unforeseeable circumstances that may expose Owners and/or their pet(s) to health risks or injury. The Owner hereby waives and releases Karma Dog Kamp, LLC, its employees, owners and agents from any claims while Owners and/or their pets are while in the care of Karma Dog Kamp.
6. If the pet(s) becomes ill, or the state of health or well-being otherwise requires professional attention, the Company, at its sole discretion, may engage the services of a veterinarian or administer medicine or other requisite attention to the animal, and it is agreed that all costs and charges thereof shall be paid by the Owner.
7. The Owner agrees to pay all costs and charges for services he/she requests.
8. All charges incurred by the Owner shall be payable at the time the pet(s) is discharged from the Company. The Owner agrees that in the event the charges are not paid in accordance with this contract and proper notice is given, the Company may exercise its rights regarding liens, abandonment consideration and disposal in accordance with Nevada State Statute law.
9. For long-term boarding arrangements, the Company, at its sole discretion, may require a deposit before agreeing to provide services. The Owner agrees to pay such deposit, as required.
10. Owner understands and acknowledges that from time to time, for the purpose of training, and/or advertising and/or promoting its business, the Company takes photographs of its employees and programs, including pets on location. In consideration of the Company’s agreement to accept Owner’s pet for participation in its programs, Owner hereby releases from liability and licenses to Company the right to use any photos of or including Owner’s pet for any lawful purpose(s) including training materials, advertising and/or promotional materials.
11. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assignees of the Owner and the Company. This contract is entered

into and shall be interpreted under the laws of the State of California. Owner agrees to submit to the jurisdiction of only the Nevada Courts with respect to any dispute relating to this agreement and/or the Owner or Owner's pet's relationship with the Company.

12. This Contract is binding for the present and all subsequent engagements for services of the Company by the Owner.

Veterinary Release Form - Karma Dog Kamp, LLC

In the event that any of my pets or large animals appear to be ill, injured, or at significant risk of experiencing a medical problem at the start of service or while in the care of Karma Dog Kamp, I give permission to Karma Dog Kamp to seek veterinary service from a veterinarian or a veterinary clinic. My preferred veterinary services are listed on each individual Pet Information Disclosure. Other veterinarians or emergency care clinics chosen by the pet sitter are acceptable. I ask Karma Dog Kamp to inform the attending clinic or veterinarian of my requested total diagnosis and treatment limit of \$_____ per pet / all pets (most common values are \$250, \$1000, or unlimited).

I understand that efforts will be made to contact me regarding any treatments, illness, injury, or potential problems as soon as the condition is deemed not life threatening and/or contact is possible. I understand that preventing accidents and injuries and keeping my pet safe is of the highest priority of Karma Dog Kamp, however such problems may occur no matter how well a pet is cared for.

I agree to allow Karma Dog Kamp care providers to use their best judgment in handling these situations, and I understand that Karma Dog Kamp and its staff assume no responsibility for the actions and decisions of the veterinary staff, the health, or death of my pet(s). I will assume full responsibility for the payment for any and all veterinary services rendered, including but not limited to diagnosis, treatment, grooming, medical supplies, and boarding. Such payments will be secured with credit card on file (see limit above) with Karma Dog Kamp. I also agree to be responsible for all Special Service fees assessed by Karma Dog Kamp for emergency transportation, care, supervision, or hiring of emergency caregivers, and will pay such fees within 14 days of each incident. I further authorize Karma Dog Kamp and my primary veterinarian(s) to share all of the medical records of all of my animals with veterinary clinics in an emergency in the interest of providing the best care for my ill or injured animal(s).

Every dog, cat, and horse at the site of service will be current (per my veterinarian's recommendations) on its rabies vaccinations prior to the arrival of any caregiver. I will also make arrangements to guarantee that each animal will remain current on its rabies vaccinations throughout each service period. I agree to notify Karma Dog Kamp of any signs of injury or possible illness before any visit as soon as the condition appears.

Karma Dog Kamp reserves the right to cancel service at any location where a pet with a potentially infectious condition exists. Karma Dog Kamp strives to provide clean, safe service to each of our clients. In doing so, Karma Dog Kamp strongly recommends that each pet and large animal be vaccinated, de-wormed, and protected from harmful insects according to veterinarian recommended standards. This agreement is valid from the date below and grants permission for future veterinary care without the need for additional authorization each time Karma Dog Kamp cares for one or more of my pets. I understand that this agreement applies

to all of the pets within Karma Dog Kamp care. In signing this contract, I agree that I have the sole authority to make health, medical, and financial decisions regarding the animals that will be scheduled to receive service.
