<u>Risks</u>: If you do not participate the community is at <u>RISK</u> of the negative effects that stem from bullying, exclusion, hatred, harassment, oppression, prejudice, racism, and violence. All of which could continue if elected officials do not deem them a priority!

Responsibilities: Through advocacy and engagement, your **RESPONSIBILITY** is ensuring human rights are no longer dismissed as an unattainable but are instead active components of the current reform movement!
