Puppy is guaranteed until his/her first birthday against any life-threatening genetic defects. To the best of the seller's knowledge, this puppy is in good health and free from any symptoms of contagious disease at the time of sale. The puppy is guaranteed against life threatening congenital or life-threatening hereditary defects that develop within twelve months after buyer takes possession which will be the date of shipping or possession by buyer. This does not include: colds, hypoglycemia, diarrhea, allergies, coccidia or other parasites all of which are easily treated. It does not include accidents, neglect or abuse, nor does it cover any infectious disease contracted after buyer takes delivery of puppy. To protect both the Seller and the Purchaser and in order to put this guarantee in place, Purchaser must have the puppy examined by a licensed veterinarian within (5) five days of the purchase date noted below or pick up date (whichever is later). If a licensed veterinarian confirms a life-threatening genetic defect he/she must provide findings in writing and written notification must be given to the Seller within 48 hours of determination. Seller does have the option to request a second opinion to be obtained by Purchaser at the Purchaser's expense. The puppy, his/her registration papers, and vaccination record must be returned within 48 hours in order to receive a refund. If the puppy dies, the Purchaser must have a necropsy performed at the Purchaser's expense to determine if the cause of death was a genetic defect which the Seller is responsible for. We do not guarantee against viruses, contagious diseases, or other illnesses that can be caused by stress and/or environmental conditions. These are things that we have no control over once the puppy leaves our home. If any part of this requirement is not met, the guarantee is null and void. **Seller is NOT responsible for any vet bills.** Puppy is being sold as a pet and is not being sold nor guaranteed as a show dog or as a breeding animal. Puppy is eligible for registration with AKC Limited registration. Full registration is available, but this option must be discussed with seller.

Your puppy's deworming and vaccination record has been given to you. It is very important that you continue the vaccinations as recommended by your vet. Many puppy viruses are contagious so we recommend that you limit his/her exposure to other dogs/puppies until he/she has received all of his/her vaccinations. You, the Purchaser, agree to take good care of the puppy and provide adequate food, water, housing, and medical care when needed. If at any time, your situation changes and you are not able to keep your puppy, please contact us first. (918) 808-3417
