## 2007 National Specialty Report

First and foremost, my deepest thanks to Norma and Tom Woolf, the CDCA Board and the many behind-the-scenes folk for their great help with the 2007 National Specialty! Special thanks go to Pat Doty and Mary Kay Morel, two friends from Queen City Dog Training Club, who were our ring stewards for the National show. Last, but never least, thanks and great appreciation goes to our trophy and ribbon fund donors, who really made this year's National Specialty "special" for everyone!

The 2007 National Specialty events were scheduled from Wednesday, September 5, through Monday, September 10, in the Cincinnati-Eastgate, Owensville, and Bethel areas of Clermont County, just to the northeast of downtown Cincinnati, Ohio. Whenever one thinks of September, the image of cool temperatures and autumn breezes comes to mind. Not so for this year. The Cincinnati area had been experiencing heat and drought for nearly the entire summer and the week after Labor Day was no exception; I brought a baby pool and hose to the hotel, not only to be used for bathing but to cool off any overheated dogs.

The events calendar started off with the welcome party on Wednesday night in the hospitality suite at the Holiday Inn-Eastgate, our host hotel, and those who attended were treated to a great variety of sumptuous food and drink and fantastic conversation, not to mention fun with the phone in the jacuzzi bathroom! I wouldn't have been surprised if that fun didn't later include the waterfalls and meandering stream in the hotel's lobby, but nothing (at least to my knowledge) came of it.

Thursday dawned early for the Board members and many cups of coffee were downed during the morning meeting, presided by newly elected President, Amanda Pough. During that time, club members checked into the hotel, wandered to the nearby mall for shopping, or perused the Responsible Dog Ownership table set up outside the meeting room prior to the afternoon Annual General Membership session. Since I had only a couple of hours sleep the night before and was distracted by last-minute show and hotel issues, I admit that I wasn't paying much attention during the AGM meeting,

especially to the announcement of the AKC Good Sportsmanship award presentation until my name was called. I was shocked, to say the least, and very humble for being given this honor, which is voted on by the Board (I was out of the Board business loop as they did it behind my back via the telephone!). Thursday evening's main activity was the Canaan Dog breed seminar for judges, presented by Cindy Grupp, the CDCA judges education coordinator, with about 6 judges in attendance and a large assortment of dogs with their owners for the hands-on demonstration.

Friday, the big day - the National Specialty show. A total of 48 dogs were entered in the show with a total of 89 entries, including 5 in obedience, 7 in rally and 10 in Parade of Titleholders. The National was held indoors in an airconditioned building at the Clermont County fairgrounds in Owensville, a 20 minute drive from the host hotel. Amanda and her 2008 National Specialty committee organized a continental breakfast in the building's kitchen area while exhibitors set up crates, grooming tables and chairs in the ample grooming area during the pre-show hours. up ringside and nearly a dozen judges took advantage of the courtesy. At 8:30 AM sharp, following an a cappella rendition of the national anthem by the audience, Jennie Larkin and her wonderful veteran dog, Tycho (Fuligin Ged Tycho, CGC, CDX, RA, AX, AXJ, NAP, NJP; CDCA-HC, V), started the show officially as they entered the ring for the first of their several classes of the day, Utility A, under obedience and rally judge, Mr. Richard Strong of Indianapolis, Indiana.

Once obedience and rally had ended and the volunteer CDCA member and friends ring crew had transformed the single ring from its obedience matting to conformation matting, Mrs. Carol O'Bryan of Sebastopol, California, stepped in to the ring to judge the 12 entries in Sweepstakes and the 8 entries in Veteran Sweepstakes. Because of the length of time since the last specialty, there was a Junior division for those entries from 6 months to under 12 months of age and a Senior division from 12 months to under 24 months of age. After evaluating all of her entries, Mrs. O'Bryan chose Mad River Cool Breeze Blowing ("Breeze"), handled by owner, Charles Sargent, as Best Junior Sweepstakes and the overall Best Sweepstakes winner and Ha'Aretz Havvim ("Havvim"), owned by Bryna Comsky and handled by Nancy Martin, as the Best of Opposite Sex In Junior Sweepstakes and Best of Opposite Sex overall Sweepstakes winner. The Best Senior In Sweepstakes went to Eastland Salina So Special ("Salina"), handled by breeder/co-owner, Annette Israel. Best Veteran In Sweepstakes was awarded to Ch. Pleasant Hill Alexandra ("Sandra"), handled by her breeder/owner, Donna Dodson, while the Best Of Opposite Sex Veteran award went to Ch. Lahat Me Shaar Hagai ("Eli") with owner, Cheryl Hennings, on the other end of the lead.

There was a brief lunch break before Mrs. Pat Hastings of Aloha, Oregon, stepped into the ring to judge Junior Showmanship and the regular and non-regular conformation classes. The word, "stepped", is a figurative one as Mrs. Hastings had broken her leg early in the spring and was wearing a leg brace and maneuvering on a crutch at the time of our show. Mrs. Hastings handed her crutch to the ring

stewards before examining each dog, but the dogs handled the strange gait of their judge rather well. After each dog was examined. Mrs. Hastings asked the exhibitors to present their dog to the ringside judges before proceeding on. Kaitlyn Carlson, showing Ch. Bless-Ed Be Cherrysh Patriot ("Patriot"), was awarded Best Junior Handler. Mrs. Hastings chose D&J Ha'Aretz Tip Top Dog ("Tip"), bred/owned/handled by Donna Davison as Winners Dog, Ha'Aretz Hayvim as Reserve Winners Dog, Mad River Cool Breeze Blowing as Winners Bitch and Renegade Camber ("Camber"), owned/ bred/handled by Renee Kent as Reserve Winners Bitch. The Veteran classes brought a great deal of applause and cheers as these beautiful, older dogs gaited in front of the audience. Ch. Arayl's Magic Springtime, CD, RN ("Zephyr") handled by owner, Norma Bennett Woolf, and Ch. Eastlands Jacob ("Jacob"), handled by owner, Melinda Linton, won their respective bitch and dog classes and went on to the Best of Breed competition.

Silence seemed to settle throughout the building as Mrs. Hastings began her evaluation of the Best of Breed entries. She divided the large number of dogs and bitches into their respective gender groups, with each waiting its turn outside the ring while Mrs. Hastings put the others through their individual exams and pulled her final cut choices to the center of the ring before thanking and dismissing the others. The final cut held everyone's breath as the judge critically eyed her selections to determine her winner. She placed her choices in the lineup and sent them around the ring for a final time before pointing to Ch. Desert Star Running Miles, CGC, RN ("Miles"), owned by Rosette Davila-Sargent and handled by Nina Fetter, as Best Of Breed/Specialty and Mad River Cool Breeze Blowing ("Breeze"), handled by Charles Sargent, as Best Of Opposite Sex To Best Of Breed/Specialty as well as Best Of Winners. Ch. Rosendog's He Who Must Be Named ("Harry"), owned by Judy March Rosenthal and Amanda Pough and handled by Kitty Burke, and Ch. Mad River Ladies First ("Lizzie"), owned and handled by Cynthia Grupp, were the Award of Merit recipients. Screams, cheers and great applause from the audience at Mrs. Hastings decisions filled the building and the ringside Canaani contingent

added their voices to the din.

The merriment from the day's big show finale continued on later that night into the annual awards banquet and auction at the hotel. Several tables held donated offerings from club members and friends and these items were closely examined by the party-goers as they entered the banquet room. Following the sumptuous dinner, Amanda Pough rose to thank everyone involved in the show and to encourage them to attend the 2008 National Specialty, which will be held in Romulus and Waterloo, New York, in conjunction with the Wine Country cluster the week of September 21st; the National Specialty itself would be held at the Sampson State Park in Waterloo within the Kanadasaga Kennel Club show. Amanda also read the poem, "What's In A Title?", at the request of Sally Armstrong in honor of her dog, "Yaki" (Ch. Pleasant Hill Yaakov Metav, NA, NAJ), who had recently passed away. As Specialty Chair and temporary Awards chair, I then recognized evervone who had earned conformation and performance titles, including those who earned Versatility and Register of Merit titles. My next task was to announce Judy March Rosenthal as 2006 Member Of The Year and Ch. Pleasant Hill Jordan as 2006 Dog Of The Year, the latters plaque accepted by Jordan's breeder/owner, Donna Dodson. The 50-50 raffle was won by Rosette Davila-Sargent, who graciously donated the proceeds back to the club. Finally, the auction began and the bidding became spirited as favored items came up for bid. By the time the hotel wait staff came in to discretely shoo us out for the night, the auction was a major success, capping off a fantastic day.

The next 2 days were the supported entry Clermont County Kennel Club shows, also held at the fairgrounds, though the conformation was held outside this time while the obedience and rally trials were held in the building that CDCA used the previous day. The CDCA had rented a large tent not far from the rings

for its exhibitors and friends and this proved fortuitous with the baking sun and unexpected afternoon rainstorms (not enough moisture to break the drought, just get everything wet). Breed judging for the Canaans was bright and early at 8:00 AM on both days with 28 entries on Saturday under Mrs. June Penta and 24 entries on Sunday under Mrs. Lee Canalizo. Best of Breed for Saturday was Ch. Desert Star Running Miles, CGC, RN, and on Sunday it was Ch. Rosendog's He Who Must Be Named, who also was awarded 4th place in the Herding Group competition. Litter brother, "Peter", CH Rosendog's Lt Columbo CGC earned a qualifying score towards his Rally Novice title with owner, Amanda Pough, in the Saturday rally trial, proving that Canaans Can-do!

Monday morning found many dedicated owners driving from the hotel to the herding instinct test 25 miles away in Bethel, Ohio; some of them ended up traveling a more scenic route when a traffic accident blocked the directed route to a by-pass road. At the end of the day, as everyone drove off to distant homes, all agreed that it had been a great National Specialty. (A complete Herding Instinct Test Report can be found on page 25.)

## The Role of the AKC Delegate

The Canaan Dog Club of America (CDCA) became an American Kennel Club (AKC) member club in January 2006. What does that mean? Well, it means that now, finally, the CDCA as the recognized parent club of the breed, has an official voice in the AKC concerning issues relating to Canaan Dogs specifically. As the first CDCA Delegate, it is an honor and a privilege to represent this wonderful club since being seated by the AKC Board of Directors.

What is the role of an AKC Delegate? As a member of the AKC Delegate body, you assume a role of enormous responsibility. Your vote directly impacts the direction the sport of the purebred dog takes in the 21st century through the rules and bylaws approved.

Established in 1884 to govern the sport of purebred dogs, the AKC is one of the oldest sport-governing bodies in the United States. The AKC is best described as a "club of clubs", meaning that clubs, such as the CDCA, comprise the sole membership of the AKC. The AKC charter, adopted in 1909, mandates that the AKC do everything to advance the study, breeding, exhibiting, running and maintenance of the purity of thoroughbred dogs.

The AKC Mission Statement is to

- maintain a registry for purebred dogs and preserve its integrity
- sanction dog events that promote interest in, and sustain the process of, breeding for type and function of purebred dogs
- take whatever actions necessary to protect and assure the continuation of the sport of purebred dogs.

The membership of the AKC is made up of more than 570 independent clubs. Each member club selects a Delegate to represent their club at the AKC's annual meeting in March and quarterly meetings in June, September and December/January. According to the AKC Constitution and Bylaws, a member club's voting powers can be exercised only through its Delegate. In essence, the Delegate body serves as the legislative body of the AKC. As a Delegate, you approve the RULES for the sport of purebred dogs and the BYLAWS for the operation of the AKC.

Delegates elect the 13 member Board of Directors from among the Delegate body. The President also serves on the Board as a nonvoting member and appoints Vice Presidents and Assistant Vice Presidents. The 13 voting Directors are divided into four classes of three, three, three and four members and hold their office for four years, with at present a two term limit. The Board annually elects the President/CEO (currently Dennis Sprung), Chief Operating Officer (currently John Lyons), Chief Financial Officer (currently James

Stevens) and Executive Secretary (currently James Crowley) at the April Board meeting, the first meeting after the annual Delegate meeting.

The AKC Bylaws do not place restrictions on the location of Delegate meetings. The quarterly meetings are scheduled for the second Monday or Tuesday of the month in March, June, September and December/January. About two weeks before each meeting, Delegates receive a call letter from the AKC Executive Secretary. The call letter is an official notification of the meeting's location, date, time and agenda. Delegates should be prepared to arrive a day or two early for the purpose of attending Delegate Committee and the Delegate Caucus meetings.

There are ten Standing Delegate Committees: All-Breed Clubs; Bylaws; Parent Clubs; Obedience Clubs; Field Trial and Hunting Test Events; Herding, Earthdog, Coursing Events; Canine Health; Dog Show Rules; Delegates Advocacy and Advancement; and Coordinating Committee (comprised of the chairpersons of the previous nine committees). The goals of these committees are (A) to provide the broad-based independent involvement of the Delegates in matters affecting the dog fancy and (B) to identify and utilize the expertise within the Delegate body and within the fancy. Each committee has a maximum of 11 members, usually representing the more influential and senior members of the Delegate body. A committee of 12 Delegates produces PERSPECTIVES, the Delegates' newsletter. Committee elections are held at the Delegates quarterly meeting in September of each year.

In summary, Delegates must approve all changes to AKC's Bylaws, and the Rules (Article XIX) contained within the rule books that apply to dog shows and field trials. (A two-thirds vote is required for any change in the Bylaws or Rules to be approved.) Additionally, Delegates elect AKC's Board of Directors. (At the annual meeting in March, Directors are elected to serve four year terms.) As you can understand, the role of the AKC Delegate is one requiring a substantial commitment of time, energy and finances on behalf of the member club represented.

(Delegates Note: Please write me at PO Box 214, Woodmere, NY 11598 or telephone me at (516) 295-4940 with any questions, problems or concerns you have regarding AKC issues, as well as suggestions for topics for future columns--with your input, this column can be an effective means of communication. Upcoming issues that may be brought to the Delegate body include a mixed breed listing program, restructuring of the Canine Health Foundation, realignment of the current AKC groups and the abolishment of term limits for AKC Directors.

## Calendar: Judy Rosenthal

As corresponding secretary, Judy will make sure the club calendar on the website is up-to-date with club events.

### **Advertising:**

This committee needs a chairman. Jobs include updating the club brochure, writing club ads for publication, soliciting ads for the Kibitzer and specialty catalogs.

## Unfinished business ILP program:

The board has been working on this issue but has not contacted AKC pending AKC's consideration of an enrollment program for mixed breed dogs. However, at the board meeting today, we voted to send a strongly worded letter stating the CDCA position on the current ILP program as it applies to Canaan Dogs.

## **New business**

New items from the CDCA Board:

- 1. CDCA will pay application fees for regional specialties or other AKC events but require reimbursement from the regional club hosting the event.
- 2. Trophies: We have several specialty trophies with names in honor of people who have given to the breed. The board is considering three options for these trophies:
  - a) create real tangible trophies
  - b) create challenge trophies that will be retired if won 3 times by the same person
  - c) Create a physical trophy engraved with the names of winners. This trophy would have to be stored by the club and mailed to each specialty. The winner would get something tangible and the trophy would remain in the club's possession.

Following discussion, Amanda said the board would consider these options.

- 3. Budget and tax items: The board is discussing which events should be self-sustaining and is researching new tax considerations that may have an impact on the club.
- 4. In August, the board raised the dues to \$30 per individual and \$35 per family to keep up with increased costs of mailings and other expenses.

Bryna Comsky asked ...


... that contested votes be done by secret ballot and counted by an outside auditor. The CDCA bylaws already allow for contested elections and votes on bylaws approval, revisions to the breed standard, and other questions determined by the board to be voted by mail with the votes returned to an independent auditor. Only the votes for a contested election must be counted by an independent auditor; revisions to the standard and the bylaws and other questions can be counted by either the recording secretary or an independent auditor.

- ... that club members be encouraged to vote for Member of the Year and Dog of the Year as few votes were cast this year.
- ... that the Board direct the AKC delegate's vote on issues that come before the AKC delegate body. The board discussed this matter at today's board meeting and will follow up with our delegate.
- ... that specialty committees schedule education sessions at our national specialties. These could be short sessions on particular topics or a day-long seminar with a speaker that would be used as a fundraiser.
- ... that we change the procedure for the election of officers to have the members elect a board and the board elect the officers from their number. (This would require a change in the bylaws.)

CDRN rescue report: Dominic Frinzi, president of the Canaan Dog Rescue Network, said that CDRN took in nine dogs in 2006 and placed eight in new homes, and took in six dogs in 2007 and placed five in new homes. He presented the CDRN calendar, the fundraiser for the organization, and encouraged people to visit the group's website at www.canaandogrescue.com for more information and to volunteer.

The Health Committee of the CDCA has had little activity since the Annual Meeting in 2006. We continue to recommend the CHIC testing protocol of Canaan Dogs prior to breeding which we are happy to report now shows Canaan Dogs with 20 CHIC Certifications.

Cancer continues to be our most often reported health problem varying in type from lymphomas to sarcomas. Therefore, we do recommend that more Canaan Dog owners/breeders support our Donor Advised fund which is research into the cytology of soft tissue tumors. This year the AKC/Canine Health Foundation has offered the advantage of online contributions to the various research projects.

## **AKC** Delegate Report

## **Delegates Forum September 10, 2007**

"The Delegates Forum is an informal meeting of Delegates that provides an opportunity for open discussion and the expression of ideas. No official business is transacted, a quorum is not required and no attendance record is kept."

## **Topic: Overcoming the Radical Animal Agenda**

Patti Strand, AKC Board member, speaking as National Director of National Animal Interest Alliance (NAIA)

Mrs. Strand's presentation outlined the tactics, goals and organizations involved in anti dog legislation; their successes; some of the purebred dog fancy's successes; and the measures that must be taken by the fancy in order to preserve and promote the ownership of, and participation in, the sport of purebred dogs.

## Delegates Meeting - Newark, New Jersey 9/10/07

Dennis B. Sprung, President called meeting to order solely for purpose of conducting votes for Delegate Standing Committees. After luncheon recess, meeting reconvened.

James Crowley, Executive Secretary, reported minutes of Delegate meeting to be published rather than transcript.

- 18 Delegates seated since last meeting.
- 16 Delegates, attending their first meeting since approval, introduced from the floor.

Minutes of June 11, 2007 Delegate meeting approved.

Central Indiana K.C. elected member of the AKC.

## Ronald H. Menaker, Chairman reports

Regarding AKC long range evaluation, from a financial standpoint, in 1995 annual report recorded total income (realized and unrealized) of \$32.4 million dollars. The 2006 figure was \$70 million dollars with no net annual loss reported in that period.

Legal and fiduciary duty to maintain sufficient pension fund—AKC pension fund is well over 100% funded.

In 1995 AKC had no Operating Reserve, not withstanding auditors advice that AKC have operating reserve of at least half of annual budget. In 2007, Operating Reserve is \$32 million dollars.

Since the nature of reserve has shifted, today endowment reserve is \$22 million dollars, in 1995 there was no endowment reserve.

Past eleven years has exhibited modernization of administration and financial operations. Highlights include:

1. Creation of AKC Canine Health Foundation and almost \$16 million dollars contribution.

- 2. \$1.7 million contribution to AKC Museum of the Dog.
- 3. Funded grants totaling \$1.5 million for Canine Support and Relief through AKC/CAR.
- 4. Increased PR advertising nearly \$10 million.
- 5. Nearly doubled capital expenditures for information technology resulting in 20% reduction of headcount.
- 6. Online registration of dogs has reached over 60% of litter registrations.
- 7. Employment of full-time archivist and creation of Breeders Newsletter.
- 8. Contribution by AKC and AKC/CAR to Parent Club conferences.
- 9. Creation of AKC/Eukanuba National Championship, one of most prestigious dog shows in world. Bred-by-exhibitor entries stand at 40%.
- 10. AKC considered "first call" for disaster relief for dogs.
- 11. 100's of thousands of dollars in scholarships awarded.
- 12. Creation of "Breeder of the Year" program and establishment of important online breeder services.

Two areas of concern in regards to AKC's financial stability. First is serious decline in AKC registrations from 1990 to the present. Some of decline is attributable to development of more competitive registries, but business and social patterns change and full explanation is yet to be understood. Second area of concern is the continuing gap in the cost of the Event Department and the income it generates. Event Department fees impact clubs and exhibitors alike. These fees, however, when analyzed over the years and compared with annual inflation figures have failed to keep up with inflation rates. Accordingly, part of this shift in revenue requires that participants in the sport share a larger portion of its cost, i.e., those involved in AKC activities will have a greater responsibility for "pay to play."

Board and management are vigorously seeking new revenues to support AKC. Serious challenges have been met in the past and AKC will continue to face unknown future challenges. Revenue sources may change dramatically. Board and management are committed to making decisions to ensure the strength and perpetuity of AKC.

## **President Sprung reports**

Many of tenets of AKC's mission statement, promoting the sport of purebred dogs, responsible dog ownership and protecting rights of all dog owners: are furthered by public education. On September 15, 2007, the AKC Responsible Dog Ownership Day Flagship events in Raleigh and New York City together with over 370 nationwide events during the month of September represent educational programs geared toward the pet-owning public. For future fanciers, New York staff will be conducting an AKC Educational Match on September 29, 2007 in Clinton, New Jersey to help educate new exhibitors about the benefits of participating in AKC -sanc-

tioned events.

Post 9/11, AKC's DOGNY raised over \$3 million dollars in contributions for AKC/CAR Canine Support and Relief for search and rescue organizations.

In 2005, after Hurricane Katrina, over \$1 million dollars was raised to aid the canine victims of the Gulf disaster.

These public outreach efforts garnered important PR for the AKC and proved that the AKC could benefit from an ongoing charitable fund.

The AKC is in the process of establishing a new and distinct not-for-profit organization, separate from AKC, to present educational programs, give to charitable foundations and accept tax-deductible donations. This entity will also be able to apply for grants. Today is the first public announcement of the new organization named the AKC Humane Fund. The Fund's mission is "to unite a broad spectrum of animal lovers in promoting the joy and value of responsible and productive pet ownership through education, outreach and grant-making". The AKC Humane Fund with the expectation of 501(c) 3 federal recognition of exemption from federal income taxes, will permit the Fund to solicit tax-deductible donations to champion specific causes as well as offer" membership" in the Fund to those who donate.

The Fund is expected to provide support to the AKC Canine Health Foundation, Companion Animal Recovery, Museum of the Dog. The Fund will be able to sponsor educational programs to provide grants to other non-profit organizations, including Parent Club Breed Rescue groups. A "Hall of Fame" is planned for fanciers, including breeders, owners, delegates, judges and handlers. For more information, please contact Daphna Straus (AKC Assistant Vice President, Business Development, <a href="mailto:dxs@ac.org">dxs@ac.org</a>), author of the plan. Club input is welcome. As part of the launch of this new entity, inaugural membership pledges are being accepted. Clubs, individual fanciers and others are invited to be founding members of this important organization. In recognition of founding member contributions, a wall of Honor will be created, bearing the names of the first founding members.

## James Stevens, CFO, reports

Total revenues for first seven months of 2007 were slightly higher than 2006 and operating expenses were 3% higher than last year, resulting in an operating surplus of \$2.3 million dollars for this year.

Year to date unrealized investment gains of \$3.8 million dollars were significantly higher than last year.

Net surplus exceeded \$6 million dollars, which was over \$1 million dollars greater than 2006.

The number of dog and litter registrations continued to decline from the previous year.

Discussion on a proposed amendment to Article VII, Sections 1 and 3 of AKC Bylaws. Intent was to enable an elected AKC Board member to retain position even if revoked as Delegate by club voted to postpone consideration of amendment until

December meeting. Purpose of postponement was to allow time for revisions to address concerns raised by Delegates.

Voted to amend Chapter 8, Section 12, of AKC's Field Trial Rules and Standard Procedures for Retrievers as follows: "Any dog entered and present at a field trail may be withdrawn from Competition by its handler upon notification to the stake marshal without loss of the dog's eligibility to compete in any other stake in which the dog was entered. The entry fee for the stake entered and withdrawn shall be forfeit."

Voted to amend Chapter 14, Section 5, of AKC's Field Trial Rules and Standard Procedures for Retrievers as follows: "Only stakes which are run on game birds and on both land and water shall be permitted in licensed retriever field trials. Premium lists should specify the kind of game to be used in each stake and, unless otherwise specified in the premium list, only pheasants and/or ducks may be used."

Voted to amend Chapter 9, Section 2, 6, and 7 of the Field Trail Rules and Standard Procedures for Basset Hounds as follows:

"Chapter 9

Section 2: At a licensed or member Basset Hound Field Trial the regular classes shall be open All-Age Dogs and open All-Age Bitches. IF however, when entries are closed there are less than six (6) entries on one of the classes, the class shall be combined if possible and run with both sexes in a single class.

Section 6: Field Championship points for Basset Hounds shall be awarded only to Hounds placing in a licensed or member field trial in open All-Age Classes in which there are six (6) or more starters and shall be awarded on the following basis:

Section 7: To be recorded a Field Champion, a Basset Hound must have won Championship points in open All-Age Classes at eight (8) or more licensed or member Basset Hound Field Trials and must have won at least two (2) first places and sixty (60) points in such classes with not less than six (6) starters."

Discussion on proposal rescinding Delegate Standing Rule providing for three minute speeches by Board candidates at March meeting. Intent was to substitute more interactive format for Delegates to get to know Board candidates at forum prior to December/January meeting. Voted to amend Delegates standing Rule as follows:

"At the meeting next preceding the annual meeting, each candidate for Director shall be allowed one speech for three minutes."

Proposed amendment to Article VI of AKC Bylaws read, to be voted on at December meeting. The amendment follows:

"Article VI, Section 5- Two additional paragraphs:

No person may become or remain a Delegate if convicted of a misdemeanor or felony involving misappropriation of funds from AKC-sanctioned licensed or member club within the

previous 10 years. The same would apply to a person found liable for the theft, embezzlement or misappropriation of funds from an AKC-sanctioned, licensed or member club in a civil court action within the previous ten years.

A conviction or admission of guilt or finding of liability in a court of competent jurisdiction involving theft, embezzlement or misappropriation of funds from an AKC –sanctioned, licensed, or member club within the last ten years, shall be deemed conclusive proof and shall be grounds for the disapproval of a Delegate candidate or the removal of a seated Delegate."

Proposed amendment to Article VII of AKC Bylaws to remove term limits read and to be voted on at December meeting. The Amendment follows:

## Article VII, Section:

The AKC shall be governed by a Board of Directors consisting of thirteen (13) voting members, all of whom must be Delegates. The Board shall be elected as follows:

At each annual meeting the Delegates shall elect Directors from the list of candidates nominated as provided in Article VIII of these Bylaws. The thirteen voting Directors shall be divided into four classes of three (3), three (3), three (3), and four (4) members. Such Directors to hold office for four (4) years or until their successors are elected. At each annual meeting the Delegates shall elect such other Director or Directors as shall be required to fill the place of any Director who has died or resigned before the expiration of the term for which he or she was elected.

No person shall be eligible to serve more than two consecutive terms on the Board. A Board member who has served more than half a term on the Board is considered to have served a full term. This section does not preclude reelection of any delegate to the Board of Directors after a one year (or greater) hiatus from Directorship

Excluding the President, who serves as a non-voting member, no member of the Board of Directors may be employed by the AKC nor may they receive remuneration from a AKC on a consulting or contract basis.

Excluding the President, no members of the Board of Directors are eligible for employment by the AKC or any AKC division or subsidiary for a period of twelve months from the date when they last served on the Board, nor may they receive remuneration from the AKC on a contract or consulting basis for a period of twelve months from the date when they last served on the Board.

The President shall serve on the Board as an ex officio non-voting member during his/her tenure as President."

Proposed amendment to Chapter 3, Section 6, of the Rules Applying to Dog Shows, eliminating the Novice Class and substituting an Amateur-Owner-Handler Class read, to be voted on at the December meeting. The Amendment follows:

"The Amateur-Owner-Handler Class shall be for dogs that

are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13)."

Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

## Ways & Means Committee Report

Objective: Fundraising

Members: Julie Haddy & Sandy Dudley

There have been several developments for the Ways & Means Committee over the last year. Participation in the Purina Pro Club has improved with reminders to the membership through the Kibitizer and on the e-mail lists. Affiliate programs have been established with several online retailers of pet supplies. When people click through the links and make a purchase, the club earns either a referral fee or a percent of the sale; shopping directly at the site without going through the referral link does not earn any rewards for the club.

The affiliate program is generating a good bit of click-throughs but so far has not been generating revenue for the club through purchases. As more people become aware of how the program works and with reminders in the Kib and the e-mail lists, we hope to see this change, especially with the holiday shopping season approaching. If members would like to suggest their favorite sites that offer affiliate programs, please contact Julie Haddy about adding the site to our program.

The committee's goal for the next year is to establish some type of program/store to provide Canaan Dog merchandise to breed enthusiasts. Feedback is welcomed on items that members would like to see available. We are researching vendors and options available for merchandise and how it would be distributed. Possibilities include working with a site such as Cafepress.com or working with a vendor with no minimum on items on a drop ship type basis. The committee needs some feedback from the Board concerning a budget for items/artwork and guidelines on how to best structure the program.

We hope the coming year will be fruitful.

## Herding Chair Report

The 2006 National Specialty herding instinct test was held at Glenrose Farm in the hills of Jamul, California, on Monday, May 22; the test evaluator was Laura Noll, owner of Glenrose Farm and an AKC/AHBA judge. Of the 14 dogs entered for evaluation,10 successfully passed, giving this year=s test a 71.4% success rate, well above average in the 40-80% range for Canaan Dogs.

Of the 10 Canaan Dogs that passed the test that day, 8 achieved their Herding Certified (HC) titles, 1 attained his Herding Certified Excellent (HCX) title, and 1 earned her second qualifying score of the required three for the HCX title.

The Best Rookie trophy (for the Canaan Dog having no prior experience with livestock) was awarded to HaTikva Cherrysh Taavi Dream (Taavi), owned by Risa Baumrind of New Harmony, Utah.

The Best Senior herding trophy (for the Canaan Dog with any type of prior experience with livestock) was awarded to CH Riverroc Three Sunrises Lyceum, HC (Marley), owned by Renee and Evan Kent of Wood River Junction, Rhode Island.

Since the National, we have had several Canaan Dogs from the USA and Canada qualify for their HC or 2nd leg on their HCX. The CDCA recognizes herding judges from international kennel clubs such as the Canadian Kennel Club, the Israel Kennel Club and the British Kennel Club as well as the United Kennel Club. Those Canaan Dogs from Canada earning the CDCA-HC title include Mofet's Avigayil, owned by Maryellen Polikoff and Ken Kantymir, and CKC CH. Ha'Aretz Gimel Northern Confidence, owned by Lawrence Meyers and Michelle Harrington.

The 2007 National Specialty herding instinct test is scheduled to start promptly at 9 AM on Monday, September 10, at Dogwood Acres Farm in Batavia, Ohio; the test evaluator is Ms. Dana Hasemeier, an AKC judge and breeder of Cardigan Welsh Corgis. Due to flock numbers, the test is limited to 20 dogs this year. There is no limit on the number of spectators that may attend and everyone is invited to come watch the Canaans in action!

## Breeder Referral Committee Report

**Mission & Goal** - Publish and mail out a Canaan Dog information package which includes a list of qualified CDCA Breeders and their current puppy status and a Meet and Greet list. To produce a "polished" information booklet that includes high quality art work and pictures. A document that the CDCA can be proud to use as an official CDCA hand out.

### **Committee Members**

Sally Armstrong, Chair - In charge of keeping all the files/information, sending out packages, and all other sundry things.

Cynthia Grupp -Phone contact; fields phone calls from persons seeking information packages.

**Accomplishments** - A committee that is organized, runs smoothly and has filled a need for many years. The development of the Meet and Greet list.

**Strengths & Weaknesses** - Current process organized and runs smoothly. Lack of time to work on current goal. Progress is painstakingly slow but progress is being made.

**Wants, Needs, Desires** - Good quality pictures of Canaan Dogs involved in any performance events, particularly obedience and rally obedience, any cute puppy pictures or interesting pictures of dogs in every day situations.

### Report

As of 31 August over 35 information packages have been sent out, in 2006 there were 61 packages sent out. In 2005: 56, in 2004: 36, in 2003: 31, in 2002: 119, in 2001: 252, in 2000: 180, in 1999: 60, in 1998: 88, in 1997: 153, and in 1996: 112. The decline in the number of hard copies sent out is due to the availability of the information on the web site, but this method remains a viable alternative. As per the Board, in

order to be on the Breeders' List a breeder must have a bitch that has produced a litter or a dog at stud that has produced a litter within the last two years from the latest update of the Breeders' List. I have had several breeders that have not met these requirements that would like to remain as contacts, as well as non-breeding owners that would like to be a contact. The Breeders' List was developed for people seeking puppies, and to direct people to breeders that are actively breeding. Therefore, a second list is available. This list, referred to as the "Meet and Greet" list, is composed of people that would be willing to have people visit there homes in order to meet Canaan Dogs in the flesh, or rather fur, and/or answer questions about Canaan Dogs, but are not qualified to be on the Breeders' List. The list was approved by the Board during last year's meetings and an application is available on the web site. The draft of the new information package that will be published in the form of a booklet is almost complete. The artwork for the cover is complete. I was hoping to unveil it at this year's specialty but I could not make it to this years specialty. Evan Kent offered his help with the typesetting; I can only hope that his generous offer will still stand when the time comes. This booklet will also be used as a hand out in our information booths. I know I sound like a broken record but I am STILL looking for quality pictures of Canaan Dogs involved in any performance events, particularly obedience and rally obedience, any cute puppy pictures or interesting (and interesting is the key here) pictures of dogs in every day situations. No show shots or posed shots will be included. I will need a signed release allowing the CDCA to use the picture. A sentence allowing the CDCA to use the picture with you signature can be written on the back of the picture. For example: "I grant the CDCA permission to publish this picture on any format or in any document" signed John Doe, date. The CDCA has a small group of dedicated people that continuously work on many projects simultaneously; this means that progress on any one project is slow, so we ask your patience. But the CDCA still has many positions open that need people willing to volunteer their time.

## Report

The size of the newsletter has been variable over the past 8 months, which makes cost analysis more challenging. Quickly looking back over the last couple years of kibitzers, the page count has ranged from 8 to 36 pages with 20-24 pages being the most common. In 2007 we have averaged approximately 3 pages of advertising per kib for a revenue of \$60 in advertising. The optimal newsletter page count should range between 20-24 pages because the new postal rates double when the newsletter cannot be folded.

We anticipate the Fall issue will likely be the largest one of the year as it will include the National Specialty info. This will mean contributing authors are asked to respect submission deadlines and be conscience of the length of their submissions. We also need to consider how much space should be used for advertisements and develop a pricing scheme to encourage the use of advertising space on a regular basis. I suggest that the price of ads covers, of course the cost of the page they utilize as well as the additional mailing costs accrued when the newsletter is made larger than 24 pages due to ads.

## Legislative Chair Report

This may be a watershed year for laws affecting dog ownership, and which way the water flows is yet to be determined.

On one side, animal rights activists have been quite successful in moving their "sterilize-everything" agenda by encouraging mandatory spay-neuter laws at state and local levels. On the other, dog owners were successful in stopping the most damaging of those laws – AB1634 in the California. CDCA participated in the effort by writing opposition letters to the lawmakers hearing the bill, and Joan Greene did a comprehensive report on the conflict in the August Canaan Kibitzer.

But the battle rages on. Dog owners in Albuquerque, New Mexico, and Louisville, Kentucky, are living in the shadow of draconian laws that reduce ownership rights. San Antonio dog owners may soon follow suit. The City of Los Angeles is in upheaval as opposing factions fight for control of the city's animal services program. Washington DC council members are considering a change in legislative language that would turn pet owners into pet guardians. Several states have become battlegrounds for various efforts to squeeze dog breeders with regulations and smear campaigns that make little or no distinction between responsible breeders who raise dogs for show, performance, and pets and those who abuse or neglect the dogs they breed and sell.

Efforts to tighten restrictions on dog owners include:

- Breed-specific laws that restrict or ban ownership based on a dog's appearance. The Ohio Supreme Court opened the door for more of these laws by ruling that a city has the right to restrict dogs based on breed in the interests of safety. In addition, the Michael Vick dog fighting case cast a spotlight on this cruel activity and helped spread panic and misinformation about bull-breed dogs.
- Various types of breeder licensing, often disguised as commercial kennel licensing or anti-puppy-mill bills. The kennel licensing bill in Ohio is a good example: while it is promoted as a solution to puppy mills, it will impact any breeder who keeps more than eight intact dogs if it passes as introduced. Hidden in its 35 pages is language that would effectively ban the use of dog crates that don't meet a certain minimum size and micromanagement of kennel standards that rob owners of choices of bedding, veterinary care, vaccinations, and even water containers.
- Mandatory spay/neuter bills such as the one defeated in California. These bills are heavily promoted as the only solution to dog deaths in animal shelters, but close examination of statistics often shows that shelter intakes and euthanasia are declining and shelter adoptions are increasing.

• Bills that propose adding "guardian" to "owner" (or replacing "owner" with "guardian" in state or local statutes. Advanced as an attempt to change behavior by changing language, these proposals actually make it easier for activists and the government to remove dogs from owners based on specious allegations of cruelty or neglect.

## Who supports these laws?

Animal rights groups raise money and gain power by distorting issues involving animals. They ignore the dramatic progress made in reducing shelter intakes and deaths, challenge the rights of accused owners to a fair hearing, twist facts to put owners on the defensive, and attempt to impose their own morality on animal owners.

HSUS is a major supporter of laws that adversely affect dog breeding and support increased government interference in animal husbandry practices. They have a huge war chest and a reputation carefully nurtured for more than 50 years, so lawmakers tend to listen. Lack of success doesn't phase them: Even though they have raised millions of dollars in their decades-long anti-dog fighting campaign, dog fighting has actually increased. In the wake of Michael Vick's arrest, they are raising even more money to step up their efforts. The puppy mill campaign is similar: USDA and AKC increased oversight of kennels to weed out the poor performers, but HSUS continues to raise money to fight commercial kennels by subtly implying that all large kennels are (or have the potential to be) puppy factories raising dogs in squalor. They support proposals (like the one in Ohio) that will impact many show and performance dog breeders regardless of the condition of their kennels.

The ASPCA and the American Humane Association don't have the high profile that HSUS has, but they also lend their support to many laws that increase authority over dog breeders and owners.

## So how does this impact CDCA?

With our low numbers and close-knit breeding community, we've been able to be complacent until recently. However, a growing number of communities have passed – or are considering – laws for high license fees for intact dogs, tougher dangerous dog laws that can affect a dog protecting its own territory, noise ordinances, anti-tethering laws, breeding licenses, mandatory sterilization for dogs picked up by animal control, and more regulations that stifle both breeding and general dog ownership. Some of the newer dangerous dog laws can cause a dog to be impounded and sterilized if it attacks or kills another animal, a real problem for Canaan Dogs with a moderate or high prey drive. A second offense could bring the death penalty.

Obviously, bad laws don't solve problems, they simply lead to more bad laws. Each time a bad law is passed, the door for activists in the next state or city or county to try a similar ordinance swings open. And when those bad laws don't work, activists come back with even more restrictions on breeds, breeders, and owners.

Also obviously, we have to shake off that complacency and get educated about laws in our communities and elsewhere. Whether the sponsor's withdrawal of California Assembly Bill 1634 will indeed be a watershed moment depends on us, the breeders and owners who love our dogs and our freedom to responsibly pursue our passion.

## What can we do?

- 1. Know your local and state animal laws. Many jurisdictions have state laws online. Dog laws are usually contained within agricultural provisions, but a growing number of states also include some breeder regulations in their commerce laws.
- 2. Know when committees, councils, and legislatures meet and keep track of agendas. Most committees will send agendas for upcoming meetings via e-mail.
- 3. Get to know your lawmakers. Some lawmakers have a personal ax to grind, but many want to hear alternative propos-

als that can keep peace in the community and not lose them votes in the next election.

- 4. Take advantage of material and alerts offered by AKC, NAIA, and NAIA Trust. AKC's legislative division keeps track of legislative proposals and issues alerts when they deem it necessary. NAIA helps keep animal owners in the animal welfare picture with educational material, legislative analysis, and, through NAIA Trust, lobbying efforts.
- 5. Inform members of local specialty, all-breed, and performance clubs when dog-related issues arise. There is strength in numbers.
- 6. Invite lawmakers to club events.
- 7. Hand out educational material at club and public events. Both AKC (www.akc.org) and the National Animal Interest Alliance (www.naiaonline.org) have materials that can help dog owners protect their rights while helping communities solve dog-related problems.
- 8. Avoid the trap laid by activists who tarnish breeders with a broad brush, especially if they trot out the claims that good breeders who do things right won't be affected by the law (usually hogwash) and that good breeders should be willing to sacrifice so they can eliminate bad breeders (a sure path to future laws that will dramatically affect all breeders).

## **Judges Comments**

Thank you very much for the honor and thrill of judging your National Specialty.

I was singularly impressed at how well everyone worked together to put on your National. A huge round of applause to Denise Gordon and her committee and friends. You are a treasure. Thanks also for my great ring stewards. I could not have done it without you.

I was very pleased with the overall entry, in numbers, in quality, and particularly in temperaments. It was not very long ago that Canaan Dogs had a reputation for having among the worst dispositions at dog shows. That certainly was not the case at this year's National. Even with my broken leg and limping as I approached them, most of the dogs I saw were totally stable. Congratulations to you all for all of your hard work in turning this around. Keep at it, as it is a constant struggle.

You had a small entry in class dogs, but I thought my winners dog "D & J Ha'Aretz Tip Top Dog" was extremely nice: Good proportions, correct wedge-shaped head with a dark almond eye, sound, and correct presence and carriage. He should finish his Championship easily.

Your entry in bitches was wonderful. There were multiple choices in each class. When the single entry in 9-12 Puppy Bitches walked into the ring, "Mad River Cool Breeze Blowing," I knew right then that she was going to be the one to beat. Her breed type was exquisite as she first moved around the ring, and when I got my hands on her and watched her move up and back, my heart raced. This is the kind of animal that you are looking for every time you walk in the ring. You very seldom find it, but when you do, it makes judging worth every minute of what you have put into it.

The largest class in bitches was Bred-by Exhibitor class, which is the way it should be at shows and particularly at our Specialties. The winner of this class was another puppy, "Renegade Camber", easily reserve winners bitch: A lovely bitch of proper proportions, head, temperament, presence, and soundness. She should finish out of the puppy class and go on to have a great career in the show ring, if that is what the owners choose to do with her.

The Veteran classes at National Specialties are always such a moving event. There are usually many people in attendance who have never seen the monarchs of the breed, so in addition to touching the hearts of us all, it is always enlightening for the "newbies" to see where the breed has come from and where it is going.

The competition in the Specials class was WONDERFUL!!!! I am sure that many of you and all of the prospective judges at ringside have never seen that many Canaan Dogs together. This is where we all learn, so thank you for bring them out.

My Breed winner was a young dog "Ch Desert Star Running Miles, RN", who had the correct outline, moved with the required athletic agility and grace, and had a proper wedge-shaped head with low set ears and a great temperament. He was pushed extremely hard by the winners bitch. It was a very close decision but in the end he won on his maturity, and the bitch, which in my opinion has a brilliant career ahead of her, ended up winning both Best of Winners and Best Opposite Sex.

My two Award of Merit winners were, "Ch Rosendog's He Who Must Be Named" and "Ch Mad River Ladies First". Both of these very nice animals will have an impact on the breed for many years to come.

I heard that your club is working on revising your breed standard, an effort with which I totally agree. I feel the weakest part of your type is proper proportions. In the first paragraph, your standard calls for a square body. "His mediumsize, square body is without extremes" leads many to believe that he has a square outline, but the standard then goes on to say: "Square when measured from the point of the withers to the base of the tail and from the point of the withers to the ground." This creates a rectangular outline.

If a square Doberman, which is measured from the prosternum to the point of the buttocks and from the highest point of the withers to the ground, was measured according to your standard, a 27-inch dog would be 38 inches long. That, Folks, is a long dog. Not off square but actually rectangular. I don't think that is what you have in mind, so you do need a better way to describe what it is that you are looking for. Many standards use a ratio. For instance, the Bearded Collie, which is a long breed, calls for 4 to 5; the Rottweiler, which is off square, calls for 9 to 10. The way your standard is written, it calls for 3 to 5, so I think you need to give this some serious thought.

The overall quality of what was at this year's National was quite nice. You do need to pay more attention to your ear size and set, as it is a unique part of your breed along with the proportions of the dogs. There were also way too many unsound dogs in the ring. I think the movement has improved greatly over the years, but you still have a ways to go. The first paragraph of the standard describes the essence of the breed, and the first paragraph of your standard includes: "moves with athletic agility and grace in a quick, brisk ground covering trot." A big part of breed type is the dog's ability to perform the job it was bred for, and for a Canaan Dog to work efficiently, he must be sound.

Thanks again for the great day, and I wish all of you continued success with your wonderful breed.

## 2007 CDCA Herding Instinct Test

Fifteen Canaan Dogs were entered in the 2007 CDCA herding instinct test held at Dogwood Acres Farm in Bethel, Ohio, on Monday, September 10th. The evaluator was Ms. Dana Hasemeier, an AKC herding judge and a Welsh Cardigan Corgi breeder, who not only tested the dogs, but gave an impromptu herding clinic that all exhibitors and spectators appreciated. Eleven of the 15 dogs passed, giving a pass rate of 73% for this year's National Specialty test; 6 Canaans attained their CDCA Herding Certified (HC) title, 1 earned the 2nd qualifying score of the 3 required for the CDCA Herding Certified Excellent (HCX), and 4 attained their HCX titles. Ms. Hasemeier awarded the Best Herding Potential trophy (for dogs with no prior livestock experience), a stock stick donated by Denise Gordon in memory of "Wolf" (the #1 herding Canaan Dog & 1993 Best Rookie), and a green pendent necklace donated by Ms. Hasemeier, to Mad River Cool Breeze Blowing ("Breeze"), owned by Rosette Davila-Sargent & Charley Sargent. Ms. Hasemeier then awarded the Best Senior Herding Potential trophy (for dogs with prior livestock experience), a sherpa crate bed donated by Denise Gordon in memory of "Wolf" to CH.
