#### 2008 NATIONAL SPECIALTY REPORT, FROM THE SHOW CHAIR

The 2008 National was dedicated to the memory of Leal Grupp. Leal was a long time member of the club, who served in many positions including President from 1993-1998. His presence was felt – and missed – throughout the week, but as we remembered him, we also celebrated another year of Canaan Dogs in the US.



This year's National was the year of the incredible, shrinking committee! Despite the fact that our committee members were hit with sick dogs, new jobs (and no time off), house destruction (err, make that renovation), broken cars and more, this year National Specialty and Annual Meetings happened. We didn't always get things done as quickly or as elegantly as we might have with more folks, but we did it! Credit for everything coming together still goes to all those committee members – in attendance or not – whose work before the week allowed everything to unfold and happen.

The 2008 CDCA National Specialty week started on Tuesday the 22<sup>nd</sup> of September. As CD folks made it to New York State, some hit the wineries, others visited local attractions and others even built in time for farther attractions such as Niagara Falls. Tuesday night we gathered in a suite at the host hotel for our traditional welcome party. Many thanks to Dominic Frinzi and Amy Schaumaier for sponsoring the suite which was used for both the welcome party and the Board of Directors Meeting the next morning. Amy Preston and Judy Rosenthal were set to host the gathering



that night, but Amy was delayed at home with a sick kid and then car trouble. Food was ordered from what turned out to be the slowest restaurant in Waterloo and grumpy neighbors tried to put a damper on the festivities, but CDCA folks know how to have fun no matter what! Special thanks to Chris Miller for sponsoring the exhibitor bags, and to Julie and Dan Haddy's Boston Terrier Indy (for the dog toys; all of which she won

at Agility trials), Innova Pet Foods (dog food samples), Lupine Pet Products (keychains) and Merial Animal Health (combs) for the contributions to the bags.

The hit of the evening was the unveiling of the Commemorative Specialty Books. We originally anticipated that these books would be a way to share some club history and contain a couple of ads. Instead, they ended up as an incredible collection of club history, memories and a representation of current Canaan Dogs from around the world. I cannot say enough about these books. History of Canaan Dogs in the US has been preserved with personal memories and photos. In full color, this book

deserves a place in the library of every Canaan Dog owner. Our appreciation to everyone who contributed: Bryna Comsky and Donna Dodson provided much of the history included, specialty memories were contributed by Bryna. Wednesday morning the Board was up and at work bright and early while our friends and dogs got to sleep in. Full minutes are available elsewhere in the newsletter. We pushed through a lot of work before noon but still had to make plans to reconvene after the AGM to finish our work.

Midmorning Susan Parsons held a handling class at the hotel. Four Canaan Dogs and owners turned out for last minute tips (for some) and first time experiences (for others) in preparation for the show the next day.

After the Board Meeting we heard a lecture by a last minute addition to the program. Dr Richard Vulliet, is on the faculty at the University of California, Davis. He had just been at the Rhodesian Ridgeback National Specialty giving the same talk, and our Delegate Dr Pamela Rosman was able to arrange him to extend



his east coast tour and come to our National. Dr Vulliet spoke from 1 to 2pm and we delayed the AGM half an hour to allow him to finish up and answer questions. Dr Vulliet spoke on the Therauptic Use of Stem Cells in Dogs. His research has the potential to impact disease affecting Canaan Dogs.

The Annual General Meeting followed. As with

the Board Meeting, full minutes can be found elsewhere in this newsletter. Special thanks to our Treasurer Chris Miller for filling in for our Recording Secretary Norma Bennett Woolf who was home recovering from surgery.

Wednesday evening was the Judges Education Seminar. We had a great turnout of judges with lots of dogs for them to see. This year the dogs were in every possible color and pattern combination – for once, black and white dogs were in the minority! Cindy Grupp and Chris Miller tagteamed the presentation.



Thursday morning dawned beautifully and the whole day we were blessed with perfect dog show weather. The Midwest Canaan Dog Club supplied breakfast ringside. Julie and Dan Haddy, Cheryl Hennings, Susan Parsons, Amy Preston and many others helped with ringside set up. Even though we were part of an all-breed show, we were separate from the rest of the show. We had the Specialty Field and tent to ourselves giving us tons of room to spread out.

At 10:45am promptly, the first Puppy Sweep-stakes class was called into the ring. Judge Chris Miller (River Rock Canaan Dogs) obviously enjoyed her entry of puppies. Congratulations to breeder/owner/handler Cheryl Hennings and her bitch Cherrysh Seventh Heaven who was Best in Puppy Sweepstakes. There were two lovely bitches in Veteran Sweepstakes and as they gaited around the ring – wagging and enjoying all the attention – they brought a tear or two to everyone's eye including our Judge. CH Pleasant Hill Hinda M Rosendog CD, bred by Donna Dodson and owned by Judy March Rosenthal, was the eventual winner. (Full results from Sweepstakes through the Supported Entries may

After Sweepstakes and photographs we all gathered under the tent for lunch. Renee Kent may not have been able to attend, but she organized all the meals for the specialty. She sent non-perishables with Amy Preston and the Haddy's picked up the rest of the food locally.

Refreshed and recharged, we moved on to the regular classes. Lester Mapes took the ring and made sure everyone had a good time. Ringside grew quiet as the Winners Dog class entered the ring. Up next, Best of Breed. The judges who had attended the seminar the night before made up the biggest part of the audi-

ence – most of the Canaan Dog exhibitors were in the ring! Word obviously spread to the rest of the show that Best of Breed was being judged as exhibitors and handlers drifted in to watch. After due deliberation, Mr Mapes organized his entry and sent the class around the ring. Best of Breed

Stud Dog and Brood Bitch rounded out the official judging. Mr Mapes stayed in the ring to hand out Parade of Titleholder rosettes as Susan Parsons called out each entrant's name. Photos taken, ringside picked up

and we had time to take a breath before cheering Camber on in the group ring.

Back at the host hotel we meet up in the evening for the Awards Banquet and Auctions. Even though our Awards Chair, Denise Gordon, was unable to attend, she sent her report and awards. Congratulations to Martha Fielder, 2007 CDCA Member of the Year and the late **CH Yashar** Ha'Aretz Machseh. 2007 CDCA Dog of the Year. Tracey Kopea won the 50/50 raffle and promptly spent her winnings in the auctions. This year we added a separate silent auction of theme baskets with the proceeds going to the AKC/ Canine Health Foundation Canaan Dog Donor Advised Club. We also switched up our traditional auctions with a small number of items live auctions and the rest done as a blind silent auction. At the end, when bidder numbers were revealed and the items distributed to the winners, multiple cries of "YOU

#### BOARD OF DIRECTOR'S MINUTES, SEPTEMBER 2008

September 24, 2008, CDCA Board Meeting

Amanda Pough, President—Julie Haddy, Board Member—Pamela Rosman, AKC Delegate, Guest—Cynthia Grupp, Board Member—Christina Miller, Treasurer—Judy Rosenthal, Corresponding Sec. Annette Israel, Guest

Meeting called to order 8:21 AM

Apologies from Evan Kent, Norma Bennett Woolf & Rosette Sargent

Denise Gordon will be calling in

Minutes of last meeting were published in the Kib – no corrections, additions deletions. Chris Miller makes motion – Julie Haddy seconds to accept as published – motion passed

Secretary report - see General Meeting minutes for report.

Amanda Pough stated that we do need a single contact person for the AKC archival process. Will ask for a volunteer at the Annual General Meeting. Discussion of what needs to be collected and how and where AKC will store the documents ensued.

Treasurer report – see General Meeting minutes for report.

Committee Reports – see General Meeting minutes for reports.

Denise Gordon - called in 8:38 AM

Pamela Rosman – AKC Delegate – Delegate reports in Kib. Delegate expenses are high, many clubs do not send delegates to all meetings due to cost. On average, Pamela is spending \$1,500 to \$2,000 per meeting for local meetings, cross country meetings are more due to airfare. Pamela considers it an honor and privilege to serve this club. Would like to have more communication with membership. Wants all members to feel comfortable in coming to Pamela with their concerns and ideas so that she may function as OUR representative. Will not do anything without our direction, unless she is directed to go on her own. Recently re-elected to the AKC Constitution and By-Laws committee.

Discussion of using BOD conference calls prior to delegate meetings for communication. Pamela will be responsible to report any results of such conference calls back to the full BOD.

Advertising committee changed to marketing committee. Still need a chair. Ideas from Bryna Comsky were received – need someone to take them forward. Will be asking for a volunteer.

2009 Specialty – committee is going forward. Sweepstakes judge – need to come up with a ranked list of three to give to Cheryl Hennings. The Board of Directors concluded on this list, in order of ranking for 2009 sweepstakes judge Martha Fielder, Merry Carol Houchard, Lorna Hastings, Nancy Martin. Specialty itself is April 30, 2009.

#### **Unfinished Business**

ILP/PAL letter – Mari-Beth O'Niell is in charge of committee that oversees ILP/PAL – she is aware of the club's stand on ILP's. Feel that the AKC as a whole does not perceive the ILP program as a problem. Without specific information and evidence, it is hard to go to AKC on specific dogs.

Discussion of dogs seen at AKC events ILPed as Canaan Dogs. Request that members with doubts/ questions both follow current AKC procedure for these dogs (speak to the AKC rep – if one at an event) as well as gather info (including photos) and provide any and all evidence to the BOD. The BOD can then comment in an informed manner and then approach AKC.

Our letter needs to be worded and reflect the following:

- Club and members have concerns on current program
- We have a unique perspective on the breed
- As there are no CD breeder judges we would request that they come to us.
- Consider us your primary and most valuable resource on designating a dog as a Canaan Dog.
- We are excited and the prospect of the potential of a separate venue for dogs of unknown heritage.
   Of concern to our members is that owners are electing to pursue an ILP as a Canaan Dog due to the lure of trialing a rare breed and gained prestige at a faster rate than more popular breeds.

#### **New Members**

David Tjhio – Chris Miller motion, Cynthia Grupp second – membership is approved

From Secretary, Norma Bennett-Woolf for Sept: Item 180902 – permanent NS specialty site at Lexington – Lexington site is in jeopardy due to a horse show coming in. – Motion defeated.

Item 80903 – permanent specialty committee – specialty liaison – keeps group on track – gives guidelines and is a "go-to" person. Should be board member and past show chair. Will also be asked to create/collect Policies and Procedures for how CDCA specialties and events are conducted. Amended by Cynthia Grupp and seconded by Denise Gordon – amendment passes – amended motion – motion passes.

Cindy Grupp has volunteered as Specialty Liaison.

#### New business

Secret Ballots –C&BL allow for Secret Ballots if we feel needed. BOD does not see need/want for secret ballots from more than one member. If get comments in future or feel a certain ballot warrants, can institute at that time.

Breed Standard Committee - Committee Report discussed earlier. Cynthia Grupp – moves to expand committee to 9 members. Seconded by Julie Haddy – Motion passed. Chris Miller and Annette Israel are nominated – Judy Rosenthal seconded – motion passed.

#### policy for CDCA:

- 1. All funds submitted for any CDCA sponsored activity will be in US currency.
- 2. Whenever possible, checks should be deposited prior to the event to allow the checks to clear. (2 weeks recommended.)
- 3. In the event of a check being returned NSF, the Treasurer will send a certified letter detailing the NSF check including date, amount, and check number. The Treasurer will also list the outstanding amount due which will include the check amount, and bank fees assessed, and a \$10 service fee.
- 4. The CDCA member will have 30 days from the date of receipt of the certified letter to return the entire outstanding amount due in order to remain in good standing with the CDCA.
- 5. After the 30-day period, if the outstanding amount has not been remitted to the Treasurer, the Treasurer shall notify *The Kib* Editor, the Membership Database Manager and the CDCA-L Listserve manager that the CDCA member is in arrears and therefore is a member not in good standing. A member not in good standing will not receive *The Kibitzer* or any designated CDCA member privileges.
- 6. The CDCA member in arrears that may apply for membership renewal will not be accepted for renewal until such time that all outstanding amounts are received.
- 7. For collection of NSF funds from non-CDCA members, the Treasurer will send a certified letter detailing the NSF check including date, amount, and check number. This has been a frustrating year to be chair of this committee. We are currently using a YahooGroup to lessen the delay which occurred when everything was mailed to all members via USPS. The YahooGroup initially helped speed communication among committee members but this is no longer so. Approximately two years ago, pairs of members were randomly assigned sections of the standard for comment/revision suggestions. All reviewed sections have been presented to the committee as a whole. However, the next step in this process (comments and discussion by the rest of the committee) has dropped off and no discussion has happened in months. The CDCA web site disseminates information about the Canaan Dog, the Club and Club events including the yearly National Specialty show. The site also makes available up to date information about Canaan Dog breeders and puppies.

The Web Committee is really just me. However, many CDCA members contribute content for the site. Sally Armstrong regularly provides updates for the Breeder Referral page. Amanda Pough has provided much information for the web site, the bulk of which concerns the National Specialty. Other members who have provided information for the website over the last year include Denise Gordon, Kathleen Hargrave, Renee Kent, Jennie Larkin, Carrie Franz-Cabrera, Amy Preston and Jeff Menkes, among others. Any information that CDCA officers, directors and committee chairs make available for the purpose is published on the web site as quickly as possible.

In February, Evan Kent suggested that we employ Google Analytics to track the usage of the CDCA web site. Since then, Evan has been able to review the many reports that Google Analytics provide. Evan has some ideas about what it is he would like to do with this information. For example, Evan says that he wants to look at site activity compared to large events, such as Westminster and Eukanuba, to help drive advertising plans.

distributes the information to the newsletter for voting by the membership (a single nomination at the deadline is automatically declared the winner), maintaining statistics/records of those Canaan Dogs earning titles from any organization for each year, obtaining engraved plagues for Register Of Merit/Register Of Merit Excellent, Versatility/Versatility Excellent, Dog Of The Year, and Member Of The Year for the annual awards banquet, and presentation of awards at the annual banquet (or designate an alternate presenter for the task). Again, while any help would be appreciated, this task can be handled by one person. The best help that the Club can give is that members be reminded to send in notification of new titles (whatever the organization) to the Awards Chair as soon as possible; otherwise, they will not be acknowledged by the club in either the newsletter or during the awards banquet. This can be best accomplished by occasional newsletter reminders and/or the website.

For Awards accomplishments in this past year, quite a few Canaan Dogs earned titles since the last National Specialty was held (September 7<sup>th</sup>). The biggest "title" earned was by CH Mad River Cool Breeze Blowing, CDCA-HC, owned by Rosette Davila-Sargent and Charley Sargent, when she became the 3<sup>rd</sup> Canaan in history to win Best In Show. In regards to AKC titles, 14 earned their Championship title, 15 earned Rally titles from Novice through Rally Advanced Excellent (the ultimate Rally title), 2 were awarded agility titles, and 1 earned the Companion Dog obedience title. Though not a title, 7 Canaans passed the AKC=s Canine Good Citizen (CGC) certification test, which encompasses obedience training and socialization (temperament). As for the CDCA titles, 6 Canaans earned their Herding Certified (HC) titles while 5 were awarded the Herding Certified Excellent titles since September 10, 2007. In addition, there was 1 CDCA Register of Merit recipient and 2 CDCA Register Of Merit Excellent recipients, all owned by Cheryl Hennings (I believe that=s a record for a single year). This year also saw titles earned by Canaan Dogs through other organizations, such as the UKC, USDAA, and 2 Canaans made history by becoming the first Australian Champions for the breed, Australian Ch. D&J Ha'Aretz Vertigo At River Rock and Australian Ch. River Rock Light My Way, both owned by Chris Miller.

#### **Health Committee**

The Health Committee reported health situations to the Kibitzer including new findings in cancer, seizure disorder and Protein Losing Enteropathy with associated Lymphadiectasis.. Also, brief reports were made regarding lectures held at the 2007 AKC/CHF conference. It was announced that there was a DVD available upon request for determination and treatment of Degenerative Myelopathy, a crippling disease. There has been minimal interest in the DVD.

A genetic test for DM is now available through the University of MO. The ICDCA and the Midwest Canaan Dog Club have taken the opportunity to test the dogs of several members and I would encourage everyone who has received their results to report their findings. If you wish to report to me please include a release statement for publication and I will report the findings in the Kibitzer. In this way breeders can work to eliminate the escalation of the problem in Canaan Dogs. If you think your dog may have a problem with DM please contact me and I will forward the procedure for testing.

At this time there is a full DVD file of 23 presentations available reviewing the AKC/CHF conference held in the Fall of 2007 including a Power Point summary. Please contact me for the file or for specific information from any of the lectures.

#### 37th CDCA National Specialty Report, with Judges Comments

It is in the nature of things, that after difficult and challenging dress rehearsals, the final play is successful. Mostly organized by remote control, the CDCA Annual National Specialty Week was no exception, and blossomed to a wonderfully jubilant event with a sustained happy and joyful atmosphere lasting to this very day. New this year was Chris Miller's publication of her "Commemorative Booklet Celebrating our 37<sup>th</sup> (Annual) National Specialty," 2008. Neatly tucked into our canvas gift tote bags was a 102 page history of our breed given through photos, advertisements, and vignettes of people who have contributed to the breed and its national club during their lifetimes. Some also wrote of their first remembered experiences at a CDCA sponsored specialty, and the actual first CCA National Specialty at Spatterdash Kennels is described. The booklet is beautifully done, and we hope that this creative idea becomes part of the breed's tradition. As Bert Sheaffer (Spatterdash) would say, "It's a keepsake."

Davis, whom Pamela had \*snared\* to head our educational program with his talk on stem cell research and its relation to degenerative myelopathy, a disease found in all breeds, and recently diagnosed in Canaans. There could even be a possible connection to Vaccine Protocols and their effect on auto-immunity reactions in dogs according to an allusion by Dr. Vulliet. Both he and Dr. Jean Dodds are acquainted and work from the same site, although on different projects. The future of stem cell research as described by Dr. Vulliet, is hopeful.

According to schedule Susan Parsons, who comes from Skye Terriers, instructed both novice and experi-

enced handlers in the fine art of presenting a dog at the same time as the CDCA board meeting, next morning. Experienced or not so, there were pearls of wisdom to absorb for all participants. Susan was also Chief Ring Steward for sweeps and regular judging at the national, and the reason why things ran smoothly. Susan didn't disappear after that, but was present at the raffle and awards banquet afterwards. If the Club made money this year, then it has Susan to thank for bringing in a yeoman's chunk of it.

The afternoon was devoured by the annual general meeting, conducted by Amanda, CDCA President. The minutes of both the board and annual general meetings appear elsewhere in this Kibitzer issue.

There was a good turnout of AKC licensed judges, and breeder-owner-exhibitors of Canaan Dogs at the evening seminar put on by Cindy Grupp. As students of the breed they contributed to the lively conversation and commentary, all upbeat ,and looked forward to the specialty judging scheduled for the next day. The entry didn't disappoint them. Though relatively small, both styles were represented giving a range of breed type that they are likely to see in their conformation rings.

Breeder-judge Mrs. Christina (Chris) C. Houchard Miller showed her joy and emotion at the sight of the young dogs and veterans in her sweepstakes classes. She thanks CDCA for "handing her the honor of judging the 2008 Puppy and Veteran Sweepstakes," and writes as her critique of the competition:

"Even though the entry was small, I truly enjoyed the dogs and the assignment. I'd like to thank the exhibitors for bringing me entries that were of quality and enjoyed the experience."

My 9-12 month dog, and eventual Best of Opposite in Sweepstakes, was well balanced, had nice bone, and a wonderful coat. When he settled into his stride, his movement finally showed through.

My 6-9 month bitch presented a lovely head and was balanced. Still a young dog needing to tighten up, and once the front catches up with the rear, she will be

very competitive. Her ring attitude was a pleasure to see.

The 9-12 month bitch had a lovely feminine head a wonderful t ail set. She was very balanced front to rear. I don't think the show ring was her favorite place to be, but when she did relax there were glimpses of nice quality.

The 12 – 15 month bitches were both of good quality. My #2 placement had wonderful pigment and was balanced. My #1 placement, and eventual Best in Sweepstakes, was square with a feminine head. She was balanced with moderate angulation.

The two Veteran Sweepstakes entries brought tears of joy to my eyes. These lovely "mature" bitches hold what is wonderful about this breed. Both bitches were of exceptional type and



held their quality for their age.

The 7 - 10 year old bitch entered the ring with attitude and grace. Square, moderation and wonderful movement propelled her to Best Veteran in Sweepstakes.

The 10 Year and over bitch was in excellent condition, well muscled and balanced.

In summary, I was very happy with the direction the puppies are going and where the veterans have taken us. I can't thank Amanda Pough enough for making my experience as Sweepstakes Judge as enjoyable and memorable as it was. Thank you to all of the show committee who worked very hard to make this Specialty very special." (Chris Miller)

Thanks to the generosity of the Midwest Canaan Dog Club, that is hosting the 2009 National next year, exhibitors and spectators were treated to breakfast and lunch before engaging in the reason-for-being-there, the 37<sup>th</sup> CDCA Annual National Specialty, 2008, competition.

It was great to see Les Mapes, the specialty judge dancing in the center of the ring, and enjoying every moment and every dog in his entry, modest in number, but with obvious quality. Both styles showed to their best advantage and Les saw a quality and continuity of type that had eluded him before. He writes of his entry:

"First of all I had a "ball." The weather turned out great, the dogs were of good quality representing their

breed well and the exhibitors were enthusiastic and were a pleasure to have in the ring. The ringside spectators were enthusiastic and that always adds to the enjoyment of nationals.

I had hoped for a larger entry but considering the economy and the price of gas, I guess it is what we must deal with at this time. The number of entries, however, impressed me with the overall quality. Yes, there were some entries that were not competitive, but overall, I was pleased. Having judged Canaan Dogs for a number of years, I have observed a wide variation in quality. These variations were not only present in breed type, but also a wide range of temperaments existed. These variations were not present at the specialty, in my opinion. The entry all looked like Canaan Dogs. This was not always the case in the past. I only had one entry that didn't care for me, but I did not feel that the dog had a bad temperament and believe it was lack of experience or socializing. The entry, in fact, was a very nice Canaan Dog and should do well when the time is right.

My eventual Winners Dog was a well balanced dog with good breed type and an excellent ground covering gait. He would have liked a bit more conditioning on him but he represented the standard well and was

rewarded for his attributes. He should continue to do well and is a competitive dog.

My Winners Bitch was a lovely feminine girl who also had good breed type and lovely movement. A very nice young puppy went Reserve Winners Bitch, which, in my opinion has a wonderful future ahead.

Nice selection of Breed dogs which gave me many choices. It made it easy as many were worthy of being my



selection for Best of Breed, but you of course must select only one for the honor. My Best of Breed selection was a bitch and Best of Opposite a dog – both representing the breed very well. Both with beautiful type, soundness and temperament.

The breed has come a long way from where it started in this country. The Canaan Dog is now being recog-

nized in the Herding Group and the consistency of quality will continue to improve. Breeders are doing a good job and it will become apparent in the show ring.

Again my thanks for allowing me to judge your specialty and my sincere best wishes to all for your continued success." (Les Mapes)

Mrs. Paula Hartinger judged the breed entry on the following day, and repeated the Best of Breed selection. Best of Opposite Sex to Best of Breed went to CH "Harry," who continued his placement for two more

days. Her choice for Best of Breed also took Group IV on the day. Mrs. Hartinger was delighted with her entry, pleased with it, thought the breed was maturing well, and was upbeat with her impressions. Her placements, along with others, were posted by Show Chairman,

Amanda Pough, on the Canaan Dog Club of America List.

Judge Mrs. Pat Hastings, who judged the CDCA National last year, 2007, wrote the following about her entry on the third day:

Once again I had the wonderful opportunity to judge a large entry of Canaan Dogs on the weekend of your National Specialty.

I was quite impressed with the numbers, the quality and the temperaments. Your breed continues to improve every year which is not the norm in numerous breeds. A long weekend is very hard on many dogs but particularly on the ones that do not have the opportunity to go often. The majority of yours handled it very well. You should be proud of the strides you have made.

I was very pleased with both my winners dog "Mad River Here's Looking At You Kid" from the open class and my winners bitch "D&J Ha'Aretz Vertigo At River Rock" also from the open class. Both of them are a real credit to your breed. Congratulaitons to the owners and the breeders.

If you were in attendance, you noticed that I measured all of the bitches in the Bred By Exhibitor class. Happily they all measured in but you have such a wide range of size allowed that many people

thought the larger bitch was too big while others thought the smaller ones were too small. Five inches is a major difference so I wanted to show everyone that they were all just fine.

Ten Specials of any breed is impressive but it is so much



more so in a small entry breed such as your Canaans. My Breed winner "Ch Mad River Cool Breeze Blowing", I am happy to report, was my best of Best of Winners and Best Opposite winner last year at the National. In my opinion, she has done nothing but get better with maturity. I wish her the very best throughout her career. My Best Opposite winner was the big winning "CH Rosendog's He Who Must Be Named". He has already proven his worth to the breed and I am sure we will be seeing his off-spring for years to come. Congratulations to both of them, their happy owners and breeders.

I hope you are making progress in your Standard revisions to help your breeders understand more of what your goal is. There still is not a lot of uniformity in shape along with a real combination of heads and ears.

Remember that the standard is a blueprint that allows the dog its ability to do the job it was bred for and soundness of mind and limb is crucial to that end.

Pat gave Breeze, her BOB winner, the Group, and previously a Best in Show. Dr. Donald A. Gill, who judged Canaans on the fourth day of the specialty weekend, was just as enthusiastic about Breeze, and gave her the Breed and the Group. He was very favorably impressed with her, and with the overall quality that he saw compared to previous entries. He also

commented on the good temperament.

So, we put another National Specialty to bed, and continue with plans for the next one, April-May, 2009, at Oconomowoc, Wisconsin.

#### AKC DELEGATES' FORUM, SEPTEMBER 9, 2008

The Delegates' Forum is an informal meeting of Delegates, providing the opportunity for open discussion and expression of ideas. The Chair of the Delegates' Coordinating Committee opened the September 2008 Forum with welcoming comments and the introduction of the forum's theme, "Meet the Legislative Caucus", main moderator and caucus members.

AKC Board member Patti Strand explained how inseparable media and legislative issues are, and presented an overview of two of the most sensational issues—overpopulation and genetic diseases in purebred dogs. Trends in pet population show great improvement over the past 40 years, mainly due to public education campaigns and free and low cost resources, such as spay/neuter programs, available to pet owners. Warped statistics often combine dogs and cats (including feral cats) in pet population numbers. The higher number of shelter dogs vs. puppies reflects a pet retention problem rather than a pet overpopulation problem. AKC breeders are able to educate the public by encouraging puppy owners to socialize and train their dogs and participate in AKC activities. Activists currently emphasize the perception of widespread disease in purebred dogs, but in actuality, organizations such as AKC, CHF and OFA are hard at work improving the health and longevity of all dogs. Many breeds in the U.S. are healthier than ever before. Talking points must be developed to articulate all that the fancy does to advance canine health and all that has been accomplished to date.

AKC Breeder Field Representative and Kennel Inspector Stacy Mason reported her observations re-

garding the improvements made by a majority of AKC high volume kennels. She was pleasantly surprised to discover that a vast majority of those breeders who have stayed with the AKC have well maintained kennels, healthy breeding stock, are eager to learn and do more. By working together through I.C.E.— Individual Communication and Education, the ice barriers between all groups will melt

AKC Government Relations Department Head Walter Bebout discussed legislative issues threatening the right to own and breed dogs responsibly. He explained the distinction between electoral and governmental politics and the necessity for purebred dog owners to become proactively engaged with elected officials at state and local levels. To maximize our ability to contest negative canine legislation, AKC's legal empowerment resources include: Taking Command, AKC's electronic blog/newsletter addressing legislative issues; Legislative Alerts; Pending Legislation Reports; Bill/ordinance analysis; Assistance/intervention in legislative process; Outreach capability to AKC constituents via email and regular mail; Seminars at dog events; and Brochures.

Subsequent to a question and answer session, "Hot Button" issues were discussed. As homework, every Delegate was assigned to bring to the December Caucus, a legislative Win and how it was achieved, or a legislative Lose and what went wrong. (Delegate Note: Canaan Dog fanciers, your input is needed. Please send me by email (pamelarosman@aol.com) details of your successes/failures so this information may be presented at the next meeting. There being no corrections to the minutes of the June 9, 2008 Delegates meeting published in the July Gazette, the minutes were approved as published.

The Ann Arbor Kennel Club and Mount Bachelor Kennel Club were approved as member clubs.

James Stevens, AKC Chief Financial Officer, gave the financial report. Total revenues for the first seven months of 2008 were 2.5% higher than last year and operating expenses were 1% lower than 2007, resulting in a year-to-date operating surplus of \$3.2 million vs. \$2.5 million in 2007. The 2008 stock market volatility led to a year-to-date unrealized investment loss of \$3.2 million vs. last year's gain of \$3.8 million. The 2008 net surplus for seven months was \$20,000 vs. \$6.3 million in 2007.

Dennis B. Sprung, Chair, gave his report. The declining registration numbers are severely impacting the AKC's core revenue and, in turn, alternative revenue. Competitors' financial incentive tactics undermine the AKC's core business, causing significant losses in revenue. In the past ten years, litters have declined 30 percent. The percentage of AKC dogs and bitches that are being bred, the number of litters registered by fanciers as well as the percentage of individual dog registrations from the fancy has remained constant over the years. It is the purebred PET owning population that is contributing to the decline. The breeding of purebred dogs is not declining; rather it is the number of litters registered with the AKC that is declining. Statistics show that there are more purebred and mixed breed dogs in America than ever before. The breeders producing 7+ litters a year, many no longer with AKC, are having the biggest impact on our overall numbers. There are now 30 all-breed registries competing with the AKC, not including additional competitors that are for specific groups of dogs. Since AKC's peak in 1992 with 1.5 million individual registrations. through 2007 registrations have declined 46 percent. An additional important factor contributing to this decline has been the loss of the one litter a year breeder, many of whom actually breed one litter in a lifetime. In 2007 compared to 2002, there has been a 10 percent decline in litter registrations for just that one single group! Many pet purchasers are no longer buying an "AKC-registrable" dog or bitch. To a significant extent, core revenue from pet registrations funded AKC and the sport's growth. Studies report that both the number of households owning a dog and the percentage owning a purebred dog has increased since 2000. Litter sizes are not smaller. The AKC registration ("blue slip") return rate has remained constant at 44percent for the last decade. Individual AKC dog

registrations are declining as a direct consequence of fewer litters being registered with the AKC; in 1992, there were over 2.7 million AKC registrable puppies, in 2007 there were less than 1.9 million AKC registrable puppies. Fewer registrable dogs equates to fewer registrations, pedigrees, transfers and less of a pool of newcomers to the sport. Less core revenue from pet registrations will shift the financial burden directly to clubs (and their members). The tactics of the "for profit" competitive registries include offering free litter registration, financial incentives to distributors for placing competitors' information in puppy packets and sharing registration fees with retailers. The pet shop industry is flourishing and will continue to grow. The percentage of retailers carrying puppies that can be registered with AKC or elsewhere increased in one year from 17 percent in 2005 to 23 percent in 2006. Many of today's fanciers purchased their first dog from a retailer. AKC Board Chairman Ron Menaker, purchased his first Bedlington Terrier from Gimbel's Department Store! Without that first AKC puppy, an entire generation of exhibitors and multiple generations of future dogs are lost. Core breeders are not able to supply the demand to the public. The AKC has made well researched business decisions resulting in significant alternative revenue streams. AKC's core business represents both our major revenue component and the platform from which to seek licensing, sponsorship and other marketing initiatives.

Ron Menaker, AKC Board Chairman gave his report. AKC faces enormous challenges to reverse the decline in registrations. Retail market share is being lost at a dramatic rate. The future of the AKC and the sport is at risk if the decline in registrations and associated core revenues continues. Management has been directed by the Board to aggressively pursue all AKC registrable dogs. The goal is to communicate and educate those in the retail sector as to why an AKC registered puppy is the gold standard. The AKC is the only not for profit registry. The AKC is committed to the integrity of the registry and the excellence of the AKC's inspections program. AKC's compliance and inspections program allows for the education of breeders about puppy socialization, genetic health screening, grooming, exercise and adherence to breed standards. Twelve years ago the Board first passed the AKC's care and conditions policies, elevating the quality of AKC registered puppies. If litters, dogs and entire colonies are lost to competing registries, then AKC can neither inspect the dogs nor educate the breeders and our sport ceases to grow. AKC used to be the dominant force in the marketplace even Macy's and Gimbel's sold AKC puppies. Many pet owners, purchasing these purebred puppies, chose to advance in the sport, becoming serious ex(Continued from page 37)

hibitors and breeders of AKC registered dogs. This is no longer the case today. The available pool of AKC registrable puppies is being lost to other registries, together with potential participants in the sport. As registrations decline, the AKC's core revenues, ability to generate alternative revenues and legislative influence all decline. For decades, millions of registration dollars were collected from AKC pet owners, which overwhelmingly subsidized our sport. Twenty five years ago almost all of AKC's revenue was registration related. In 2007, less than 50 percent of AKC's revenues came from registrations. Dog registrations peaked at 1.5 million in 1992 and by the end of 2008 a 53 percent decline is projected. As the AKC aggressively pursues all AKC registrable dogs, the AKC will not compromise our values and high standards and will continue to support the Parent Clubs' Codes of Ethics. If dog registrations decline to 250,000, the AKC will face an annual revenue shortfall of \$40 million. If AKC relied solely on increasing event service fees to compensate for this revenue shortfall, the fee would increase to \$20 per entry! A \$40 million revenue shortfall would necessitate a two thirds reduction of expenses. Since 2002, AKC has reduced our headcount by more than 50 employees and aggressively controlled expenses which have remained relatively flat since 2003 notwithstanding inflation. The problem is not expenses; it is a serious revenue problem. The exigency is to secure AKC and our sport for future generations of dog lovers, respecting the rich heritage and traditions of the past while adapting for the future.

The Chair reported that on October 22<sup>nd</sup>, the Chair, Board Chairman and Delegate Committee chairs will meet in New York to discuss AKC's future.

There was a VOTE on the proposed amendment to Chapter 11, Section 1 of the Rules Applying to Dog Shows, and Chapter 7, Sections 1, 2 and 3 of Beagle Field Trial Rules and Standard Procedures for Brace, Small Pack and Small Pack Option Field Trials and Two Couple Pack Hunting Tests; Beagle Field Trial Rules and Standard Procedures for Large Pack Field Trials: Field Trial Rules and Standard Procedures for Basset Hounds: Field Trial Rules and Standard Procedures for Dachshunds; Field Trial Rules and Standard Procedures for Pointing Breeds; Field Trial Rules and Standard Procedures for Retrievers; and Field Trial Rules and Standard Procedures for Spaniels. This amendment would require that dogs be individually AKC registered to compete in AKC licensed or member events, thus resolving numerous issues resulting from ineligibility caused by dogs shown on litter numbers. The proposal was adopted to be effective January 1, 2010.

There was a VOTE on the proposed amendment to Chapter 7, Section 13 of the Rules Applying to Dog Shows. This amendment would clarify the limit of entries and eliminate longer days that can result from multiple entries of the same dogs and also permit judges to complete their provisionally approved breeds and advance to approved judging status without an avoidable delay. The proposal was adopted.

There was a VOTE on the proposed amendment to Chapter 5, Sections 1, 2 and 3 of the Field Trial Rules and Standard Procedures for Retrievers, which would add wording to make these sections consistent with Chapter 14, Section 3, providing that only amateurs may judge, and Chapter 5, New Section 5; and Chapter 14, Section 23 of the Field Trial Rules and Standard Procedures for Retrievers, improving the quality of judging by increasing the experience required for approval of a person to judge his or her first stake in which championship points are awarded. The proposal was adopted.

There was a VOTE on Chapter 14, Section 8 of Field Trial Rules and Standard Procedures for Retrievers. The amendment would provide clarification of retired gun tests without intruding on the reasonable discretion of the judges in setting tests. The proposal was adopted.

There was a VOTE on Chapter 14, Section 20, of the Field Trial Rules and Standard Procedures for Retrievers. The amendment clarifies the use of birds, which are not to be retrieved, as diversion in blind retrieves. Subsequent to a motion made and seconded to change "poisoned" bird to "diversionary" bird, the proposal was adopted.

There was a VOTE on Chapter 14, Section 10, a new paragraph, of the Field Trial Rules and Standard Procedures for Retrievers. The proposal to allow for CKC Field Champions to meet eligibility requirements to participate in same level AKC events, subject to AKC registration requirements, was adopted.

There was a VOTE on Chapter 14, Section 25 of the Field Trial Rules and Standard Procedures for Retrievers. The amendment would eliminate all references to walk ups from the rules and clarifies rules for a handler and dog. The proposal was adopted.

James Crowley, Executive Secretary, READ a proposed amendment to Chapter 17, Section 2 of the Rules Applying to Dog Shows, to be voted on at the December 2008 meeting. The amendment would permit monthly billing of AKC superintendents to improve the efficiency and accuracy of accounting.

The Executive Secretary READ a proposed amendment to Chapter 9, Section 6, of the Beagle Field Trial Rules and Standard Procedures for Brace, Small Pack Option Field Trials and Two Couple Pack Hunting Tests, to be voted on at the December 2008 meeting. The amendment differentiates the Beagle Field Trial Championship title by the three distinct hunting styles demonstrated in different field trials.

The Executive Secretary READ the proposed amendment to Chapter 9, New Section 11, of the Beagle Field Trial Rules and Standard Procedures for Brace, Small Pack Option Field Trials and Two Couple Pack Hunting Tests, to be voted on at the December 2008 meeting. The amendment would provide for a new national championship for Gundog Brace Beagles.

The Executive Secretary READ the proposed amendment to Chapter 9, Section 6, of the Beagle Field Trial Rules and Standard Procedures for Large Pack Field Trials, to be voted on at the December 2008 meeting. This amendment will differentiate the Beagle Field Trial Championship title by the three distinct hunting styles demonstrated in different field events.

John Lyons, Chief Operating Officer, announced the October 14<sup>th</sup> Open House in AKC's North Carolina facility, presented the Third Quarter Community Achievement Awards (Lyons Township Dog Training Club; Salisbury Maryland Kennel Club, Delegate: Barbara Furbush; Myrtle Beach Kennel Club, Delegate: Linda Witouski), and 25 year delegate service medallions (Barbara Furbush, Susan M. Napady, Edmund R. Sledzik, James W. Smith, Constance B. Vanacore).

Daisy Okas, Assistant Vice President of Communications, gave an update on the Club Classified Advertising Program. Earlier this year, the Demand AKC Papers Advertising Program was started. This aggressive campaign, centered around local newspaper classified advertising, is an effort to direct the puppy buying public to responsible breeders and AKC registered puppies by informing consumers about how to find a responsible breeder. Six different URLs direct puppy buyers to learn about the value of AKC papers and registered puppies, and provide links to parent and member club web sites through a directory or breeder referral. The objective is to enlist clubs to place their advertising in communities and make certain to include the AKC brand which sets AKC clubs, dogs and breeders apart. Club educational credits are offered in return for meeting certain criteria. The minimum criterion is 200,000 readers in the club territory annually. Ads should refer readers to an AKC web site and clubs should include their own web site or local contact information. Clubs can implement the program in

whatever way they like. They could choose to reach this audience in one day by placing the ad in a paper with a circulation of 200,000 or a club might place an ad 20 times consecutively in a paper with a circulation of 10,000 to reach the minimum. Some Golden Retriever clubs pooled their resources to create an ad (in the April 2008 issue of Dog Fancy, running consecutively), representing the parent club and highlighting the fact that they are a member club of the AKC. (Delegate's Note: Would this be appropriate within the Canaan Dog community?) For more information, go to the AKC web site (www.akc.org) under the clubs on the home page. AKC spends millions of dollars each year on PR advertising and public education. Next Sunday's issue of Parade magazine has a banner celebrating responsible dog ownership day and an ad inside the magazine, one example of national advertising that the AKC is doing. To impact your local communities, each and every club needs to reach out through events like AKC Responsible Dog Ownership Day and the Demand AKC Papers Program.

Nominating Committee, appointed by the Board of Directors, to nominate candidates for the class of 2013, announced: Erik Bergishagen, Chair, Rey Burgos, Blackie H. Nygood, Harry G. Ottmann, Jack G. Smith; Carl E. Holder and Patte Klecan, alternates.

During New Business, several delegates questioned the AKC Board vote on mixed-breed dogs and urged the AKC Board and staff to continue to explore the inclusion of mixed breeds in companion events. A resolution made requesting that the Board reconsider the question of pursuing mixed-breed dogs in some form was supported by an overwhelming majority of the Delegates. Other delegates spoke about forming another ancillary organization to the AKC to enhance lobbying ability and create a continuing stream of income; reaching out to celebrities who own purebred dogs to give public service announcements extolling the virtues of an AKC registered purebred dog and the worthwhile programs the AKC supports; Petland; declining registrations; donations to the U.S. War Dog Association; the December 2008 AKC/Canine Health Foundation Gala in Long Beach.

The next AKC Delegates' Quarterly Meeting will be held Tuesday, December 16, 2008 at the Hyatt Regency, Long Beach, California.

If this proposal is approved by the AKC Board of Directors, it must be read at the next Delegate meeting and voted on at the following Delegate meeting.)


