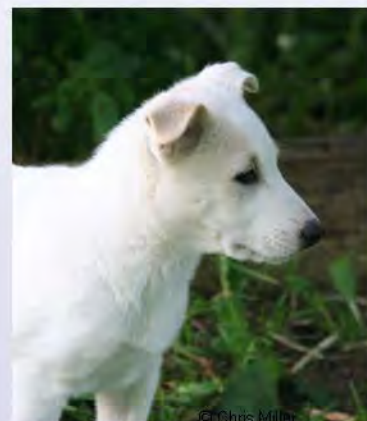

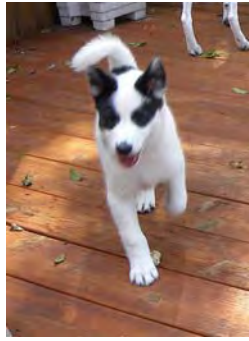

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

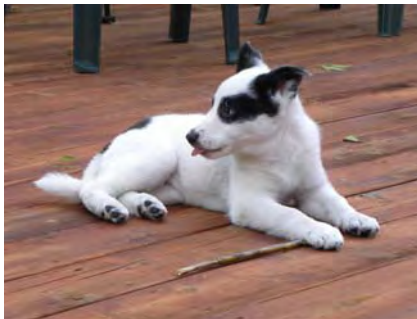

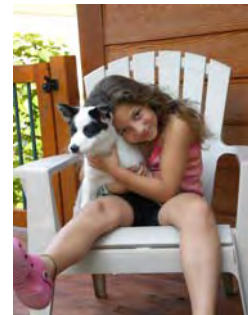

The Carolina Foothills Dog Show Cluster 2009

Three all-breed shows and 3 obedience and rally trials at Greenville, South Carolina, drew four (4) Canaans in all to the Carolina First Center, showsite for one of the largest dog shows in the country. As one of eight herding breeds offered to the Carolina Dog Judges Study Group, Canaans were presented by Chris Miller on Friday, July 24, 2009, the first day of the cluster.

Judge Mr. Fred Bassett judged Canaans on the first day and put up his BBE bitch, "Kate", over her dam, CH Vala, for BOB at the Spartanburg Show. Vala would win on Saturday, handled by Ethan Miller. Fred Bassett had attended the CDCA National Specialty in 2002, and has been a serious student of the breed ever since.

On Saturday, Judge Ms. Mary Anne Brocious had an entry of three Canaans. Orela me Shaar Hagai, owned by Julie Haddy and Daniel Haddy, came in to play, and won RWB. The judge put up CH Vala as predicted, and Kate was satisfied with her WB award for another point. Chris and Ethan handled the River Rock dogs, and Daniel Haddy, Orela. As show chairman for Spartanburg Kennel Club, Daniel was not eligible to show his dog on Friday, their show day. Julie Haddy, Paul Smallwood and I cheered from ringside.

"Gibson," CH Bsnatch Rosendog Ran Away to River Rock, took Breed on Sunday under Judge Mrs. Lee Canalizo. Kate was WB for two more points because she went up over her "mom" again, and Orela took Reserve. Orela was outnumbered by the presence of the more traditional style of Canaan Dog in the weekend's array. Her ancestry goes back to recent stock from the Israeli desert. Both styles are judged under the current AKC breed standard. The number of exhibits from either style often determines the winners on the day. Mrs. Canalizo has been a long-time supporter of Canaans after she met them for the first time when they competed in miscellaneous class at their regional specialty show event at Riddle Field, Ohio, and had been judged by the late Ms. Martha Jane Ablett in 1989. After their decades-long wait for full AKC acceptance, it is still a thrill to watch a Canaan dog compete in Herding Group. We finally made it!

Chris Miller gave the Canaan Dog presentation to 25 students who currently judge, or aspire to judge, Canaans. There was a PowerPoint program with historical photos going back to the first four imports and their ancestors to Dugma. Hands-on judging took place in a separate ring. Ethan helped hold and show dogs as did Julie Haddy. I believe Dan was there too, despite his responsibilities as show chairman that day. The content of the seminar covered the history of the breed in photos and followed its progression and keeping of breed type through the decades of its existence since the re-domestication of Dugma in the 1930's by the Menzels.

At CDCA member, Meir Ben-Dror's, recommendation, the Canaan Dog people rounded out a packed day on Friday by enjoying dinner at a Middle Eastern restaurant owned and run by Israeli Christian Arabs. The food was delicious, and special Greek pastries were served with Turkish coffee to end a perfect meal. Meir, Chris, Ethan, Dan and Julie, and Paul and I talked about Canaans and made up a small but happy group. Paul is from South Carolina, and brought with him his two Canaans: CH Starli and his new puppy, "Blanca," sister of Tiny Tina, Tobey, and Stella! This was Paul's first visit to a dog show!

I left with my fellow travelers on Sunday morning to look at homes in unrestricted areas around Knoxville, Tennessee. The last one was right across the street from a herd of milk cows! By late Sunday evening we were home from a grueling but great trip from Chicago, Illinois, to Greenville, South Carolina, with another Meir Ben-Dror recommendation: South Carolina peaches!! Our Canaan Dog group at Greenville was small, but enthusiastic, and the breed was well represented.

On a very serious note, Darrell Hayes, a vice-president of the American Kennel Club, addressed the students at the Judges' Study Group about the state of the AKC's financial affairs and ability to keep its leadership position in the dog world. Over the last ten years, registrations have dropped by nearly a million dogs to a number approaching 700,000. The AKC is now competing against 50 independent registries in addition to drawing legislative battle lines against the well-organized and well-financed intrusions of PETA and HSUS. The AKC will always retain its history and uniqueness as an organization of dog clubs, but will never be as influential again as it once was, despite the fact that it supports the CHF (Canine Health Foundation), its library of 18,000 books in NYC, its dog museum in St. Louis, its monthly publication, the AKC GAZETTE, and its summer intern program to attract aspiring youngsters who will find dog-related careers. The AKC maintains its programs, despite being forced to defend itself and what it stands for, against those who would destroy it.

Chris and I shared a sentimental moment when we recalled the presence of Dylan, Paws, and Raiah on this same site ten years ago. We both showed Dylan in obedience, and I showed Paws in Breed. Now their offspring carry on for them in their paw prints and tradition.

Health Report, by Donna Dodson

I have thought about the suggestion from the 2009 National Specialty that we formulate and present a new HEALTH SURVEY. I am eager to have the CDCA and the general Canaan Dog population involved in the creation and presentation of a new HEALTH SURVEY. 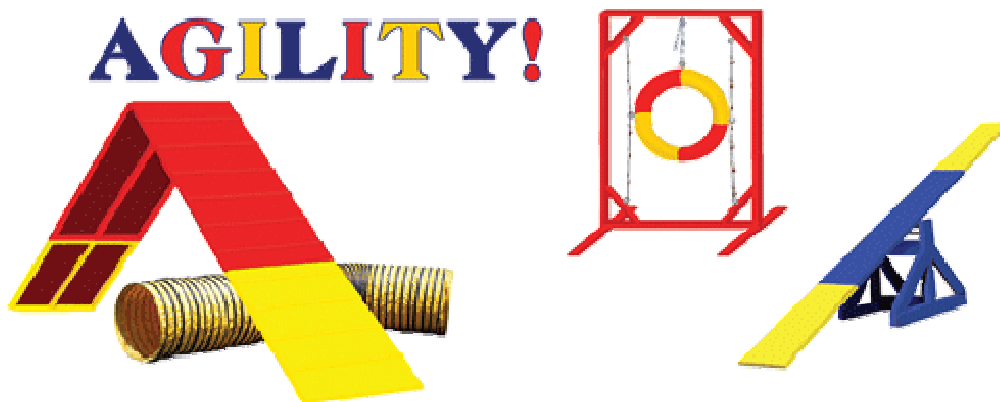

Dennis B. Sprung, President in the
Chair, called the meeting to order.

James Crowley, Executive Secretary,
read the names of the 16 Delegates
seated since the last meeting; 15
Delegates attending their first
meeting since approval were intro-
duced from the floor.

Minutes of March 2009 Delegates
meeting were approved.

Boca Raton Dog Club, Mississippi
State Kennel Club and Norwich Ter-
rier Club of America were approved
as member clubs.

Dennis B. Sprung gave the Presi-
dent's report.? Registration is a
serious concern.? Fewer litter reg-
istrations lead to fewer dog regis-
trations, pedigrees ordered and re-
duced entries at dog events.? This
means less opportunity for programs
such as AKC Chase credit card, PPI
dog health insurance and fewer new
owners to reach out to on behalf of
AKC Companion Animal Recovery (CAR),
AKC Canine Health Foundation (CHF)
and the AKC Museum of the Dog.? From
a business perspective, AKC is chal-
lenged by sheer numbers in marketing
the AKC brand to sponsors and licen-

sees, resulting in reduced revenue
channels.? In this economy, a com-
pany is often defined by reputation,
customer base and constituency
size.? The AKC tradition is exem-
plary but unless registration num-
bers are restored, the cumulative
effect on the future will find the
AKC smaller and less influential.?
Today's evolving business world re-
quires AKC's business to be crea-
tive, capable, informed, practical
and first to market.? Being first to
market is dependent upon quick deci-
sions and for AKC that is a govern-
ance issue.? (Delegate Note: The
Delegate Bylaws Subcommittee charged
with the future governance of the
AKC, of which I am a member, is de-
liberating this issue presently.)?
The goal now is to reverse the reg-
istration decline and grow the core
business, requiring team effort.?
With the Board's encouragement,
staff has set in motion initiatives
to improve registrations, including
the AKC Registration Pledge and the
Online Record Keeping service com-
plimentary to all breeders with a My
AKC account.? (Delegate Note: If
you haven't already done so, go to
the AKC web site, www.akc.org and
follow the instructions to create a
My AKC account.)? Now, while main-
taining mating, whelping, registra-
tion information and viewing litter
registration data for all puppies,
breeders can assist in improving AKC
registration numbers by verifying
that every puppy sold has been indi-
vidually registered or following up
with the new owner to do so.? A
turnaround will not be immediate but
will continue, endure and succeed.?
Registration, revenue and legisla-
tion are the focus of AKC's chal-
lenges.? The AKC's assets are many--
Delegates, dogs, clubs, dog events
and entries, 125 years of tradition,

etc.? Registration will provide the influential numbers necessary to continue the good work.? Proud of our past and actively involved, now is the time to be bold and face our challenges to establish a solid foundation for the next generation of dog fanciers to enjoy what we all have experienced and cherished.

James Stevens, Chief Financial Officer gave the Financial report.? For the first five months ending May 2009, total revenues were \$3.4 million (12% lower than 2008), total operating expenses were 3% lower than 2008, resulting in an operating profit of \$700,000 for five months.? In 2009, the improved performance of the stock market produced a year-to-date investment gain of \$1.8 million, representing an excellent turnaround from the 2008 investment loss of \$1.4 million.? Positive investment results led to a net surplus of \$2.4 million for the first five months of 2009, approximately \$500,000 higher than 2008.

The Executive Secretary read a Resolution passed by the Board of Directors, honoring Noreen Baxter, AKC Vice President Communications, who is to retire in June 2009, in gratitude for her twenty years of service to the AKC.

The Chair reviewed some benefits, considered by the Group Realignment Committee, which will result from realigning the groups.? They are to better group breeds similar in conformation or function; improve judges' education by building on these similarities; improve spectator understanding of dog shows; help

decrease the size of five groups affected by addition of new recognized breeds and increase participation through 12 additional group placement awards.? There are two types of costs associated with Group Realignment, the actual monetary expenditures for the program and the opportunity cost.? The actual expenditures related to Group Realignment, including printing and discarding obsolete publications, is estimated to be \$65,000.? The opportunity cost is the cost of time existing employees will spend working on this program that could be used on different income producing programs.? The time spent on Group Realignment will delay other programs that could produce more income; if the deferred programs were determined to be more critical they would require overtime or contract labor to meet all of the requirements.? The value of these hours is estimated to be \$150,000.?

The Executive Secretary read the proposed amendments to Chapter 3, Sections 1, 16, 18, 19, 20 and 21 of the Rules Applying to Dog Shows and Chapter 2 of the Rules Applying to Registration and Discipline, Registrable Breeds by Group, splitting the Sporting and Hound Groups, replacing the Non-Sporting Group with a Companion Group and the Northern Group, and change all references from seven groups to ten.? The amendment was submitted by the Board-appointed Group Realignment Committee and is recommended by the AKC Board of Directors, to be voted on at the September 2009 meeting.

Dr. Robert D. Smith, judge, Board and Group Realignment Committee member, spoke in favor of the proposed amendments, citing concerns about

several groups approaching nearly 40 breeds in the next five to seven years and the Committee's effort (working in conjunction with the affected Parent Clubs), to place breeds in groups of like individuals to make more logical sense.? In 1983, when the Working and Herding Groups were split, many herding breeds were not well represented in Working Group competition and were not in great numbers in entries at shows.? Since then, those numbers and entries have increased and breeds in both the Herding and Working Groups have thrived with those changes.? Similar results are expected from the changes proposed by the Group Realignment Committee.? Increased entries in the breeds affected, especially in groups reduced in size, will benefit AKC, individual clubs and all involved in the Fancy.? (Delegate Note: Even though Canaan Dogs are NOT affected by the proposed Group Realignment and remain in the Herding Group, Canaan Dog fanciers do you have any comments regarding the aforementioned statements?)?

The Executive Secretary read the proposed amendment to Chapter 3, Section 5 of the Rules Applying to Dog Shows--Dog Show Classifications to permit the further division of the 12-18 month class at the option of the individual club.? The amendment was submitted by the Delegate Dog Show Rules Committee and is recommended by the AKC Board of Directors, to be voted on at the September 2009 meeting.

The Executive Secretary read the proposed amendment to Chapter 8, Section 9 of the Field Trial Rules

and Standard Procedure for Retrievers--Eligibility of Dogs for Entry updating the wording to address all contagious and communicable diseases.? The amendment was approved by ballot by the 2008 Retriever Advisory Committee and recommended by the AKC Board of Directors, to be voted on at the September 2009 meeting.

The Chair read a statement about Delegate eligibility and procedures to fill vacancies on Delegate Committees at the September election.? The Executive Secretary read the list of vacancies for the Delegate Committees to be filled in September 2009.

John Lyons, Chief Operating Officer, announced several awards and presented information on AKC's registration initiatives.? The second quarter 2009 AKC Community Achievement Awards honorees are Bakersfield Obedience Training Club, Lori Finlayson of the Mid-Continent Kennel Club of Tulsa (Karen Gibson, Delegate) and Penn Ridge Kennel Club (Marieann Gladstone, Delegate).? These awards are given to clubs, AKC federations and their members who have made outstanding contributions to public education or canine legislation activities.? The honorees receive an AKC Certificate of Recognition and AKC donates \$1,000.00 to each honoree's club or federation.? Details about the honorees' accomplishments are published in the AKC Gazette and featured on the AKC web site.? The AKC Humane Fund's first Breed Rescue Grant, in the amount of \$1,000.00, was presented to the Silky Terrier Rescue Charitable Trust, a 501(c)3 organization supported by the Silky Terrier Club of

America.? AKC Companion Animal Recovery (CAR), which supports and recognizes outstanding disaster relief and preparedness efforts conducted by AKC-affiliated clubs and their members, announced the creation of the Diane Albers Memorial Disaster Relief Award, to be known as the "Albers Award", as a tribute to Diane Albers' trailblazing in the arena of disaster preparedness and relief.? Diane Albers, who passed away in December 2008, was the Delegate for the Central Florida Kennel Club and President of the Florida Association of Kennel Clubs.? The Albers Award will be granted to either an AKC club or an individual member of an AKC club.? Honorees will receive a plaque and their club will receive from \$1,000.00 to \$5,000.00 to further volunteerism associated with disaster preparedness and/or relief efforts within the community.? Nominations will be accepted throughout the calendar year and awards may be granted once every quarter.? The inaugural winners for this quarter are Deb Hoff (Secretary, Fargo-Moorhead Kennel Club) and the Fargo-Moorhead Kennel Club, for extraordinary service during the recent floods in Fargo, North Dakota.? The Fargo-Moorhead Kennel Club was sent a \$5,000.00 check to continue their good works in the area.? One of the steps to stop the decline in registration numbers is a registration initiative introduced in both the All Breed and Parent Club Committees.? To restore the AKC registry, one area of opportunity concerns the return of AKC litter "blue slips".? The present average return rate is only 44% for all litters.? Dogs are lost from our registry, households from participation in the AKC community, translating into lost revenue, lost resources for clubs and diminished influence in canine legislation and

health research.? What can we do to help solve the problem of decreasing registration numbers?? As a start, all AKC Member Clubs are being asked to make a commitment, starting at the club level and following through to the entire membership.? This "Call to Action" is a pledge that as a club you believe it important for your members to do whatever is necessary to guarantee their puppies become AKC registered.? Either the breeder can register the puppies themselves before they are placed or provide the new owner with the blue slip and be certain to follow up with the owner to complete the Full or Limited Registration process.? The objective is for the breeder to take ultimate responsibility for the successful registration of their puppies.? The goals of this program are to raise awareness of the problem of blue slip return and to involve AKC's core constituency, dedicated breeders, in the solution by asking them to ensure completion of the registration process.? This pilot program is for AKC Member Clubs only.? Based on the participation and response to this pilot program, it may be extended to all licensed clubs and then throughout the Fancy to those who are active but do not necessarily belong to a club.

Patty Van Sicklen, AKC Staff, introduced the AKC Registration Pledge Challenge, a pilot program for AKC Member Clubs to issue a call to action to their club membership.? The following pledge that every member of every AKC Member Club is being asked to take is simple, direct and achievable:?"AS A RESPONSIBLE OWNER OF PUREBRED DOGS, I PLEDGE;? I WILL ENCOURAGE, ASSIST AND FOLLOW UP WITH MY PUPPY BUYERS TO ENSURE THAT 100% OF THE PUPPIES

I PRODUCE ARE AKC REGISTERED."? Since dog fanciers love competition, there is a contest! AKC Member Club Presidents, Vice Presidents, Corresponding Secretaries and Delegates will be sent communication by email with a web link to go online and accept the Registration Pledge Challenge on behalf of the Member Club.? As part of the club opt-in process, available through July 31, 2009, the number of individual (not household) members of the club must be provided.? Once the club is signed up, the next step is to encourage every club member to individually accept the Pledge.? The online Pledge will be available August 1, 2009 and individual members have until November 30, 2009 to take the Pledge.? (Delegate Note:? To assist in communicating the call to action, the attachments include the AKC Registration Pledge Challenge Contest Terms, Flyer and Newsletter inserts to be used to promote the Registration Pledge Challenge via existing club communication channels.) ? In Round One, Member Clubs with the highest PERCENTAGE of members who sign the Pledge will be honored and presented certificates at the December 2009 Delegates meeting.? In Round Two, Member Clubs with the highest PERCENTAGE of dog registrations, either full or limited, from among litters born June 1, 2009 through December 31, 2009 (registrations must be completed by April 30, 2010), will be honored at the June 2010 Delegates meeting.? Winning clubs will receive \$1,000.00 and reserve winning clubs will receive \$250.00.? There will be four competition categories for AKC Member Clubs.?
