










## CANAAN DOG RESCUE NETWORK (CDRN) NEEDS YOU NOW!

The Canaan Dog Rescue Network (CDRN) has been going strong since its incorporation as a non-profit in 2003, but we are now in desperate need of volunteers for officer and director positions.

CDRN is currently run by a three person Board of Directors, who oversees a staff of four officers, consisting of a President, Vice-President, Treasurer, and Secretary. There are also regional volunteers, who serve as rescue coordinators and foster families.

Since our inception, we have helped to foster and re-home Canaan Dogs, conduct fundraising and even educate the public on the importance of responsible dog ownership. This would not have been possible without our dedicated volunteers.

As we end 2011 and look forward to the future, we are hopeful this will be a successful year of transition and change for CDRN. Under our by-laws, our Directors serve five-year terms, the maximum allowed by Tennessee, where we are incorporated. I will be coming to the end of my five-year term as president and will be

resigning my positions as president and as one of the three directors; however, I plan to serve as a consultant until a successful transition has occurred. Therefore, we are looking to elect a new president and director as soon



as possible.

At this time we are calling out to the Canaan Dog community to see who might be

interested in volunteering their time to keep this organization running. We would like to see volunteers step into officer and other volunteer roles (such as regional rescue coordinators). # THE THREAT TO SHAAR HAGAI KENNELS OF ISRAEL ... AND HOW YOU CAN JOIN CD FANCIERS AROUND THE WORLD SPREAD THE WORD AND ADD YOUR SUPPORT.

The following was posted on the blog of Myrna Shiboleth on October 25, 2011 and is reprinted here with her permission. More information follows.

Shaar Hagai...

I have always tried to laugh at myself and at the vagaries of life that come my way. It is the way that I have managed to stay (reasonably) sane.

But there are times when there is simply nothing to laugh about.

The Israel Lands Authority, a government agency, has filed suit against us, to demand our eviction from the place we have called home for 42 years.

I came to Israel as a naïve American (and at least, in those days, there was nothing as naïve as a young American). A dog and animal lover from birth, I quickly met a few other unconventional people who were interested in finding a place to breed Canaan Dogs, the natural breed of Israel that still existed free living, but was already starting to disappear. We looked for an isolated place where the dogs would not be a nuisance to anyone, and found it at Shaar Hagai.

The buildings had been built by the British in the mandate period, for the engineers and workers that were running the adjoining water pumping station, the main water line to Jerusalem. When they left in 1947, the place was abandoned and remained empty, not used for anything other than as an occasional campground for passing Bedouins with their flocks.

When we found it, the buildings were semi ruins, and the whole place was so overgrown that it was hard to even find the buildings.

It was perfect for breeding dogs.

After much searching to try and find who was responsible for the place, we were informed that Mekorot, the national water company, had the rights to it, and we signed a rental contract with them and paid rent for a number of years.

We never had any money, so just about everything that had to be done, we did ourselves. I laid cement, plastered, painted, built fences, paved, dug out rocks, and a whole range of other activities that had never entered my mind as a future occupation when I was filling out college applications. But there is no feeling quite like being able to look at

something that you have built, with your own hands. We lived for 17 years without electricity (no, not with a generator, but no electricity – a kerosene run refrigerator, storm lanterns, and no telephone), but it was a great place for the dogs. Generations of Canaans, and of collies, my other breed, grew up here, and went on to become breed founders all over the world and valued companions and working dogs. There are footprints preserved in some of the patches of cement, where the dogs couldn't resist leaving their mark while it was still fresh.

Some years after we moved in, Mekorot decided that they wanted to end the contract – and then we discovered that they had no rights on the place at all. After being transferred

from one agency to another, in the end the place was the responsibility of the Israel Lands Authority. We contacted them many times to ask to clarify and legalize the situation, with no answer.

Meanwhile, we paid taxes and tried to behave like good citizens. An official road sign to "Shaar Hagai Kennels" was even placed on the highway just before our entrance.

Then, a few months ago, we got notification that the Lands Authority intended to file suit to evict us. Why now, after 42 years, when we were not significant

enough to notice? Who knows? But where we live is within the boundaries of a national park, and people are not allowed to live in a national park (not dogs either, apparently). It doesn't seem to matter that the area was declared a national park some years after we were already living here, and the buildings we live in were built, long before any ideas of parks, for the purpose of dwellings places for people...


I have never been very good at or interested in, politics, and the whole game of using influence. I have only been interested in quietly breeding good dogs and enjoying them. My daughter was born here and my grandchildren as well, and they can't imagine having to leave. I certainly can't.

The dogs tell me that they will follow me anywhere. But the possibilities are very limited – property is extremely costly here, and people are not very tolerant of barking dogs...

So we are doing all we can to fight. You can help by signing the petition (see the link), and spreading the word. If anyone knows some rock star that loves dogs...

Meanwhile the dogs help me to keep laughing.

#### THE THREAT TO SHAAR HAGAI, CON'T

The CDCA and the UKC's national CD club (the ICDCA) have written a joint letter (below) to the Israel Lands Authority urging them to continue/resume their negotiations with Mrs. Shiboleth.

To Whom It May Concern;

This letter is in support of Mrs. Shiboleth's efforts to keep her kennels at their current location. To evict Mrs. Shiboleth would be of great detriment to the Canaan Dog breed in the world.

As the Canaan Dog Club of America and the Israel Canaan Dog Club of America we represent the interests of the many Canaan Dog owners in North America.

Canaan Dogs are the National Dog of Israel and are native to the country. Preserving this breed and sharing it with the world have been the focus of Mrs. Shiboleth's efforts for over 40 years. Mrs. Shiboleth is following in the work of Drs. Menzel who were asked by the Haganah to develop a dog for guarding the isolated Israeli settlements and supervise the build-up of war dogs for the fighting of the War of Independence. They developed the Canaan Dog breed from a specific type of dogs living in Israel.

Canaan Dogs have since been exported to the United States and numerous other countries. Many people in North America first learn about the breed when they explore their Jewish heritage. Canaan Dogs are now known and recognized everywhere as the Israeli breed and they have acquired a strong and passionate number of friends in the world of dog lovers.

There are many Canaan Dogs in the world that have some ancestor hailing from Shaar Hagai. Numerous breeders have acquired dogs from Mrs. Shiboleth or are planning to do so. In addition, Mrs. Shiboleth's prestige in the international dog community is such that much tourism occurs from people coming to visit Mrs. Shiboleth and her Shaar Hagai kennels.

Very important for the future of the Canaan Dog is the ongoing work of Mrs. Shiboleth to augment the small gene pool of the breed by acquiring good specimens from the Bedouins. For the last couple of decades she has been the only one in the world with the know-how and the facilities to introduce these new dog lines to the breed.

We urge you to work with Mrs. Shiboleth to preserve the home of Shaar Hagai kennels in their current location so that she may continue her work in support of the breed and of the reputation of Israel in the world of dog lovers.

By now, we hope that you have seen AKC's recent messages regarding the importance of registration. If you have not, here they are in a nutshell: Every registration makes a difference to everyone involved in the world of purebred dogs. Registrations help AKC maintain a strong legislative influence, fund canine health research, provide for disaster preparedness and relief, and promote responsible doe ownership. The best way to ensure that our traditions remain strong is for breeders like you to ensure that every puppy you produce is AKC registered.

For a long time, conventional thinking among breeders has been that AKC registration was only required if a puppy they bred was going to compete in the field or the show ring. However, breeders are realizing that registrations are the foundation for our sports and support AKC's good works. "I used to think that the only

time I needed to make sure a puppy I sold was registered was if it was going to a show home." said Mary Ellen Fishler. Delegate of the Poodle Club of America. "But recently I learned why every dop needs to be registered. From contributing to canine health research to supporting our efforts against radical legislation, funding provided by AKC registrations makes a difference...for all of us and our dogs. I love our sport and want to ensure a strong future for it. The easiest way for me to do that is through AKC registrations,"

Lastly, the Full Litter Offspring PLUS form allows breeders to register all the puppies in a litter after it's been registered, each either in the name of the breeder or of the new puppy buyers. For either of the last two options, if a puppy is not named at time of registration, AKC will later contact the new puppy buyers to get the name of their puppy. #### **Breed Standard Revisions**

The recent CDCA membership vote to approve the breed standard revisions brings cause for celebration to the Ha'Aretz camp. Several descriptions are now closer in meaning to those given by the Menzels in their original standard published in PARIAHUNDE. The subsections of general appearance, size and proportion, gait, coat and tail are addressed and more clearly and accurately defined. The Land of Canaan is named as the place where Canaan dogs originated as wild or semi-wild pariah dogs. Proportion is returned to square; size preference is retained; and the disqualification for size is dropped. All this work brings the revised standard closer to the Menzels' standard, and to the standards of the rest of the world.

## JUNIORS WITH CANAAN DOGS

Yes! They do exist! Although sometimes thought of as a mythical creature, there are Juniors out there with Canaan Dogs. Our low numbers as a breed and less than a handful of Juniors showing them make a sighting a rare occurrence. Many Junior Showmanship Judges may go their entire career without judging a Junior/Canaan Dog team. But for those rare mythical occasions when one does land in your ring, there are a few points to pay special note. The points you should see with a Junior and a Canaan Dog include proper gaiting speed, proper presentation and consideration for Canaan Dog temperament.

One of the pinnacles of Canaan Dog breed type is their effortless, endurance trot. The Junior handler needs to be very conscious of the proper gait and speed for correct Canaan Dog movement. The Canaan Dog trot is quick, effortless and covers more ground than expected. Don't be afraid to line the Canaan Dog and Junior up with your faster moving breeds. You should see a loose leash and a nice tandem of handler and exhibit.

Proper presentation of the Canaan Dog should include the tail over the back. The traditional presentation is with the handler holding the tail curled over the back. Many Canaan Dogs can be enticed to curl their tail over their back. For these Canaan Dogs a more traditional Herding Breed presentation of the handler standing in front of the exhibit is acceptable. In either case, an alert, noble Canaan Dog should be the picture that you view.

The Canaan Dog is an aloof Herding breed, thus care needs to be given in the Junior Showmanship Ring. The Canaan Dog/Junior team needs to be approached with confidence. Please do not approach from a direction that the Canaan Dog cannot see you coming. Do not swoop down on the exhibit or move swiftly. Once the initial approach is complete, and you and the exhibit are comfortable, a smooth and firm examination should be conducted. Canaan Dogs tend to try and watch the exam, do not take a turning of the head to watch as a sign of aggression. As long as the handler is in control, as with any breed, your exam should be completed with ease.

A Junior and Canaan Dog team is more than an entry in your ring. There is a special bond that exists between the two. A Junior with a Canaan Dog is with that Canaan Dog because they love the breed. They enjoy the challenge of showing a breed that is not a push-button breed or very flashy in the JS

ring. There is a tremendous amount of work that goes into making a well oiled Canaan Dog/Junior Team. Some of you will be lucky enough to have that mythical creature land in your ring someday. If you are one of the lucky ones, take note, enjoy the experience and reward it if it's worthy on the day.

## **AGILE CANAANS**

Minnie and Orela will be competing in agility at the AKC/EUKANUBA INVITATIONAL 12/16-18/2011 in Orlando, FL. Minnie, as she has done for the past 5 Invitational's will be at the Canaan Dog meet the breed booth on Friday afternoon ready to meet you!

Now getting serious about positive training: I tell my clients that the only time they should reprimand their dogs for

"bad" behavior is when they catch them in the act. And even under these circumstances, punishment should be restricted to a firm "NO."



A friend de-

scribed an event he witnessed a few months ago which is a great example of how not to treat your dog. Somehow a dog got off its lead when walking with a child and came bounding across the play yard, his body language just screaming, "WoooHOOO! Lets run lets run! Yippee! Hey ... look, there's my Mom," at which point he ran over to a woman who was calling to him from a bench.

Now when your dog is running loose, what do you want him to do? Come when called, right? But instead of praising her dog for coming, the woman pinned him to the ground and yelled at him.

My friend was sure the woman thought she was reprimanding the dog for running away in the first place, but the dog will remember the punishment as what will happen when you "come" after running loose. Good luck getting him back next time.

The RECALL is the one command that could save your dog's life. The reaction to the recall should be immediate and quick. NEVER call a dog, especially a Canaan Dog, for discipline or to do something unpleasant. Canaan Dogs are one of the most intelligent breeds and they will never forget negative training.

For training the recall I start with 2 exercises:

- 1. Call the dog in for dinner: Prepare the dog's dinner. Call her, using the recall cue (come or here, etc.) word to eat. I do this whether my dog is outside or sitting right in front of me. It helps the dog to associate the cue with dinner/positive experience.
- 2. Use the recall word when the dog is approaching you on his own. Reward the dog for taking the initiative and pair it with the recall word.

Once your dog understands and relates to the recall word, still in a safe environment, I gradually increase the distance. To stimulate a faster recall I throw a toy behind me, just as she gets to me or I run away just before she reaches me, rewarding "on the run." **Always reward!!** 

The next step is to take your dog out in public starting in a relatively distraction free environment. With your dog on a long line, allow the dog to become distracted. You can do this by ignoring her and allowing the dog to sniff or investigate something.

Now call her name and recall word then take a step backwards; if she turns and looks and even takes one step towards you praise her, continuing to back up and treat when she reaches you. **Gradually increase the distance and the distraction factor.** Never repeat a command. If she ignores you, shorten the distance and/or less distraction and if needed go back to the 2 starting exercises. Reward each success; this will keep your Canaan Dog motivated! **Always reward!!** 

People have told me that their Canaan Dog is not motivated by treats. Actually all dogs must eat, just some require better or more
