

We have the potential for 5 sets of majors in each sex as we are offering the Major Reserve option at the National. If we have twelve or more dogs/bitches entered in the classes at the National, Reserve Winners for the sex with that entry will receive a three point major. (Winners in that sex will earn a five point major.) A relatively recent AKC rule change allows for this option at our National, but we need the entry (twice the number in a sex needed for a five point major) for it to be awarded. Please keep this in mind when placing your entries for the National weekend. (This option is only available at the Friday show.)

The Annual Meetings for the club are as important or more than the National Specialty. This is your chance to bring your concerns, ideas or volunteerism to the attention of your fellow club members.

REMEMBERING

More on Bert—Bertha Sheaffer ... the original copy this appreciation and remembrance of Bert is floating around in cyberspace and was never received by the editor. My thanks to Donna & Bryna for their understanding and follow-through to make sure I received it for this issue. - AMP

Bertha Sheaffer may now have left us in body, but her spirit lives on in many of us who had business with her through our early years in Canaan Dogs, and that spirit lives on in her legacy of love for the breed and the knowledge which she willingly forwarded to those of us who were also interested in breeding and promotion. I hold five letters from her that were her response to my questions, from those dated Nov 16, 1971 as I began my search for a Canaan Dog through April 25, 1975 as I began to breed and needed additional advice. Even as problems surfaced, "Bert" was loyal to Dr. Menzel's contribution to the breeding she established on this continent.

In those five letters she was open and candid about problems she saw developing as breeding progressed but always had suggestions to avoid furthering the problems in our breeding programs. I am the first to admit that I did disregard some of her advice



and did suffer as a result. Her recommendations came from the dimension of perfection in which she lived as a breeder of Dalmations and as wife of AKC judge, Jay Shaeffer, who served as early guardian of the CCA Studbook.

In addition to her loyalty to the breed which she observed through our struggles with problems throughout the development of the breed including health problems, club efforts with changes in the breed standards and our long suffering attempts for AKC recognition, she was always ready with a compliment for a job well done.

She acknowledged our personal problems and sorrows, be it a breeding gone bad or the death of a loved one. My last communication from her was an expression of her sympathy at the loss of my husband.

I will open her letters to any breeder wishing to see her communications to me. Therein you may see her vision for the breed which the Sheaffers supported under the name of Spatterdash Canaan Dogs.


REMEMBERING

CANAAN DOG CLUB OF AMERICA ANNOUNCES "JUMP START" DONATION TO STUDY OF BREED POPULATION GENETICS ANALYSIS

Donation Will Help Canaan Dogs Today And In The Future

March 16, 2014—

The Canaan Dog Club of America, Inc. is pleased to announce a major donation to the Institute of Canine Biology for their Canaan Dog Population Genetics Analysis Project. We hope this large donation will help "jump start" this project and inspire other Canaan Dog clubs and fanciers to contribute as well. In addition, the club is helping researcher Carol Beuchat, PhD, collect and prepare pedigree information for this project.

The Canaan Dog is an ancient landrace breed of dog native of the desert and wilderness of what is now Israel. The original breeding stock of the domesticated population was collected from the wild and from the nomadic Bedouin, and over the years additional dogs have been added to expand the gene pool. However, as the Bedouin culture declines, the native dogs are becoming scarce, and eventually the ability to obtain additional dogs will end.

The purpose of the Canaan Dog Population Genetics Analysis project is to assess the current genetic status of the breed, and to provide information to breeders that will help them maintain genetic diversity into the future.

Canaan Dog breeders, owners, friends and clubs around the world are encouraged to support this project, which will benefit the global population of the breed. Pedigrees of Canaan Dogs from around the world are essential to this project, and the Canaan Dog Club of America, Inc. is organizing the collection of a comprehensive global pedigree database. If you can provide pedigree information, either of individual dogs or as a database, it can be submitted by

email to pedigree@cdca.org (or cdpga4all@gmail.com). The data should be submitted as a spreadsheet (e.g., Excel) containing the registered name of the dog, names of the sire and dam, birth date, sex, and registration numbers and registration body (e.g., AKC, IKC, etc). However, information is still welcome even without all the details. If you need technical assistance preparing your data, please send a request to pedigree@cdca.org.

The Institute of Canine Biology (ICB; www.InstituteofCanineBiology.org) is an independent, global consortium of canine biologists and geneticists that provides research, expertise, education, and information about dogs and especially genetics, to breeders, researchers, and the public. Led by Scientific Director Carol Beuchat PhD, who has complied similar population analysis for other breeds, the Institute adds the Canaan Dog to a list of ongoing projects about other breeds including the Mongol Bankhar, Norwegian Lundehund, and Poodle.

The Canaan Dog Club of America, Inc. (CDCA) was formed in 1965 with the arrival of four Canaan Dogs to the United States. As the AKC Parent Club, the CDCA offers education and events for Canaan Dogs and other breeds, and promotes the breeding and preservation of these desert survivors.

The Canaan Dog Club of America, Inc. is excited to support the Institute's study of Canaan Dog Population Genetics, which will help the breed now and in the future. Carol Beuchat is a vertebrate biologist with broad expertise and research experience that encompasses physiology, ecology, behavior, and evolution of every vertebrate group except fishes (mammals, birds, reptiles, and amphibians). She has over 30 years of experience working in both the field and the laboratory, asking questions about the interactions of animals with their environment and the mechanisms they use to cope with particular physiological challenges. Her background in comparative biology and an interest in the biology of dogs motivated the for-



mation of the Institute of Canine Biology as a means of bringing scientists studying various aspects of canine biology together with the dog breeders and owners who have vast collective experience and knowledge of dogs. The increasing number of genetic disorders in dogs are a huge concern for breeders, who lack the tools and resources to address these problems. At the same time, there is a revolution in genetic research fueled by the discovery of the dog as a model animal in which to study genetic disease in

humans. The possibilities for fruitful interaction between the scientists and the dog breeders and owners are potentially endless.

Carol holds an appointment as Visiting Scholar in the Division of Genetics, Genomics, and Development, Dept. of Molecular & Cell Biology at University of California at Berkeley. She is a member of the Species Survival Commission of the Conservation Breeding Specialist Group (CBSG) at the International Union for Conservation of Nature (<u>IUCN</u>). She has an English Springer Spaniel from Finland named Finn.

How long, how much?: Courses are 8 weeks and normally \$95 BUT CANAAN DOG PEOPLE ARE INVITED TO TAKE THE CLASS AT NO CHARGE due to our breed participation in the Pedigree Project.

How hard?: You to work at your own pace. "Basic" courses start with the basics. We know you want to be a breeder, not a scientist.


How much time will it take?: Generally there will be 1-3 hours of reading and homework exercises each week. Some people will do more, some will do less.

How will we meet?: We will have a private Facebook Group where we can discuss and ask questions, each at your own convenience.

Is there a textbook?: Students are *strongly* advised to purchase a copy of *Introduction to Veterinary Genetics* (1995, by Nicholas). If you can find it, another great book is the larger version of this book, *Veterinary Genetics*, but it's out of print; I got my used copy for about \$12.00 (!!!), but you might have to dig around to find that kind of price. Otherwise, it's about \$100, but I would say it's a great value even for that. (Also see the recommended books list on the ICB website.)

Are there breed-specific courses?: The Basic course is for all breeds. Once you have taken that course, we can arrange a breed-specific course module - usually 2-3 weeks and with an enrollment of at least 5 students.

Why You Need Population Genetics: The "Elevator Pitch" by Carol Beuchat, PhD

- 1) All the useful genetic variation your breed will ever have was in the dogs that founded the breed. This genetic diversity is finite.
- 2) Each generation, alleles can be lost by chance (this is called "genetic drift") and also through artificial selection by breeders, who select for dogs with the traits they like and remove other dogs from the breeding population.
- 3) Because the stud book is closed, genes that are lost cannot be replaced.
- 4) So, from the moment a breed is founded and the stud book is closed, loss of genetic diversity over time is inevitable and relentless.
- 5) You cannot remove just a single gene from a population. You must remove an entire dog and all the genes it has.
- 6) You cannot select for or against a single gene, because genes tend to move in groups with other genes (this is called "linkage"). If you select for (or against) one, you select for (or against) them all.
- 7) Breeding for homozygosity of some traits breeds for homozygosity of all traits. Homozygosity is the kiss of death to the immune system. And by the way, as genetic variability decreases, so does the ability of the breeder to improve a breed through selection, because selection requires variability.
- 8) The consequences of inbreeding (in all animals) are insidious but obvious if you look decreased fertility, difficulty whelping, smaller litters, higher puppy mortality, puppies that don't thrive, shorter lifespan, etc. Genetically healthy dogs should get pregnant if mated. They should have large litters of robust puppies, with low pup mortality. Animals that cannot produce viable offspring are removed by natural selection.
- 9) Mutations of dominant genes are removed from the population if they reduce fitness. Mutations of recessive alleles have no effect unless they are homozygous. So rare alleles are not removed, they are inherited from one generation to the next, and every animal has them. Lots of 'em.
- 10) If you create a bunch of puppies from your favorite sire, you are making dozens of copies of all of the bad alleles in that dog (which were never a problem before because they were recessive; see 9) and spewing them out into the population. Now, a (previously) rare mutation will become common, its frequency in the population increases, and the chances go up that some puppy will be produced that is homozygous (has two copies of that bad allele) and homozygous recessive alleles are no longer silent.
- 11) So, genetic disorders caused by recessive alleles don't "suddenly appear" in a breed. The defective gene was probably there all along. Make a zillion copies, and suddenly you have a disease.

- 12) Using DNA testing to try to remove disease genes from the breed will not make dogs healthier (see 2, 5, and 6).
- 13) The breed will continue to lose genes every generation (by chance or selection) until the gene pool no longer has the genes necessary to build a healthy dog.
- 14) At this point, the breed might look wonderful (because of selection for type), but it will suffer from the ill effects of genetic impoverishment inbreeding depression, diseases caused by recessive alleles, increased risk for cancer, etc.
- 15) The health of individual dogs cannot be improved without improving the genetic health of the breed. The only way to improve the genetic health of the breed is to manage the health of the breed's gene pool.
- 16) Population genetics provides tools for the genetic management of breeds or other groups of animals. Breeders CAN improve the health of the dogs they breed if they understand and use them.

Editor's Note: The original breeding stock of the domesticated population of Canaan Dos was collected from the wild and from the nomadic Bedouin, and over the years additional dogs have been added to expand the gene pool. However, as the Bedouin culture declines, the native dogs are becoming scarce, and eventually the ability to obtain additional dogs will end. For these reasons, Canaan Dogs offer a unique opportunity for this Breed Population Genetics Analysis Project—in some ways, we do not yet have a closed stud book. The Board of the CDCA knows that breeders will not—nor should they—make all breeding decisions based on Dr Beuchat's work, just as breeders should not make a breeding decision on one single piece of data. We do believe that this project will have a positive impact on the breed now and into the future.



A Political Action Committee (PAC) is a private organization that collects funds from its members and makes political contributions to those in office or those running for office. The funds from a PAC can only be used as campaign donations. The AKC PAC is set up to help elect dog-friendly candidates.

The AKC PAC can help elect officials who support the position of the fancy on animal legislation; this in turn leads to protection of your rights as a breeder, dog owner, and show person. It is crucial that we have individuals in office who are open to our views on legislation and are willing to support our position on any canine legislation that is proposed. By donating to those officials or candidates who support our views, we are showing that we have faith in them and support them in office.

Any member of an AKC-affiliated club may contribute to the AKC PAC; however such donations are not tax deductible.

AKC-affiliated clubs cannot donate to the AKC PAC, but clubs may hold fund-raisers among members for the PAC and may solicit or provide other opportunities for their members to make contributions to the AKC PAC. The funds, however, must come from the members and not the club.

As we look across the country during this legislative season, we are seeing more and more antibreeder, anti-owner, and anti-dog legislation being
introduced. Many of those proposing this type of
legislation are backed by animal rights groups such
as HSUS which have put hundreds of thousands of
dollars into donations to candidates and officials that
will back their views on animal legislation. We have
been slow in realizing that it is time for those in the
fancy, and those who love dogs, to step up and
support our own candidates who take a stand in favor
of dog owners. That is where the AKC PAC comes
in. We now have a means for making donations to
"our" candidates.

Those who give to the AKC PAC can also help determine who receives funds from the AKC PAC by recommending officials or candidates (who have either promoted dog-friendly legislation or opposed anti-dog legislation) to the AKC PAC Board through the AKC Government Relations Department. The AKC PAC Board will work with you to arrange a presentation of those funds in a face-to-face meeting with the official or candidate.

It takes money to run for office and our donations are critical to electing dog friendly legislators.

At this time we don't have the hundreds of thousands of dollars that HSUS has to put into a campaign, but we could. If each Delegate and each member of an AKC Member Club or Licensed Club gives to the AKC PAC, we would have the money to support dog-friendly legislators or candidates. If 20,000 members each gave \$25.00 to \$30.00 a year (the approximate cost of one entry at a show), the AKC PAC would have \$500,000.00 to \$600,000.00 to make those crucial donations to those in office or candidates for office.

The goal of the AKC PAC is to have the funds available to help elect dog-friendly officials on a state and national level. As a Delegate, you are in a position to make this goal a reality both by giving personally and, more importantly, by educating the members of your Club on the AKC PAC and why it is important to support the PAC with your donations.

I challenge each of you to personally raise a minimum of \$25,00 from each of 10 members of your Club during the remainder of 2009. These donations can be done two ways: one is to fill out and mail in a donation card; the other is to go to AKC.org, click on Government Relations and then click on "Help Support AKC's Legislative Fight" to make an online donation.

As we look forward to the grand celebration, in December, of the 125th anniversary of AKC and the Sport of Dogs, please remember we must elect officials who are dog-friendly if we are to continue this wonderful sport! You have it in your power to help the AKC PAC help to elect those officials.


