PRESIDENT & EDITOR'S MESSAGE

As I write this, summer is heading into a last hurrah. Kids will start back to school soon (the Northeast starts later than other parts of the country), a couple of trees have dropped a leaf or two as a warm up to leaf peeping and my Canaan Dogs are FINALLY no longer shedding in tufts but are starting to prepare for winter coats. It is the little things that get me excited!

The CDCA and the Canaan Dog community are getting excited about changes coming as well. We are well on our way to having not one but TWO AKC licensed Breeder-Judges in the US. Previously, when we wanted the opinion in the ring of those who knew our breed inside and out we were limited to Sweepstakes entries where CD Breeders did the judging. Now, we can see a day soon where a win will come from someone who knows this breed in a way an outsider will never obtain. Bryna Comsky and Donna Dodson have devoted their lives to Canaan Dogs. Without them, this breed would not be where it is in this country. They have generously given their time to breeders, owners and judges. Both have judged Sweepstakes at CDCA National Sweepstakes to much acclaim. Watching them judge was a lesson in the breed as you watched where they put their hands during the exam, saw what they rewarded in the ring and read their comments afterwards.

Today, they are one step closer to being granted AKC judging privileges. AKC has a program where Parent Clubs may recommend individuals to be extended invitations to apply for judging approval. This program essentially "jump starts"

the application process. The CDCA had submitted Bryna and Donna's names to AKC under this program. We have just received notice that the AKC Judges Review Committee has extended them an invitation to apply for the breed. As I write this, both ladies are working on the final pieces of their applications to AKC. (Later in this issue in the minutes from the Board & Annual General Meetings you will see Board discussion of another AKC program to allow the club to obtain permission for an individual to be granted approval to judge a National or Regional on a one time only basis. We want to have Bryna and Donna judge during the 50th Anniversary of CDs in the US. Celebration. Should their judging applications still be in processes with AKC when we need to list our judges for the 2015 National and Regional, we will use this program, but are hopeful that the ladies will have completed their process with AKC well before that time.)

To show to a Breeder-Judge is the ultimate honor in dogs. I have class placements under Border Terrier Breeder-Judges that carry more weight than breed wins under an all-rounder. Under a Breeder-Judge, I know the breed specific strengths of my dog are being appreciated and rewarded. Under too many all-rounders, I do not get the feeling that they truly understand the nuances of the breed. Good all-rounders do their best, study a lot and always continue their knowledge, but they themselves will be the first to admit they do not and cannot know a breed as well as those who breed and live with the dogs.



Among his many accomplishments, Magnum has broken every breed record in history – the first Bronze and Silver Grand Championships; first to win three all-breed Best in Shows and a Reserve Best in Show, 29 Herding Group Firsts and over 170 Group placements. Best of Breed 2009 to 2013 at Eukanuba, and 2010 to 2014 at Westminster. Best of Breed at the CDCA National three years in a row. All this, and Mags is usually the only Canaan Dog at the shows he attends. Please join me in voting for Magnum as our 2013 DOTY.

Owners' statement by Richard Vulliet, DVM, and Pamela Rosman

We are thrilled that Magnum is nominated for the Dog of the Year Award. Magnum's breeder Donna Dodson, Pleasant Hill Kennels, first recognized his potential for the show ring and finished his AKC Championship title from the Puppy Class. Magnum is exhibited by Bruce and Tara Schultz ("Team Magnum"). Following in the tradition of Max, Tootsie, Emmitt, Harry, Paws, Breeze and others, he became very competitive in all-breed competition and placed in the Top 20 Herding Dogs. He is the first CD to earn a Silver Grand Championship, a Bronze Grand Championship, three Bests in Shows and a Reserve Best in Show. He won the CDCA National Specialty three times in a row. His most memorable achievement was at the Westminster Kennel Club (2013), where he earned a Herding Group placement. Magnum is the first CD to have been awarded a group placement at this prestigious event. In addition, to date, he has won thirty Group 1 placements.

What is most remarkable about Magnum is his personality. He is calm, unruffled and is the definition of "reactive-aloof" that characterizes our breed. If everything is normal, he is cool, laid back and sipping Perrier (actually, he doesn't like it-the bubbles tickle his nose). But let a UPS or Fed Ex truck get anywhere near his neighborhood and "World War III" breaks loose. For most judges and exhibitors, Magnum is the first CD that they have seen. Most are impressed with his stateliness and effortless motion, as reflected by his show performance. Magnum has set or broken every record that the AKC keeps for Canaan Dogs. He deserves your support.

I'd like to nominate Carrie Franz-Cabrera, whom I've known for years. She's worked tire-lessly in Canaan Dog rescue, a painful and largely thankless job – but she's been able to find homes for the bulk of the dogs that have come under her auspices and it seems, somehow, that the bulk of the rescues end up being in her territory. She's revised/re-written some fair number of the club publications. In addition, Carrie has helped to initiate and coordinate the CDCA-sanctioned herding instinct tests in Arizona. When there was news of a need for pet oxygen masks for fire departments, she established the first CDCA donation drive at the National Specialty in Longmont, Colorado, where enough money was raised to provide the Longmont Fire Department with two sets of pet oxygen masks, and thus provided the precedent for future National Specialty donations. Carrie has provided, quietly and largely in the background, support and encouragement to new Canaan Dog owners when they've had questions and problems. She's been a cheerful, dependable, and supportive competitor as we try to revive the Canaan Dog show population in the western part of the country. IMOP, she's contributed significantly to the Ca-

naan Dog community, both human and canine, and I'd love to see it recognized.



Due to miscommunication issues, there was no 2013 National herding test, much to the disappointment of many folk. However, between the time of the 2013 and 2014 National Specialities, one Canaan Dog, Jo-Clem Fire Defies The Sun ("Nolan"), owned by Julie and Dan Haddy, was CDCA herding certified by a licensed judge during a herding event in Perry, Georgia. In addition, Julie Haddy formatted the evaluation score sheet used for all CDCA sanctioned tests into a single page printable document, which is now located in the Herding Program section of the CDCA website.

Chris Miller graciously stepped up to oversee the 2014 National herding test when I was unable to attend. Additionally, Chris generously donated the prizes of a stuffed sheep toy and shepherd's crook, the latter being the traditional prize for Best Rookie, as well as the beautiful rosette ribbons for all who passed the test and for Best Rookie and Best Experienced. The test was held on Monday, June 23rd, at Elysian Farm, owned by Kim Torson-Schneider, in Pine City, Minnesota. The evaluator for the test was JoAnna Yund, a licensed AKC and American Herding Breed Association (AHBA) judge from Minneapolis. Seventeen Canaans were tested and 14 passed, which is an 82.4% pass rate. Six Canaans earned their HC title, an equal number of six Canaans qualified for the 2nd leg towards their HCX title, and two Canaans were awarded the HCX title, the top herding title offered by the club. From those dogs who passed the test, Ms. Yund chose UKC CH. Mazel Tov Matan ("Matan"), owned by Cathi and Craig Oskow, as Best Rookie and GCH. RivRoc Onto Somethin Bsnatch Rosndog, CDCA-HC ("Cayman"), owned by Chris and Ethan Miller, as Best Experienced.

Many thanks to all who braved the weather (and footing) to participate in this year's test. I especially want to thank Chris Miller for her time and effort in coordinating and running the test. Photos of the herding test can be found on the club's Facebook web page.

Congratulations to all who titled! Plans are underway for the next National herding test which will be held in November 2015 in Benson, Arizona.

2013 Awards Chair Report

The period of eligibility for the club's Top Performance awards is from January 1 through December 31 and qualifying scores may be submitted at

any time prior to the deadline of December 31st of that year. For 2013, there was a recipient in each of the categories of Agility, Obedience, Rally, and Novice Dog/Novice Handler. CH. Orela Me Shaar Hagai, RN, MX, MXB, MXJ, OF, CDCA-HC, owned by Julie and Dan Haddy, repeated her qualifying prowess in AKC agility and earned the Top Agility Canaan Dog award. Donna and Jackie Davison, with their dog, D&J Ha'Aretz Peaceful Flight, NAJ, earned the Top (Novice) Performance Handler/ Dog Team award with their qualifying scores in AKC agility; scores from any performance trial level event is eligible for this award as long as both owner and dog are first-time exhibitors in that sport. In the last 2 categories, mother and son were the recipients: Mother, CH. Madriver Samara Desert Star Dawn, CGC, BN, RAE, CDCA-HCX, VX, owned by Denise Gordon, Cynthia Grupp, and Pamela Rosman, was awarded Top Obedience Canaan Dog for earning qualifying scores in the Beginner Novice and Novice events, while son, Desert Star's Midnight Comet, CGC, BN, RE, CDCA-HCX, V, owned by Denise Gordon, earned the Top Rally Canaan Dog award.

There was only one recipient for a Register of Merit category award. Christina Miller was presented the award for the relatively new Grand Champion Register of Merit for CDCA DOTY, Aust. CH., AKC GCH. D&J Ha'Aretz Vertigo At RivRoc, CDCA-HC, ROM, GROM. To earn this top award a bitch must produce 3 and a dog sire 5 offspring who have attained the AKC Grand Champion title.

The Versatility program has been updated with Board approval and became effective as of January 1, 2014. It is hoped that this revision of the program will encourage more owners to train their Canaans for a multitude of events. As many know, Canaans are not limited to one job or capability.

The Board also approved a revision in the Dog of the Year nomination process. Previously the club member nominating the candidate was the sole author of the nomination, which consisted of a paragraph of 500 words. However, now the owner (s) of the candidate can share the authorship of the nomination with both parties each generating 250 words. For 2013 Dog of the Year, there was only one candidate, Silver GCH., CH. Pleasant Hill Magnum of Samara, CDCA-HC, nominated by Joan Capaiu-Greene and owners, Richard Vulliet and Pamela Rosman.

For Member of the Year, there were 2 sets of candidates, Carrie Franz-Cabrera and Christina and Ethan Miller, so per the rules, a ballot was sent out to the membership. The voting for these outstanding members was very hotly contested up until the day of the deadline and quite a few people told me that it was very difficult to choose between the nominees as they all deserved the award. The results were kept secret until the annual awards banquet on June 21, 2014 in North Branch, Minnesota, when Carrie Cabrera's name was announced. I will say that I wished we did award more than one MOTY because of the quality of our candidates.

Congratulations to all and I look forward to those who will be in the running for awards next year!

Desert Bred Canaan Dogs

During the 2014 CDCA Board Meeting, it was determined that a feasibility study should be performed regarding the creation of a U.S. domestic registry for desert bred Canaan Dogs and their offspring. This registry could be modeled after the one developed by the Society for the Perpetuation of Desert Bred Salukis. Such offspring determined to have a three generation purebred pedigree through this program could eventually enter the AKC Stud Book for our breed.

The study will develop and consider issues potentially impacting the feasibility of creating and maintaining such a registry. Its' findings will in turn be reported to the Board, which will then determine the appropriate course of action. These issues could include a probable five to ten year startup period before the first desert dogs registered might be considered for addition to the Stud Book

(dependent on AKC's procedures); fundraising needs; and a minimum ten year time commitment on the part of the registry's major active participants, in addition to others.

New Federal Regulations Protect Canine Health and Restrict the Age of Puppies Imported for Resale

Notes from our Legislative Committee: AKC has issued a press release to remind breeders that USDA is enforcing its new retail store regulations as written and has not yet clarified the definition of "breeding female" or to specifically exempt breeders with more than four breeding females who may sell occasional pets sight unseen. The clarification and exemption were directed by Congress in the 2013 farm bill and are expected within a year. However, breeders with more than four intact females and those who sell puppies sight unseen by the buyer should be aware that they may be required to have a USDA license.

The United States Department of Agriculture's Animal and Plant Health Inspection Service

(USDA APHIS) today released new regulations, effective November 17, that will restrict the importation of puppies younger than 6 months of age into the continental United States for the purpose of resale, research or veterinary treatment. The new regulations do not restrict individuals who wish to import dogs they intend to keep for personal use, such as a pet or as part of a breeding program.

The AKC is pleased about the finalization of these regulations, which implement an amendment to the 2008 Farm Bill (Pub. L. 110-246/7 U.S.C. 2148) supported and developed by the American Kennel Club and a number of other animal welfare groups. The rule addresses public health concerns about the large numbers of puppies that are imported with little oversight into the United States for the purpose of resale or adoption. The AKC supported and provided some remarks during the rule's public comment in September - October 2011.

The rule is designed to assure the health and welfare of dogs that are imported into the US from overseas. In many cases, these animals come from unknown origins (strays or street dogs) or unregulated high volume commercial breeders and may pose health and temperament risks to both the human and canine populations they come into contact with. The measure is expected to curtail the "dumping" of puppies from unknown origins or substandard breeding facilities on US markets, where in many cases they may be marketed as "rescues".

Strong enforcement of the Animal Welfare Act is supported by the American Kennel Club and other animal welfare organizations who rec-

ognize that that a large number of puppies are being bred overseas and imported into the United States in order to bypass the welfare regulations and standards required of U.S. breeders. In many cases, irresponsibly bred and undocumented foreign puppies end up at shelters, rescues or other informal or unregulated retail venues. Diseases borne by such animals can create public health risks for both animal and human populations.

What the Rule Does:

The new regulations allow for implementation of section 18 of the Animal Welfare Act (AWA), which "prohibits the importation of dogs into the United States for resale purposes, unless the Secretary determines that the dogs are in good health, have received all necessary vaccinations, and are at least 6 months of age."

The regulations provide guidance needed by US Customs to prevent the continued "dumping" of unregulated foreign puppies for resale onto US markets. The underlying law (7 U.S.C. 2133) defines resale to include "any transfer of ownership or control of an imported dog of less than 6 months to another person, for more than de minimis consideration."

The new rule further clarifies that USDA considers de minimis to have "the standard dictionary meaning, which, according to Merriam -Webster is, 'lacking significance or importance; so minor as to merit disregard.'" In most cases, adoption fees would not be considered de minimis; hence there is not a specific exemption for rescue dogs.

Similarly, the rule also clarifies that "consideration" means, "the inducement to a contract or other legal transaction; specifically: An Act or forbearance or the promise thereof done or given by one party in return for the act or promise of another.'"

The rule does not consider that dogs imported for training as working or service dogs to be imported for the purposes of resale. Therefore, the rule will not apply to the importation of those types of dogs. APHIS recognizes that not all dogs that are imported for training purposes ultimately achieve their final training goals, and some may be subsequently transferred. However, APHIS also warns that if puppies are imported for working, personal use or other exempted categories, and " it appears that a person is importing dogs for resale, research or veterinary treatment without meeting the requirements of the rule, [APHIS] may initiate an investigation and take appropriate action based on the results of that investigation "

The new regulations do not restrict individuals who wish to import dogs they intend to keep for personal use, such as a pet or as part of a breeding program. The U.S. Centers for Diseases Control (CDC) govern importation of dog imported into the U.S. Although the CDC does not require general health certificates for pet dogs, many airlines, transporters and states do will require this information. Pets are also subject to inspection upon entry and dogs that do not have rabies certificates may be required to complete a period of confinement, demonstrate proof of rabies immunization, or obtain a rabies vaccination prior to or upon arrival. For more information about im-

porting a pet visit the US Centers for Disease Control website.

AKC Government Relations will continue to provide information and guidance regarding the implementation and impacts of this new rule.

AKC Delegate Hired By APHIS and Seeks Comments From The Dog Fancy

"For those who have been following the APHIS issues:

I wanted to be sure that Delegates who were not at the meeting today and all club legislative liaisons received word of the announcement I made at today's meeting.

Small hobby and show breeders have all been concerned about the implications of the revision to the "Retail Pet Store Rule" by APHIS and the implication for that group. APHIS has heard your concerns. At last year's NAIA conference the APHIS Deputy Administrator met with about 20 of us after the session to discuss our concerns and issues. He committed to work with us to work to resolve these issues.

Two weeks ago, I was hired by Animal Care within APHIS as part of it central policy staff. My position, Canine Program Advisor, was advertised to bring in someone who would facilitate communication among APHIS, the breeder community, rescue groups and related animal interest groups. I will be providing APHIS staff with technical guidance on dog issues, assist in training their field staff, participate in developing program information material, conduct outreach and education and, most significantly, work on developing related policies and rules.

Both the amendment to the Animals Welfare Act

in the Farm Bill and Conference Committee Report provide an opportunity for APHIS to clarify the existing rules and provide for a more clear structure for exemptions from licensing. APHIS was asked to clarify the definition of "breeding female" and I will be working with other staff to do that. The changes to the law give the Secretary the authority to exempt from licensing those whose activities have a minimal impact on interstate commerce and the welfare of animals. Both the AKC GR staff and NAIA are aware that the additional authority granted by Congress was, in large part, directed at addressing concerns expressed by smaller breeders who were breeding to preserve bloodlines.

I have asked for feedback from the Delegates and all clubs regarding what fact-based standards would work for your breed in your real world activities. APHIS needs solid data, not conjecture, to bolster each type of exemption and the exemptions should be tailored, to the extent possible, to a range of situations, not just a particular breed. For example, what data are there to provide a basis for determining when the number of animals being bred is insufficient to maintain breed existence? For all of the concerns expressed during the process of adopting the new rule, real world, grounded examples are needed to support an suggestions made to provide for exemptions.

As I said at the Legislative Caucus, drafting rules to include one group of require licensing of another group are fairly easy. What is difficult is writing a rule that the bad actors can't wiggle around while still permitting those properly caring for their animals through. This all started because large breeding facilities that were previously excluded from the retail pet store definition because they sold wholesale, began selling dog of questionable health directly to purchasers through internet sales. That was the target of the rule revision. It is your mission (in your own self interest) to provide APHIS with the information that justifies including one group under licensing requirements, while

exempting another group. And it can't be "because we are the good guys." It has to be some fairly objective criterion or criteria that are unassailable. Because you know there are those out there who will claim that just because you breed, you are suspect.

Juian.D.Prager@aphis.usda.gov. I look forward to your assistance in developing clear rules and meaningful exemptions for activities which have a minimal effect on interstate commerce. If you have any comments, questions or suggestions, please let me know. This is a complex process and it will take time to address Congress' changes to the law and requests to the agency. In the meanwhile, the current rule is being enforced. Since discussions are just starting internally, I cannot tell you where this will wind up, but there is a way forward and I ask for your help in establishing a clear path ahead.

AKC EXPANDS THERAPY DOG TITLING PROGRAM

New York, NY - In an effort to honor the thousands of therapy dog teams that make a difference in the lives of others daily, the American Kennel Club® (AKC®) has added four new titles to the popular AKC Therapy DogTM program.

In addition to the AKC Therapy Dog (ThD) title (awarded after 50 visits), the AKC now offers:

AKC Therapy Dog Novice (ThDN) - Awarded after 10 visits . AKC Therapy Dog Advanced (ThDA) - Awarded after 100 visits . AKC Therapy Dog Excellent (ThDX) - Awarded after 200 visits . AKC Distinguished Therapy Dog (ThDD) - Awarded after 400 visits

"The AKC heard from many dog owners whose dogs had already earned the ThD title and who wanted additional formal recognition of their ongoing commitment to volunteering to help others. We're pleased to expand the AKC Therapy Dog program as a result of these requests," said Doug Ljungren, Vice President of AKC Sports and Events. "We've also added a way to acknowledge beginning therapy dogs, hoping that this will encourage even more dogs and owners to participate in therapy dog work."

Dogs who are registered and approved by recognized therapy dog organizations may

apply to earn the AKC Therapy Dog titles, which will be listed on the dog's AKC title record. Any dog, including mixed breeds, can earn AKC Therapy Dog titles as long as the dog is AKC-registered, listed with AKC Canine Partners or enrolled in the Purebred Alternative Listing (PAL) program. AKC does not train or certify therapy dogs.

Applications for the new titles will be accepted beginning June 1st, with titles awarded beginning July 1st.

CDC Rabies Vaccination for Imports

An alert for those who import puppies for their own use and those involved with rescue groups that import street dogs from foreign cities:

The US Centers for Disease Control has changed the rabies vaccination requirement for puppies and dogs imported from countries not considered rabies-free. The new rule tightens the requirements for vaccination and for confinement in case the vaccination requirement is waived. It goes into effect on August 11. There are two changes: one requires a current vaccination certificate for all dogs, not

just dogs over the age of three months; the other is intended to reduce the number of waivers from the vaccination requirement.

The rule changes mean that all dogs must be vaccinated at least 30 days prior to entry into the US, including puppies. Since puppies aren't vaccinated until three months of age, they will be four months old before shipping to the US unless the importer qualifies for a local confinement waiver.


At the Board Meeting this June, the Board agreed to accept Sheila's donation and pledged funds to cover final production of the story as a physical book.

NUMBERS, TEMPERAMENT AND TYPE AS SEEN IN AKC REGISTERED CANAAN DOGS—Round Table Discussion at the 2014 National Specialty

The following facts, comments, questions and conclusions are taken from the educational program that was held on June 18, 2014, during CDCA National Specialty Week near North Branch, Minnesota. A dozen CDCA members discussed these topics that are related to the future of Canaans in the US and abroad.

NUMBERS (with apologies to Norma)

The call for registered Canaan Dogs in the US and the rest of the world yielded only those that had been registered in the AKC Studbook from 2005 to 2013. We can only guess at numbers outside the US. The list below gives individual registration statistics for Canaan Dogs endeared into the AKC Studbook from 2005 to 2013, and also their rank among 171 recognized breeds. By contrast there are tens of thousands of Labrador Retrievers registered annually.

TEMPERAMENT

Temperament means the reaction of a creature to a threshold of sensation, and its capac-

ities to quickly absorb environmental stimuli and to deal with them. It also means the capability to adapt quickly to changeable situations. Besides this, a certain positive attitude toward life belongs to the lively, vivacious dog. (Pariah Dog translation, p. 32)

Most participants seemed satisfied with the present perception of positive progression of good temperament visible in the breed today. A common feeling prevailed that the breed's reputation concerning its temperament and behavior is acceptable, or becoming acceptable, to the fancy and the general public. Breeders, owners and exhibitors continue to champion dogs that show a 'positive attitude toward life' while keeping their desirable feral traits intact. What are the breed traits that are attractive to the public? And what are the extremes in Canaan Dog behavior that make it unattractive? Is it necessary to perpetuate these undesirable traits? Would it help or hurt the breed's reputation to de-emphasize extremes in behavior such as over-aggression and over-timidity, and to pursue a "lively, vivacious" personality that expresses joie de vivre instead? Can a "natural" dog with a feral background also show a happy countenance? What is your signature trait? What is your opinion?

TYPE

Are there two types, or styles, of Canaan Dog? Could one be referred to as Dingo-like, and the other Collie-like? Could they be called Type 2 and Type 3? How do the Menzels de-

scribe breed type? Is there a visible difference in breed type between American-bred and Israeli-bred Canaans? Would you agree with Rick Beauchamp's definition of the elements of breed type using character, profile, movement, head and expression, and coat to describe it? Is it in the breed's best interest to work toward a unification of breed type that avoids the quest for a generic show dog image? Should this ideal image uphold the Menzels' definition of their Type 3 pariah dog as ideal?

The presence of a 'certain positive attitude towards life' reflects a 'lively, vivacious' being, joy of movement, joyful sounds and a penetrating, inquisitive look that runs straight to the soul. Much as a tracking dog seeks an elusive glove, so does a Canaan dog look for a positive reputation in the fancy. I believe the security of its future existence rests on this reputation.

Notes of the Roundtable Discussion on Numbers, Temperament and Type in Canaan Dogs

On June 18, 2014, the Wednesday evening before the CDCA National Specialty, members engaged in a roundtable discussion on "Numbers, Temperament and Type" in Canaan Dogs. Fifteen minutes were allotted to each of the three topics, to get the discussion started, with the hope that follow-up discussions will continue on the e-Lists and other forums.

#1 NUMBERS

The first discussion topic was numbers. People tried to determine how many Canaan Dogs are living in the United States and in the entire

world. In the US and Canada, approximately 560 are registered. Some people think that 1000 or possibly 2000 Canaan Dogs may live in the US. Others think there may be 2000 or 2500 in the entire world. Lorna Hastings is gathering information about how many Canaan Dogs live in the rest of the world.

Bryna Comsky asked, "Is our breed registering enough numbers to sustain the breed, especially healthfully?" She said of the years 2005-2013, in the highest year, 2005, 75 Canaani were registered. Another year 50 were registered, another year, 30. In 2010, 43 were registered. By contrast, in the most numerically popular breed in the US, Labrador Retrievers, tens of thousands of dogs are registered annually.

Joan Capaiu Greene indicated that 2500 dogs are necessary to maintain good health in a breed, from a genetic point of view. Others felt that 1000-2500 are needed. Most of us are small breeders who can keep few puppies ourselves. It was suggested that we look for creative arrangements, such as co-owners willing to keep a dog intact for breeding and for the breeder to show if that owner is not interested. But many of us have tried such arrangements, and they do not always work out.

Some suggestions: Breeders should let other breeders and Canaan Dog folks know when new Canaan Dog puppies have moved into their area. The people close to where the new people live should invite them to dog shows, and invite their kids, too. Mentor and familiarize them.

#2 TEMPERAMENT

Members agreed that temperament is extremely important, and that there is a genetic component

to temperament thresholds, but environment plays a strong role, as well. Clarence Pfaffenberger's book The New Knowledge of Dog Behavior, first published in 1963, revolutionized the selection and rearing of puppies for guide dog training, and popularized puppy testing and handling methods that influenced many subsequent breeders. He said to evaluate puppies' basic temperament at 49 days, and then environment kicks in. Many dog people now believe that experiences to which you expose puppies younger than that will influence their personalities, so some Canaan Dog breeders are now enriching their litters' environments from an early age. Temperament tests are not perfect in predicting how a pup will turn out, and some Canaan Dog breeders put more stock in personal observation, but many use a combination of the two. Any information helps. But we also noted that puppies change as they mature, and the effects of experiences they have later may well change what was observed at seven or eight weeks.

One question was "Do extremes in Canaan Dog temperament detract from its appeal to the public?" One answer was it depends on which extreme. An extremely happy, gregarious Canaan Dog, for example, may appeal to a lot of people. If a dog goes to a different extreme, where he is dangerous in a home or in examination by a judge, that detracts immensely from the breed's appeal for those who experience such a temperament.

But the question arises even in some of these cases as to how much of the aggressive affect was nature and how much nurture? An example was given of a male puppy that seemed very sweet in the litter, and who went to a well-meaning family, but who had many disruptive experiences after leaving the breeder, some of them frightening, and some reinforcing behaviors that made him difficult in a family situation. This dog, though well-meaning, became a problem nipper in playing with children, not exhibiting proper bite inhibition,

and very aggressive with other dogs, due to fear from earlier encounters. Proper owners are crucial if we produce more puppies in this particular breed, and not everyone is a good candidate for our breed. But sometimes, even if we have properly vetted candidates, unforeseen factors occur in the puppy's subsequent life with them.

Another set of questions were: "Should the breed's current reputation for temperament and behavior remain as is? Describe the breed's current reputation. What breed trait or traits are attractive to the public? Which one, or ones, are not? What is your signature trait?"

Some descriptions of breed traits were: Intelligence, awareness of the world, pack mentality, and thriftiness. Without these characteristics, would it be a Canaan Dog? Chris Miller said that one attractive trait was the ability to recover after startling, etc., and cope. Another person said that some Canaan Dogs she has known are more of a handful than Akitas. An opinion was stated: "If you want to preserve the more feral qualities of Canaan Dogs and have them live in caves that is fine, but if we want them to be in pet homes and the show ring we need to continue to work on temperament." It is noted that many judges and other people who have observed Canaan Dogs over the decades they have resided in the United States have found progression to much more even temperaments than in the early years.

#3 TYPE

The first questions regarding Type were: "Are there two basic types of Canaan Dog? What are they? Could you refer to them as dingo-like and collie-like? Could you also call them Type 2 and Type 3?" The Menzels decided to breed the type of Middle Eastern Pariah Dog they studied which they designated "Type 3 – Collie Type." They pulled in some of "Type 2 – Dingo Type." There has appeared to be some difference in type between the dogs bred in the United States from the earliest specimens sent over by the Menzels, and

dogs that came from Israel in more recent years. Some people feel, as two examples, that earlier US dogs had a more elegant head, and the more recent imports have more coat. But different types are less evident in the United States than they were several years back, as more people have bred to the middle. It was suggested that if you remove the color in a photo and concentrate on the Canaan Dog's silhouette, you will see less difference than you might expect.

People agreed that character, profile, movement, head and expression, and coat are all key elements of type, as described by Rick Beauchamp's definition.

When asked what is the most important trait in the breed, various answers given were: "Moderation." "Head and expression. An elegant, noble head, collie-like." (Important to note: This refers to the old style of collie head, not the modern trend.) And: "Brain. The way they think. You will be outsmarted.... [This dog can figure out:] if you do 'A,' 'B,' then 'C,' then 'D' will happen."


that same screen.

Update: Fourth Show—Herding Group 4!

The FCI World Show at Helsinki, 2014

The Finnish Kennel Club celebrated its 125th year jubilee by hosting the FCI World Show at Helsinki on August 8-10, 2014. The whole city welcomed us to the show (Suomen Kenneliito), and our sightseeing group, designed by Freshpond Travel, stepped into three days of touring, educational seminars and single breed specialties in preparation for the main show. We walked and rode from flea market to department store (Stockmann's); manicured park to dinner aboard ship or at an authentic Finnish restaurant that served great tasting reindeer meat. The pre-show seminars were held at the hotel.

Among the stories told to us by our tour guide, always punctuated by his coda, "and so it goes," was his description of Jewish history in Finland during WWII. At the beginning of the war, when Finland was allied with Nazi Germany, the Nazis offered to help the Finns with their "Jewish problem." "Helping" meant transporting the entire Jewish population to concentration camps. When the Finns replied that there was no problem, they saved 2,000 lives. Nine Jews, who were not Finnish citizens, were transported to their deaths.

The press release issued on July 11, 2014, by the FKC, announced that the FCI World Dog Show, which would be held at the Messukeskus Expo and Convention Center, would be the biggest event held anywhere in the world in 2014. More than 21,200 dogs from 60 countries would be showcased, and the total entry would exceed 23,000, after all participating dogs, breeder categories and brace entries were counted. Finland account-

ed for the largest number entered, over 10,000, with Russia (4,000+) and Sweden (2,000) following suit. The Finish Lapphund attracted 500 entries alone, and more than 200 Lapponian Herders and 100+ Finnish Spitz, Finnish Hound and Karelian Bear Dogs competed.

In conjunction with this event twenty different countries sent some 100 competitors to the FCI Obedience World Championships. The Heelwork to Music and Freestyle World Championships were also arranged at Messukeskus with 50 competitors from nine countries vying for a title.

At its peak the FKC's entry system held up well under its load and processed nearly 600 dogs per hour; this in contrast to the Westminster Kennel Club whose entry limit of 2500 dogs was reached in one hour! Now that the classes are shown at the Piers, 3500 dogs may enter over two days, compete for BOB, and then return to the Garden for Group and BIS.

The FKC oversees a breeding program that aims to assure that dogs used for breeding are above the breed average in desired characteristics "in order to achieve genetic improvement and diversity." It supports programs that increase knowledge of the heredity, health and diseases of dogs, and cooperates with FKC veterinarians and researchers in this field. Veterinarians also claim to support the principles and objectives of the breeding strategy. The FKC influences the international community through the Nordic Kennel Union and the FCI with the goal of promoting greater knowledge of dog breeding. "Our actions within the international community always set

the health and wellbeing of dogs as the most important goals."

Concurrently with the show special programs were offered that presented the achievements, hopes and goals of the committees of working and service dogs and dogs for special needs. The processes of tracking injured game and removal of large predators from urban areas were described. This is a country with a long history of hunting. (Titi Broman, M.SC. Agric.) The breeders and owners of five native breeds spoke passionately about their dogs: the Finnish Hound, Leni Finmne; the Finnish Lapphund, Saara Sampakoski; the Finnish Spitz, Angela Cavil; the Karelian Bear Dog, Marko Laine; and the Lapponian Herder, Karin Sundstrom. The five breeds were shown in conformation, and the Finnish Hound won its Group. Enthusiasm, outright love, and pride in their animals shoe were native to Finland, were always evident. FCK takes promoting the health of their dogs through breeding very seriously. Finish dog registration guidelines impose requirements on breeding dogs that apply to all breeds. General breeding strategy for all breeds has been in effect since 2012. It provides detailed recommendations on how to select dogs for breeding in order to produce optimally healthy and good-tempered pups. Each breed also haS its own breeding program and can be included in the health program for canine genetic diseases and defects (PEVISA). This program requires breeding dogs to be examined for specific hereditary diseases, and can set a limit to the number of progeny per sire. The Kennel Club also maintains a public breeding database which offers access to all official dog health examinations. This system accumulates data on

60,000 - 80,000 health examination results per year. Its database also contains estimated breeding values (ETV) for hip and elbow dysplasia. (Katarina Maki, breeding expert PHD. The Finnish Kennel Club).

There are 10 Groups. On Friday, August 8, 2014, at the World Dog Show, Groups 2, 4, and 8 were shown. Pinscher and Schnauzer types make up Group 2; Dachshunds, Group 4; and Retrievers, Flushing Dogs and Water Dogs are in Group 8. On Saturday, Group 3, Terriers; Group 5, Spitz and Primitive types; Group 6, Scent hounds and related breeds; and Group 10, Sighthounds were shown. On Sunday, Group 1, Sheepdogs and Cattle dogs (except Swiss Cattle dogs); Group 7, Pointing Dogs; and Group 9, Companion and Toy dogs were in the rings. Canaans are in Group 5 in the FCI countries and Utility Group in the UK.

Evening Group judging on the way to Best in Show brought much fanfare. The practice of pre-judging assured movement at a fast clip through all ten regular groups and their varieties. Hans Letinen was the ultimate choice for Best in Show urge. HIs credentials reveal a life spent in the sport of dogs as a breeder of cocker spaniels and black schnauzers. Dogs carrying the kennel prefix "Rivale" influenced the breeding of Norwich terriers. Lehtinen was active in the Finnish Toy dog association and served on many committees in the FKC. He became the youngest person qualified to judge in Finland in 1953, and has judged all over the world as an all-rounder. The FKC honored him in front of the media on the morning of BIS judging. He responded by stating that he would judge the finale "his way," and this he did by giving BIS to the Af-

fenpinscher, a son of Banana Joe, had won at the Garden last year. Both sire and son were handled by Ernesto Lara. FCI President Rafael de Santiago gave the BIS trophies.

Canaans had a presence at the show in a field of 12 dogs. Israeli judge Mrs. Yolanda Nagler-Magal, originally from Romania, had the entry. Breeders and exhibitors from Finland, Germany, United Kingdom and Israel showed in the classes. Canaans need more numerical strength to qualify to compete for CACIB awards. Dogs from Shaar Hagai, Katafaronja, Nizzana, de Solomel, Samarodok, Bat Yerushalaim, Cherrysh, Lorianna, Kirifix, and Chancos competed. Miia Jormanainen won BOB, Breeders Class and Brace, and went to Group competition. Inna Blayvas was BOS with her Bat Yerushalaim Shel Zahav, now 8 years old, who has been to many World Shows. Most of the owners and six of the dogs were identified on the Facebook photo. More information is most likely still available on the FKC site.

Our Freshpond Tour Group split after the show, and only half of us took the train the next morning eastward, to St. Petersburg, Russia. We were all oh-so-impressed by the sight of the Hermitage Museum, castles and parks of Peter the Great and Catherine the Great, and their personal stories. The amber room by itself was unique. For me, the opportunity to see a performance of Swan Lake by the St. Petersburg ballet was far and away worth the trip. it was magnificent!
