#### **AKC & POLITICS**

Local, State and Federal Laws are more and more often focusing on issues that impact our ability to own dogs and breed them. For Canaan Dogs, this can be an issue that could impact the very survival of the breed.

Pamela Rosman, CDCA's AKC Delegate, submitted the following:

There was discussion at the most recent delegates' meeting about the work of this committee, and how to contribute to its support. The information below is quoted from AKC PAC flyers which may be seen at AKCPAC@akc.org or call 919-816-3720 for questions or assistance.

I. WHAT EXACTLY DOES THE AKC PAC DO? The AKC PAC makes financial contributions to the campaigns of legislators who share our commitment to the rights of responsible dog owners and the future of purebred dogs.

HOW DOES THE AKC PAC DECIDE WHICH CANDIDATES TO SUP-PORT? The AKC PAC is a non-partisan, single-issue PAC—we support

dog-friendly candidates as determined by the AKC PAC Board of Directors. The PAC contributes to the campaigns of federal and state candidates who are committed to upholding the rights of responsible dog owners, exhibitors, and breeders and who support legislation favorable to the health and safety of dogs.

HOW IS THE AKC PAC FUNDED? Your PAC is funded by your donations. Support comes from individual members of AKC clubs, individual members of AKC-affiliated federations, and AKC employees.

DOES THE AKC PAC HAVE A FACEBOOK PAGE THAT WE CAN SHARE? Laws that prevent the AKC PAC from asking the general public for donations also limit use of social media. However, here's a web link that can be shared with anyone because it asks for club affiliation info before opening the donation page: www.apps.akc.org//apps/pac/index.cfm.

CAN WE RECOMMEND A CANDIDATE FOR AN AKC PAC DONATION? Absolutely! Please tell us about officials who have assisted in promoting dog-friendly legislation and who have helped oppose or amend anti-dog measures. Please also sug
gest new candidates you believe will

gest new candidates you believe will support dogs and dogs owners.

#### Reminder: CDCA Policy - AKC Outstanding Sportsmanship Award

Per AKC "The AKC provides member club club's the ability to award AKC Outstanding Sportsmanship Awards on a yearly basis. This award honors those individuals who deserve special recognition that have made a difference in the sport of purebred dogs, embodied the AKC Code of Sportsmanship, and have been an active and valued mem-

ber of an AKC member club. Medallions are awarded solely at the club's discretion." Club's are under no obligation to present this award.

The CDCA Board of Directors feels that the AKC Outstanding Sportsmanship Award should not be an award given out "just because we can," but instead should only be awarded after a thoughtful and deliberative process.

CDCA Members are encouraged to suggest members who they feel should be so honored. The Board of Directors shall have final decision over which members are chosen to receive this award.

When a recipient has been selected, this information shall not be shared beyond the Board of Directors and the Delegate. The Delegate will inform AKC of the need for a medallion and coordinate engraving of this medallion. A


presentation of this award will be made during the next Annual General Meeting of the club.

This award is separate from the CDCA Club Award for Member of the Year. MOTY nominations are voted upon by the whole club (or approved by the BOD if only one nominee), and will have a deadline for nominations of August 1, 2016. See page 12 for this year's call for nominations.



#### CANAAN DOGS AND THE CAT

We've all seen our dogs "play kill" a stuffed toy by biting, shaking, tearing and ripping it apart. This is prey drive on a toy. There's also pouncing, carrying, digging and burying behaviors that go with prey drive. Don't forget stalking behaviors whether they are directed at a cat, squirrel or a blowing leaf. It's all prey drive. If you want to know how high your dog's prey drive is take the Volhard Personality Profile test that's offered on-line:

Go to the AKC website and read all the information posted on Lure Coursing and the Coursing Ability Test (CAT)..

Canaan Dogs on the whole have an intact prey drive (all 5 stages present) and it is usually high. It's how they survived on their own in the desert. To train your CD to participate in Lure Coursing sport (unfortunately limited to CAT with the AKC) all you need to do is act like a fool and run around your yard holding a plastic bag by the handles and let it fill with air and bellow up. Make a lot of noise and your CD will chase you and especially the bag. Let your dog "catch" the bag and play tug for a few seconds. Repeat this game for a few minutes - not too long and not too often as it has to become a special game, otherwise your CD will become bored with it. You can use scissors to cut the bottom of the bag in strips so it will flap in the wind as you run. Movement and noise just make it all the more enticing. You can also make your own flirt pole by using a wooden dowel or broom handle 2-3 feet long and attach the bag to one end. Now run holding the other end. Twist and turn and raise and lower the flirt pole to keep you dog's attention. Don't forget to let him "catch" the bag every so often. It would be good to have taught your dog the "out" or "drop it" command so that you can get the bag back! You certainly don't want the dog shredding and swallowing the bag. It's also a good idea to teach your dog the "go and/or get it" command. This means to go out in a straight line and "get" whatever you have tossed (ball, Frisbee, Kong, toy). My dog knows "go" as a release word to run out in the direction I'm facing and eventually something will be there. I add "get it" when I want her to bring that something back to me.

When you go to a CAT for the first time make sure to let you dog watch the sight hounds run in the trials. This will excite your CD and he'll get the idea of chasing the "rabbit" around the course. Don't worry about the high pitched barking - almost like shrieking - that your CD may make. Don't stay and watch too long as your dog will tire out from barking. Your CD will remember the next time you go - no need to refresh his memory by watching other dogs run.

When it comes your turn to run be prepared for your CD to be wary of the ground wire and mechanisms. You may have to take a detour to the starting line. The dog's adrenaline and heart rate will be high and it will make it difficult to walk to the start line and control the dog at the same time. You can place your dog between your legs to help contain his enthusiasm. Walk slowly to the start line. When the Huntmaster yells "Tallyho" release your dog with your "go" command and then don't say another word. Don't encourage your dog to keep going, don't use the dog's name. You don't want to do anything that will break the dog's concentration on "catching" the bag. Make sure your fingers don't get entangled in the leash.

I don't suggest you do 2 runs in one day. The dog may be willing but he will also learn to cut corners on the course as it is the same design only run in reverse. The Canaan Dogs are way too smart!

The hardest part is getting your dog to come to you after the run. The first time your CD runs it may be very tired out and easy to catch but by his second run this may not be the case, so a good "Come" command is needed. Catching an excited CD who wants to "go again" is very hard. Have a favorite toy or high value food in your pocket. If it takes too long to catch the dog you may have to pay an additional \$10 for delay caused to others. I would suggest that you leave a collar on your dog for the run (flat, no tags). If everything fails to get your dog at the end of the run you can always lay down on the ground and cry (real tears or pretend) and that should get your CD within arm's length. At least it worked for me.

It's really a shame that the Canaan Dog can't participate in the sight hounds trials. I know that they can be competitive. Watching them run is pure joy.

# LETTER TO THE EDITOR FUTURE CD JUDGE ATTENDS NATIONAL

Hi Amanda. Candy Way here.

### Valley Fever Concerns for those who live or visit the Southwest; Canine Valley Fever and Vaccine Development

Dr. Shubitz is the premiere expert on Canine Valley Fever in the United States. She owns and shows terriers (unfortunately not Borders). She has graciously written an article for us as she wants as many dog owners to be aware of this very serious, but quiet disease. Since the drought in California, the incidence off Valley Fever in AZ, CA, and NM has risen to it's highest levels. We all should be aware!

Ever traveled to Phoenix or Tucson for the winter to enjoy the sunny, warm weather and give your Border Terrier a break from snow higher than his head? Take in a few shows or agility trials? Enjoy a hike the beautiful desert mountains, or a rambling walk in a wide, dry wash where your four-legged sniffer can stretch her legs and do "dog things" without that 6- foot strip of nylon? Well, there is an unwelcome, microscopic pest lurking in this warm, dry air and those lovely, smelly rodent holes: Coccidioides, a soil fungus more commonly known by the name of Valley Fever, the disease it causes.



Valley Fever is a fungal disease that dogs (and people) get from inhaling spores that are in the soil and the air in the desert southwest. The Coccidioides spp. fungi reside in desert soils of the western US, Mexico, and areas of South America. Though all mammals are susceptible to infection, not all infections result in illness, and some species are more susceptible to becoming sick than others. Humans, dogs, llamas and alpacas, and nonhuman primates are among the most susceptible. It has the greatest economic impact on dogs and people due to the sheer number living or traveling in regions where the spores live. Dogs and people can get infected and never know they encountered spores (asymptomatic infection) or they can become sick enough to need medical care. A very few die from severe Valley Fever in spite of treatment.

In the US, about 70% of all cases of Valley Fever occur in Arizona, primarily the area from Tucson to Phoenix. In addition to the high resident population in this area, there is also a huge influx of winter visitors and their dogs during the time of year when Valley Fever most commonly occurs. There is a significant spike in cases following the monsoon after the soil dries and the weather cools. This stays high through about February. The Arizona Department of Health Services human surveillance data show that Valley Fever cases increased again in 2015 compared to 2012-2014. While we don't have statistics on dogs because cases are not tracked by the health department or CDC, canine cases follow a similar pattern. The biological reasons for the yearly increases or decreases are not understood at this time.

Early symptoms of Valley Fever include coughing, lethargy, lack of appetite, weight loss and fever. Not all signs are present in every dog. If your dog is exhibiting these signs for more than a few days to a week, it would be a good idea to have your veterinarian examine your dog and have a blood test performed. Some dogs do not exhibit respiratory signs and the



first you may know of it is in a bone, the central nervous system, or some other location outside the lungs. Valley Fever can be devastating and dogs can die from it, but the good news is that most cases will recover if diagnosed and treated with antifungal medication. However, the lengthy treatment and monitoring is a thorn in the owner's side, both financially and in terms of time. Also, if you traveled to Arizona but live somewhere in the midwest, northwest, or east, your veterinarian back home will not be familiar with Valley Fever and it may go undiagnosed longer. If your dog becomes sick, tell your veterinarian you visited an area with Valley Fever.

A vaccine to prevent Valley Fever in dogs is really needed to reduce both illness in dogs and the financial burden on their owners. A severe case of Valley Fever may cost an owner \$10,000 to treat; most owners will spend in the low thousands to treat even an uncomplicated case because it takes a year or more to treat routine infections. In addition to the cost of medication, regular monitoring is needed for blood cell counts, x-rays, Valley Fever titers, and liver enzymes that can rise from the medications. Scientists at the University of Arizona (Valley Fever Center for Excellence and other departments) are working on a live mutant vaccine. The vaccine strain fungus, called delta-CPS1, has a large gene removed from it so it is virtually impossible for it to revert to a normal strain. This mutant has been shown to cause no disease in mice, even immunocompromised mice, and provides strong protection against lethal challenge of Valley Fever to the lungs. More than half of mice have no fungus in their lungs when tested at the end of a study. Research in the upcoming year will be heavily focused on development of the mutant strain into a vaccine. The USDA (animal vaccine regulations) and FDA (human vaccine regulations) require additional modifications to the structure, and the spores need to be formulated with stabilizers so they can be stored in vials and have a reasonable shelf life. The dog vaccine is a pathway to developing this vaccine to prevent Valley Fever in people, too. In parallel, the researchers are working on studies to better understand the immune response of mice to the vaccine, and dogs to naturally acquired Valley Fever. T-cell responses and cytokines are being studied in client-owned dogs that have, previously had, or are naïve to Valley Fever. The dogs donate blood cells and these are stained to assess the immune response. This dog study is helping develop a test for the vaccine that will determine if dogs are making what we think is the right immune response to the vaccine before performing clinical trials.
