

The 2016 CDCA National Specialty Herding Test

This year's national herding test had a couple of "firsts" – it was held <u>before</u> the specialty show and our evaluator was not a licensed judge, but rather the farm owner. Normally, the herding test is held after the specialty and subsequent events (meetings, banquet, supported entry and designated specialty shows) and allows members and their families plus any spectators to relax and enjoy a stress-free day outdoors while watching Canaans herd under the gaze of an AKC, American Herding Breed Association (AHBA), or Australian Shepherd Club of America (ASCA) licensed judge. However, due to the Rosh Hashanah holiday falling on our traditional herding date, our herding test was moved to Tuesday, September 27th, at Central Bark Canine Events in Central Square, New York. Our scheduled evaluator was AKC herding judge, Colleen Cody, but several days before the test, she was admitted to the hospital with a brain tumor. The farm owner, Eva Razka, who teaches herding at Central Bark, offered to evaluate the test in Colleen's place and I waived the licensed judge requirement due to the unusual circumstances. Because Colleen was also scheduled to bring extra sheep to Eva's farm, we also had to hold the number of test runs to 15 rather than our usual unlimited number.

Despite the circumstances, our herding test day proved to be a wonderful one. The weather was perfect, sunny and not too hot or humid. Eva and her friend, Deb Eldridge (who helped manage the stock during the test), had a fantastic reception awaiting us. They not only prepared goodies for us to eat afterwards, but had sheep motif soap for each participant and made a lovely photo backdrop of bales of hay with fall foliage and the club logo! In addition, Eva had the entire test videotaped using her tablet with either Deb or one of the bystanders acting as videographer. For a couple of Canaans that weren't sure about the sheep during their test, Eva had their owners introduce them to a flock of ducks used for the farm's training lessons. It was New York herding folk at their finest!!

Of the 15 dogs tested that day, 14 passed, which makes a fantastic pass rate! For the "first timer" Canaans, who have never seen or worked with livestock prior to the test, Eva chose Serenity Lane What Do You Say, ("Layla"), owned by Melinda Linton as Best Rookie. Melinda received the traditional shepherd's crook and a Best Rookie rosette for their prize. For Best Experienced, Eva selected CH. Jo-Clem Fire Defies The Sun, CDCA-HC, ("Nolan"), owned by Julie and Dan Haddy, with Julie receiving a crate bucket with toys and Best Experienced rosette for their prize.

As a reminder, members who can't make it to a national or CDCA-sanctioned herding test can get their Canaans certified via private evaluation with an instructor who is a licensed judge or at an AKC, AHBA, or ASCA sanctioned herding test. See the herding certification program guidelines on the CDCA website or contact me for further information. Marcia Muller with her Canaan, CH. River Rock Reach Any Higher, CA, CGCA, CDCA-HCX, ("Ziva"), completed the HCX title in January at an AKC herding test, while Jennie La Prade and her Canaan, Kol Tuv Jesse's Odyssey ("Jessie"), earned the second qualifying score towards her HCX title at a farm with an AKC licensed judge in October.

Those dogs earning titles may be found on page 4 of this issue of this issue of the newsletter. 2nd qualifying scores towards an HCX were earned by: HaTikva Kismet Mi Corazon De Oro, CDCA-HC ("Cora"), owned by Alla Geretz and Serenity Lane What Do You Say, CDCA-HC ("Layla"), owned by Melinda Linton.

Congratulations to all and I hope to see everyone at the 2017 national herding test in Georgia!

It is always a privilege to judge and should never be taken for granted as a given. I thank all the exhibitors for their entries and great sportsmanship shown in accepting my "breeder judge" decision which was, as always, very much based on the dogs on the day. The show was held outdoors at Sampson Park and the rings were partially covered enough for the exhibits to stand under out of the dreary drizzle before gaiting around the nice sized rings. Braving the cooler northern autumnal weather, I opted to not wear a raincoat or a hat as I wanted the youngsters to enjoy their ring experience without consternation and concern of a "strangely draped adorned in large clothing type of person" which is how they may possibly view me intruding in their world.



My Best In Sweeps was a very handsome black with white markings young male, who caught my eye as soon as he entered the ring, at the higher end of the standard in height, he was well balanced, correctly proportioned, everything was in the right place and he was age appropriate in his temperament. Comments on the CDCA 2016 Nationals Specialty

My thanks to the Canaan Dog Club of America, Inc. for the honor of judging the 2016 National Specialty. The Board was able to juggle the schedule to avoid direct conflict with the High Jewish Holidays, but we also knew that for some, this specialty would be early in the school year, and that the location is in a corner of country making it a long trip for many. Despite the hurdles, the entries came, and they were lovely examples of the breed.

First, my thanks and appreciation to all who worked on this National, especially to Amy Preston and Christina Miller. Chris and I have co-bred and while she legally could show to me, she sacrificed a National so as not put either of us in an awkward position. It takes a village - and a club - to host a National and it was so nice to see so many stepping up when asked to help with the National before and during the week.

September, in upstate New York, can be iffy in terms of the weather. We had rain on the National day and by the time I was judging, a raincoat was needed. None of the dogs were bothered by it, and the only reactions to rain dripping off the tent were from the humans (myself included).

I have written about what I look for in a Canaan Dog before so won't quote it all back to you. I always seek out a Canaan Dog who has TYPE. We find the definition of type throughout the Canaan Dog standard, starting with the "athletic agility and grace" called for in the *General Appearance*. *Size, Proportion, Substance* give a size and shape to the dog. So much of the Canaan Dog breed's type is set in the head, and befitting this the *Head* section is the longest part of the standard. *Neck, Topline, Body* help define the parts that make the whole dog. Continuing to read the standard directs you to seek out and reward the moderate dog who could, and did, survive the harsh terrain and isolation of the Negev region. I was pleased to find type in my entry despite the small number entered. I was then able to concentrate on finding the strengths in the entry and reward it.

Squareness, an elongated head and correct gait were where my decisions were made. My Best of Breed Dog and the Best of Opposite Bitch were lovely examples of the correct Canaan Dog gait. Their "brisk and tireless trot[s]" carried them to the front of the line.

Finally, when I recorded my impressions immediately after judging, I commented that I expected I would find that many of my placements would prove to be in age order. The fully mature Canaan Dog has often moved on to other pursuits & activities and may no longer be seen in the breed ring. It is a shame that judges don't get to see the strength of our mature dogs except on special occasions. I was thrilled to find a number of these dogs in my ring. They often proved to be more than the sum of their parts and were rewarded because of it.

To continue this discussion of maturity, we will start with my Best of Breed dog, CH JAYKAY RICHELIEU RULES RN, bred & owned by Genevieve Landis. Technically eligible for the Veterans class, the boy caught my eye from the first go round. From his smooth head planes, to his correct, protective double coat, to his hard, muscled body (which gave power to the potential of his structure), he was everything I could ask for in a Canaan Dog. I asked his handler who he was as I gave her his Best of Breed winnings as I did not recognize

him. Turns out, I did know him, but had last seen him in person five years ago. While I had liked him them, I was thrilled to see the finish maturity had brought him. I was pleased to see him receive recognition in the Herding Group and throughout the weekend.

Best of Opposite Sex went to the bitch GCH CALIENTE GALE FORCE WINDS, bred by C. Sargent & R. Davila, owned by Linda Clark, Rosette Davila, Pamela Rosman and Cindy Zelbst. Like the dog ahead of her, she is in her prime: conditioned, pretty head and, on this day, moved at a correct speed for her size which showcased her movement.

The Select Dog, GCH SUFAT SHELEG JASPER'S DUBHAN, BN, RN, CGCA, breeder M. Harrington, owner Cathey Dunn, is just slightly younger than the Breed winner. He rose far on his type, and his movement carried him above the rest of the dog specials.

For Select Bitch, I had two eligible girls in the ring. One was very enthusiastic (very, very enthusiastic) about being in the ring. The second seem to take the weather and the early-morning ring time as a personal affront. Neither was moving like I expected based on what I felt during their individual exams. Finally my eventual winner, CH JEZEBEL, bred by D. Dodson, owned by Dave Pohl, gave me enough correct strides to put her over her competition. I was pleased to see as the weekend progressed that excitement levels dropped, the weather improved and both bitches showed better & better.

I had one Award of Merit available and it was awarded to GCH PLEASANT HILL AVRAM OF CARTERS CREEK, bred by D. Dodson, owned by Cynthia Dodson & David Golden. He was one of the youngest entered in the class. He looks his age and while his movement took him far, I preferred the length of loin of those ahead of him.

Having been preaching about maturity, Winners Dog/Best of Winners was the exception to the rule. HATIKVA TK KISMET MAGNIFICENT THOR, bred by A. Geretz and owned by Tracey Kopea & Alla Geretz, came from the 12-15 month class and proved that when the parts are all correct, they fit together into a complete package. While he was obviously not as mature as some of my winners, he was all over a Canaan Dog and went Best of Winners over the Winners Bitch for his ease of movement and obvious athleticism.

Winner Bitch, SERENITY LANE WHAT DO YOU SAY, bred & owned by Melinda Linton, and her littermate who won the Bred By Bitch class, were the oldest two in the Winners Class and so were perhaps the start of my being able to find fully mature Canaan Dogs in my winners. Winners Bitch took the class on her more correct head and gait. Reserve Winners Bitch, RELIC'S CHALOM NA'IM ME HALCYON, came from the 15-18 month class, bred by F. Plouffe and owned by Carla Levesque. She had lacked confidence in the exam in her class, but recovered by Winners where her correct movement gave her the win.

Once again, thank you for the opportunity to judge such an exciting and lovely entry. After checking in the Best of Breed class, I turned around and felt a smile burst across my face. I had been having fun & enjoying myself, but seeing the quantity & quality of dogs in front of me excited & pleased me immensely.





CDCA Board Meeting

President Julie Haddy. Called the CDCA

Board Meeting to order at 8:40PM on September 28, 2016 at Sampson State Park, Geneva, NY.

All Board members were present either personally, electronically or had made provision for their report to be read. They were Melinda Linton, Bryna Comsky, Amy Preston, Amanda Pough, Christina Miller, Julie Haddy, Joan Capaiu Greene and Risa Baumrind by Skype. Apologies from Donna Davison whose Health Committee Report was read by Amy Preston.

Minutes from the last board meeting on November 4, 2015, were approved as published in the Kibitzer. There was no other report from the Recording Secretary.

The President called for Report of Officers: Corresponding Secretary Melinda Linton: no report.

Treasurer Christina Miller:

CDCA holds \$20,682.45 after earning about \$5,000 beyond expenses from two agility trials. CDCA broke even on last year's National Specialty in Tucson, AZ.

Report of Committees:

Agility: AKC changed rules to add new classes, eliminate chute (tunnel) and armbands.

Delegate Pamela Rosman: please see report in the AGM minutes, also on the CDCA website.

AKC Gazette breed column: Denise Gordon thanked Becki O'Donnell for contributing an article.

Breeder referral (Sally Armstrong): Report could not be opened. Sally mails requested packets of information. She also maintains the available puppies, adult dogs and planned litters shown on the CDCA website.

Health chair Donna Davison's report, given by Amy Preston, also appears in the AGM Minutes. Autoimmune thyroiditis is reaffirmed as a necessary test along with hip, stifle and eye tests, to qualify for a CHIC number. DM tests are recommended when normal by parentage doesn't apply.

In order for our breed to be included in canine research, we must have samples available. Help make this possible by submitting blood to the CHIC DNA REPOSITORY. A form to donate blood and tissue values is available on the OFA website. We would like to encourage use of our health surveys. Users are also reminded to update information.

We would also like to utilize some short term surveys to extend our knowledge of what is going on with health in the breed. The recommendation is to start with the eyes first. The information must come from a board certified ophthalmologist. Breeders are encouraged to participate in the CHIC Program.

"The Kibitzer" (Amanda Pough): Thanks to Becki O'Donnell and David Golden for Guest Editing the past two issues.

Always looking for content and help with newsletter.

Amanda requests BOD approval to print the SPE-CIALTY ISSUE (usually the one immediately after the NS depending on deadlines) with a color cover. Additional cost but leaves three other covers available for sale (front cover dedicated to NS winner) so potential for more ads/more income. Approved by BOD.

Discussion about storage of photos and other CDCA documents. Currently as part of my position as Editor I have many in my personal storage. Should club consider Club Storage? Cloud, etc. Chris Miller to investigate and report back to BOD.

Desert bred project (Joan Capaiu Greene). The Saluki Program to include desert bred dogs in their stud book will be adapted for use in the Canaan Dog breed according to AKC FSS (Foundation Stock Service) guidelines. Basenjis have used a similar process to include dogs from the Congo in their stud book in order to broaden their gene pool. Currently there is a influx of street dogs that are not purebred into this country. They come from Israel without proof of good health and pedigrees, and appear on Facebook pages. Their advertisers claim authenticity. Discussion of DNA profiles, a CHIC numbers and DM status as part of program.

Awards (Denise Gordon): Coursing ability was added to count toward the Versatility Award. Dates & format were set for Dog of the Year and Member of the Year awards for 2017 and on.

Health Committee (Donna Davison, Chair): Amy Preston gave Donna's report. Autoimmune Thy-

roiditis is reaffirmed as one of the four CHIC requirements for Canaans despite its higher cost because the disease occurs in the breed. Recommended but not required is the DM (Degenerative Myelitis) test or the dog can be considered normal by parentage. (Both parents have tested normal.)

In order for the breed to be included in canine research, we must have samples available. Help make this possible by submitting blood to the CHIC DNA REPOSITORY.

A form to donate blood and tissue values to the Canaan Dog is available on the OFA website. We would like to encourage use of our health surveys. Users are also reminded to update information.

We would also like to utilize some short term surveys to extend our knowledge of what is going on with health in our breed. The recommendation is to start with eyes first. The information must be based on the findings of a board certified ophthalmologist.

Breeders are encouraged to participate in the CHIC Program.

Meet The Breeds: There is always a need for people and dogs to man the booths. This is a great opportunity to showcase Canaan Dogs.

Desert bred project (Joan Capaiu Greene). The Saluki Program to include desert bred dogs in their stud book will be adapted for use in the Canaan Dog breed according to AKC FSS (Foundation Stock Service) guidelines. Basenjis

have used a similar process to include dogs from the Congo in their stud book in order to broaden their gene pool. Currently there is a influx of street dogs that are not purebred into this country. They come from Israel without proof of good health and pedigrees, and appear on Facebook pages. Their advertisers claim authenticity. Discussion of DNA profiles, a CHIC numbers and DM status as part of program.

Legislative front (Joan Capaiu Greene). In two states the sale of one dog qualifies the seller as a pet dealer who requires a license to sell pet dogs. The AKC Government Relations Department publishes legislative alerts as does NAIA (National Animal Interest Alliance) www.naiaonline.org.

Donation Will Help Pets In Seneca County New York

In celebration of the Canaan Dog Club of America, Inc (CDCA, Inc.) and their 46th National Specialty and Annual Meetings, members of the CDCA, Inc. raised enough money to donate SEVEN Pet Oxygen Masks kits to Seneca County New York. While firemen attempt to get pets safely out of burning structures, they are not able to revive them unless they have the proper equipment — pet oxygen masks. These specially-designed animal masks can be used both on conscious pets that have suffered from smoke inhalation and pets that need to be resuscitated after losing consciousness from exposure to the dangerous toxic fumes." Each kit allows rescue workers to help animals as small as birds and pockets pets up to large dogs.


