2017 Awards Chair Report

The awards chair position covers the Versatility/ROM program as well as the Top Canaan performance awards and this year saw major changes to both programs that would be effective in 2018.

First and absolutely foremost, I would like to thank and give massive credit and recognition to Versatility Committee members Julie Haddy, Jennie Larkin, and Risa Baumrind as well as the Board of Directors. The Versatility program was sorely in need of an enormous overhaul and without these wonderful people, it would have taken me forever (well, almost forever) to accomplish this task by myself. The new program matrix and submission form are now posted under Versatility Awards in the Programs section on the club website and became effective as of January 1, 2018.

It is with some sadness that I also report that after December 31, 2018, the Top Performance Canaan Dog awards program will be discontinued. The awards banquet now recognizes the top Canaans in both conformation and performance and continuing the program would be a duplication of time and effort that can be put to better use for the club's benefit. In addition, very few members participated in the program compared to the number of people showing their Canaans in the performance arena. The final winners will be announced at the 2019 National Specialty awards banquet in Franklin, Tennessee.

In the meantime, my congratulations to everyone who earned a title in any organization this past year and keep up the good work!

2017 HERDING CHAIR REPORT By Denise Gordon

First, I would like to thank Amanda Pough and Christina Miller for stepping in for me at the 2017 National Specialty herding instinct test. They are the best! The test was held on Wednesday, October 18th, at Woods End Farm in Watkinsville, Georgia. The test evaluator was the farm's owner and AKC and American Herding Breed Association (AHBA) licensed judge, Doyle Ivie. Mr. Ivie was very complementary about the dogs that he saw that day. The results of the test were published in the Fall issue of the *Kibitzer*, so I won't duplicate them here, except to congratulate everyone again on a wonderful test!

As I've mentioned before, while not everyone can make it to a National Specialty test, I encourage Canaan Dog owners to take advantage of the club's herding evaluation program; the guidelines and evaluation forms are on the club's website. Dogs can be tested through private instructor who is a licensed judge or at an AKC, ASCA, CKC, AHBA, or CDCA-sanctioned event where the dog can simultaneously earn a qualifying score for that organization's herding degree as well as for the CDCA-HC or HCX title. If the dog passes the evaluation, the owner sends in a copy of the scoresheet (evaluation) form to me as Herding Chair and will receive

acknowledgement of the qualifying score as well as presentation of the HC or HCX certificate at the next annual awards banquet.

Likewise, in the past, members have obtained permission from the club to hold CDCA-sanctioned herding tests, where their dogs may be evaluated and receive titles or qualifying scores towards club herding titles. If any member would like to hold a CDCA-sanctioned test, please contact me at desertstarcanaans@yahoo.com and I will help you in every way possible.

The 2018 herding instinct test will be held on Wednesday, May 30th, at the herding facility of Purina Farms in Gray Summit, Missouri; the test evaluator will be Ms. Tracy Parciak, AKC and AHBA licensed judge. Plans are underway for the March 2019 herding instinct test to be held in Franklin, Tennessee.

To the Board of Directors of the Canaan Dog Club of America, Since the last Annual Meeting of the Canaan Dog Club of America (CDCA) in October 2017, held in Atlanta, Georgia, there have been two American Kennel Club (AKC) Delegate meetings--the December 2017 meeting held in Orlando, Florida and the March 2018 meeting, held in Newark, New Jersey, where I have been honored and privileged to represent the CDCA as your Delegate. I am currently serving my fifth term on the Delegate Bylaws Committee, which reviews and makes recommendations on pro-

I have also served on the Bylaws Joint Subcommittee (with the Delegate Advocacy and Advancement Committee) on the Future Direction of the Delegate Body, examining the growth and governance of the AKC. As a voting participant in these quarterly meetings, I am authorized to act per the instructions of the CDCA Board of Directors. The AKC Delegates' Quarterly Meeting transcripts are sent electronically to the CDCA Board of Directors e-list and are posted to the CDCA web site as a web site link, in a password protected members only section for easy accessibility by the CDCA membership. Attached are the Delegates' Meeting transcripts for the last two AKC Delegate meetings.

The AKC Board of Directors Meeting minutes are sent electronically to the CDCA Board of Directors e-list. Throughout the year, I communicate electronically and by telephone with the CDCA Board of Directors and the CDCA membership regarding AKC issues. Annually, at the CDCA Board of Directors Meeting and the Annual General Meeting, I report to the Board and Membership, respectively, on all actions and matters discussed at the AKC Delegate meetings. In addition to reviewing highlights from the Delegate and Board Meetings held during the past year, a general overview of AKC activities is presented. Please attend these important meetings and contribute to the interactive discussion. Remember, your Delegate is the voice of your club in the AKC. Breeder Referral Committee Description/Mission:

- Maintain a file of qualified Breeders, insure that their applications are keep current and that they meet CDCA qualifications.
- Track the CDCA Breeder's "puppy statuses". The "puppy status" is the tracking of the status from breeding through whelping.
- Track the CDCA Breeder's older puppy and dog statuses. This keeps track of any older puppies, adolescents and adult dogs that need placing.
- Publish the CDCA Breeders' List which includes puppy/ dog status (for inclusion in the CDCA information package).
- Keep the Web Chair informed of all updated information for the web Breeders' List.
- Publish the Canaan Dog information package, insure that the information remains current.
- Keep a file of persons qualified to be on the Meet and Greet list.
- Keep the Web Chair informed of all updated information for the web

Meet and Greet List.

- Publish the Meet and Greet list (for inclusion in the CDCA information package).
- Answer inquires, via e-mail and phone, from people seeking information on Canaan Dogs, Breeders and their puppy/dog status.
- Mail out information packages to potential puppy buyers.

Committee Member: Sally Armstrong, Chair, in charge of keeping all of the files, information gathering, answering e-mail inquiries, publishing and sending out packages, fielding the phone call inquires and other sundry things.

In 2013 a committee was formed to update the information package. Thanks to Carrie Franz taking the lead on the project, the package was updated. I now have a copy on my computer from which I can make hard copies to send out when requested or send via email. All of this saves the club money and gets the information out faster. I am still getting a trickle of people that request a hard copy and we are still receiving phone calls from people that have additional questions, but appreciate that it has significantly reduced the work load.

As per the Board, in order to be on the Breeders' List a breeder must have a bitch that has produced a litter or a dog at stud that has produced a litter within the last two years from the latest update of the Breeders' List. The Breeders' List was developed for people seeking puppies, and to direct people to breeders that are actively breeding.

A second list is available for breeders that have not met the Breeders' List requirements that would like to remain as contacts, as well as non-breeding owners that would like to be a contact. This list, referred to as the "Meet and Greet" list, is a program composed of people that would be willing to have people visit their homes in order to meet Canaan Dogs in the flesh and answer questions about Canaan Dogs.

The CDCA Board, Breeders and Members need to do more to generate interest in this program. For breeders, this program can go a long way to introduce more potential puppy buyers to the breed and give the breeders an avenue to learning more about potential buyers that do not live close-by. It will also help buyers determine if the Canaan Dog is the breed for them. All puppies are cute, it is the adult dog that you live with for many years, and the Canaan Dog is not the breed for everyone. For Members, the willingness to participate in the Meet and Greet program is an avenue to become more involved in the positive promotion of the Canaan Dog. The Meet and Greet program was approved by the Board in 2006 and an application is available on the web site.

Once you obtain board approval to be on the Breeders' List you can move back and forth between the Breeders' List and the Meet and Greet List as your situation dictates. This way if you have not produced a litter within the last two years you can still actively introduce potential puppy buyers to the breed and jump back on the Breeders' List as soon as a breeding is planned. If you are approved to be on the Meet and Greet list first and you need to move over to the Breeders' List, you must first obtain board approval.

For our new members, I would like to introduce a couple of documents that are available for sale. The Breeders Guide was developed as a guideline "for the preparation, breeding and follow-up care of the Canaan Dog dam, sire and puppies." Its information is an invaluable primer for the first-time breeder as well as a refresher for the occasional breeder. It highlights everything from necessary health tests for the sire and dam, breeding procedures, care of the pregnant bitch, whelping, raising pups, placing puppies, contract examples and much more. This Breeders Guide is \$12.00 plus \$2.00 s&h.

The committee also has the Breeders Reference Guide available. It contains photographs of, and invaluable information on, most of the foundation dogs found in Canaan Dog pedigrees. It originally sold for \$50 but was reduced to \$30 plus \$3.00 s&h.

Both documents are always available from the Breeder Referral Chair. Send your request along with your check made payable to CDCA to Sally Armstrong, 2300 Crossover Road, Reno, NV 89510-9354.

This committee is organized, runs smoothly and has filled a need for many years. Generating more interest in the Meet and Greet program continues to be of great importance. This will serve the best interests of all Canaan Dog fanciers.

2017-2018 Web Committee Annual Report

Dear Officers, Directors and Members of the Canaan Dog Club of America:

During the past year the members of the Web Committee of the CDCA have continued to make sure that any information that CDCA officers, directors and committee chairs make available for the purpose is published on the web site as quickly as possible. Most often this information concerns the National Specialty, but there are also updates

to programs, breeder information, and the like.

Since February 2008, we have been using Google Analytics to track the usage of the CDCA web site. As of May 19, 2018, we have 1,449 active users over the previous 28 days. 47% of visitors to the CDCA web site find it via search engines, and 44% of visitors enter the URL of the site directly or use a bookmark. 9% of visitors are referred from other web sites, including Clemson.edu (because of the CDCA all-breed agility trials to be held there), DogTime.com, Facebook, and Relic Canaan Dogs, in that order, among others.

Domain name registration for cdca.org, the CDCA website domain name, is provided by 1&1 Internet. Domain name service (DNS) for cdca.org is provided by Sine Wave Solutions, LLC. Hosting services for cdca.org are provided by antibozo.net, a small not-for-profit service that hosts email and a handful of web sites.

CDCA legislative report May 2018

Not much has changed in the seven months since our last report. Anti-breeding activists are still targeting breeders and pet stores and promoting retail rescue efforts over the sale of purpose-bred puppies. Breed-specific laws continue to plague owners of many large breeds, and many companies and communities continue to over-react to incidents involving dogs.

PET STORE PUPPY LAWS

Pet stores are under continuous attack for selling puppies from commercial breeders. Hundreds of communities nationwide have instituted local bans and California and Maryland have statewide bans on the sale of purpose-bred puppies. Pet stores in these jurisdiction must get their puppies from rescues or shelters, thus encouraging the national and international transport of dogs into the growing industry of retail rescue.

Ohio took a different tack and passed legislation to license pet stores and limit where they can buy commercially bred puppies to breeders licensed by USDA and by a state agency if applicable.

EMOTIONAL SUPPORT DOGS

A relatively new concern is the proliferation of claims that dogs are needed as emotional support animals, resulting in confusion over access to public facilities and transportation. The federal Americans with Disabilities Act requires that businesses and agencies that serve the general public allow access for service dogs that are trained to aid their owners accomplish certain tasks or cope with physical disabilities such as immobility, blindness, deafness, PTSD or other health conditions. The federal Transportation Act also requires that airlines make accommodations for trained service dogs in airplane passenger cabins. These laws have been misinterpreted and misappropriated by pet lovers and others, resulting in a broad spectrum of complaints and a proliferation of new policies regarding animal presence in offices, dormitories, classrooms, restaurants, airlines, and other places.

Not all is peaches and cream. In a couple of cases, airline passengers have been bitten by “emotional support” dogs, and some states have considered or passed laws that criminalize fraudulent claims that a dog is a service dog under federal or state law. Some universities and businesses have been forced to deal with unruly dogs and to make allowances for students or employees who are allergic to or fearful of dogs.

HSUS IN OHIO

After it failed to derail passage of Ohio’s pet store licensing law, HSUS and local rescues devised an anti-breeding petition that defines a hobby breeder as someone who owns fewer than eight intact female dogs and a high volume breeder as one who owns more than seven intact female dogs. A show dog breeder with eight intact females could become a high volume breeder by breeding a single litter if the petition becomes law.

Lawmakers responded with HB 506 a bill that changes current high volume breeder law. Written in part by veterinarians and commercial breeders with input from AKC, the bill has passed the House and will go to the Senate floor after several amendments by the Senate Agriculture Committee. HB 506 clearly separates hobby breeders from commercial kennels.

Animals in hot cars

Another recent arrival in many state legislatures is bills that allow people to break into vehicles to remove animals in distress without subsequently facing liability if they damage the vehicle. These bills generally require the rescuers to reasonably believe the animal is in danger, to make an effort to locate the owner or to notify authorities, to determine whether the vehicle is locked before breaking in, to put the animal in a safe place after the rescue, and to leave a note on the vehicle to tell the owner where the animal is being held.

Corresponding Secretary’s Report:

The majority of my activity has involved forwarding email correspondence from the AKC to the Board list in a FYI format. Most of these communiques do not require discussion or a vote and are forwarded for information only.

There were two requests for CD rescue that were forwarded on to Carrie. We also received a heart wrenching description from an American living in Amman Jordan who had heard gunshots and a puppy squealing. She raced over to find the local Amman Municipal Services shooting local dogs. She found a survivor, wondered if he were a pure-bred CD and if we were interested in rescuing him.

We did receive several letters from people thinking that their dog was a Canaan Dog because of similarity of appearance or being “told by their vet”. After responding with a polite variations on “if they don’t have papers, they are not CDs”, I went back and checked our website about “miyun” and the registration of dogs from the wild. I think that we should expand this area on our website as part of breed promotion. The British Canaan Dog Society does a better job with it. I think that it is mentioned once in our website about what dogs can be bred. Joan, I would be willing to work with you on this although miyun is probably not realistic for the US. I think that it is a very cool thing about our breed that makes us unique.

We are one of a few breeds that can brag about the natural selection of our dogs and how all of their phenotypic features contributed to their survival over the centuries. I think that this is very positive spin for our breed and for our mission to protect them.

When I started as corresponding secretary, there was no introduction, instruction or description of what I should be doing. When we bring new people into new positions, some sort of cross training is going to be necessary. I still do not know about “Sunshine card”. Where to get them, what to say in them, etc.

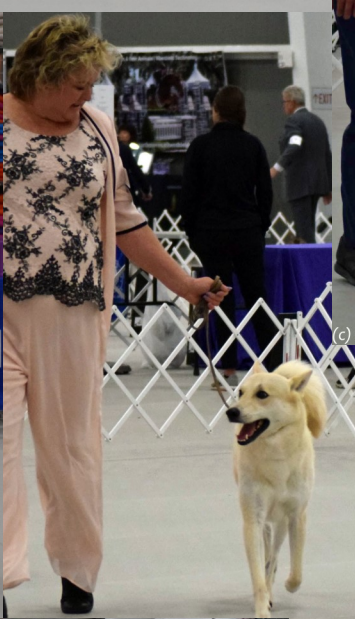
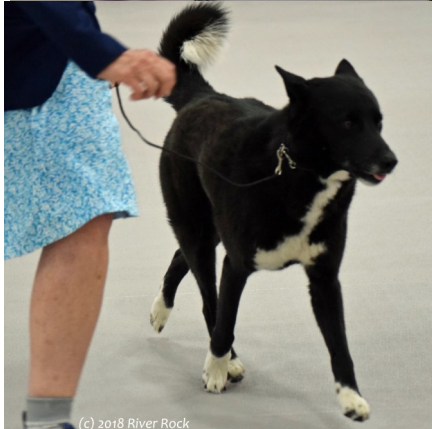
