



# CDCA REGISTER OF MERIT AND VERSATILITY AWARDS

Do you have a Canaan Dog eligible for a Versatility or Register of Merit award?

Canaans that have sired or produced AKC Champion of Record offspring and/or versatility-titled offspring may be eligible for the various Register of Merit (ROM) awards.

Canaans who have titled in CDCA and/or AKC companion and/or performance events may be eligible for the Versatility awards.

Dogs both living and deceased are eligible for the CDCA Versatility and ROM awards.

The new Versatility Title Matrix as well as eligibility requirements and forms for both ROM and Versatility are on the CDCA website (www.cdca.org) in the Programs menu. If your dog(s) are eligible for any of these awards, please fill out the form(s) and send them via email as PDF or JPEG files or via the U.S. postal service with copies of required certifications to CDCA Awards Chair, Denise Gordon at the address below.



Forms must reach Denise's home **no later than <u>August 1, 2020</u>** for presentation at the 2020 National Specialty awards banquet on Saturday, October 17<sup>th</sup> in Wilmington, Ohio. Those awards not picked up at the banquet will be mailed to the recipient after the National Specialty.

# TALI AT THE 2019 AKC OBEDIENCE CLASSIC IN ORLANDO

Over the past few years, Tali has earned a number of invitations to national competitions, but I never took her to any of them. This past year, however, she qualified for the AKC Obedience Classic in Orlando (in Novice Obedience), and I decided it was time. The thought of going to Orlando in December (just when it is starting to get cold and dark in Maryland) also encouraged me to enter.

To earn a spot at the Obedience Classic in Novice, Open, or Utility, a dog must earn 3 qualifying scores in that class during the preceding year. Tali did not just earn three qualifying scores, she did so in 2 days, winning the class each time, and also earning a High in Trial! With this background, I thought there was a good chance that we would put in a respectable showing. Competition is pretty fierce, since the National Obedience Champions (NOC) and multi-Obedience Trial Champion (OTCH) handlers and dogs compete at this event. While I didn't think that we were going to be competitive to win, I did think that we could put in a good showing.

My goals were five-fold:

- 1. Enjoy warm weather and palm trees for a few days.
- 2. Road Trip!!!!!
- 3. Shop the vendors!
- 4. Demonstrate to the AKC and the top obedience competitors and judges in the country what a nice working Canaan Dog looks like (though they have seen Victor Kaftal and his dogs work in obedience and rally, its nice to have more than one handler out there)
- 5. Scope out what the Agility Invitational is like (I have every hope of going back in December 2020 for the Agility Invitational with Tali!)

Making this experience complete was the opportunity to road trip down there with my friend Julie and her corgi Wallace (Honeyfox Lover Of Wensleydale CDX PCD BN GN RE CGCA TKA). Julie and I discussed

our goals and hopes during the drive down. And I empha-

sized that (in addition to shopping and being warm), I wanted us to show well — not just for us as a team, but because I wanted to give a good impression of the Canaan Dog breed. As a rare breed, every time a Canaan Dog is out in



public or at an event, they are representing the breed. And as Dr Menzel established Canaan Dogs to be a working dog, it helps present a more complete picture of the breed to show its working abilities.

Preparing: While it wasn't that long a trip (1.5 day drive down, 2.5 days in Orlando, then 1.5 days back!), Julie and I had to plan how to pack for two people and their dogs, and the enormous number of crates required. Tali had the crate in the car to travel in (her Variocage), a crate for the venue, but we needed a third crate for our hotel room! Happily, I got to borrow one from a friend that folded up very nicely )so

nicely that I need to go out and by myself a new crate so I can have one that convenient all the time). We had a largely uneventful drive down (except for some torrential down-pours in Georgia and Florida that made it hard to see the road or much of anything). The dogs were perfect, and Wallace soon took to following his long-legged girlfriend around on all of our potty breaks.

In Orlando: I was especially happy to be traveling with Julie when she politely but quite firmly ensured that we got nice, ground level rooms near to each other and parking at our hotel. And the hotel was everything I could have hoped for — it seemed to cover more than a square mile, with multiple pools, gardens, palms trees, and it was walking distance to Sea World!

When we arrived at the convention center, we got a taste of its enormi-



## 2019 DOTY/MOTY NOMINATIONS

It's never too early to start sending in nominations the 2019 Member Of The Year (MOTY) and Dog Of The Year (DOTY)! Nominations of recently deceased candidates will be accepted.



#### **MEMBER OF THE YEAR**

Please send your nomination of **250 words or less** explaining why a past or present CDCA member should be honored for his/ her past and/or current contributions to the breed and/or club. If more than one person would like to co-nominate the same candidate, that co-nomination may be an **additional 250 words** maximum, for a total of no more than **500 words** for the candidate's overall nomination. **If no nominations are received, we cannot present this award.** 

#### **DOG OF THE YEAR**

Please send your nomination **250 words or less**. Please include all of the dog's titles, breeder, and sire and dam names (not counted in the final word tally of the nomination) and explain why this dog should be honored for his/her past and/or current contributions to the breed. Once received, if the nomination is that of a dog that you do not own, the owner will be contacted to allow him/her to send in a co-nomination statement about the dog, again, not to exceed **250 words for a maximum total of 500 words**. If no nominations are received, we cannot present this award.

The ballot will contain the write up from the nominator and owner (if received from the latter). Should the owner not choose to submit a nomination, the ballot will only contain the write up from the original nominator. Please note, if you nominate a dog you own or co-own, only the initial write up (max. 250 words) will be published.

For both MOTY and DOTY, a photo of the nominee either in hard copy print or electronic format (preferably JPEG) should be included with the nomination. All hardcopy photos will be returned.

Nominations should be mailed at the address below or emailed to Denise Gordon **no later than April 1, 2020**. If there is more than one candidate for either DOTY or MOTY, ballots will be mailed to members. Voting may be done either by ballots returned via US Postal Service or electronically (email). Otherwise, a single nomination in either category by the deadline will be declared the winner as confirmed by the Board of Directors. Winners will be announced at the 2020 National Specialty awards banquet on Saturday, October 17<sup>th</sup>, in Wilmington, Ohio.

wrong turns, we found the parking lot and lucked into a good parking space so we could unload our gear. Entering the Convention Center was disorienting, especially as the entrance we went in was right by the Dock Diving Dogs, whose competition was in full swing. If you haven't been to a dock diving event, bring your ear plugs — they are really loud! Julie and I found the check-in room for obedience (but were half an hour early), so Julie joined the line of people waiting to check in while I went to find the obedience area and grab some crating space. Luck was with us again, as there were two remaining crating spaces, right next to each other and near the securely guarded exit to the back side of the convention center. Yeah! Our home for the next 2 days!

The competition started the next day. As a Novice dog, Tali and I were in the ring four times: twice on the first day for individual exercises and twice on the second, once for individual exercises and once for group stays. Since Wallace was competing in Open, he was in the ring 3 times (no group stays!). I will spare everyone the breakdown of the details of how we did on each exercise, and will summarize: Weeks, months, and years of training paid off. I entered the ring with a dog who was connected and focused, and I was very pleased with how well she worked. My favorite exercise (and most difficult) is heeling, and Tali did an outstanding job. She charmed the judges — the first judge she decided was A Very Nice Man and when we were setting up for the recall (just after he petted her on the Stand For Exam) she went over to him and surprised him by inserting herself between his legs and smiling up at him. He looked like this was not a thing that had ever happened to him before while judging. The next day, one of the judges partway through our performance spontaneously enthused that she would "love to take her home!". Our overall score was lackluster because we had an ongoing training issue: she has been confused trying to distinguish between the Open Drop on Recall and the Command Discrimination exercises — and the result was her freezing in place and not coming on a first command. So two of the Novice rounds I had to give a second Come command. But by the third she had regained her confidence and she put in a nice and speedy recall on the first try! If not for the recall issue, she would have scored in the top 20 Novice dogs.

However, Tali put in really nice working performances and represented the breed well.

She also got a gorgeous new collar (as did a my Papillon Tip) from Paco Collars.

And we did our best to cheer on the Canaan Dogs entered at the National Championship (but it was hard with our busy obe-

dience schedule)

And one of the most special things of all is that she earned the High Scoring Canaan Dog medallion, sponsored by the CDCA. It is a very large and impressive medallion, and it was an honor to represent the breed and earn it.

Our trip home was smooth and speedy, and Julie and I wafted home on waves of success. Wallace qualified all three times in Open with very strong performances, and he earned High Scoring Pembroke Welsh Corgi!!! Wallace beat a number of other Corgis who were competing at the Classic for the honor.

Recently a new brand of discrimination raised its head, this time in Naperville, a Chicago suburb. There, an ordinance prohibiting pet stores from selling purebred puppies was narrowly passed. Happy? Investigate before you cheer. These pet stores may sell only animals received from rescues and shelters, not from (commercial breeders), thereby depriving pet stores from a source of their income. There is no requirement that shelters and rescues supply pet stores with mixed breed

puppies. Excluding privately and commercially bred puppies from the pet store market is not the way to go to preserve the purebred dog community either. Most shelters and rescues are controlled by the Animal Rightists. It will become less likely to see dogs and puppies, purebred or not, in pet stores because the ARs receive and control the distribution of animals arriving from foreign countries. Moreover, emotional propaganda depicting the suffering of dogs and cats left outside to freeze and starve derects

the dog-loving public toward shelters and away from breeders. "For every dog sold by a breeder, a shelter dog loses its life!" Yikes! Not true, but people like to feel good about their purchases.

#### Thoughts about Freedom of Choice

Opinions on the subject have changed over this decade. No longer do we strongly criticize breeders and owners who have purchased cockatoos, labradoodles or randomly bred dogs from shelters. The proud slogan, "for purebred dogs buy from a breeder" has all but disappeared. Buyers, i.e. adopters, are turning in droves to shelters and rescue organizations before seeking out serious, sincere, preservation and purposefully bred puppies from knowledgeable breeders. Oh, the horror of it all! Or is it really so horrible? Should not buyers be encouraged to choose among rescues, shelter dogs, street mutts or purebreds? Further, should people who own and love their mongrels be encouraged to compete in companion dog events, excluding conformation, side-by-side with purebreds? The answer now is Yes! and the thought of Bob Berndt, former AKC all-breed judge and chairman of the AKC board, turning in his grave is not a deterrent.

How did we get to this amazing conclusion? Would it surprise you to know that 95% of shelter dogs are not put-bred? Even if we wanted to, we could not supply the dog-owning public with enough dogs to satisfy their demand. Our empty litter boxes are pushing the public to rescues and shelters. Like it or not our banner praising purebred, purposely bred dogs is still raised high, though now it embraces randomly bred dogs also. And why not?

It's time for breeders to cast away their halos earned by not breeding. We are angels for not adding to the already too high dog and puppy population. Ha! If you believe that myth then yo deserve to watch the decline of the purebred dog population and the increase in the number of low-entry breeds. For dogs' sake breed!

Several months ago, two AKC breeder-judges, Bill Shelton and Doug Johnson, gave AKC delegates a lecture on the subject of breeding dogs. They pointed out clearly that slowing down our breeding programs plays right into the hands of the animal rightists. The fewer dogs purposefully bred by preservation breeders the more space there is left to admit imported dogs, and lots of people want to rescue dogs. Both Bill Shelton and Dog Johnson are master breeders of Clumber and Sussex spaniels, field spaniels, and Pembroke Welsh Corgis.

Did you know that 95% of shelter dogs are not purebred? And that, Chihuahuas discounted, 2% are left? and that percent-

ages are maintained with deliveries of foreign-born dogs, specifically now from Korea and Egypt. It's no surprise that some of these imports bring rabies and infectious diseases with them. But, some buyers want to buy from pet stores or shelters, and that is their right, it is also their right to expect to get a healthy dog or puppy.

Breeders have the right to operate a reputable breeding or boarding kennel without fear of invasion by animal rightists. We have all heard horror stories of confiscations of dogs for minor or made-up infractions. In Illinois new ordinances now require owners' presence 24-7 or installation of an automatic sprinkler system in order to operate a kennel that houses 4 or more breedable bitches. What can we do to hold on to our rights as breeders and owners of multiple dogs? It is time to show ourselves as exemplary owners, and take an active part in grassroots democracy. The AKC can advise us from the GR (Government Relations) department. It reviews 2500 bills annually on federal, state and grassroots levels. Eleven lawyers work full time with notable successes that pale compared to the millions of dollars of support given to AR organizations from PETA, HSUS, and ASPCA. To allow freedom of choice, we breeders must become informed and active on the grassroots level.

The AKC supports freedom of choice. Purebred or randomly bred. The AKC also supports informed breeding of purposefully bred dogs. AR's have cleverly slowed out breeding efforts by praising breeders for not breeding on the ruse that there are too many dogs in shelters. How can that be when they're importing puppies and dogs by the hundreds of thousands over a year's time? As breeders we must act in favor of purebred dogs as predictable and purposeful, and still outstretch our hands in welcome to our doggy community, Then we begin to justify freedom of choice.

# SUSTAINABILITY COMMITTEE: IT'S A WRAP!

Almost two years ago, the idea of a Sustainability subcommittee was born. What a groundswell this topic caused! We didn't anticipate the widespread interest in the topic, but are glad that we began to talk as a group. Through roundtable discussions, it became our goal to find ways to ensure that each AKC breed is represented by purposely bred dogs that

sented by purposely bred dogs that exhibit the temperament, type, and purpose noted in its respective breed standard. With an awareness

We started by defining breed sustainability as an equation: type+purpose+temperament.

that for breeds with low population counts sustainability is necessary for survival, our mission became one of ensuring that there will always be breeders and owners who will strive to maintain the necessary gene pool to keep each breed going.

We started by defining breed sustainability as an equation: type+purpose+temperament. A dog should look like its breed, be able to do what it is bred to do, and have the proper temperament to do so. From this we moved to questions relative to the issue of demand and whether there are enough dogs and breeders to keep up with the demand. Are the dogs being bred healthy enough to carry on the breed? Are the breeders able to fulfill the demand and generous enough to mentor new people who wish to become breeders? How can we increase the number of healthy pure bred dogs that reflect their breed standard?

Over a period of almost two years, the roundtable discussions concentrated on health and breeding issues. We discussed popular sires, small litter sizes, high fatality rates during whelping, and genetic diversity. The need for more "good breeders" became apparent.

We also found that public education and judges' education are important as well as breeder education. While a pet owner should be aware that each breed has a standard, a judge must know that standard and adhere to it. The health status of a breed must also be conveyed. Media attention that showcases a breed through a movie, Facebook, or a television show, can sometimes cause the public to potentially make a breed very popular for a short time. Conversely, the use of media to educate the public is a huge opportunity for clubs. Many breed clubs have developed Facebook pages and groups to get pet people involved with experienced, ethical breeders. Pictures posted and educational articles related to health and activities available for each breed can help ad-

vance the sustainability of a breed. Positive advice on how to find a well-bred pup is essential to the continuation of our individual breeds.

Breed mentoring was also discussed. It is vitally important to encourage responsible breeders to help in the stewardship of each breed. Many people involved in breeding do not belong to a parent club, or even know that one exists. Reaching out to these people can be a positive force. The mentoring of juniors is essential for our sport to continue. Young people who are enthusiastic and positive become valuable to the sustain-

ability of pure-bred dogs.

The Marketplace was a focal point for many of the discussions.

Much attention has been focused

on the negative aspects of the Marketplace, but responsible breeders need to become a pro-active part of the Marketplace. Breeder of Merit listings are free and can move the commercial and high-volume breeders to a lower place on the listing. Suggestions were made for better PR involvement by AKC. Each parent club should update their health information regularly on the AKC Marketplace and on the AKC Breed Information link.

A major topic for our talks involved low entry breeds. The continued existence of some of the lower entry breeds is in question. Most people are aware of the top ten breeds in popularity, but few are aware of the lesser known breeds. While not well known, some of the low entry breeds might be a better fit for pet owners than the designer dogs or pitbulls which have become so popular. The difficulty in finding purebred dogs is a challenge to the public and we must remain welcoming and inclusive. All of us must help to direct the public to good breeders and answer the questions posed about the appropriateness of each breed and the fit into someone's lifestyle.

The committee had several excellent presentations that showcased how to preserve a low entry breed, but the ideas expressed would work for all pure-bred dogs. Rescue options were also discussed and many participants shared the ways their clubs work in rescuing purebred dogs.

Many people participated in our Sunday night meetings. While our numbers were small at first, they grew to upwards of 60 people who were willing to offer suggestions. This article does not house all of those suggestions just the major ones have been highlighted. It is our hope that informal discussions will continue and that suggestions can be shared to ensure that our breeds are sustained as they were meant to be.

# THE CHALLENGES OF TRAINING THE INDEPENDENT CANAAN DOG

When asked about the toughest part of living with a Canaan Dog, most owners will readily respond that the breed's independent behavior is the greatest challenge. Some even describe their Canaans as "reincarnated cats," a fair portrayal of the breed's autonomous and occasionally haughty nature. Canaans believe that an action must be worth the bother, either in terms of food, toy, or another positive reward, before they will even consider yielding to a command. If the reward is not attractive enough, the Canaan will ignore the request no matter the bribe.

This hardwired autonomy sets up a dilemma for owners who treasure the breed for its self-reliant nature, because it underscores the meaning of a true partnership rather than sycophantic servitude by their dogs—even though it requires creative solutions to training problems. While this self-determination does not imply that the breed is "unbiddable," it does mean that the owner must be at least as smart as the dog.

Training can be complicated by what seems like a contradiction to many owners: This highly independent and easily bored breed may choose the time and place for rewards or develop its own ritual behaviors. For instance, a behavior repeated once can become practice if the perceived reward is highly desired.

Obedience training is highly recommended for every Canaan, whether the dog's future is in the breed or performance ring or as a family pet. Owners should know that the first rule of owning a Canaan Dog is that force cannot be used to make

the dog respond to the owner's wishes, because "A Canaan will forgive, but never forget." Those who have tried to physically force a Canaan to their bidding have usually had disastrous outcomes.

Long periods of repetitious training are almost as ruinous as physical force. The Canaan Dog is highly intelligent and can rapidly learn what is required, if the owner is patient and makes the lesson as a game rather than an exercise in robotic precision. Being highly intelligent also means that the dog can get easily bored. However, unlike some breeds

that get frustrated when presented with another tedious repetition of the same exercise, Canaans instead tend to mentally shut down and totally ignore their owners for the rest of the lesson—or longer. To illustrate: One of the top herding Canaan Dogs once got bored with continuously doing practice outruns and decided to blast through the flock instead, scattering them so that he could chase and play with them. During his spree, he thoroughly disregarded commands and returned to the owner only when he tired of the game. The owner learned her lesson: Limit the number of outrun practices.

A Canaan of a less dominant nature is no less independent than a more dominant one, and the challenge of training such a self-governing breed remains the same. Canaans have high prey-drive and a historical instinct for survival; some work better for a toy reward, while others work better for food treats. Whichever category the dog falls into, owners should work their dogs in very short sessions, even ending the lesson after a few minutes if the dog starts to show signs of mental shutdown. While training a Canaan for any purpose can be a challenge, the rewards of achieving a true partnership far outweigh any difficulties.
