AMERICAN KENNEL CLUB WELCOMES THE INTRODUCTION OF THE HEALTHY DOGS IMPORTATION ACT OF 2020

New York, NY- The American Kennel Club (AKC®), the world's largest purebred dog registry and advocate for all dogs, is pleased to express strong support and gratitude for the introduction of the Healthy Dog Importation Act of 2020 in the U.S. House of Representatives today.

The organization would like to thank Congressmen Ralph Abraham (LA-5), Ted Yoho (FL-3), and Kurt Schrader (OR-5) for sponsoring this bipartisan legislation that will ensure all dogs imported into the United States are fully immunized; free of infection, parasites and contagious diseases; and are individually certified as such by an accredited veterinarian.

"AKC is grateful for Representatives Abraham, Schrader and Yoho's leadership in sponsoring the Healthy Dog Importation Act," said AKC President & CEO, Dennis Sprung. "In the last several years, zoonotic diseases such as rabies, canine influenza and distemper have been carried into the U.S. by dogs imported without basic veterinary checks or valid health certificates. With an estimated one million dogs entering the U.S. annually, this represents a ticking time bomb for animal and public health. The basic health certifications that this bill requires for every dog imported will protect the health and wellbeing of all dogs in our nation - and the humans who care for them."

The AKC also thanks the National Animal Interest Alliance (NAIA) for their long-time leadership on the issue and the American Veterinary Medical Association (AVMA) for their support.

As our country works diligently to end the COVID-19 pandemic and prevent the spread of other zoonotic diseases, this legislation is an important step in addressing concerns about recent documented incidents of unhealthy dogs being brought into the U.S.



2020 NATIONAL SPECIALTY UPDATE

COVID-19 Precautions At The Specialty

At the time of this update, the National Specialty events were still on schedule. However, with the COVID-19 situation, things may change prior to October (we are keeping our fingers crossed that it's still on schedule by then). For all up-to-date reports regarding the National Specialty as well as the Designated Specialty and Supported Entry at the Clermont County Kennel Club shows, please go to the websites for the CDCA www.cdca.org), the CCKC (www.clermontcountykc.org), or the Superintendent (www.foytrentdogshows.com). Both the CDCA and CCKC will follow local and state COVID-19 recommendations and requirements for all events.

PLEASE NOTE THE FOLLOWING REQUIREMENTS WILL BE IN EFFECT AT THE SHOW SITE (PER CCKC):

- All exhibitors will wear masks while indoors and encouraged to wear them while outdoors if social distancing is not practical
- There will be no chairs provided at ringside; all exhibitors should bring their own chairs and chairs must be placed 6 ft apart at ringside

- Exhibitors are encouraged to "show and go" instead of staying at ringside or at crate set-up after breed class for the Clermont County KC shows



Clermont County Kennel Club Rules For The Show Site

- **PARKING:** Ample free car parking is available.
- The Show Site will be available to exhibitors at 7:00 am on Friday, October 16, 2020. Dogs must be removed from the Show Site immediately following Best in Show judging Sunday, October 18, 2020.
- Royal Canin Ring will be locked from 10 p.m. to 6 a.m. daily.
- Dogs left overnight must have contact information clearly posted.
- Grooming in designated areas only!
- No gasoline or diesel generators permitted within 100 ft. of any building in which the show is conducted.
- Use of private exercise pens is not permitted inside the building and are strongly discouraged around the building perimeter.
- Inside crating in designated areas only. Crates must be stacked. No soft-sided crates permitted.
- No crates permitted ring side except crates on dollies, during judging only.
- Dogs must be on leash except when crated or as required for judging.

There is a multi-tub wash area (shed) at the back of the Roberts Centre. Access to that area can be gained by using the dock doors closest to the RV parking side of the building.

Versatility Program Clarification

A question arose recently with the new matrix of the Versatility program, so it was decided to clarify titling under the new matrix. First of all, the new matrix is the latest of in the series of matrices, an improvement of the previous one. It is not meant to be a wholly new titling regime, but rather a continuation of titling within the program itself. This means

any titles earned in the previous matrix or matrices are permanent; in other words, the entry level Versatility (V) title earned in a previous matrix does not need to be re-earned with the new matrix. A further example: dogs that have earned the Versatility Advanced (VA) in the previous matrix have the rough equivalent of Versatility Intermediate (VI) in the new matrix and therefore, the owner can then submit additional documentation for the next title, the Versatility Intermediate Multipliers (VI+; e.g., VI2, VI3, etc.) where each VI title requires an additional 4 AKC titles across at least two different categories in the new matrix. Hopefully, this clarification helps with the transition from the previous matrix to the new one. and Vino was shown by Cydne Clark, an all-breed handler from Watauga, Tennessee, so was not owner-handled.


