#### *Nomination:*

In 2002 Keith and Cheryl Shank welcomed their first Canaan Dog, Jake, into their lives. Since then, they have owned 5 Canaan Dogs, which they have shown in conformation, exhibited to advance the public's knowledge about the breed and the Club, and bred. In short, they have been an integral part of the Canaan Dog community for almost two decades.



Throughout the years, the Shanks have worked on a wide variety of CDCA events. For example (and way back when), Keith assisted with organizing and running the 2005 National Specialty in Rochester MN. More recently, in 2014 Keith served on the Specialty Committee for the National Specialty held in North Branch Minnesota. Cheryl's incomparable performance as part of the duo presenting "the traditional Welcome Song presented by Minnesota Members" is memorialized at: https://www.youtube.com/watch? v=4VUHFEiwIyc. For the past, several years Keith and Cheryl and their dogs have anchored the Canaan Dog booth at the Orlando Meet the Breeds. They're members of the Anoka County Minnesota Kennel club and have single-handedly constructed and manned (dogged?) the Canaan Dog exhibit at the Minnesota State Fair, the largest in the country attended by over 2,000,000 visitors every year.

The Shanks currently have 3 Canaan Dogs, which they had shown extensively, raising awareness of our breed. The two youngest (father and daughter) have had many conformation successes, including each winning the breed at the last two AKC Championships. Keith and Cheryl are true assets to the Canaan Dog and the CDCA.

#### Nomination:

Hava is a perfect example of the courageous spirit and determination present in the Canaan Dog breed.

Hava is the first Canaan Dog to earn the Tracking Excellent (TDX) title. This is an enormous accomplishment. I have no doubt that Hava would have qualified in the Variable Surface Tracking (VST) test and earned the title of Champion Tracker (CT) were it not for her current



physical limitations. Hava loves to track, and the joy Debby receives from knowing Hava's spirit and desire are still strong at almost age 14 is an inspiration to any dog owner who is dealing with Degenerative Myelopathy.

Hava was awarded the Versatile Companion Dog 1 title after earning her CD, NAP, NJP and TD titles. She also earned the Beginner Novice, Rally Advanced, and Open Agility Preferred titles.

"Living with Degenerative Myelopathy - Hava's Story" in the Kibitzer provides encouragement to other owners dealing with DM along with some helpful hints. Hava certainly is a "Courageous Tracker."

I've seen a dog in a full quad wheelchair compete in Nose work trials and it is a testament that dogs can overcome obstacles that humans think are insurmountable. The joy they experience from doing what they love to do is what is important. Owners learn to deal with the hardware and other challenges with a little encouragement from friends, family, club members and other competitors.

I am nominating Hava for the CDCA 2020 DOTY award. She deserves to be recognized as an excellent role model of what's possible.

#### Owner's Statement:

I am honored at Hava's DOTY award nomination. Hava and I have been partners on a journey which has helped showcase Canaan Dog capabilities and temperament. I most fondly recall that her calm, friendly nature made her an excellent breed representative. Never pushy, she always wanted to politely greet people at performance events. During her hospitalization for IBD, technicians sent notes about her sweet personality. At treatment conclusion, her typically very serious doctor suddenly softened and asked to button her winter coat because he would miss her.

But anyone coming to my front door knew that she was my protector.

With her determination, Hava demonstrated to the tracking community just what Canaan Dogs are made of. She will never give up. Although her DM has progressed and she is now in a full quad wheelchair, she still wants to do her job. Her dedication has been truly inspirational to trackers during recent challenging times. She seems to take DM in stride, adapting to changes in equipment and routine, wanting to remain with family and participate in activities.

Hava approached obedience and agility with the same determination to get the job done properly. Although she was rather perfunctory in these venues, I received compliments on her precise performances. Nevertheless, Hava always preferred outdoor activities. She enjoyed being with sheep when I could give her the opportunity, and she was instinct certified. But tracking has always been her passion, and she was out searching for articles today!

# **2021 DOTY/MOTY NOMINATIONS**

2021 Member Of The Year (MOTY) and Dog Of The Year (DOTY) nominations are now open! Nominations of recently deceased candidates will be accepted.

#### **MEMBER OF THE YEAR**

Please send your nomination of 250 words or less explaining why a past or present CDCA member should be honored for his/her past and/or current contributions to the breed and/or club. If more than one person would like to co-nominate the same candidate, that co-nomination may be an additional 250 words maximum, for a total of no more than 500 words for the candidate's overall nomination. If no nominations are received, we cannot present this award.

#### DOG OF THE YEAR

Please send your nomination 250 words or less. Please include all of the dog's titles, breeder, and sire and dam names (not counted in the final word tally of the nomination) and explain why this dog should be honored for his/her past and/or current contributions to the breed. Once received, if the nomination is that of a dog that you do not own, the owner will be contacted to allow him/her to send in a co-nomination statement about the dog, again, not to exceed 250 words for a maximum total of 500 words. If no nominations are received, we cannot present this award.

The ballot will contain the write up from the nominator and owner (if received from the latter). Should the owner not choose to submit a nomination, the ballot will only contain the write up from the original nominator. Please note, if you nominate a dog you own or co-own, only the initial write up (max. 250 words) will be published.

For both MOTY and DOTY, a photo of the nominee either in hard copy print or electronic format (preferably JPEG) should be included with the nomination. All hardcopy photos will be returned.

Nominations should be mailed at the address below or emailed to April Gray no later than April 1, 2022. If there is more than one candidate for either DOTY or MOTY, ballots will be mailed to members. Voting may be done either by ballots returned via US Postal Service or electronically (email). Otherwise, a single nomination in either category by the deadline will



be declared the winner as confirmed by the Board of Directors. Winners will be announced at the 2022 National Specialty awards banquet.

# **Brag Box!**

Since the last Kibitzer, "Ziva" (River Rock Reached Any Higher) earned 2 AKC Scent Work titles: Virtual Scent Work Excellent (VSWE) and Scent Work Handler Discrimination Novice (SHDN). In UKC she earned 5 Nosework titles: Advanced Exterior (AE), Advanced Vehicle (AV), overall Advanced Nosework (AN), Superior Exterior (SE) and Master Container (MC) - this one was earned on her 8th birthday.

In a November Barn Hunt trial "Ziva" received the Judge's Choice Award for her first qualifying Open leg, along with a 1st place ribbon.

The icing on the cake was learning that Ziva earned an Outstanding Breed Award and was named the #1 Canaan Dog, Elite Performer, in the AKC 2021Trick Dog National Competition. The story line is "A CANNAN DOG APPLIES TO THE AKC CANINE COLLEGE" and here's the video link: https://www.youtube.com/watch?v=opRP5RaOq-A

I've been entering the AKC Trick Dog Virtual Competition since 2019. Your dog has to have earned the Trick Dog Elite Performer (TKE) title before you can enter this competition. Once entered you have to qualify. Then a panel of judges score your video on creativity, fluency, flow, handling skills, entertainment value and overall impression.

A winner and 2 semi-finalists were chosen. An additional 20 Outstanding Performances were posted on the AKC results page. I found out last week when I received a big box of Bling that Ziva was chosen for an **Outstanding Breed Award (#1 Canaan Dog)** - **2021 AKC Trick Dog National Competition**. I had hoped to get my video posted on AKC and some recognition for our breed but I'm happy that the judges saw what's possible with a Canaan Dog. AKC doesn't give a Breed Award to every breed entered. Performance has to be considered Outstanding. We couldn't keep repeating for perfection, so I'm happy with what I got. As Canaan Dog owners you know what I mean when I say Ziva gets bored with repetition.

Story line is: A Canaan Dog applies to the AKC Canine College

The hardest trick was having Ziva remove a ring already on a post and move it to another ring. This was NOT a fluke. It was part of the trick routine.

I'm already working on a story line for next year's competition.



I thought my Best Veteran In Sweeps was in great condition and if I had judged the Specialty I would have made him a serious contender for Best Of Breed.

Kudos to all the breeders for a job well done and presenting to me such beautiful specimens of your breed. Thank you again for this honor and I truly enjoyed my experience.

I was very pleasantly surprised at the overall quality and soundness of the entry. I don't see that nearly often enough. Swinging elbows and restricted reach are commonplace now - not to be found with this entry. Granted the Canaan temperament is not very outgoing as befit your heritage, but tail carriage is still important. More work needs to be done in that matter. Lastly, conditioning and handling were much more than I expected. As a judge it is quite exciting to find so many well conditioned entries. Keep up the good work and thank you for giving me the honor to have judged your specialty.

#### **Designated Specialty**

Thank you to the membership CDCA for electing me as the 2021 Designated Specialty Judge. It was an honor to again judge an entry of depth and quality. I would have happily taken a number of dogs home with me!

Despite the fact that for some dogs, this show was their 4th, 5th, or 6th time in the ring in three days, I was extremely impressed by the behavior of young dogs in the ring. We had a couple "hokey-pokey" dogs (as one handler described her charge) but as I don't expect robots in the ring, nothing that was unusual or of concern.

My winners all were pleasing in movement and head and this is where I most often made my decisions. My Best of Breed dog filled my eye upon entering the ring and proved to be as impressive on exam and in motion. I was pleased to see him rewarded later in the group. Well muscled, he covered ground with a "brisk and tireless trot." He has a lovely wedge shaped, elongated head, that is distinctly masculine, on a well arched neck that is balanced to his body. His athleticism was evident both in his footfalls and topline on the move. I asked ages of him and my eventual BOS winner; while I was surprised how young she was, learning he was technically a Veteran reinforced my appreciation of this breed when fully mature.

A reminder; while the head is described as a "wedge" in the standard, it is also described as "elongated." This was especially in my mind in the Winners Bitch class.

In addition, while "his trot tends to converge to the center at higher speeds," there should be no evidence of interference in that convergence. Above all, "correct movement is essential to this breed."

Thank you again to the Western States Canaan Dog Club for the hospitality on my trip, and to the breeders, owners, and handlers in my ring.

# **CDCA National Specialty 2021: Impressions from The Show**

Nine days of all-breed and specialty shows, Nov. 10-16, 2021, including the National and Sweepstakes competitions with entries around twenty dogs.

All dog and handler teams represented the breed well. Special mention to Laura Alton and her Canaan Dog team member who excelled in Rally competition.

Attending the AKC judges seminar were two aspiring judges of Canaans and several interested CDCA members. Noteworthy was a glimpse into how breed descriptions had evolved over a twenty-year period from Ann Hier's original illustrations to what they are today. Fortunately the understanding of the breed among newcomers and old-timers hasn't strayed far from the Menzels' description. Dr. Jim Edwards and Ann Heir made their invaluable scientific and artistic contributions which ended at AKC in 2019 with the takeover of DNA.

Good fortune and planning brought us judges familiar with Canaans. Robert Frost had judged the breed since the beginning of point shows for the breed, and Amanda Pough started in the breed as handler, then breeder, and now judge. Mr. Frost judged the National this year, and Ms. Pough the designated specialty. Sweepstakes judge was the much loved and respected Kitty Burke. A necessary judge change brought Ms Regina Lee Bryant into the Sweepstakes ring on Sunday, a fortunate find for the breed. Without exception judges on all five days of competition were knowledgeable, consistent, made predictable choices, and a pleasure to watch.



In May of 1972, Bert and Jay C. Schaefer put on the first CCA, now CDCA, National Specialty Show at Spatterdash Kennels, Emmaus, Pennsylvania. That was the first step on the way to full AKC recognition for Canaan Dogs. Over 20

dogs and owners participated. Tess Hensler, whose breed was Dobermans, judged.



In August 1997, our first AKC "pointed" national specialty was held in Kentucky. Fittingly, Anne Rogers Clark judged our bunch of "wild Indians". She must have included most of the handlers in that statement also. As they say in a variation of Pennsylvania Dutch, "you've come a long way baby!" Yes, we did!



Annual Meeting of the Club, held in conjunction with the Annual Specialty in Tucson and via Zoom on 11-11-21 called to order at 4:24pm local time.

Attending were Board members Keith Shank, Annette Israel, David Golden, and Bryna Comsky.

Also attending in person were Members Laura Alton, Cynthia Dodson, Debbie Friedman, and Richard Vulliet. Members attending via Zoom were Laura Fochtmann, Julie Haddy, Dan Haddy, Marcia Muller, Jenni Pickard, Cathi Oskow, and Pamela Rosman.

President's report. Keith talked about the Board's desire to engage better with each other and with the general Membership by having more frequent opportunities to connect. He outlined new schedules for (a) monthly Board meetings via Zoom on every 3rd Thursday, (b) bi-monthly General membership meetings via Zoom on the 2nd Tuesday, starting in February 2022, and (c) informal Zoom Canaan Dog "happy hours" on alternate 2<sup>nd</sup> Tuesdays, beginning in January 2022.

Vice-President's report. Annette gave a brief summary of the Committee reports she had received from Committee Chairs that weren't present, and which Committees needed additional help. Debbie Friedman graciously agreed to begin taking over Membership Committee duties from Risa Baumrind.

Treasurer's report. David discussed the Club's new bank account structure and gave a year-to-date overview of the Club's financial position. The Club had an average daily cash balance for the month of \$23,341. He noted that the Club's cash flow would increase dramatically, both in and out, during November, given that two of the Club's three biggest events—the National Specialty and Thanksgiving Agility Trials--were taking place during the month.

Bryna talked about looking for opportunities to get with other clubs and her activity as "Sunshine" Chair, recognizing on behalf of the Club Member's happy and sad events.

David G. summarized several proposals for the Publicity and Public Education Committee, including a potential Member Survey using Survey Monkey to capture information on (a) Canaan Dog breeding stock in the US, and (b) additional Member interests not currently being served by the Club. He also discussed generating more Member engagement with photos, brags, etc., that could be posted across the Club's social media platform to inform and promote about the versatility of the Canaan Dog breed.

Dan H. gave an update on the Thanksgiving Agility Trial: 550 entries, a big increase over 2020. He also requested more help from the membership.

Pamela went through her AKC Delegate's report.

New business: Marcia M asked for an update about the Club's efforts to get the ATTS temperament test accepting for titling by the AKC.

Cynthia then made a motion to adjourn, and Deb seconded it.

The meeting ended at 5:49pm local time.

The job description is that the NS Board Liaison(s):

- 1/ assist the National Specialty Chair & Committee with any questions regarding CDCA policy and procedures (P&P) regarding the National Specialty;
- 2/ makes sure deadlines are met for applications, ensures applications are signed by an Officer and are complete under AKC rules, etc. Follow up with AKC as needed to ensure applications are approved in a timely manner;
- 3/ maintain communication between the NS Committees and the Board;
- 4/ answer AKC and CDCA policy/rule questions in regards to the National;

AKC filming will take place in Orlando, Florida December 14th through 19th; Portland, Oregon January 19th through 22nd; and Denver, Colorado February 18th through 20th. There may be an additional session in Houston, Texas in July, but that has not been confirmed as of yet.




