Treasurer's Report: David Golden

If any club member is interested in the full treasurer's report they can contact David Golden.

Our big cash outflows and inflows are all associated with our due season, but more importantly, our events.

The two agility trials that the club has one in May and one in November, which are both our biggest cash in inflows and are biggest cash outflows as well as the National.

October 29 of last year, we had \$20,908 in cash in the bank

This year, on the comparable day, today, we have \$20,306 in the bank.

The cash balance has been pretty steady as a snapshot at around \$20-21,000 a year.

The previous 12 months this club has spent over \$70,000.

The past year we've taken in about \$70,000

We have two agility trials, which cost \$ 30,000 a year to put on. These are big venue big trials 500-600 Dogs entered three or four days, judges equipment \$10,000 and AKC fees etc..

Agility trials are our biggest moneymaker

We get \$3,700 a year in dues.

We make very little money selling catalog ads. Should we continue to print the end of the year hard copy of the Canaan Connections?

Agility Committee: Dan Haddy & Julie Haddy

We continue to work to put on two all breed agility trials in South Carolina. The trials are in May and Thanksgiving. They're well attended and well supported by the southeast agility community, operating with a healthy income for the CDC.

The new bank account at Wells Fargo is working well for us to be able to deposit entry event entries, RV fees, etc.

The trials worked better previously when the committee could process payments for the trial related expenses.

Lack of communication is a problem with the board. We do not receive any notification from the board. When event apps are filled, filed so that we can make sure that the app apps are processed correctly at the AKC Thanksgiving events are currently pending, as they have not received event fees and we have received no follow up message about them being sent two weeks ago. The premium cannot be released until the events are approved to host the agility trials.

Denise Gordon comment

I'm on the board for Claremont. I'm also the unofficial assistant trial chair. But I go on the AKC Event Management sign on, and then put in all the information. I use my own credit card to pay the fees, then the club reimburses me for that. Because we don't as a club have a credit card

Health Department: Donna Davison

We have an ad asking for donations for \$25 for Hemangiosarcoma research in Canaan Dogs. The suggested amount of \$25 commemorated the 25 year anniversary of the Canaan Dog being recognized by AKC.

We have collected \$323.23 so far.

We had a litter of puppies that were born with pixie ois. There is a researcher who wants to blot out the genetics and hopefully come up with a test and the original amount that was put forth was \$10,000 that was estimated that would be the cost for that and going further into the process.. If the actual amount is \$8,614 and we do through Purina there is a donor advised fund that from submitting Your Purina points, that currently we have \$1,411.26 in that. So that could be subtracted off the top. After that, it became the crowdfsource of both clubs at the time.

A year ago we expressed interest in helping to fund this. So I need to know where we're at and what this club would be willing to do so that I can also check with the other club.

Delegate Report: Pamela Rosman

Three AKC delegate meetings since the last National in November 2021.

It was the 21st anniversary of the AKC national championship with over 5000 entries and events in many areas of our sport.

The AKC board had established the detection dog Task Force which Breiner had referred to previously and also the patriotic puppy breeders program.

The AKC Board has endorsed the concept of a preservation bank purebred preservation bank, which has subsequently been established now as a Delaware corporation. This will be a repository for semen samples, and also incorporate DNA technology.

I'm hoping our club as well as many other parent clubs will be able to take advantage so we don't lose valuable genetic material from the historic line of Canaan dogs.

The board has also collaborated on expansion of opportunities for juniors and encouraging clubs to promote Junior activities.

AKC events have been up and our litter registrations. Individual registrations are up.

The development of virtual events was very significant and getting us through the COVID crisis.

There have been several proposed amendments to the AKC bylaws over this past year. Most of them are housekeeping amendments. The delegate Bylaws Committee has proposed several of those, owing to the fact that the AKC bylaws have been not been totally overhauled, maybe in 137 years

The delegate standing committees have proposed some of these housekeeping changes. For example, one of them included adding sent work to one of our delegates standing committees. As you know, there have been various amendments to the bylaws concerning age divisions and age calculations for multiple day shows how we calculate six months etc.

The December meeting, the new AKC CHF CEO Dr. Darren Collins was introduced and will be moving forward with CF CHF initiatives.

The CA The canine Health Foundation president's award was presented to Dwayne and Connie booth terrorists who are Afghan breeders and very well deserving.

March is our annual election of the AKC board of directors. The class of 2026 was unopposed. I was privileged to sit on the nominating committee for 2026 and the nominating committee slate consisted of the three incumbents Chris Sweetwood, Harold red, Tetro and Wallen who were returned to the board without opposition.

At the March meeting, there was a very moving tribute to Ron Menaker, who had passed away a short while before the meeting, and to talk about his legacy including but not limited to the AKC museum of the dog and various programs and initiatives that he was behind for so many years and so passionate about the sport, including meet the breeds.

Club development is ready to help all struggling clubs so if we're struggling, we need to connect with club development. At the December meeting, it was reported that we have in total 4992 clubs only 645 of which are member clubs 4166 are licensed club 95 sanction a and 86 sanction B and the AKC delegate body is concerned as to what will happen if all of those license clubs become member clubs and how will we adequately represent all areas of our sport.

With the help of Keith, our president, the AKC now has allowed the T T designation temperament testing to be affixed to our Canaan dog titles

AKC now has a Business Intelligence Committee. And the board has encouraged us to welcome all new club members that are at our events, all new exhibitors and do everything possible to keep them involved.

The AKC does have an update program which we participate in where new owners are given literature with regard to their new puppies and hopefully this will increase their involvement in various programs.

Social media is an important communication tool for the AKC and the fancy. And at this September meeting, which will be held on Sep. tember 12th In New Jersey, that will be the election for the delegate committees. I have sent out to the board and we discuss out of all 11 committees there are only three committees that are having an actual election, which is the Olbrich committee Bylaws Committee, and the field trial

CDCA Board Note—2023 National Specialty:

[The] Board has approved a change to next year's National Specialty. As part of rescheduling the 2020 National (stay with me here), the previous Board moved the show originally scheduled for the Friday of AKC Calendar Weekend 37 in 2022 at Purina Farms, MO to the same Friday next year (2023).

[Unfortunately, while one source said that weekend was not a Jewish Holiday, those who for whom this would impact did not check the dates themselves.] Unlike in 2022, that day in 2023 is the beginning of Rosh Hashanah. When the current Board learned this, it held a special meeting to explore options. One of those options, proposed by member Cathi Oskow, was to move the National up by one day, to Thursday, September 14, 2023, which is not a holiday. At this upcoming meeting in Newark, there will be 14 votes on proposed amendments to the bylaws and two reads on matters which will be voted on in December 2022. In Orlando. Most of them are housekeeping issues. However, there are two votes that stand out, which was discussed extensively with your board of directors.

The AKC proposed amendment to the bailout or to establish term limits was passed by a single vote. So it did not have overwhelming support. What it did was it would allow directors to serve for two consecutive four year term terms on the AKC board, and after which they must go off the board for one year, and then they are eligible for reelection. It was done to encourage supposedly new blood and to bring fresh ideas to the board. In actuality, it hasn't happened because the same individuals who went off the board were reelected subsequently. And it was very disruptive to our organization even to have a one time one year hiatus.

The second vote, which is significant concerns the awarding of championship points to dogs who may not have any competition in the breed rank. And this, of course, is specific to our Canaan dog breed because we are a low entry breed. It was put forth to encourage individuals to show and not pull their entry if they have only one dog in competition.

Agility Trial Chair

Breeder Referral Status Report

Breeder Referral Committee Description/Mission:

- Maintain a file of qualified Breeders, insure that their applications are keep current and that they meet CDCA qualifications.
- Track the CDCA Breeder's "puppy statuses". The "puppy status" is the tracking of the status from breeding through whelping.
- Track the CDCA Breeder's older puppy and dog statuses. This keeps track of any older puppies, adolescents and adult dogs that need placing.
- Publish the CDCA Breeders' List which includes puppy/ dog status (for inclusion in the CDCA information package).
- Keep the Web Chair informed of all updated information for the web Breeders' List.
- Publish the Canaan Dog information package, insure that the information remains current.
- Keep a file of persons qualified to be on the Meet and Greet list.
- Keep the Web Chair informed of all updated information for the web Meet and Greet List.
- Publish the Meet and Greet list (for inclusion in the CDCA information package).
- Answer inquires, via e-mail and phone, from people seeking information on Canaan Dogs, Breeders and their puppy/dog status.
- Mail out information packages to potential puppy buyers.

Committee Member: Sally Armstrong, Chair, in charge of keeping all of the files, information gathering, answering e-mail inquiries, publishing and sending out packages, fielding the phone call inquires and other sundry things.

In 2013 a committee was formed to update the information package. Thanks to Carrie Cabrera taking the lead on the project, the package was updated. I now have a copy on my computer from which I can make hard copies to send out when requested or send via email. All of this saves the club money and gets the information out faster. I am still getting a trickle of people that request a hard copy and we are still receiving phone calls from people that have additional questions, but appreciate that it has significantly reduced the work load.

Report:

As of 30 August 2022: 7 information packages have been sent out.

•In 2021: 91 •In 2020: 14; •In 2019: 13; •In 2018: 24; •In 2017: 35; •In 2016: 44; (previous years available on request).

As per the Board, in order to be on the Breeders' List a breeder must have a bitch that has produced a litter or a dog at stud that has produced a litter within the last two years from the latest update of the Breeders' List. The Breeders' List was developed for people seeking puppies, and to direct people to breeders that are actively breeding.

A second list is available for breeders that have not met the Breeders' List requirements that would like to remain as contacts, as well as non-breeding owners that would like to be a contact. This list, referred to as the "Meet and Greet" list, is a program composed of people that would be willing to have people visit their homes in order to meet Canaan Dogs in the flesh and answer questions about Canaan Dogs. The CDCA Board, Breeders and Members need to do more to generate interest in this program. For breeders, this program can go a long way to

introduce more potential puppy buyers to the breed and give the breeders an avenue to learning more about potential buyers that do not live close-by. It will also help buyers determine if the Canaan Dog is the breed for them. All puppies are cute, it is the adult dog that you live with for many years, and the Canaan Dog is not the breed for everyone. For Members, the willingness to participate in the Meet and Greet program is an avenue to become more involved in the positive promotion of the Canaan Dog. The Meet and Greet program was approved by the Board in 2006 and an application is available on the web site.

Once you obtain board approval to be on the Breeders' List you can move back and forth between the Breeders' List and the Meet and Greet List as your situation dictates. This way if you have not produced a litter within the last two years you can still actively introduce potential puppy buyers to the breed and jump back on the Breeders' List as soon as a breeding is planned. If you are approved to be on the Meet and Greet list first and you need to move over to the Breeders' List, you must first obtain board approval.

For our new members, I would like to introduce a couple of documents that are available for sale. The Breeders Guide was developed as a guideline "for the preparation, breeding and follow-up care of the Canaan Dog dam, sire and puppies." Its information is an invaluable primer for the first-time breeder as well as a refresher for the occasional breeder. It highlights everything from necessary health tests for the sire and dam, breeding procedures, care of the pregnant bitch, whelping, raising pups, placing puppies, contract examples and much more. This Breeders Guide is \$12.00 plus \$2.00 s&h.

The committee also has the Breeders Reference Guide available. It contains photographs of, and invaluable information on, most of the foundation dogs found in Canaan Dog pedigrees. It originally sold for \$50 but was reduced to \$30 plus \$3.00 s&h.

Both documents are always available from the Breeder Referral Chair. Send your request along with your check made payable to CDCA to Sally Armstrong, 2300 Crossover Road, Reno, NV 89510-9354.

This committee is organized, runs smoothly and has filled a need for many years. Generating more interest in the Meet and Greet program continues to be of great importance. This will serve the best interests of all Canaan Dog fanciers.

CH Joshua of Gray Mesa, owned and handled by Barbara Burr, won three consecutive national specialty matches, one of them judged by Mr. Jay C. Sheaffer.

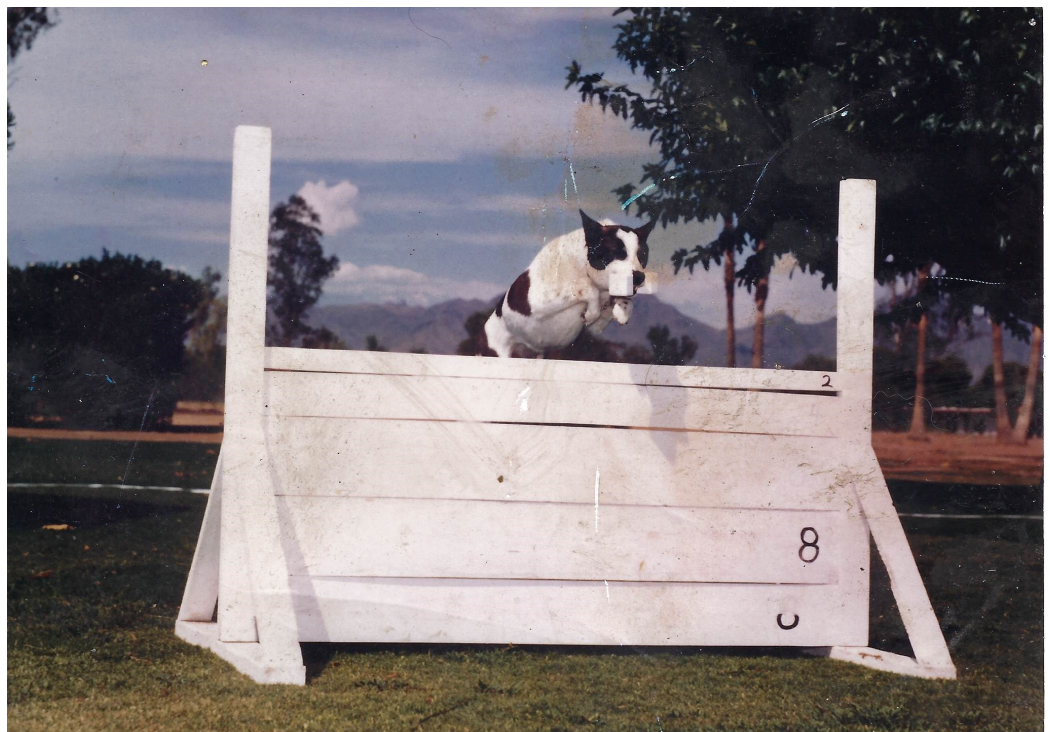

Christina Miller, Ethan Miller, Ms. Amanda Pough and Judy M. Rosenthal are his breeders. He was sired by GCH Rosendog's He Who Must Be Named RN and GCHCH D&J Ha'Aretz Vertigo at River Rock. Christina Miller and Ethan Miller are his owners.

Judges at this year's CDCA National had been recommended or approved by the CDCA membership, and were familiar with the breed. The judges were Dr. Albert P and Mrs. Liz Bianchi, Mrs. Cindi Stansell, Laura King, Mrs. Lili Russell, Mrs. Dr. Kaluzniachi and Mr. Lawrence B. Terricone. Almost all the exhibits were well behaved and typey looking. At the same moment as a sigh of relief in recognition of good behavior was exhaled came the swell of pride that the exhibits looked uniformly like Canaan dogs. How was this look of conformity accomplished? Well, breeders and owners had sized up what judges were likely to prefer, entered the appropriate exhibits, and left the rest home. Around forty Canaans competed in the five shows plus two Sweepstakes.

Ahuvah, trained by Kathy Conro Rohlwing, earned her AKC CDX obedience title while the breed was still in miscellaneous class. This issue of the Kibitzer carries the image of Ahuvah scaling the high jump, a great moment for her owner and the breed.

In May, 1972, Bertha and Jay C. Sheaffer put on the first Canaan dog National Specialty match at Spatterdash Kennels. Everyone attached to Canaans has come a long way since then.
