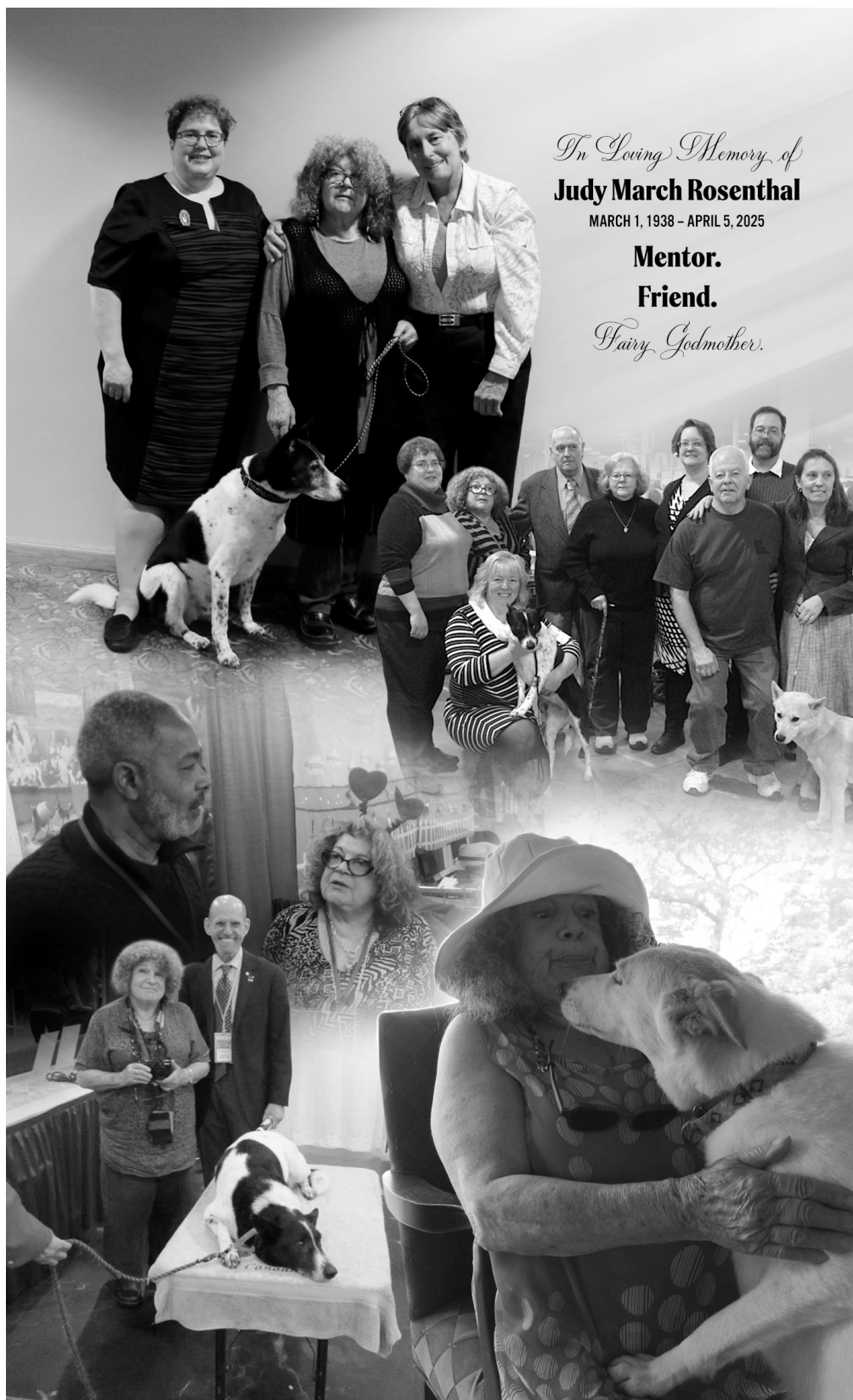

MEMBER OF THE YEAR

Please send your nomination of 250 words or less explaining why a past or present CDCA member should be honored for their past and/or current contributions to the breed and/or club. Nominations of recently deceased candidates will be accepted. If more than one person would like to co-nominate the same candidate, that co-nominator may provide an additional 250 words maximum, for a total of no more than 500 words for the candidate's overall nomination.

DOG OF THE YEAR

Please send your nomination of 250 words or less explaining why this dog should be honored for his/her past and/or current contributions to the breed. Please include all of the dog's titles, breeder, and sire and dam names; this information is not counted in the final word tally of the nomination.

Once received, if the nomination is that of a dog that you do not own, the owner will be contacted to allow them to send in a co-nomination statement about the dog of 250 words or less for inclusion in the ballot, for a maximum total of 500 words. Please note, if you nominate a dog you own or co-own, only the initial write up (max. 250 words) will be published.



If there is more than one candidate for either DOTY or MOTY, information on the nominees will be e-mailed to members and electronic voting will occur. Otherwise, a single nomination in either category by the deadline will be declared the winner as confirmed by the Board of Directors. If no nominations are received for an award, we will not be able to present an award in that category. Winners will be announced at the 2026 National Specialty awards banquet.

THE CANINE of CANAAN

a 3,000-year-old breed returns from its Diaspora



a loud, growling "woof!"

He is the Canaan dog, a rare breed first brought here from Israel in 1965. Despite his ordinary looks, nobody questions his pedigree. Still, he has no choice but to abide by the rules of the American Kennel Club which say that, besides proving his pedigree, he must be bred in at least twenty states for three generations to be recognized here officially.

The lineage of the Canaan dog—in Hebrew, *Kelev C'naani*—goes back three thousand years. He was domesticated and used to keep intruders away from the camps and herds of the Israelites. Queen Jezebel, the Bible says, kept one bound to her throne by gold collar and chain.

The fate of the Canaan dogs was that of their masters. When the Jews were driven out by the Romans the dogs fled to the Negev where they soon reverted to their wild state. Diaspora for man and dog.

Dr. Rudolphina Menzel, dog expert, authority on the origin of the C'naani, and émigré from Vienna to Israel in 1934, was asked by the Haganah to develop a breed suited for protecting settlements and serving in the military. She remembered the tough indigenous breed of ancient times. The test dog was named Dugma, meaning "model." When his redomestication proved a success, Dr. Menzel began a breeding program designed to retain the C'naani's ruggedness. Highly intelligent and easily trained, the dogs have

served the Israeli Defense Force since the 1948 war as sentries, messengers, medic helpers, even as experts in landmine detection. Dr. Menzel founded an institute for the blind near Haifa when she discovered that the C'naani made excellent seeing-eye dogs. At least two eye clinics in the United States are following the lead. One American breeder insists that the C'naani is superior to the traditional shepherd—more reliable, trustworthy, docile and, with a basically white coat, an advantage at night.

IN the ghetto Diaspora of Eastern Europe, dogs were rare among Jewish households. Indeed, the *shtetl* Jew generally held a fear of dogs. "The dog is referred to forty-one times in the Bible and almost without exception with strong disfavor," you learn from the book *The Animals in the Bible*. This disapproval—probably the beginnings of the epithet "dirty dog"—comes from the Biblical era when dogs, traveling in wild, ravenous packs, were regarded as more like their relatives the wolves and jackals, than the domesticated pets we know today.

From the fourteen Canaan dogs imported here, the number has multiplied to eighty-one. Their principal locations are two kennels in Pennsylvania and California.

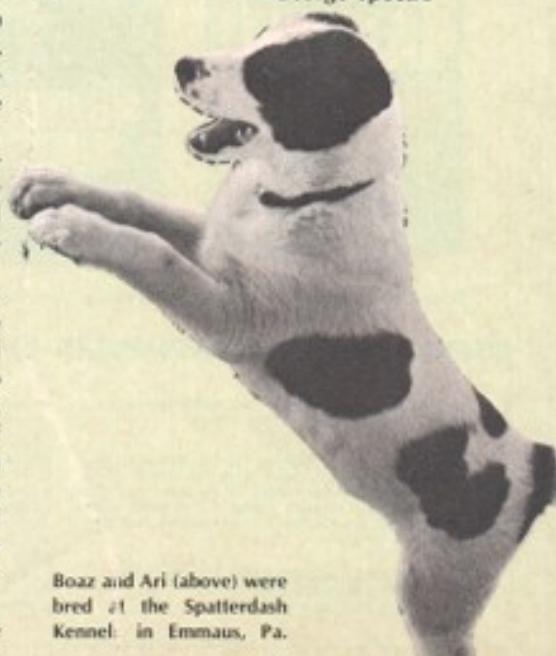
The first four Canaan dogs that immigrated to the United States came September 7, 1965, aboard an Israeli liner. Their arrival culminated two years of correspondence between Dr. Menzel and Mrs. Jack H. Berkowitz of Oxnard, Calif. The first in the eastern part of the United States came in June 1966, when the Jay C. Sheaffers of Emmaus, Pa., decided to add another breed to the Dalmatians at their Spatterdash Kennels.

The C'naani is of two types—one

with pricked ears and smooth coat, the other with button or floppy ears and a rough coat. Their white bodies are streaked with black or red markings and they range in height from nineteen to twenty-four inches. They weigh from thirty-five to fifty pounds. Mrs. Scheaffer finds them to be quick, alert and intelligent, very gentle, yet very good watchdogs. "They have an innate sense of protection," she says.

Israelis do not, as a rule, have house pets. This has less to do with affection for animals than with small apartments and the continuing housing strain. But Israelis who are dog fanciers fancy the C'naani. "They've got a *Yiddishe kop*," says a Foreign Ministry aide who has reared one from puphood. His C'naani is, six days a week, frisky, frolicking, alert to commands. Comes the Shabbat, the dog curls up in a corner of the living room and, no matter what, refuses to be budged. His day of rest too.

Phoenix and Fern: A 2025 Fast Cat Invitational Story

Wednesday, October 15—Saturday, October 18, 2025 at the Roberts, Center in Wilmington, OH

A cacophony of wild barking, crying, whining, woofing, and yipping greeted us as soon as we entered the parking lot in Ohio. We had made it to the right place. And if I had any lingering doubts about the location, Phoenix's excited whimpering upon seeing the Fast CAT course was indisputable proof. He finally knew why we had just spent seven hours towing a camping trailer across Appalachia – he was here to chase the "bunny"!

Phoenix enjoys all kinds of Lure Coursing – he has earned UKC Novice Precision Coursing (RACEN) and AKC Coursing Ability Advanced (CAA) Titles in addition to his AKC Fast CAT (FCAT) Title – but being part of the 2025 AKC Fast Cat Invitational (FCI) was something special for both of us this year. Phoenix had dislocated his shoulder running in the mud earlier this season and I was concerned his "bunny" chasing days were behind him. In addition, I have been recovering from surgery number 4 on my left leg and was unsure if I would be able to manage his wild leaping and lunging at a coursing event. Thankfully, a canine chiropractor successfully treated Phoenix's injury, and I was given a full release from my Dr. before the event, so we made plans to attend the FCI at the Roberts Centre in Wilmington, Ohio.

According to the AKC website, the sport of Fast CAT was introduced in April 2016, after identifying the need for a Coursing Ability Test (CAT) that would be accessible and fair to all breeds, and not just as a pass/fail 600-yard event based on coursing that was originally designed for sighthounds. The Fast CAT organizers decided upon a timed 100-yard dash that included a

handicap for the size of the dog. However, even AKC did not anticipate the growth of the sport into one of the most popular events by number of entries.



Dogs earn points based on their speed and handicap that count toward Fast CAT Titles, and in addition, the Top 5 dogs are invited to the Fast CAT



Invitational each year. Moreover, the Top 20 ranks the fastest dogs in each breed across their lifetime. In 2018, the ranking system was modified to reflect an average of a dog's three best runs to reduce the effects of an atypical run, and in 2021, electronic timers became mandatory because hand timers were not accurate enough. Phoenix qualified for the 2025 FCI as the #3 Canaan Dog in 2024, with an average speed of 27.72 mph, and he currently holds the #9 spot in the Canaan Dog Top 20.

After suffering his early season shoulder injury this year, my only goals for the FCI included that Phoenix successfully completed his qualifying runs, that we all have an enjoyable experience, and no one gets any new injuries. So, in preparation, instead of running Fast CAT events this season, we focused on rebuilding his shoulder strength through hiking and walking fitness. However, Phoenix happened to be the only Canaan Dog in attendance at the Invitational this year, so even though his run times were slower than his personal best of 28.02 mph – he was rewarded for his efforts with the coveted Best of Breed ribbon, in addition to all the other neat Top 5 Finalist swag.

We also met fellow Fast CAT'ers from all over the country. According to the FCI Catalogue, 417 dogs representing nearly 200 dog breeds from 45 States, DC and Canada were registered. We happened to meet the owner of "Fritz," this year's Pure Speed winner (he completed the 100-yard dash in 5.611 seconds!), a Greyhound from Georgia, while getting pizza at a local restaurant. And, because run times were assigned alphabetically, we became friends with the owners of the Cane Corso and Carolina Dog in attendance.

At the conclusion of the events each day, we retired to our camper set up at a nearby Ohio State Park. Fern enjoyed the trip even more than Phoenix, and especially embraced camp-

ing. We all enjoyed downtime exploring the area, including several great hikes at Paint Creek and Rocky Fork State Parks, a visit to Highlands Nature Sanctuary, as well as stumbling across a championship disc golf course at Caesars Ford Park. Chris and I also tried excellent local farm-to-table cuisine, and homemade baked goods from a popular Amish Market. We even discovered that Ohio ranks fourth in Bigfoot sightings nationwide!

In December 2024, Cindy Oxley, Jen Wise, and Tom Cassel joined Annette on the committee. Our first goal was to develop a mission statement and committee responsibilities. The statement was presented to the Board:

CDCA Ways and Means

Mission Statement: The Canaan Dog Club of America Ways and Means committee endeavors to devise, develop, and implement fiscal fundraising plans and projects to progress the breed.

Responsibilities:

- Provide Fundraising Ideas
 - The What
 - The How
- Provide Fundraising Support
 - Brainstorming ideas with other committees
 - Auctions
 - Raffles
 - Sponsorships
 - Sales
 - Logistics
 - How many tables
 - How many items
 - Price points, etc.
 - Troubleshooting
 - Signage
 - Feet on the ground when/where possible
- Set Financial Goals
 - Set an annual goal
 - Determine likely financial outcomes for specific events
- Implement Event Plans
 - Help those hosting events
 - Additional help based upon location and availability

Actions Taken by the Newly Formed Committee:

The committee set an annual fundraising goal of \$5,000. To date, we have raised \$4,500. This amount does not include the 2025 National Specialty revenue because that revenue was a part of their budget. Fundraising is not a part of the 2026 National Specialty because the proposal and budget developer turned that portion of the NS over to W&M.

- 101 Fundraising was provided for all committee members
- The committee co-chair reached out to Star Ott to offer W&M's guidance, suggestions, and help where possible
- The club treasurer was contacted for guidance concerning handling physical monies and was provided. The committee will reach out to the new treasurer for specific guidance.

The Board was asked for a list of needs and expressed a need for a traveling suitcase for MTB. The committee co-chair contacted the Publicity & Ed Chair to offer assistance. We have not been asked for assistance.

A QR code was developed for the club

The committee contacted the Board for permission to use the club logo and contacted the Publicity & Ed committee to garner permission to design signage appropriate for the committee fundraising events. Permission granted and implemented.

Supported Entries

The committee has discussed many ideas to raise funds and decided to focus on fundraising events at Support Entries.

We chose the following:

Bake Sale

Since the auction in Doswell 2024 was so successful, the committee began to discuss fundraising possibilities at Supported Entries:

SE Doswell 2025

This event raised approximately \$3,000: bake sale \$1,029.28

During the four days, we offered a bake sale

Our analysis revealed the following:

Partnering with a local bakery was ideal. They cut portions and packaged them.

Exhibitors who remained for the following Show asked CDCA members where the bake was, so we are now branded in Doswell

We chose not to attempt a drawing because the hosting club conducted one

Silent Auction

The analysis to date has shown the following:

Alcohol, practical items, and dog-themed items are top bided items. There is a need for contributed auction items. Currently, just a few individuals are donating and that is not sustainable

SE Doswell 2025

This event raised \$944

The auction was held over four days

Our analysis revealed the following:

The silent auction was small, but just as effective as the 2024 NS silent auction

SE Concord 2025

This event raised \$909

Items varied

The auction was held Friday and Saturday—Saturday was the better day

50/50 Drawing

Each state raffle law is reviewed

David Golden, attorney, is asked to review the state laws

SE Concord 2025

Net revenue \$220

The critical part is selling tickets

Large item drawing

These items provide maximum revenue when they are donated. Currently, none have been donated, so the committee sought permission to purchase an item with the understanding that the purchase cost would be reimbursed. Permission given.

SE Concord

The wagon, liquor, wine, and beer was valued at more than \$1,200

Liquor purchased was \$608

Gross revenue \$1,060; net revenue \$450

Our analysis shows that alcohol sells, and more revenue is possible if it's donated.

NOTE: Our overall analysis of fundraising events in Concord revealed that our location was a large factor. It was poor. Steps have already been taken to improve that for the 2026 NS.

Director West: Richard Vulliet. Nothing to report since National Specialty. Richard advised that he has not yet seen the final fiscal report for the 2025 National Specialty. Brief discussion, Richard to reach out to Starr Ott, Chair of NS25, to request a final report.

Director-at-Large: Jennie LaPrade. Jennie reiterated Lorna and Christina's comments in appreciation of the outgoing Board.

Committee and Delegate Reports

AKC Delegate Report: Pamela Rosman. Pamela thanked the Board for reappointing her and thanked both BOD and membership for their confidence in her. Pamela reported that she received a request for an update on the CDCA Health Statement; an inquiry whether the CDCA will participate with the Pupdate program; and noted that nominations for the Eddy award are due by September 1, 2025.

Agility Trials: Dan & Julie Haddy. Per AKC, November 2025 Agility Trials approved. Judging premium not yet listed. Trial entry fees raised by \$1, entries open late September. Julie requested rates from local hotels. Dan seeking hands on help from our members.

Committee Reports:

Membership: See attached report from Debbie Friedman.

Herding. Denise emailed Maple Grove Farm, located 45 mins from Concord, NC, asking whether we can hold herding tests there as part of 2026 National Specialty.

Website. Jen Wise offered to hold a tutorial session on accessing the CDCA website and email accounts. BOD members can reach out to Jen for help. Discussion held about possibly forming a new committee that encompasses Facebook and the website content. Committee would put out a call to Club members to share (copyright free) photographs and videos that would be uploaded to the website and the Club's Facebook page. Jen requested that a policy be created pertaining to posts. Christina moved to "Create a content policy for social media which gives

the Social Media Committee the ability to post materials and items that fall within the policy.” Denise seconded, motion passed, unanimous vote.

By-Laws. David Golden is stepping away from this committee and received thanks for his efforts. A new chairperson is being sought.

Publicity and Public Education. Richard invites all CDCA members to be a part of the committee and expressed his opinion that every Club member already is a de facto member of this committee by virtue of having a CD and being able to “promote” the dogs in ordinary settings. Richard expressed a need to cultivate a demand (i.e., good homes) for pups and for breeders to breed more puppies (he estimates that only about 18 pups were born last year). AKC intends to limit Meet the Breeds to NYC (NYC is the only venue that is financially successful), our breed education and promotion efforts need to be more concerted. Satellite (mini) Meet the Breeds events are currently in discussion. Richard suggests that a President’s monthly newsletter be created to improve communications with the Club’s membership. Richard wants to hold Publicity Committee Zoom Meetings and looking for members to be more active. Interested members should email Richard.

Ways and Means. In addition to attached report, Cindy Oxley reported that the W&M committee has made \$4,500 of its \$5,000 fundraising goal for this year. Cindy is exploring the possibility of a supported entry in Doswell, VA March 2026. The W&M committee is gathering auction items for the 2026 National Specialty which will be held in Concord, NC in July. There is a need for a wagon donation for the liquor drawing and a big-ticket item (est. \$500-\$1000). Cindy asked if anyone was willing to contact a business to donate a suitable item. Richard suggested that a big-ticket item could be offered on a limited ticket basis such as \$50/ticket and only have 50 tickets available to increase a person’s chance of winning.

Cindy offered the committee’s assistance to Dan for the November 2025 Agility Trials. She is asking for more people to volunteer for the W&M committee and has submitted a proposed letter to membership in that regard. Christina made a motion to have Cindy Oxley’s letter, calling for member’s help and donations, to be sent to Risa for dissemination to the membership. Denise seconded the motion. Jennie abstained. Additionally, Cindy informed the Board that prizes are needed for the third supported entry, contact Amy Preston; a draft of the program has been started; and noted that the grooming spaces have been changed to a more desirable location. Christina and Lorna said that we should request to be assigned to the same ring throughout so that the dogs remain in a familiar ring. Cindy has sent a list of judges to cluster chair for consideration.

National Specialty 2027. Call for proposals. Denise is talking to her Kennel Club about the possibility of our National Specialty in Wilmington, Ohio (Roberts Center). She will check the dates.

Supported Entry – Philadelphia Kennel Club, November 13-16, 2025. 4 days of supported entries. Tom Cassel reports that this is a benched show. He is working on getting trophies. Jen asked whether the media may be interested in doing a breed spotlight interview of a CD for national TV.

AKC Judges List – Member Questionnaire. The proposal is that we have a sample form where members can report their experiences with judges for those judges possibly to be considered at future National Specialties and Supported Entries. Discussion of this issue was tabled and will be addressed at a future meeting.

New Business

Future Shows – Supported Entries

National Specialty Club Memorial Trophies. Jen requested brochures, slides, and other information which would be useful for the CD booth.

Liora made a motion to allow Jen Wise to use the logo specifically for this 'Big E' West Springfield 2025 event. Christina seconded the motion. Motion passed. Pamela to reach out to AKC to find out local media contacts for West Springfield.

Chris made a motion "Pamela Rosman may forward items regarding AKC matters in her position as Delegate to Jen Wise to be posted on the CDCA website in the members only section". Seconded by Denise. Motion passed by a unanimous vote.

Director East: David Pohl commended Jen and Holly for a great job with an informal meet & greet. He noted that they provided a good representation of the breed.

Director Central: Vacant

Director West: Richard Vulliet had nothing to report.

Director-at-Large: Jennie LaPrade had nothing to report.

Committee and Delegate Reports

AKC Delegate Report - Pamela Rosman's will be sent separately.

Agility Trial – Neither Dan nor Julie Haddy was available for this meeting. In their place, Lorna reported that the agility trial is open; it is listed on our Facebook and website pages.

Judges' Education Report - David Golden informed that there is an Advanced Judges' Institute Seminar on Friday December 12th 2025, at 11 a.m. There will be a 90-minute Breed Standard 'classroom style' Presentation followed by a 'Hands On Exam' from 1.30-2.30 p.m. The AKC requests that 1 or 2 Canaan

Dogs be present during the first portion of the seminar at 11 a.m. and then 6 - 8 Canaan Dogs be present for the 'Hands On' session. It is important that we have the required number of Canaan Dogs available otherwise this section of the seminar will not provide potential Canaan Dog Judges with additional CEU's. Keith Shank has tentatively agreed to bring one of his dogs. Christina Miller can tentatively commit to bringing two dogs. More Canaan Dogs are needed for this event. This is a huge opportunity for educating Judges. Lorna Menaker advised that the AKC prefers that the Presentations do not include dogs who are currently 'Ranked Dogs' or being 'actively campaigned.' Canaan Dogs are a low entry breed and we need dogs for the judges to be able to complete the 'hands on' session. Given these factors, it would be highly recommended that any dogs currently being shown, and should they attend this Judges' Education Presentation, they are advised to refrain from exhibiting to those attending judges to avoid any potential or perceived conflicts for a minimum period of 6 months post the 'hands on.' There is a Judges' sign in sheet which they have to compete prior to the seminar commencing so we should know the names of those attending judges.

Additionally David Golden is requesting photos of Canaan Dogs to use to update Judges' Education Materials - in particular photos of dogs who are not white with black patches or black with white marking (due to some judges having the misperception that the breed standard is white with black markings). We need to educate judges regarding the breed's coat color range and coat patterns.

Lastly, there are judges' requests for ringside mentoring at the Supported Entry in Philadelphia.

Publicity & Public Education – In reiterating his opinion that each Canaan Dog owner is a de facto member of this Committee by virtue of everyday interactions with our dogs in the public, Richard Vulliet discussed several new projects that he is working on, including increased writings/literature to increase interest in the breed and encouraging Club members to give lectures and seminars at community events.

Lorna Menaker thanked Jen Wise for co-ordinating an informal 'Meet & Greet' at the New England 'Big E' event.

The Kib - Amanda Pough is accepting submissions through November 1st

Ways and Means – See attached report.

Website & FB Social Media – The Board thanked Jen Wise for the amazing job she is doing in updating and raising the profile of the CDCA Facebook page. Our Facebook page was recently cloned by a "hacker" and has been reported by several members

Reports from the Board

Lorna Menaker greeted all in attendance

National Dog Show will be televised on NBC Thanksgiving Day. Tom Cassel arranged to have CDs ring time after 10:00 a.m.

Agility Trials – will take place on Thanksgiving weekend. The Premium is now out.

AKC National Championship – will take place in early December in Orlando, Florida. A Judge's Education Seminar for Canaan Dogs will be held. It is one of the biggest and most important opportunities to educate judges on our breed. We need volunteer dogs – at least 6 of them – for hands-on portion of the training.

Meet the Breeds 2026– we will have a CDCA booth at this event on February 7 & 8 in New York City. Pamela Rosman and Richard Vulliet are the co-coordinators. Tom Cassel will

attend and assist.

“Dog of the Day” – On October 28, 2025, the Canaan Dog was featured as AKCs “Dog of the Day” on Facebook. That has led to many social media posts by CDCA members displaying pictures of their dogs.

Vice-President: Christina Houchard Miller thanked committee members and members of the club who are involved and staying involved.

Recording Secretary: Liora Ben-Sorek had nothing to report.

Corresponding Secretary: Risa Baumrind had nothing to report.

Treasurer: Denise Gordon reported the bank balances and a total of \$31,555.46 in assets.

Director East: David Pohl had nothing to report.

Director Central: Alla Geretz had nothing to report.

Director West: Richard Vulliet had nothing to report.

Director-at-Large: Jennie LaPrade had nothing to report.

Committee and Delegate Reports

Public Education and Publicity – Richard Vulliet suggested that members should spread the word about CDs by speaking at community events and the like. He also asks members to send him their suggestions on how to publicize CDs. Denise Gordon thought that articles should again be published in the AKC Gazette

Kibitzer – Amanda reported that the deadline for submissions was extended to November 1, 2025. Liora asked whether the Kib could include a section to welcome new Club Members.

Ways & Means – Cindy Oxley reported that the committee is moving forward with the Doswell, VA Supported Entry (March 2026) efforts. A baker is on board, preparing a menu and price list. Items for the auctions are being collected. There are enough items for the Supported Entry, but items are still needed for the dinner.

Cindy Oxley requested:

an 8-foot banner with the CDCA Logo, or a “pull-up banner.”

A new foamboard. The current one has been used since 2024 and has the logo (which includes “Inc.” in the Club title). The proposed new foamboard would have-of course-the corrected logo, plus a QR code for Paypal, Venmo, or Zelle. Lorna Menaker indicated that Denise Gordon was working on QR codes for Zelle and Venmo.

Cindy updated everyone on the 2026 National Specialty which will take place in July in Concord, North Carolina. While the venue will not permit the Club to hold a food/bake sale, there are plans for fundraising and two drawings (a 50/50 and for a larger item).

Website and Social Media – Jen Wise recommended creating an

Instagram account. Anyone with experience on TikTok can either join the Social Media committee or reach out to Jen for advice. Jen invites members to forward pictures to her for posting on the website and/or Facebook accounts. Examples include Thanksgiving, Christmas, and Hanukah photos.

New Business

Lorna Menaker posed this question to the membership: “How do we increase membership?” Our membership numbers remain the same. As a Club, our challenge is to increase membership numbers. Lorna suggested that if each member were to engage in breed promotion and get one person to join, our club membership could double.

Tom Cassel recounted that, under the prior administration, passed a measure to give all new puppy owners a one-year complimentary membership to the CDCA. Our goal should be to have those members renew at the end of the year. Tom also suggested that new owners be paired with a mentor/experienced CD owner within the same geographic region.

Rosalie Steinberg pointed out that television is helpful to see/promote dogs. Lorna added that there are three television opportunities coming up in the next few months: (1) the National Dog Show in November; (2) the AKC National Championship in December; and (3) Westminster Dog Show in February.

Lorna also suggested that members create videos of their dogs and that the Club put them together and post on YouTube.

Denise Gordon asked the membership for suggestions or recommendations for judges for the June 2027 National Specialty.

Marcia Muller suggested a Zoom Forum where members can gather to ask advice or help.

Laura Fochtman noted that new owners may be unfamiliar with AKC lingo. An introduction to conformation webinar was suggested. Laure also noted that it is difficult for associate members to find a second person re: letter of recommendation for full membership. Tom Cassel’s proposed “buddy” mentor system would be one way to alleviate that situation.

One other observation is a chicken vs. egg conundrum. We need to create more of a demand and additional interest in the breed in order to help breeders produce more puppies. Some breeders will wait until there is enough interest in puppies before breeding a litter.

Morris & Essex dog show is an experience steeped in history like no other whether one attends as an exhibitor, spectator or a judge, it will be etched in your memory. Going back in time almost everyone attending dressed in the 1927-1957 theme era, which is when its creator, the famous Mrs Geraldine Dodge, hosted the show on her husband's New Jersey estate. Mrs Dodge grew up with a great love of dogs and horses, art and had a passion for philanthropy. The last show hosted by Mrs Dodge was in 1957 and it lay dormant until Wayne Ferguson (Cherrybrook Fame) resurrected it in 1996. Wayne brought together a team of distinguished dog people and the first re-vamped show was held in 2000 and it continues every five years on grounds close to the original estate. The total entry was 4455 dogs, with 7 Canaan Dogs entered at this prestigious one day show.

Arriving well in advance of the scheduled 7.30am ring time, it was very autumnal and slightly chilly although the dogs did not seem to mind the cold. Due to traffic delays for exhibitors getting into the show grounds the start time was pushed back to 8am to allow for exhibitors and their dogs to get to their rings. There was an air of excitement as the show day began. Canaan Dogs were first in the ring per the judging program.

There were two class females who were both very lovely examples of the breed, albeit different in style, both had a lot to offer. They gaited well around the ring. Both were of moderate size and substance. My first placed female was white with an attractive desired red mask, owned by Thomas Cassel, Kochav Valentina Deli Shel Ahavah CGC TKN. , bred by Keith Shank, Roberta L Moore &



Cheryl Shank. This moderate size girl had a correct elongated wedge shaped head, dark almond shaped eye and dark lip and nose pigment, good alert expression, erect ears. Moderate bone throughout, body and head were balanced, moderate angulation front and rear. Moderately broad thigh and in good coat and muscle condition. (Winners) My second place female, owned by Jenifer Wise, Amy Preston & Amanda Pough, Bandersnatch Triple R Go Forth And Have No Fear TKN, bred by Amanda Pough & Judy March Rosenthal & Christina Miller, was of a solid red body color with white trim and a very pretty feminine expression enhanced with her dark mask and dark eye. Nice outline with moderate reach and drive on the move. When she got into her stride she moved around the ring in a brisk trot, covering the ground effortlessly. She does need a little more ring experience to bring her out of herself and make her shine, she is a lovely girl. (Reserve Winners).



BOB competition there were 2 males and 2 females present, with one Special female absentee. The males were both distinctly masculine and the females feminine.

My BOB winner today was GCHG CH Revelation Adiva Aviva Of Samara. Owned by Pamela S Rosman & Phillip R Vulliet and bred by David Golden, Cynthia Dodson & Donna Dodson. A very typical Canaan Dog in stature, medium size and moderate throughout. Coat of White with Black markings and ticking. Pleasing elongated wedge shaped head with dignified expression and correct erect ears slanting slightly forward. Excellent well arched neck flowing into a moderate forequarters and shoulder placement matching an equally moderate rear angulation. Forequarter legs were straight. Flexible pasterns with a very slight slope.

Chest was moderately broad and deep reaching to the elbows. Correct catlike feet. Her double coat was flat lying with the outer coat of desired harsher texture. Held her top-line gaiting around the ring in a tireless trot giving the appearance of endur-

ance and the ability to change speed and direction instantaneously. Her flawless breed specific movement on the day won her Best Of Breed. She was presented in excellent condition, was well muscled and expertly handled to perfection.

My BOS today was GCH Woodland West's Front Runner owned by Ann Murphy Daily, bred by Kent Clark. A good size male with excellent bone and substance. Coat color white with large black body patches, markings and ticking on his legs. Masculine wedge shaped head, low set ear. He is another very impressive quality dog of good size and moderate substance with moderate angulation front and rear. His outline was held on the move, he has a slight arch of neck, strong top-line, high tail set with one full curl and carried over his back. He covered ground in a breed specific brisk tireless trot and coming towards me he presented the correct slight convergence. He was agile and gave the impression to be able to change direction and speed in an instant.

Select Dog, GCHS Revelation Aharon Aviv BCAT CGC TKN FITB, owned by Mr Richard and Mrs Marianne Vargas, bred by David Golden, Cynthia Dodson & Donna Dodson. An honest and impressive up to size male with a lot to like about him. He was predominately white in coat color with the desired red mask. His handsome wedge shaped head and alert expression was enhanced by his dark eye and alert, erect ears, set moderately low. He was moderately balanced in front and rear angulation. He gaited

around the ring in a ground covering tireless trot. His gait was clean going away and around the ring, he held his top-line. Beautifully handled and presented in good double coat of medium length, dense soft undercoat, a correct pronounced ruff, and a very correct thick brush tail carried over his back presenting a very pleasing outline and overall picture.

Select Bitch GCH CH

Eastlands Revelation Ellenni Zarah Hadash BCAT CGC FITB, owned by Marianna Vargas & Richard Vargas & Lenni Brett Cipriotti, bred by David Golden & Cynthia Dodson & Lenni Brett Cipriotti & Annette Israel & Angele. Coat color predominately white with a few red body patches and correct red mask. Overall of medium size, moderate and appropriate bone substance. An appealing head and expression enhanced with her dark eye and dark rim pigment, dark nose pigment all

giving a very appealing alert expression. Good depth of chest extending to elbows, slight arch over the loin and moderately broad upper thigh. She covered the ground well with a brisk trot around the ring and her tail carried up over the back. Nicely presented.



Overall the quality of Canaan Dogs I had the honor of evaluating was remarkable. They distinctly created a good overall representation of the breed and good breeding stock which is what the judge is evaluating. Thank you to all who brought their Canaan Dogs for my opinion. It is always an honor to judge the breed and a great pleasure to see how well the breed is doing.

Six Things You Need to Know About the AKC PAC

- 1. What is the AKC PAC?** The American Kennel Club Political Action Committee (AKC PAC) helps elect dog-friendly candidates. The purpose behind the fund is to protect your rights as a breeder, dog owner and fancier by helping elect leaders who share that commitment.
- 2. What makes the AKC PAC different from other AKC funds such as the Canine Legislative Support Fund (CLSLF)?** CLSF contributions are used to educate officials on a federal, state and local level to ensure that your rights as a responsible owner and breeder are protected. Without dog-friendly officials in office; however, the CLSF cannot do its job. AKC PAC funds are used to help elect dog-friendly leadership in Congress and state legislatures across the country. PAC funds can only be used as campaign donations and not to lobby or educate an official on a particular position.
- 3. Who can contribute to the AKC PAC?** AKC PAC accepts contributions from United States citizens who are members of AKC-affiliated clubs, AKC employees, and a small number of other groups as limited by federal and state campaign finance laws. Although clubs may not contribute, they may hold fundraisers for the PAC or provide opportunities for their members to contribute. For example, a club may allow members to include a PAC contribution when paying their regular dues. The club may then forward the contribution to the AKC PAC. Clubs may also choose instead to contribute to the CLSF. Contributions other than AKC PAC and CLSF are not tax deductible.
- 4. How does the AKC PAC benefit dog owners?** The PAC allows the AKC to support dog-friendly candidates and elected officials. The more dog-friendly officials in office, the more assured you can be that your rights will be protected.
- 5. May I recommend candidates for AKC PAC contributions?** You may advise the PAC about officials who have assisted in either promoting dog-friendly legislation or opposing anti-dog measures. You may also suggest new candidates who you believe will support dog owners. Names of those you feel deserving of PAC funds may be submitted to the AKC PAC Board through the AKC Government Relations Department. Contributions may not be given on behalf of a specific candidate.
- 6. How can I help the AKC PAC acquire donations?** You can make a personal donation or encourage club members to each contribute to the PAC. You may also ask clubs to hold a fundraiser for the AKC PAC or allow members to include a PAC donation in their dues. Remember - without donations to the PAC the AKC cannot support the campaigns of dog-friendly candidates!
