Upon final payment by CLIENT, CLIENT is granted limited license to use and or display resulting images as outlined in Usage Rights on p2 of this document. Said images may not be altered or used in any manner outside what is prescribed in this document without prior written permission of Paul Mordecai Rosenberg Photography. The CLIENT must obtain written permission from and compensate Paul Mordecai Rosenberg Photography prior to the CLIENT, its associates, friends or relatives re-distributing or selling the photographs for any reason not prescribed in this document.
