****PLEASE READ & INITIAL EACH SECTION****

1. _____ Remi's K9 Academy & Pet Resort, LLC reserves the right to immediately change each pet's type of boarding or daycare, if we believe it is necessary, to protect the health and well-being of the pet, other pets, or our staff. Owner agrees to pay additional costs associated with the change.
2. _____ Owner agrees to pay all costs and charges for special services requested, and provide updated vaccination records from the owner's veterinarian before coming to Remi's K9 Academy & Pet Resort, LLC for boarding, daycare, training, or grooming.
3. _____ Owner agrees to give twenty-four (24) hours notice of a non-holiday and/or forty-eight (48) hours notice of a holiday boarding stay if canceling their reservation. If owner fails to calls to cancel any reservation within the stated time frames, owner agrees to be charged a 15% fee of the total cost for the reservation.
4. _____ Owner agrees that the pet(s) shall not leave Remi's K9 Academy & Pet Resort, LLC until all charges are paid in full.
5. _____ Owner agrees to be solely responsible for any and all acts or behavior of the owner's pet(s) while in the care of Remi's K9 Academy & Pet Resort, LLC.
6. _____ Owner specifically represents that they are the lawful and valid owner of the pet(s), free and clear of all liens or encumbrances.
7. _____ Owner specifically represents that the pet(s) has/have not been exposed to rabies or distemper within thirty (30) days prior to boarding.
8. _____ Owner agrees that in the event the boarding charges are not paid when due in accordance with this agreement, Remi's K9 Academy & Pet Resort, LLC may exercise its lawful right upon ten (10) days written notice delivered via first-class mail to the owner's address. A pet that is unclaimed at Remi's K9 Academy & Pet Resort, LLC for ten (10) days beyond its scheduled discharge date is considered abandoned and will become the property of Remi's K9 Academy & Pet Resort, LLC. Every effort will be made to contact the owner if abandonment becomes an issue. If, for any reason, the pet is not going to be picked up on the scheduled dismissal date, the owner shall contact Remi's K9 Academy & Pet Resort, LLC to make arrangements to extend the animals stay, and will pay the additional charges based upon the aforesaid nightly rate.
9. _____ If a pet becomes ill or if the state of the pet's health otherwise requires attention, Remi's K9 Academy & Pet Resort, LLC, at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the animal up to and including \$200 or \$_____, whichever is greater.**

10. ____ If a veterinarian determines that emergency treatment, which **exceeds** the authorized amount, is needed to save the pet's life or quality of life, and Remi's K9 Academy & Pet Resort, LLC cannot reach the owner, or the emergency contact, Remi's K9 Academy & Pet Resort, LLC may authorize the veterinarian to perform the emergency treatment. Owner agrees to be responsible for all veterinarian costs provided to the pet.**

**If the owner does not agree, DNR (do not resuscitate) may be written with the owner's initials.

11. ____ Owner agrees to release, indemnify, and hold harmless Remi's K9 Academy & Pet Resort, LLC from any and all manner of damages, claims, loss, liabilities, costs and/or expenses, including reasonable attorney's fees and/or related costs, arising out of or related to Remi's K9 Academy, LLC's services, except which may arise from the gross negligence or intentional and willful misconduct of Remi's K9 Academy & Pet Resort, LLC, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Remi's K9 Academy & Pet Resort, LLC, (ii) your pet(s), including but not limited to destruction of property, animal bites, injury, and/or transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.

12. ____ This agreement shall be governed by and construed in accordance with the laws of the state of Missouri. Each party consents to the exclusive personal jurisdiction of the state and federal courts of the state of Missouri. The owner and Remi's K9 Academy & Pet Resort, LLC must negotiate and mediate in good faith prior to either party filing a cause of action.

13. ____ Force Majeure. Neither owner nor Remi's K9 Academy & Pet Resort, LLC shall be responsible for failure or delay in performing its duties under this agreement, if such failure or delay is due to tornadoes, thunderstorms, fire, floods, drought, riot, war or other acts of nature.

14. ____ Entire agreement. This agreement, and any addendums attached, constitutes the entire agreement between parties. All terms and conditions of this agreement shall be binding on the heirs, agents and assigns of the owner and Remi's K9 Academy & Pet Resort, LLC.
