ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

In consideration for permitting me to participate in any way in the CCW Permit training and instruction being offered by Teng Artillery Vault (hereinafter "Sponsor"), a DOJ and NRA certified firearms instructor, who provides training, a training facility located at 871 Sperling Parkway, Lincoln, CA 97867 ("Premises"), and the use of various shooting ranges ("Range"), which include instructor-administered live ammunition firearms use and activities, and non-lethal projectile training weapons, I, for myself, my legal representatives, agents, successors, heirs, and next of kin:

Initial Here	HEREBY ACKNOWLEDGE that firearms and firearm ammunition may be hazardous in nature and may cause substantial injury to persons and property. I recognize the inherent dangers associated with shooting, including, but not limited to: loud noise, flying or rebounding bullets, fragments, smoke, dust, exposure to lead, uneven surfaces, and similar issues. Moreover, I recognize that exposure to such environments can result in personal injury, loss of hearing, loss of eyesight, and other health hazards up to and including death. I also understand that others will be using the Premises and Range, and I acknowledge that others are present. I also acknowledge the presence on the Premises and Range of signs posted under Proposition 65 warning of hazards to exposure to chemicals known to cause cancer by the State of California, such chemicals including, but not limited to, lead, and I have the opportunity to ask for and receive a list of all such known cancer-causing chemicals on the Premises and Range.

Initial Here	With these facts in mind, I VOLUNTARILY ASSUME ALL RISK OF INJURY to my person and property, and WAIVE the right to bring any and all claims against Sponsor, the Premises and/or Range owners or any of their officers, directors, members, employees, agents, administrators, successors, and assigns (hereinafter collectively the "Released Parties") from all claims, demands, and causes of action, foreseen and unforeseen, relating to or arising out of death, personal injuries, sickness, damages to property or property rights, and every other loss and expense, arising out of or in any way connected with my participation in firearms activities on or appurtenant to the Premises and/or Range, except as to Sponsor's willful, intentional or criminal acts. I will not take any legal action contrary to this RELEASE OF LIABILITY. I also agree to be responsible for, furnish, or purchase, and wear appropriate eye and ear protection at all times on the Range.

Initial Here	I further WAIVE for myself and for my executors, legal representatives, successors, heirs, and next of kin, any and all rights and claims for damages, losses, demands, and any other actions or claims whatsoever, which he/she may have or which may arise against Sponsor and any of the Released Parties, which may in any way whatsoever, arise out of, be related to, or be connected with the use of the Premises and/or Range and for any course of instruction offered on the Premises and/or Range. I, on behalf of myself and on behalf of my executors, personal representatives, administrators, assignees, heirs, and next of kin, hereby EXPRESSLY RELEASE Sponsor and all the Released Parties from all such claims and liabilities.

Initial Here	I EXPRESSLY ASSUME THE RISK of taking part in activities on the Premises and/or Range, which include, but are not limited to, instruction in the use of firearms, the discharge of firearms, and the firing of live ammunition. I acknowledge that I understand that firearms are inherently dangerous, and, as such, any injuries or accidents that occur while I am on the Premises and/or Range, or while engaged in range, or firearms training activities, whether due to weapons malfunction, or due to my negligence or mishandling, are not the responsibility of Sponsor or any of the Released Parties. I understand that Sponsor has the right to inspect any firearms, ammunition, accessories, case, bag, or equipment I bring onto the Premises and/or Range upon request.

Initial Here	I acknowledge that I will read and agree to comply with the Range Safety Rules that will be provided to me at the shooting range. I also acknowledge that the Range(s) are kept as natural as the shooting activities allow and may pose additional hazards. I further agree to obey all other posted or communicated safety and range rules and obey all instructions by the Range Manager and Sponsor staff. I understand that failure to obey the Range Safety Rules, any rules or instructions I receive, or to allow inspection of items I have on the Premises and/or Range may result in removal from the training activities, expulsion from the training class, or other disciplinary and remedial action as the Sponsor management deems to be appropriate. I further understand that I must use caution accordingly and EXPRESSLY ASSUME THE RISK of encounters with these elements while using the Range and/or Premises.

Initial Here	I VOLUNTARILY AGREE TO EXEMPT and relieve Sponsor and all the Released Parties from liability for personal injury, property damage, or wrongful death caused by the negligence of another, including releasing Sponsor from liability for any claim I could assert based upon personal injury. I also AGREE TO immediately DEFEND, INDEMNIFY, AND HOLD HARMLESS Sponsor and any of the Released Parties from and against all claims, losses, damages, and costs (including attorney's fees and costs of suit) caused by, arising out of, or related to the actions of myself, and those third parties for whose conduct I am expressly or implicitly responsible whether such duty arises under this agreement or by operation of law. But for this agreement to defend, indemnify, and hold Sponsor harmless, Sponsor would not allow me enrollment in the training activity or entry onto the Premises and/or Range or to engage in live ammunition firearms activities. Should Sponsor or any of the Released Parties be required to incur attorney's fees and costs to enforce this agreement, I agree to INDEMNIFY AND REIMBURSE Sponsor and any of the Released Parties for such fees and costs.

I certify that I am at least 21 years of age and may lawfully own and operate firearms within the State of California and that I am not disqualified from possessing firearms or a prohibited person by operation of California or federal law. I understand that Sponsor is further relying on this representation to allow me access to the training activities and the Premises and/or Range. If I am furnished with ammunition from Sponsor, I agree that I will not remove such ammunition from the Premises and/or Range.

I acknowledge that information provided to me in connection with the Class ("Class Information") is for the sole purpose of my instruction and/or participation in the Class. I acknowledge that I do not intend to and will not use Class Information to instruct others. I also agree to hold harmless and to waive, release, and discharge the Released Parties from and against any and all Claims arising out of or in connection with my use of the Class Information.

I grant to Sponsor the permission to reproduce, publish, distribute or otherwise use in any reasonable manner my name, photograph, likeness and statements ("My Information") in connection with the promotion of the Class (or other similar Classes) in all media, including without limitation, the internet, news articles, advertisements, or other electronic or printed materials. I also agree to hold harmless, waive, release and discharge the Released Parties from and against any and all Claims arising out of or in connection with the use of My Information, including without limitation, any and all claims for invasion of privacy, publicity, defamation and/or portrayal in a false like, copyright infringement, and any claims and/or demands for compensation and/or royalties.
