### BACKGROUND

- A. The Client is of the opinion that the Contractor has the necessary qualifications, experience and abilities to provide services to the Client.
- B. The Contractor is agreeable to providing such services to the Client on the terms and conditions set out in this Agreement.

**IN CONSIDERATION OF** the matters described above and of the mutual benefits and obligations set forth in this Agreement, the receipt and sufficiency of which consideration is hereby acknowledged, the Client and the Contractor (individually the "Party" and collectively the "Parties" to this Agreement) agree as follows:

### SERVICES PROVIDED

1. The Client hereby agrees to engage the Contractor to provide the Client with the following services:
  - Transport Mini horses to appointed location.
  - Provide educational materials, grooming tools, and safety instruction to participants.; and
  - Monitor and guide organized participant interaction with Minis.

### TERM OF AGREEMENT

2. The term of this Agreement (the "Term") will begin on the date of this Agreement and will remain in full force and effect until the completion of the Services, subject to earlier termination as provided in this Agreement. The Term may be extended with the written consent of the Parties.

### COMPENSATION

3. The Contractor will charge the Client for the Services as follows (the "Compensation"):
  - Client will provide a free-will donation in the amount of \$275.00 prior to scheduling of event. An additional charge of .50 cents per mile will be charged for any site exceeding 50 miles from 2717 Gaston Farm Rd, Chester, SC 29706.
4. Compensation is due at the signing of this agreement.
5. The Contractor will not be reimbursed for any expenses incurred in connection with providing the Services of this Agreement.

### CONFIDENTIALITY

6. The Contractor agrees that they will not disclose, divulge, reveal, report or use, for any purpose, any Confidential Information which the Contractor has obtained, except as authorized by the Client or as required by law. The obligations of confidentiality will apply during the Term and will survive indefinitely upon termination of this Agreement.

**INDEMNIFICATION**

Except to the extent paid in settlement from any applicable insurance policies, and to the extent permitted by applicable law, each Party agrees to indemnify and hold harmless the other Party, and its respective directors, shareholders, affiliates, officers, agents, employees, and permitted successors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, reasonable legal fees and costs of any kind or amount whatsoever, which result from or arise out of any act or omission of the indemnifying party, its respective directors, shareholders, affiliates, officers, agents, employees, and permitted successors and assigns that occurs in connection with this Agreement. This indemnification will survive the termination of this Agreement.

**MODIFICATION OF AGREEMENT**

- 9. Any amendment or modification of this Agreement or additional obligation assumed by either Party in connection with this Agreement will only be binding if evidenced in writing signed by each Party or an authorized representative of each Party.

**Safety Instruction for Discussion Prior to Minis on the Move’s Visit**

- Always speak to a horse with an inside voice.
- Approach from the side, to avoid his "blind" spots which are directly in front of and behind him. Touch him first on the neck or shoulder.
- Do not run around or cause commotion while near the horse as this may provoke him to startle.
- Stand near the shoulder or next to the hindquarters rather than directly in front of or directly behind a horse when grooming his head or brushing or braiding his tail. To walk behind a horse, go either (1) keeping one hand on his rump as you pass around; or (2) far enough away to be well out of kicking range.
- Be mindful of a horse's feet while you're working around him, as horses are often careless about where they step.
- We recommend that all participants wear closed toe shoes for safety.
- We will divide into groups to ensure each participant an equal amount of time and enhance their experience with the minis.
