LFWI Annual Council Meeting Saturday 11th April 2026 – Our ACM will be held at the Lowther Pavilion Theatre on Saturday 11th April 2026 from 1 pm – 4.30 pm. We are following the same procedure as the 2025 meeting in that we are asking WIs to reserve their free delegate ticket in advance. Each WI is entitled to send a delegate to the meeting. Make and Create Team A Day of Slow Stitching Tuesday 20th January 2026 - 10 am - 3 pm

Come and spend the day enjoying the art of Slow Stitching. Slow Stitching is a mindful, creative approach to needlework with the emphasis on relaxation and the process of crafting. Using simple hand stitching techniques, Linda will guide you in creating a piece of stitched work using materials in a sustainable way.



The stitched piece will be created using a background of calico. The piece will be created using fabrics, embroidery, reusing perhaps a favourite fabric or lace, buttons, and embroidery. It will be a day where you can use your creative freedom, with Linda guiding you to use different materials, stitches, and designs.

Once completed, the design can be used as you would wish, perhaps to back a book, sew into a bag, or begin a stitched journal. The ideas will be your own.

Linda will bring to the day many years of creative experience and expertise to help you be creative, but also to enjoy the mindful experience of letting your needle create something beautiful and sustainable.

Linda will provide a kit including the calico, wadding, and access to many scraps of materials, laces, buttons, embroidery threads etc. This will be £5 and payable to Linda on the day. Also, bring your favourite fabrics from home that you might like to include, perhaps from a favourite or sentimental piece.

Bring your sewing kit, including scissors, needles and pins etc. This workshop is suitable for all, even beginners.

From the NFWI to WI members: Five Practical Pledges

Yesterday was WI Day, marking 110 years since the first WI meeting took place at Llanfairpwll WI on Anglesey, and we were very excited to celebrate this occasion.

On WI Day 2024, we asked you, our members, to help us shape the future of the WI and share your thoughts about everything WI related, from subs, to meetings, to the magazine. The feedback has been brilliant. Thousands of WI members wrote letters and emails, hosted and attended discussion sessions and shared your views. The NFWI team visited hundreds of you, sharing some brilliant and inspiring conversations, which demonstrated to us how much pride we all have in the WI and that we want to pass this organisation on to more generations of women, stronger and better than ever.

We have used that feedback to launch step one of the new plan – our Five Practical Pledges from NFWI to you as members, reflecting the areas you want us to improve upon. Based on the feedback received, the NFWI Board is committing to the following actions over the next 5 years:

- 1. Review the percentage allocation of the annual membership subscription to ensure that our WIs are financially sustainable and able to offer a vibrant and varied programme for their members. This will ensure they continue to thrive. You told us that with rising costs such as venue expenses, a greater percentage of the membership fee allocated directly to WIs is essential to help you give the very best experience to your members. We will focus on this in our annual discussion with National Council about the subscription to make sure you have the vital resources you need.
- 2. Review and extend the membership model. We must build in options that work for women at every stage of their lives. We heard from you that the current model doesn't offer enough flexibility (for you or for the women you are trying to recruit). You also said that other organisations have more fluid membership models. We're going to undertake a fundamental review of the membership model and explore ways we can offer more flexibility to both existing and potential members. This is a huge piece of work, but it's essential that we get the offer right for women in the 21st century.
- 3. Launch a new approach to setting the NFWI's campaigning priorities (our 'resolutions process'), ensuring that member voice and experience remains at the heart of it and offers all WI members the chance to have their say. In the consultation process we were honest and shared that the process no longer works perfectly for us nationally as a campaigning organisation and you were honest in your feedback that it really doesn't work for you either! The process feels burdensome and too fast, with new priorities and information coming out too frequently.



4. Introduce a revised system for member data collection, storage and analysis, to replace the existing MCS system and ensure NFWI can better tailor its services and products for members, while also supporting administration and communication. In our consultation, it was clear that many of you feel very strongly that the WI could be better at customising its offer for you (and be able to do this for each successive generation of members).

You also shared that sometimes the administration of your WIs is unnecessarily difficult and that you would like technology to support you to make it easier. As our current system (the MCS) heads towards retirement, we will ensure that a new system is designed and launched that better enables you to run your charities and better enables NFWI to know who you are and what you want.

5. Undertake a comprehensive review of WI Life magazine to revisit the balance of adverts and editorial content, while maintaining the high quality and cost-effectiveness of the magazine. We have heard from many of you that you wish to retain the magazine (particularly those who are less digitally active) as a way of feeling part of and belonging to the wider organisation and celebrating the achievements of fellow members. We also know many of you use the magazine as a recruitment tool in your communities. We remain committed to offering the magazine, but we have heard your thoughts on the content and advertising and will ensure this is reviewed and revamped to better reflect our members now and those of the future.

The second step will come at the start of 2026: the **Vision Statements and Strategic plan**. These will look at the aspects of our work which can have the greatest impact on our future strength, helping the WI appeal to new audiences of women. These statements will challenge us all to look differently at the work we do, try new things and consider the needs of women who aren't yet in the WI family.
