NOMINATIONS FOR ELECTION TO THE BOARD OF TRUSTEES 2027-2030

We are currently inviting nominations for the Lancashire Federations of Women's Institutes Board of Trustees. If anyone is thinking of applying to go on the LFWI Board, LFWI Chair Heather Williams will be holding a coffee morning on Friday 16th October at 10.30am This is advertised separately in this mailing.

RULES FOR THE ELECTION: The Board of Trustees consists of a minimum of 6 elected members and a maximum of 10 members who represent all the Institutes in the Federation and who have the power to co-opt to a maximum of 15 under the terms of the current articles of association.

- Candidates must be nominated by a Women's Institute or by a member of the current Board of Trustees, both of whom shall be entitled to submit up to 10 nominations.
- The election if required, will be conducted by ballot postal or electronic.
- Any member of a Women's Institute who has paid her subscription for the current year shall be eligible for nomination provided she is not a salaried official of the Federation or a member of the Board of Trustees of another County Federation.

INFORMATION FOR PROSPECTIVE CANDIDATES:

- The Board of Trustees meets once a month on the 3rd Thursday at the WI Office, the meetings usually last from 10.00 a.m. to approximately 2.30 p.m. The first meeting of the newly elected Board of Trustees will be held on **Monday 12th April 2027 at 10.00 a.m.** for the election of officers.
- Petrol expenses or public transport expenses are paid quarterly.
- Board members may be required to sit on a team (formerly known as sub-committees) as Board Liaison, attend Council Meetings, Federation events and represent the Federation at other meetings and conferences at the invitation of other organisations as requested and attend other meetings as required. They may also be asked to undertake additional responsibilities as part of their role as a Trustee.
- Regular training for members of the Board of Trustees is available.
- Members of the Board of Trustees are Charity Trustees of the LFWI, which is registered with the Charity Commissioners, and will become Company Directors whose details are recorded and registered with the Registrar of Companies at Companies House. Under the Articles of Association of County Federations Trustees are not allowed to be paid. Membership of the Board of Trustees is rewarding as it gives an opportunity to bring new ideas and skills to help the development of the Federation.

ADVICE ON FORWARDING NOMINATIONS: Please send any nominations on the enclosed form. Extra forms are available from the Federation Office if required. The **written consent** of a new nominee must be forwarded with her nomination, along with some biographical notes, including details of WI work, which will be circulated with the ballot papers if an election is necessary. Members currently serving on the Board of Trustees need to be nominated, with their permission, but you do not need to seek their written consent.
