General InformaTion

Membership of management committee

- (1) The Management Committee of the association consists of a President, Vice President, Treasurer, and three other members elected at a general meeting.
- (2) A member of the Management Committee, other than a Secretary appointed by the management committee under rule 15(1)(b)(iii), must be a member of the association.
- (3) At each annual general meeting of the association, the members of the Management Committee must retire from office, but are eligible, on nomination, for re-election.
- (4) Retiring members of the Management Committee shall be eligible for re-election without any requirement that they be nominated thereto but if a retiring member wishes to seek re-election that member must notify the Secretary in writing not later than 14 days prior to the Annual General Meeting.
- (5) A member of the association may be appointed to a casual vacancy on the management committee under rule 21.
- (6) A Management Committee member cannot also be an employee of the Association.
- (7) A maximum of one family member may serve on the Management Committee at one time.
- The first 2 pages of this form is to be filled out in full and emailed to <u>secretary@wynnummanlytouch.com.au</u> by no later than close of business the 23rd of July 2025.
- A list of nominated candidates will be posted on website, Facebook and emailed to all members at least 7 days prior to the AGM.
