USFS: 21 ac to be burned @ Observatory Campground; 11 ac behind Palomar Sta; 13 ac @ Fry Creek; NIPA/Surveying completed for Conifer firebreak. Burn Permits available.

CERT: None

PMVFD: Land donation and new crew quarters both proceeding.

PMPO: Articles for News letter due mid-April. CB willl write for PMFSC.

Active Grants: CCI - Forester Tim Morin to write CEQA for the 12+- acres involved @ cost of \$5K by end July. Can request up to 25% of grant funds at a time. How long to be funded? RC and Lee Silvesi of StumpMasters will write contract for brush clearing. Honeysuckle Trail in Bailey Meadow should be done if we have enough \$.

SDGE - MW will apply; applications we be out in next 3-4 weeks, due 2 wks after that.

NRP - Still have \$ for chipping and several dumpsters. Next dumpster April 3-10, space and weather permitting.
