7.) Presentation(s) (15 Minutes per presentation)

1. Lorene Lynn: Soil Scientist / Restoration Ecologist, Red Mountain Consulting – UAF graduate, 31-year Alaska resident. Primary subject tonight is to talk about wetlands. Update on current regulations. The best approach to wetlands regulations is to work collaboratively with governing agencies. Lorene's specialty is functioning as a facilitator for collaboration between landowners and agencies. Information handouts provided to attendees. Audience request: Please talk about the 2023 US Supreme Court Sackett decision, and its importance for Alaska. 2. Keith Dodson: Proposal for Big Lake; forming a community development cooperative, based on the 2008 Big Lake Comprehensive Plan, with expansion to include organizing as a cooperative, establishing a Special Use District (SPUD) and exploring fundraising strategies for purchasing a 42-acre parcel that is currently for sale in an area near local businesses, and could serve as an identifiable multi-use town center for the Big Lake community. Information handouts provided for attendees.

8.) Reports

1. Legislative (State House & Senate)

Senator Shower: Not available

Representative McCabe: It's good to be back. Provided updates on current legislation, meetings with US legislators, Murkowski, Sullivan & Begich, status of the Alaska state budget, and the Port Mackenzie Rail Spur project. Update on coming reductions in EPA regulations. Heads-up that future Community Assistance Program (CAP) amounts will be significantly decreased. Available to answer questions after the meeting.

2. Assembly (District 5)

Assemblyman Gamble: The MSB budget passed, with a decrease in mil rate. However, property tax bills increased for owners, due to higher property value assessments. Big Lake Lions Club property and adjacent parking lot will be purchased, staffed, and managed by Mat Su Borough. Additional \$26k secured for the Jordan Lake Park project. Updates on other legislation currently in progress.

3. Fire Service (West Lakes Fire Department – WLFD) Fire Officer McCabe provided the monthly callout tallies. Safety reminder: burn barrels are a common source of both wildland and structure fires. WLFD has posted a map of the Big Lake area in the Lions Club meeting room, showing where smoke and CO alarms have been installed, and where subsequent fire calls have shown lives saved by alarm installations. Update from Cathi Kramer on the complementary fire & CO alarm grant program, street address sign program, and community Firewise program 19-year anniversary.

4. Road Service Area: Terry Gorlick – update on most recent meeting and announced Andrew Traxler as Big Lake RSA Primary. Meetings will be changed from monthly to every other month, and held at Station 7-3 to facilitate Zoom attendance by interested community members.

1. Lake Setback Ordinance & Waterbody Setback Advisory Board – Update: The current revised legislation was presented to the assembly on May 20, 2025, and was referred for 120-day MSB Board and Planning Commission review. According to information posted on the MSB website:

"The Assembly has referred the draft Ordinance to the Transportation Advisory Board, The Agriculture Advisory Board, The MSB Fish and Wildlife Commission, The Parks, Recreation & Trails Advisory Board, The Water and Wastewater Advisory Board, and the Planning Commission. Staff mailed info to each Community council in the borough. The public hearing for the Planning Commission Resolution is August 4, 2025." The public comments period is open, with comments due by August 20, 2025.
