Mr. Mayfield expressed significant concerns about provisions of the proposed legislation that would adversely affect hundreds of property owners in the Big Lake area. According to Dan, the work of the committee was intended to provide a more workable pathway for homeowners to bring non-standard properties into compliance. Instead, it appears that the proposed legislation would make it significantly more difficult for owners to utilize their property.
