

**7.) Presentation(s) (15 Minutes per presentation)**

1. Mike Buck (Alaska Safe Riders). Provided short video presentation to attending members. Also recommended attendees listen for Alaska Safe Riders radio advertisements. Alaska Safe Riders has been in existence for 40+ years. Alaska Safe Riders organizational mission: To promote safe and responsible practices with users of multi-use vehicles (ATV, Snowmachine, Side-by-Side, etc.) in Alaska. 2. Glory Dollerhide (Public Health Nurse – State of AK Department of Health, Mat Su Public Health Center) Travels as an itinerant nurse to various communities in the area. Interacting with community members and learning what health needs need to be met and identifying resources. Public health addresses infectious diseases, promotes childhood wellness, and works in TB and STD prevention. Alert: there is currently an outbreak of pertussis in Alaska. Updates: measles risk in Alaska (low), but TB risk is on the rise again. Notice: the public health express clinic is open on Tuesdays and Thursdays from 2-4pm (no charge) at the main facility (3223 E Palmer-Wasilla Hwy Unit 3, Wasilla). Giardia alert: Summer is the time of higher risk for both humans and pets... Wash hands, beware of untreated water from lakes, streams, rivers, etc. Recognition and appreciation: Mat Su area awareness and action regarding the opioid epidemic. Any questions or needs?
