It has now been two years since my term as President began. COVID-19 is still having a global impact and keeping us aware of the sudden impact it can have. During the past year, we had to cancel one sanctioned event being the 2020 South Island Boccia Championships, but fortunately we were able to deliver the 2020 NZ National Boccia Championships in October, which was the only sanctioned event delivered during the year.

In October 2020, our Director of Boccia, Scott Martin relocated to Christchurch from Auckland, and I would like to acknowledge Ken Sowden and the team at ParaFed Canterbury for the support they have provided Scott since his move south.

During the past year, the Boccia NZ Board have evaluated current processes and developed a new 2021 - 2025 Strategic Plan and 2021 - 2028 High Performance Strategy to shape the strategic direction and development of boccia and Boccia NZ moving forward.

There has been no high-performance activities / international events due to COVID-19, however we look forward to getting back to international competition in the coming year, given it is safe to do so.

Financially, Boccia NZ finished the year with a small surplus of \$4,280.71, leaving BoNZ with approximately \$28,000.00 in net assets.

This past year, Boccia NZ has been financially independent, meaning we did not receive a financial contribution from the Cerebral Palsy Society of NZ.

There have been no new purchases and the DoB has done an excellent job in steering finances for the period.

Enhancing financial sustainability is a priority, and moving forward a key strategic goal for the organisation will be to diversify revenue streams and build cash reserves.

Sport development remains both a key strategic priority and challenge for Boccia NZ as we continue to engage with regional delivery partners to identify and implement an effective approach to regional sport development across the country.

Over the past year, work in this area centered around key actions identified within the strategic action plan developed during the 2019 National Grassroots Planning Forum including:

- Engaging new regions and facilitating the formation of boccia clubs / groups
- Providing administrative support and development opportunities to existing clubs / groups
- Developing online accreditation for coaches and referees (regional and national level)
- Developing an online resource for athlete and official's development pathways
- Delivering a BISFed Basic Classifier Course

The highlight of the year has been the development of a boccia group in the Hawke's Bay region. In collaboration with Sport Hawke's Bay, Boccia NZ delivered a workshop in Napier in November 2020 which involved a coach development session followed by a 'Have-A-Go' community session. Following this, and after a period of planning and preparation in the early part of 2021, the group launched a 6-week programme in June 2021 with great success.

The group has established a core of 6-8 players as well as a few wonderful volunteers and are looking forward to building towards becoming an affiliated boccia club in the coming year.

Moving forward, Boccia NZ is committed to working with regions to establish, enhance and support the development of boccia and is looking to target regions within the ParaFed Network to ensure any new or existing clubs and groups have the necessary administrative support and resources to deliver quality programmes and opportunities and to ensure they remain sustainable and progressive.

Over the past year, Boccia NZ has been developing new coach and referee accreditation with the purpose of providing a development pathway for coaches and referees to strengthen the capacity and capability of coaching and refereeing nationwide and having accredited coaches and referees engaging at all levels. This new accreditation includes Coach Level 1 (regional) and Level 2 (national) Accreditation and Referee Level 1 (regional) and Level 2 (national) Accreditation.

Given the ongoing challenges posed by COVID-19 and the limited human and financial resources of Boccia NZ, a key focus for this accreditation is the ability for it to be delivered online / virtually to ensure the accreditation is accessible and cost effective.

The accreditation has now been piloted within small tests groups and is now set for regional delivery. The new accreditation accommodates regional delivery partners, clubs / groups and individuals and will align and enhance coach and referee development across the country to ensure the experience of boccia is delivered in a consistent manner throughout the country.

In addition to new coach and referee accreditation, Boccia NZ is working on creating a development pathway resource for athletes, classifiers, coaches, referees and sports-assistants. This resource will outline the pathway including accreditation and events within each role from grassroots / community level through to high-performance / international level. This resource will help individuals / volunteers entering the sport to understand what their journey will look like depending on the role they wish to pursue.

This resource is currently in draft format and once finalised, will be uploaded to the Boccia NZ website.

Boccia NZ had plans of delivering a BISFed Basic Classifier Course in October 2020, with the purpose of recruiting and developing new medical and technical classifiers within the sport of boccia. However, travel restrictions caused by the COVID-19 Pandemic meant this course was cancelled and unable to be postponed. As a result, Boccia NZ was forced to rethink its approach to classifier development. With the support of Paralympics NZ and there Classification Manager, Boccia NZ has been fortunate to engage a medical classifier and secure a HPSNZ scholarship to support the development of this new medical classifier.

Boccia NZ is very excited to welcome Christine Ongley into our sport and organisation and we are very fortunate to have the services of a medical classifier with the level of knowledge, skill and experience that Christine has.

Christine has a background in physiotherapy with experience working with neurological impairments and is also an internationally accredited classifier in the sport of Para Alpine Skiing.

Moving forward, Boccia NZ is in a position to conduct complete National classification for our athletes, which plays an important role in the implementation of a wider classification plan aimed at increasing organisational and sport capability in this area.

EVENTS SANCTIONED

The COVID-19 pandemic had a significant impact on our sanctioned events for the year, with the 2020 South Island Boccia Championships (Christchurch) cancelled and the decision to push back the 2021 Regional Championships Auckland until September, due to uncertainty surrounding COVID-19. The 2020 NZ National Boccia Championships were able to go ahead in Christchurch, providing the opportunity for live competition and giving our athletes the chance to test themselves against the best players from around the country.

28 athletes from across 7 regions competed in Teams, Pairs and Individuals across 4 days of quality competition.

1. Statement of Accounting Policies

The financial statements presented here are for the entity Boccia New Zealand Incorporated, an Incorporated Society registered under the Incorporated Societies Act 1908.

The financial statements of Boccia New Zealand Incorporated have been prepared according to special purpose financial reporting.

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historical cost basis have been used, with the exception of certain items for which specific accounting policies have been identified.

2. Changes in Accounting Policies

There have been no changes in Accounting Policies. All policies have been applied on bases consistent with those used in previous years.

3. Goods and Services Tax

These financial statements have been prepared on a GST exclusive basis as the entity is registered for GST. GST is accounted for on the payment's basis.

4. Taxation

No provision for Income Tax has been made as there is no current or deferred tax payable.

5. Revenue

Boccia New Zealand received grants from various Trusts and income in the form of donations, membership and event fees, interest and player contributions which are recognised in the period they are received. Income is also received from equipment sales and is recognised in the period the equipment is supplied.

6. Grant Usage

Boccia New Zealand must continue to comply with the specific purpose, terms and conditions attached to each grant.

7. Subscriptions Receivable

Receivables are stated at their estimated realisable value. Bad debts are written off in the year in which they are identified.

8. Related Parties

There were no related party transactions during the year under review.

9. Review
