



Thank you for inquiring about making Shelby Manor Senior or Riverside Apartments your new home!

In order to apply for an apartment with our community each applicant will need to return the following information to our office.

- 1) Completed Application
- 2) Copy of Driver's License
- 3) Verification of Social Security Card
- 4) Copy of two (2) most recent bank statements that show your income (direct deposits), award letters, and/or copy of your last two (2) paystubs if currently employed.
- 5) \$50.00 Application processing fee (cash, check, or money order) made payable to Shelby Manor Apartments or Riverside Apartments (*Depending on which community you are applying for*).
- 6) If applying to an available apartment:

\$500.00 check (holding fee) to reserve the apartment until your move-in date. This \$500.00 payment goes toward your total move-in cost. *After 24 hours the \$500 is non-refundable.*

If applying to the waiting list:

\$125.00 Waitlist fee to reserve placement on the waiting list for upcoming availability with a completed wait list agreement form. This \$125.00 payment goes toward your total move-in cost once an available apartment is accepted.
