## Factors to Consider That May Occur During the Repair of Your Vehicle

Re-inspections: Hidden damage requires us to stop work, notify your insurance company, and wait for re-inspection and approval before continuing. Their supplemental paperwork confirms the updated repair process.

Parts: Delays may occur if parts are not available or require ordering. I authorize Speedway Autobody to order parts on my behalf for the repair of my vehicle.

Color Match: Every color is unique. Even new vehicles require precise color tinting which may take over two hours.

Reassembly: To prevent overspray or peeling, we remove and later reattach painted parts with care, which takes time.

Weather: Cold weather slows drying. Hot weather may cause unwanted chemical reactions.

Previous Repairs: Repairs overlapping previously repaired areas may require additional work to ensure quality.



If we cannot repair your vehicle, a charge will apply for labor done during disassembly and damage estimation.

## **Payment Information**

All charges MUST be paid at the time of pickup/delivery. We accept:

- MasterCard, Visa, American Express, Discover
- Debit cards, business/personal checks (up to \$1,500 with ID), cashiers checks
- Insurance checks, and cash

Speedway Autobody and its vendors may operate your vehicle for testing or transport. During repairs, your battery may be disconnected, which could erase radio stations or memory presets.

### **Warranty & Parts Policy**

We guarantee Body & Paint for as long as you own the vehicle.

Labor and paint are guaranteed for as long as you own the car.

- Parts warranty: 12 months or 12,000 miles (whichever comes first)
- Suspension alignments: 3 months or 4,000 miles
- No warranty on rust repairs
