The last two years were very difficult with The Pandemic when we faced a series of problem which reaffirmed our faith is dedicated and selfless service. At this juncture YUVA feels important to explore the possibilities for Prioritizing Children who have suffered great losses – in learning, nutrition, and emotional health due to prolonged closure of schools and anganwadi centers by Initiating Education Accelerator Model – Addressing Learning Deficit, initiating village based teen clubs for children at Risk of distress migration, and implementing an integrated model to eradicate child malnutrition.

We are extremely thankful to the team for their tireless efforts in ensuring vaccination of the most vulnerable segments of the society against COVID who could not have taken vaccines on their own. YUVA emphasized on ensuring small livelihood activities for the reverse migrants and with those families who had lost their near and dear during COVID. The support for livelihood was focussed on vending activities, non-farm and farm based.

It's worth that the organization has developed livelihood models of agriculture and animal husbandry at Kurdeg Block in Simdega and has achieved milestones in our work with the children under difficult circumstances in the coal mining areas of Hazaribag and Ramgarh.

YUVA is playing vital role in capacity building of social activists of small VOs of Bihar/Jharkhand- which in turn will benefit many thousands needy people of the community. Joining hands with The CII, UN GLOBAL Compact Network, IICA, TISS has introduced partner VOs on new techniques and importance of local fund raising.

We extend our heartfelt congratulations to all those who had developed Prototype replicable models of development. We are very much grateful to all our donors, supporters, friends and staffs, those contributed for the social developmental Initiatives. We are equally thankful to our critics who have made us active throughout the year.

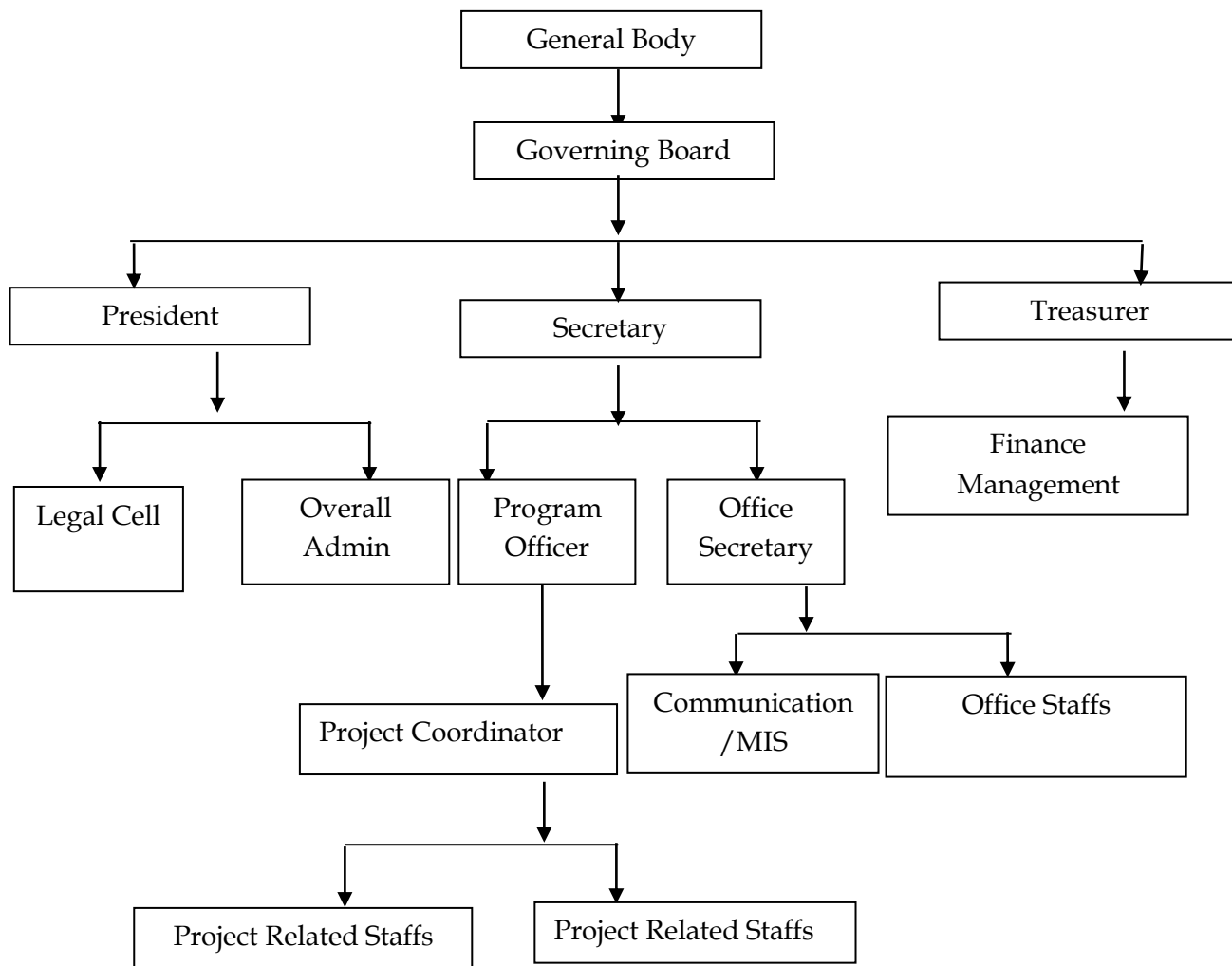

## Key Activities Undertaken

- **Ramping Up COVID Vaccination Drives Among the Most Vulnerable Population:-**

YUVA undertook a formative study to identify the vulnerable target groups who could not come on their own for vaccination centers. Five such groups were identified. It was observed that some of the target group members are either weak physically and some are financially weak and as a result of it they would not come to the vaccination centre for their fear of losing their one day earning. This might result in their own safety and the safety of the others in the society. Counselling was done to ward off myths and misconceptions if any related to vaccination against COVID. Support of a good ration kit with some eatable in the ready form were promised to be provided to each of the targeted beneficiary during each vaccination. Had the dry ration kit and transportation in some cases not provided to them they could not have come to the centers for vaccination. Had not we provided the support of the volunteers for booking of the slots for their registration the targeted beneficiaries could not have got vaccinated. The three districts in Jharkhand namely Hazaribag, Koderma and Ramgarh were taken up for ramping up the vaccination drive as the pace of vaccination was found to be slow in comparison to the other districts in the state.

In addition to these Vaccination Drive The Intervention on COVID was taken up in the first and second phase with the support of dry ration kits and Hygiene Kits to nearly 2760 families in the poorest of the poor segment of the society. The dry ration kit contained raw food items to serve the basic requirement of one family with 5-6 members for one month along with nutritional supplements. The hygiene kits included masks, sanitizers, sanitary napkins, soap and savlon etc.



The supply of ration kits was undertaken in Sadar and Govindpur Blocks of Dhanbad and in the coal mining areas of Ramgarh District in Ramgarh.

In addition to the above mentioned support the noteworthy intervention undertaken were:-

1. 422 Adolescent girls were supported with hygiene kits in Chatra District.
2. 2 Food Stalls were initiated at Koderma Railway Station to Support the Migrants who returned to their homes during lockdown.
3. Supported the Department of Health at four district namely Hazaribag, Ramgarh, Chatra and Koderma with Help Desks involving our youth volunteers during second phase of COVID to support the affected people with hospital beds, consultation with doctors. This was done in coordination with the respective District Administration.
4. Supported the District Administration of Hazaribag making provisions for Quarantine Centers being run for the migrants during the phase 1.

Among the reverse migrants and those who had lost their sources of livelihood during COVID, small livelihood initiatives like the support for setting up of small vending activities were taken up, some families were supported for initiation of non farm activities.

1. 41 Ultrapoor families in Ramgarh and Hazaribag who lost their bread earners during COVID were supported with livestock to boost their supplementary and complementary livelihood opportunities. (Piggery, Goatry, Poultry and Duck Rearing )
2. 67 families were supported with seeds and fertilizers to support their economic activities.

3. 7 families were supported with mushroom production to support their livelihood.

## **2. Jharkhand Tribal Empowerment and Livelihood Enhancement Intervention**

With Support from IFAD through the Jharkhand Tribal Development Society, Ministry of Tribal Development, Govt. of Jharkhand, an integrated livelihood planning and empowerment project is being undertaken by YUVA in Kurdeg Block of Simdega District, Jharkhand. The Updated progress of the Livelihood Intervention in kurdeg block is as follows:-

- Initiation of Small Group Based Livelihood Intervention with 49 Women Self Help Groups out of the 128 women self-help groups which have been formed in 19 tribal villages. 100% of the 128 women self-help groups have been linked with the Jharkhand State Livelihood Promotion Society.
- 21 villages based youth clubs formed and each one of the youth club has initiated a livelihood intervention with the corpus support from Jharkhand Tribal Development Society.
- The Livelihood Intervention taken up by the YCs are Initiation of Tent House, Initiation of Light and Sound System, Internet Café, Small food stall, Mushroom Production Unit, leased based joint farming practices for tomato production.
- Patch wise GSRMLP (Gram Sabha based Resource Mapping and Livelihood Planning Exercise Undertaken for each of the revenue villages of 5 Panchayat.
- 8 piggery, 8 piggery, 20 poultry, and 117 nutrition garden undertaken.
- Semialata experimented with 62 farmers.
- 12 irrigation ponds 21 dug wells have been completed.
- 66 low land ring wells for irrigation purposes developed for winter vegetables.
- Through Integration with MGNREGA 11 ponds have been constructed for improved irrigational requirements.
- Promoted System of Rice Intensification for promotion of Kharif Paddy, wheat, pulses and maize.
- Distributed Solar Lamp to each of the tribal households.
- Developed plan of convergence with the various on going schemes of the govt. for the resource-less poor tribal families.



POP was developed through identification of such crops keeping in mind the soil health, and the following considerations the POP were developed for them. During the sessions with the farmers the developed POP were discussed and they were oriented on the methods and technical knowhow to adopting such measures.

The crops were identified based on the following considerations.

- Direct seeded
- Short duration
- Little land Preparation
- Less Investment

- Can tolerate temperature change in October
- Can also yield fodder
- Can contribute significantly to family need

### **Combating Gender Discrimination**

Under Support from European Union through Plan India the Organization undertook several initiatives to fight the worst forms of gender discrimination, declining child sex ratio, cases of atrocities against women through development of an integrated plan of action through convergence.

- Based on NFHS 4 and 5 Reports, HMIS Data reflecting the poor status of sex ratio at birth YUVA took leadership roles in the development of district observatory group for improved action on the sex determination were formed and empowered. The district level body was constituted under the chairpersonship of the District collectors and included the Superintendent of Police, Secretary DLSA, DEO, DSE, Civil Surgeon, District social Welfare Officer and the District Child Protection Officer.
- Developed a platform of Collaborative Action group of Media and NGOs to strengthen the mass base for community action on worst forms of gender discrimination.
- Supported the department of health and family welfare, Department of health
- Oriented the members of the District Advisory Committees, District Inspection and Monitoring Committees under the PC & PNDDT Cell of the Department of health of Hazaribag, Ramgarh and Koderma on the provisions of the Act. Sensitized the Owners and Operators/Doctors of the USG Clinics/GC/GCC/IVF Centers on the provisions of the Act and the mandatory compliances of under the Provisions as well as the penalties for the non compliances.
- Tracked 907 families through MIS to ensure the improved health status of the pregnant women and the new born. Through the house hold visits to the targeted families we ensure 100% institutional deliveries, pre and post natal care, regular tracking, improved immunization status, none of the families moved ahead for the determination of the sex of the foetus, immunization of the new born, the registration of their births and death.
- Mobilized 922 Peer Educators from segments of Adolescents, Youths, New Weds and In Laws to act as Gender Ambassadors in their areas to ensure improved gender roles, changes in the mindset of people.
- Mainstreamed the Youth Clubs based at the villages and got them affiliated with the Nehru Yuva Jendra Sangathan which is an autonomous body under the Ministry of youth Affairs and Sports. GOI.
- Nurtured and Strengthened the 10 Village based Child Protection Committees and 10 Village health and Sanitation Committees as Community action groups in the villages to reduce incidences of gender discrimination at the village level and ensure child Protection through the vulnerability planning, tracking of children and development of planning for mainstreaming of children with the various schemes of the govt. Trained 400 such members in the year.
- Oriented govt. front line workers namely the Anganwadi workers, the ANMs and the Sahiyya on Gender Sensitization for their improved roles in the society.

- Organized media Campaign in consultation with SWAR a leading media house in Jharkhand for undertaking promotion for the cause of improving the survival of Girl Children with the slogan of Let Girls be Born , Stay Alive and Lead a life of dignity and respect. The campaign was flagged off by the DC, Ramgarh and was undertaken through Mobile Van for 10 days in our Intervention area. The same intervention was inaugurated Ranchi by the Urban Development Minister , GOJ, Ranchi.
- Celebrated UN Girl Child Day on the theme of Take Over on the themes of the UN for its celebration. Both the Mukhiyas of the two Panchayats handed over their responsibility to some of the leading women /girls in their Panchayat for one day to understand their priorities and hence see the interventions in Gender Perspective.
- Celebrated National Girl Child Day through the celebration of the birth of Girl Children within the communities.
- Identified 21 cases of atrocities against women and worked in close coordination with them through the gender resource center of the organization which acts as a one window for improved access to the schemes of the various govt. departments. Presented with DLSA, Ramgarh for their legal support so that the victim gets justice.
- Developed tools for tracking the progress, community based gender sensitization tools as and made efforts to identify and plan for changing at least one gender roles.
- Organized state level orientation workshop for the departments like health, women and child development, JHALSA, NGOs and Media in consultation with State Commission for Protection of Child Rights.
- The model of Intervention of YUVA on Combating Discrimination was identified as a replicable model and was posted in the YouTube of European Union. The successful stories of change of two peer leaders were also uploaded on the Facebook account of EU. PLAN India sent all their partners working in 9 districts of the country across three states for an exposure to learn from the prototype model. YUVA was appreciated by the govt. and was included in the District Advisory Committees as well as on the District Inspection and Monitoring Committees of the two districts namely Ramgarh and Hazaribag in the area.

- **Health and Education For Children Working in Coal Mining areas of Ramgarh**

With support from PHF, UK YUVA undertook the task of empowering and strengthening of the School Management Committees for improvement in the status of class room transactions. The Previous Intervention was focussed on ensuring 100% of the children are mainstreamed in the formal system of education. All those admitted are retained in schools and their average attendance is not below 80 %. On accomplishing the same it was observed that owing to poor class room transactions at school the children and their parents



were showing disinterest in the formal system of education. YUVA undertook extensive efforts to strengthen the SMC and develop their ownership in ensuring that their children have access to quality education. The SMCs were trained on the roles and responsibilities of the members, election processes, Annual Budget and how to develop their own budget aimed at the welfare of their own children. The teachers at school were orientated on life skills and media advocacy was taken up to ensure that the children have access to quality education. Media advocacy was also helpful in improving the status of Children teacher ratio in each of the schools in the coal mining pockets which initially was very poor.

The Pandemic turned down all the milestones which we had accomplished during the five years of Intervention which had brought 3127 out of school children from the ultra poor families in the coal; mining areas of Ramgarh District to the formal system of education. The complete lockdown during COVID resulted into reversal of enrolment drives and retention fell down drastically. When the families lost their livelihood the entire family including their children got involved in the picking up of coal from the defunct coal mines and its sale to meet their both ends.

The affect of pandemic resulted in increased domestic violence, reversal of children from school, early marriages of the girl children and even cases of trafficking were found to be on the rise.

During the lockdown YUVA managed to involve the children and the parents through their online counselling and efforts are being made to explore the possibilities for Prioritizing Children who have suffered great losses – in learning, nutrition, and emotional health due to prolonged closure of schools and anganwadi centers by Initiating Education Accelerator Model – Addressing Learning Deficit, initiating village based teen clubs for children at Risk of distress migration, and implementing an integrated model to eradicate child malnutrition.

YUVA supports the 12 teen clubs in the coal mining pockets of Ramgarh which act as communication teams in their respective areas to advocate issues related to children. Several Nukkad Nataks were performed at each of the locations either separately or jointly with the girls team members.

- **Health Awareness Camps in Hard to Reach Areas:-**

Keeping in mind the poor access of the health services in the rural as well as in the urban areas of Hazaribag and Ramgarh YUVA is in partnership with non financial support from Kshitiz Hospital and Research Center which is Super speciality hospital in the district through which we provided the noteworthy services.

- Organized 42 health camps in this financial year at different locations in the rural areas of Hazaribag and some areas of Ramgarh during COVID in which a total of 2776 cases were dealt. The cases were mainly of the following nature – Basic health problems curative care, basic treatment against commonly and seasonal problems, distribution of tonics, IFA, anti natal and post natal care, referral services in difficult cases of pregnancy,



counselling support for specialized care, deworming, treating cases of malnutrition. These camps were organized to ward off the issues of mobility and connectivity from the unreached areas. Dr. Kaushik Roy, MBBS, MD, one of the board members of the organization provided all support in organization of health camps involving several doctors from the IMA and has mobilized medicines through the association of representatives.

- YUVA has undertaken VIDYAJYOTI School Eye Health Program covering 100% of the schools for identification and correction of refractive errors among students and teachers at Ramgarh District in Jharkhand. During Post COVID Period Eye Clubs have been promoted in each of the schools to promote eye care in each of the schools. The Intervention was initially supported by Essilor Foundation, NPCB and SSA.
  - YUVA has undertaken interventions for the promotion of health and hygiene in the areas through the adoption of CLTS tools in the areas for warding off the cases of water borne diseases, unnatural deaths owing to incidences of Cholera, diarrhoea, loose motions, indigestion etc.
  - YUVA provides resource inputs to the Department of health in the strengthening of NRHM Interventions of the district and is also included in the membership of District Advisory Committee formed by the department of Health. YUVA also represents in the DIMC of Department of health.
  - Smile Foundation has approved the support of Smile on Wheels Program for increasing the reach of the health services of YUVA in the hard to reach areas. This support would be an added advantage to the Intervention of YUVA to improve the accessibility and availability of the quality health services in inaccessible areas.
- **Empowerment of Youths**

Empowerment of Youths in all the spheres of life so that they can realize their full potential is the main thrust of the organization. YUVA being a resource agency of Nehru Yuva Kendra which is an autonomous body under the Ministry of youth Affairs and Sports, Govt. Of India undertakes the responsibilities of capacity building of its National Service Volunteers, National Youth Corps and its youth leaders. It is also one of the DART members of Rajiv Gandhi National Institute of Youth Development Activities, Sripermbatur.



The strength of Youth force was utilized during the period of COVID in order to ensure that each one in their village gets vaccinated and adopt a COVID Appropriate Behaviour to make our villages a safe place. The registration and slot booking exercise of the vulnerable segments of the society for their complete vaccination was done by the youth club members.

In order to develop a positive atmosphere in the society after COVID sports activities were promoted in the areas. During the financial year we accomplished the following

- 12 youth clubs have been affiliated with NYKS.
- 07 training programs on ARSH and personality development undertaken.

### **Quality Education Program for Children**

YUVA runs a quality education program at Edison Public School increased in Tati Jharia. The affect of COVID had an adverse impact on the strength of the students at school. The student strength fell to 213 from 686. The noteworthy achievements of the education unit of the organization was as follows:-



- Run the classes through online mode for the limited number of students
- Undertook teachers training program by using various resource persons.
- Organized online Science Exhibition, Quiz Program, Talent Hunt Programs, Singing and Dance Competitions, Dainik Jagaran Rakhi Making and Posting Program for the Indian Army.
- The various programs were aimed at the development of competitive spirit among the students.

The intervention of quality education is on self-sustained mode by YUVA from its own resources.

### **Empowerment of Persons with Various Disabilities:-**

- 1219 people with various forms of disabilities were added in the DPOs list.
- 4 training programs involving 209 PWDs were trained online on RPWD Act.
- One training program was undertaken to develop among the 23 DPO Leaders on the development of their own business plans, feasibility studies of the various income generation activities.
- Counselling Programs for the trainees as well as career melas were organized to promote their employment as well as self-employment. Through the mela the candidates became able to know the opportunities for them to improve the prospects of livelihood for them.



- YUVA has Identified 79 cases of Children living with mental sickness, mental retardation (with or without epilepsy) and cerebral palsy. In order to get the same treated at RIMS for their course of action a vehicle support was provided by Stock Holding Corporation of India Limited, Mumbai. As it was difficult to take the families along with their children in the public mode of transport to RIMS for their free medical consultation the support from SHCIL proved to be a milestone for their diagnosis. The organization is providing regular hand holding through home visits to support to the children and their families in their community.

### Institution Building

Institution believes that a strong civil society is essential for both economic development and democracy. Individuals from Different walks of life lead initiatives that bring about change. We synergize collective efforts to become powerful agents of change to make our institution a durable, dynamic, and capable of significant Impact.

In its efforts to build our Institution efforts have been taken to modify and develop regulatory frameworks for Personnel policies, skill up-gradation, Crisis and Conflict Management, Performance Appraisal, Impact Assessment, M & E and Documentation.

A Cell for advanced planning and research is planned to be constituted to meet the growing needs of the Institution in the years to come to face the cut throat competitions.

The Sole purpose of Institution building is improving organizational effectiveness which is more about perspectives and processes and less about money.

- Initiative undertaken to improve the institutional efficiency through enhanced skills of the manpower on issues related to Education, Health, NRM for livelihood promotion.
- Upgrading personnel policies to improving the institutional efficiencies and effectiveness in dealing with the organizational requirements.

The Program Committee also advises the professional staffs on the development skills and Knowledge required.
