While registering your employees, it is necessary to upload their Aadhar Card number also and correct details of name, date of birth, address of the employee and their family members. It would also be necessary to check the drop box for attachment of your employees with an IMP (Insured Medical Practitioner) for Hazaribagh. After that, a printout of the TIC (Temporary Identity Card) and Med 7B form is required to be given to the concerned employees so that he can approach the IMP with the TIC which will show IMP attachment.

It is also informed that tie up arrangements with an IMP are finalized and his address is Dr. Rajat Chakraborty, HZB Arogyam Hospital, Hazaribagh, Contact No 9431140150 has been appointed as IMP for Hazaribagh.. Kindly send your employees to him/her with TIC and Med 7B after online registration of your unit on esic web portal.

Sub : Implementation of the E.S.I. act, 1948 and Registration of Employees of the Factories and Establishments under Section 1(3)/1(5) of the ESI Act, as amended.

Dear Sir(s),

1. It is informed that under section 1(3) of the ESI Act, 1948 is applicable to all factories covered under the Act within the area where your factory is situated.
2. It is further informed that the appropriate Government has extended the provisions of the Act to other establishments Under Section 1(5) of the Act in this area
3. Under Section 2 A of the Act such a factory/establishment is required to register itself under the Act and Chapter IV thereof casts a responsibility on the principal employer thereof to get his employees registered and pay contributions in respect of these employees covered under the Act.
4. On the basis of the particulars in respect of your factory/establishment submitted by you/ on the basis of the report of the inspection conducted by the Social Security Officer, who inspected your factory on -NA-, your factory falls within the purview of Section 2(12) of the Act with effect from 01/03/2017. In case, however, subsequent facts reveal that your factory was coverable from a date prior to the date mentioned above, you shall make yourself liable to comply with the provisions of the Act from such earlier date.
5. It is requested to take immediate steps for registration of your employees by submitting declaration forms online, payment of contribution, maintenance of records etc. from the date of coverage of your factory/establishment under the act.
6. You are also requested to submit employer's registration form (form 01) on line, as required under the provisions of sec.2-A of the ESI Act , 1948 read with regulation 10-B of the ESI(General), Regulations, 1950(only in case your Code No. is allotted as a result of Survey by a Social Security Officer of ESI Corporation).
7. For the sake of convenience your factory/establishment has been allotted code No **60001609960001301** which may kindly be used in all communications sent to this office and on all forms at the place indicated for the purpose. The Branch Office of the Corporation situated at **Branch Manager, ESIC, Marar, Ranchi Road, Ramgar** has been instructed to render necessary assistance to you in connection with registration of your employees. In case you find any difficulty or for any other purpose which may be necessary in connection with the Scheme you are requested to contact the Manager of the above Branch Office who will render necessary help in the matter.
